What actions were you able to avoid because of the capital infusion of CPP/CDCI funds?

Without the infusion of capital, we would have restricted deposit accumulation in order to maintain capital levels. This has permitted us to maintain staffing levels at the prior year's level

What actions were you able to take that you may not have taken without the capital infusion of CPP/CDCI funds?

We had earmarked these funds as a long term investment that would be used to support the growth of our mortgage portfolio. We are now observing mortgage loan growth of 18% over the past year. Our consumer loans have also increased by 17%.

Please describe any other actions that you were able to undertake with the capital infusion of CPP/CDCI funds.

DC Federal Credit Union has been successful in enhancing its capital strength and serving our communities by making credit available to 11,000 individuals. The productive use of CDCI funds is one of the tools that we have found helpful for our accomplishment of these objectives.
