MARTIN J. SULLIVAN

President and Chief Executive Officer, AIG

Martin J. Sullivan is President and Chief Executive Officer of American International Group, Inc. (AIG), the world's leading global insurance and financial services organization operating in 130 countries and jurisdictions worldwide. Mr. Sullivan served as Vice Chairman and Co-Chief Operating Officer from May 2002 until March 2005, when he was elected to his current position. He also serves on the AIG Board of Directors.

Mr. Sullivan joined the company in the Finance Department of American International Underwriters (AIU), AIG's non-life insurance company in the United Kingdom, in 1971. In 1974, he joined the Property Department and held a succession of underwriting and management assignments in the UK and Ireland. In 1983, Mr. Sullivan was appointed Property Manager for the UK and later Regional Property Manager for the UK/Ireland Division.

In 1988, Mr. Sullivan was named Manager of AIU's London office and Regional Marketing Manager for UK/Ireland. He was later appointed Assistant Managing Director of AIG Europe (UK) Ltd. in 1989 and Chief Operating Officer in 1991. In 1993, he was named President of AIU's UK/Ireland Division and Managing Director of AIG Europe (UK) Ltd.

Mr. Sullivan was elected Senior Vice President, Foreign General Insurance in 1996 and Executive Vice President, Foreign General in 1998. In 1996, he was appointed Chief Operating Officer of AIU in New York and named President in 1997.

Mr. Sullivan is Chairman of the US-ASEAN Business Council, an Associate Member of the Chartered Insurance Institute, a Fellow of the Institute of Leadership & Management and a Member of the Chartered Management Institute. He also serves in the following capacities: a Director of the Geneva Association; a member of the Business Advisory Committees of the St. George's Society and The British Memorial Garden Trust; a member of the American Advisory Council of the London Symphony Orchestra; a member of the International Advisory Council of Guanghua School of Management at Peking University; a member of the Board of Trustees of the American Associates of the Royal Academy Trust; a member of the Board of Overseers – School of Risk Management, St. John's University; and a member of the Board of Directors of the Inner City Scholarship Fund. He was also formerly the President of British American Business Inc.

Mr. Sullivan was made a member of the Order of the British Empire in the 2007 Queen's Birthday Honors list.

Mr. Sullivan is married and has two daughters and a son.

STEVEN J. BENSINGER

Executive Vice President and Chief Financial Officer, AIG

Steven J. Bensinger is Executive Vice President and Chief Financial Officer of American International Group, Inc. (AIG). He has served in that capacity since March 2005. Mr. Bensinger joined AIG as Treasurer in October 2002 and was elected an AIG Senior Vice President in January 2005 when he was named Treasurer and Comptroller.

Prior to joining AIG, Mr. Bensinger was Executive Vice President and Chief Financial Officer of Combined Specialty Group, Inc., the insurance underwriting operations of Aon Corporation. Prior to joining Chartwell, Mr. Bensinger was President and Chief Operating Officer and a director of Skandia America Reinsurance Corporation, a position he assumed in early March 1991. Prior to that, he served as Skandia America's Executive Vice President and Chief Financial Officer. Mr. Bensinger also served as Chairman of the Board of numerous Skandia subsidiaries.

Mr. Bensinger joined Skandia America in October 1987 after an eleven-year career with the international accounting and consulting firm of PricewaterhouseCoopers, where he was a partner in the New York insurance practice.

Mr. Bensinger is a Certified Public Accountant and a member of both the American Institute of Certified Public Accountants and the New York State Society of Certified Public Accountants. He graduated from New York University's Stern School of Business in 1976. Mr. Bensinger has served as a Board member and as President of the Stern School of Business Alumni Association. Edmund Tse is Senior Vice Chairman – Life Insurance of American International Group, Inc (AIG) as well as Chairman and Chief Executive Officer of American International Assurance Co., Ltd. (AIA). AIA is one of the largest life insurance companies in Southeast Asia and a member company of AIG.

An industry veteran, Mr. Tse has been instrumental in building the Group's successful life insurance business in Asia as well as in many emerging markets. He began his career with AIG in 1961 when he joined AIA in Hong Kong. In 1970, he was posted to an affiliate of AIG in Taiwan, Nan Shan Life Insurance Co., Ltd., which has since grown to become one of the largest insurance companies in Taiwan. He was appointed President and Managing Director of Nan Shan in 1975, and Chairman in 1990. Upon his return to Hong Kong, Mr. Tse was named President and Chief Executive Officer of AIA in 1983, and Chairman and CEO of AIA in 2000.

Concurrent with his move in AIA, Mr. Tse was given charge of AIG's growing life insurance business globally when he was elected to the AIG Board of Directors in 1996 and appointed Vice Chairman in 1997.
