The Notes (as defined herein) (other than the Class A-1LT-b Notes and the Class E Notes), the Class X Notes and the Preferred Shares (as defined herein) (collectively, the "Offered Securities") are being offered hereby in the United States to qualified institutional buyers (as defined in Rule 144A under the United States Securities Act of 1933, as amended (the "Securities Act")), in reliance on Rule 144A under the Securities Act, and, solely in the case of the Class X Notes and the Preferred Shares, to accredited investors (as defined in Rule 501(a) under the Securities Act) who have a net worth of not less than U.S.\$10 million in transactions exempt from registration under the Securities Act. It is a condition of the issuance of the Securities that the Class A-1LT-a Notes, the Class A-1LT-b Notes and the Class A-2 Notes be issued with a rating of "Aaa" by Moody's Investors Service, Inc. ("Moody's") and "AAA" by Standard & Poor's Ratings Services, a division of The McGraw-Hill Companies, Inc. ("S&P," and together with Moody's, the "Rating Agencies"), that the Class B Notes be issued with a rating of at least "Aa2" by Moody's and at least "AA" by S&P, that the Class C Notes be issued with a rating of at least "A2" by Moody's and at least "A" by S&P, that the Class D Notes be issued with a rating of at least "Baa2" by Moody's and at least "BBB" by S&P and that the Class E Notes be issued with an initial rating on the Closing Date of at least "Ba3" by Moody's and at least "BB+" by S&P assuming the Maximum Issuance Amount and the Maximum Coupon for the Class E Notes. The Class X Notes and the Preferred Shares will not be rated. A credit rating is not a recommendation to buy, sell or hold securities and may be subject to revision or withdrawal at any time by the assigning rating agency. See "Ratings of the Notes."

The Offered Securities are being offered by Goldman, Sachs & Co. (in the case of the Offered Securities offered outside the United States, selling through its selling agent) (the "Initial Purchaser"), in each case, as specified herein, subject to its right to reject any order in whole or in part, in one or more negotiated transactions or otherwise at varying prices to be determined at the time of sale *plus* accrued interest, if any, from the Closing Date (as defined herein). It is expected that the Class A Notes, Class B Notes, Class C Notes, Class D Notes, Regulation S Class E Notes and Regulation S Preferred Shares will be ready for delivery in book entry form only in New York, New York, on or about October 20, 2005 (the "Closing Date"), through the facilities of DTC and in the case of the Securities sold outside the United States, for the accounts of Euroclear Bank S.A./N.V., as operator of the Euroclear System ("Euroclear") and Clearstream Banking, société anonyme ("Clearstream"), against payment therefor in immediately available funds. It is expected that the Preferred Shares (other than the Regulation S Preferred Shares), the Class E Notes (other than the Regulation S Class E Notes) and the Class X Notes will be ready for delivery in definitive form in New York, New York on the Closing Date, against payment therefor in immediately available funds. The Notes and the Class X Notes sold in reliance on Rule 144A will be issued in minimum denominations of U.S.\$250,000 and integral multiples of U.S.\$1 in excess thereof. G Street Finance Ltd., an exempted company incorporated with limited liability under the laws of the Cayman Islands (the "Issuer") and G Street Finance (Delaware) Corp., a Delaware corporation (the "Co-Issuer" and, together with the Issuer, the "Issuers"), will issue U.S.\$266,000,000 principal amount of Class A-1LT-a Floating Rate Notes Due 2041 (the "Class A-1LT-a Notes"), U.S.\$50,900,000 principal amount of Class A-2 Floating Rate Notes Due 2041 (the "Class A-2 Notes" and, together with the Class A-1LT-a Notes and the Class A-1LT-b Notes (as defined herein), the "Class A Notes"), U.S.\$57,000,000 principal amount of Class B Floating Rate Notes Due 2041 (the "Class B Notes"), U.S.\$30,000,000 principal amount of Class C Floating Rate Notes Due 2041 (the "Class C Notes"), U.S.\$24,000,000 principal amount of Class D Floating Rate Notes Due 2041 (the "Class D Notes") and the Issuer is authorized to issue up to U.S.\$5,000,000 principal amount of Class E Floating Rate Notes Due 2041 (the "Class E Notes" and, together with the Class A Notes, Class B Notes, Class C Notes and Class D Notes, the "Notes") and U.S. \$1,500,900,000 Notional Principal Balance of Class X Notes Due 2041 (the "Class X Notes") pursuant to an Indenture (the "Indenture") dated on or about October 20, 2005 among the Issuers and LaSalle Bank National Association, as trustee and securities intermediary (the "Trustee" and the "Securities Intermediary," respectively). The Class E Notes are not being offered hereby.

In addition, the Issuer will issue 1,000 Preferred Shares, having a par value of U.S.\$0.01 per share and an Initial Stated Amount (as defined herein) of approximately U.S.\$9,000 per share (the "Preferred Shares" and, together with the Notes and the Class X Notes, the "Securities"), as part of its issued share capital in accordance with the Issuer's amended and restated memorandum and articles of association and certain resolutions of the Issuer's Board of Directors. The Preferred Shares will be subject to a Preferred Share Paying and Transfer Agency Agreement (as defined herein).

On the Closing Date, the Issuers will also issue U.S.\$1,064,000,000 of commercial paper notes (the "CP Notes") with maturities of no more than 270 days from the date of issuance. If the put option under the CP Put Agreement is exercised in whole or in part prior to its expiration, the Issuers will issue the Class A-1LT-b Floating Rate Notes due 2041 (the "Class A-1LT-b Notes") in one or more placements to the CP Put Counterparty which will have an aggregate principal amount equal to the face amount of CP Notes to be retired as of the date of the exercise of the put option under the CP Put Agreement. Payments to the CP Notes and the Class A-1LT-b Notes, if any, will be paid *pari passu* with the Class A-1LT-a Notes. The CP Notes and the Class A-1LT-b Notes are not offered hereby.

The net proceeds received from the offering of the Securities and the CP Notes will be applied by the Issuer to purchase a portfolio of Residential Mortgage-Backed Securities, Commercial Mortgage-Backed Securities, CDO Securities and Asset-Backed Securities as described herein (collectively, "Collateral Assets"), and certain Eligible Investments (as defined herein). Certain summary information about the Collateral Assets is set forth in Appendix B to this Offering Circular. In addition, certain of the offering documents, term sheets, trustee reports and remittance reports relating to the Collateral Assets are included on the CD-ROM attached to this Offering Circular. On the Closing Date, the Issuer will enter into one or more Hedge Agreements (as defined herein) and the CP Put Agreement (as defined herein). The Collateral Assets, the Eligible Investments and certain other assets of the Issuer will be pledged under the Indenture to the Trustee, for the benefit of the Secured Parties (as defined herein), as security for, among other obligations, the Issuers' obligations under the Notes and the CP Notes (but not the Preferred Shares) and to certain service providers.

Interest will be payable on the Class A Notes and the Class B Notes in arrears on the 8th day of each calendar month, or if any such date is not a Business Day (as defined herein), the immediately following Business Day (each such date, a "Payment Date") commencing January 9, 2006 (or the first Payment Date following the date of issuance in the case of the Class A-1LT-b Notes) and interest will be payable on the Class C Notes, the Class D Notes and the Class E Notes in arrears on January 8, April 8, July 8 and October 8 of each year, or if any such date is not a Business Day, the immediately following Business Day (each such date, a "Quarterly Payment Date") commencing on January 9, 2006 or the first Quarterly Payment Date following the date of the exercise of the Class E Issuance Option in the case of the Class E Notes. The Class A-1LT-a Notes will bear interest at a per annum rate equal to LIBOR *plus* 0.32% from the Closing Date to the November 2008 Payment Date and 0.34% per annum thereafter for each Interest Accrual Period (as defined herein). The Class A-2 Notes will bear interest at a per annum

rate equal to LIBOR *plus* 0.40% for each Interest Accrual Period. The Class B Notes will bear interest at a per annum rate equal to LIBOR *plus* 0.58% for each Interest Accrual Period. The Class C Notes will bear interest at a per annum rate equal to LIBOR *plus* 1.40% for each Interest Accrual Period. The Class D Notes will bear interest at a per annum rate equal to LIBOR *plus* 3.00% for each Interest Accrual Period. The Class E Notes will bear interest, following the exercise of the Class E Issuance Option, at a per annum rate equal to LIBOR *plus* a margin equal to or less than 3.00% for each Interest Accrual Period. The Class A-1LT-b Notes, if issued, will bear interest at the per annum rates described herein. Dividends and other distributions will be payable on the Preferred Shares from funds legally available therefor. The Class X Notes will be entitled to receive the Class X Payment to the extent of funds available in accordance with the Priority of Payments on each Payment Date.

All payments on the Securities and the CP Notes will be made from Proceeds (and, with respect to the CP Notes, the CP Reserve Accounts) available in accordance with the Priority of Payments and, in the case of the CP Notes, in accordance with the CP Issuing and Paying Agency Agreement. On each Payment Date, except as otherwise provided in the Priority of Payments, payments on the Class X Notes will be senior to payments on the Class A Notes, the CP Notes and the Class B Notes; and payments on the Class A Notes and the CP Notes will be senior to payments on the Class B Notes. On each Quarterly Payment Date, except as otherwise provided in the Priority of Payments, payments on the Class X Notes will be senior to payments on the Class A Notes, the CP Notes, the Class B Notes, the Class C Notes, the Class D Notes, the Class E Notes and the Preferred Shares; payments on the Class A Notes and the CP Notes will be senior to payments on the Class B Notes, the Class C Notes, the Class D Notes, the Class E Notes and the Preferred Shares; payments on the Class B Notes will be senior to payments on the Class C Notes, the Class D Notes, the Class E Notes and the Preferred Shares; payments on the Class C Notes will be senior to payments on the Class D Notes, the Class E Notes and the Preferred Shares; payments on the Class D Notes will be senior to payments on the Class E Notes and the Preferred Shares; and payments on the Class E Notes will be senior to payments on the Preferred Shares, in accordance with the Priority of Payments as described herein. Certain of the Notes (other than the Class E Notes) are subject to mandatory redemption and the CP Notes are subject to defeasance, if a Coverage Test is not satisfied on any date of determination which may result in variations to the seniorities of distributions described above and as more fully described in the Priority of Payments.

The Securities are subject to redemption and the CP Notes are subject to defeasance, in whole and not in part, (i) at any time as a result of a Tax Redemption (as defined herein), (ii) on an Auction Payment Date (as defined herein) as a result of a successful Auction (as defined herein) or (iii) as a result of an Optional Redemption (as defined herein) on or after the January 2009 Payment Date. The stated maturity of the Notes and the Class X Notes and the date on which the Preferred Shares are scheduled to receive their final distribution (if any) and to be redeemed by the Issuer is the Payment Date in January 2041. The actual final distribution on the Securities is expected to occur substantially earlier. See "Risk Factors—Securities—Average Lives, Duration and Prepayment Considerations."

Notes (other than the Class E Notes) sold in reliance on Rule 144A under the Securities Act ("Rule 144A") will be evidenced by one or more global notes (the "Rule 144A Global Notes") in fully registered form without coupons, deposited with a custodian for, and registered in the name of, a nominee of The Depository Trust Company ("DTC"). Beneficial interests in the Rule 144A Global Notes will trade in DTC's Same Day Funds Settlement System, and secondary market trading activity in such interests will therefore settle in immediately available funds. Except as described herein, beneficial interests in the Rule 144A Global Notes will be shown on, and transfers thereof will be effected only through, records maintained by DTC and its direct and indirect participants. The Class E Notes and the Class X Notes sold in reliance on Rule 144A under the Securities Act will be evidenced by one or more Definitive Notes in fully registered form.

TRANSFERS OF THIS NOTE SHALL BE LIMITED TO TRANSFERS MADE IN ACCORDANCE WITH THE RESTRICTIONS SET FORTH IN THE INDENTURE.

PRINCIPAL OF THIS NOTE IS PAYABLE AS SET FORTH HEREIN. ACCORDINGLY, THE OUTSTANDING PRINCIPAL OF THIS NOTE AT ANY TIME MAY BE LESS THAN THE AMOUNT SHOWN ON THE FACE HEREOF. ANY PERSON ACQUIRING THIS NOTE MAY ASCERTAIN ITS CURRENT PRINCIPAL AMOUNT BY INQUIRY OF THE NOTE PAYING AGENT.

9. The purchaser acknowledges that it is its intent and that it understands it is the intent of the Issuer that, for purposes of U.S. federal income, state and local income and franchise tax and any other income taxes, the Issuer will be treated as a corporation, the Notes will be treated as indebtedness of the Issuer, and the Class X Notes and the Preferred Shares will be treated as equity in the Issuer; the purchaser agrees to such treatment and agrees to take no action inconsistent with such treatment.

10. The purchaser understands that the Issuers, the Trustee, the Initial Purchaser, the Collateral Manager, the Collateral Adviser, the CP Put Counterparty and the CP Note Placement Agents and their counsel will rely upon the accuracy and truth of the foregoing representations, and the purchaser hereby consents to such reliance.

SUMMARY

The following summary is qualified in its entirety by the detailed information appearing elsewhere in this Offering Circular. For definitions of certain terms used in this Offering Circular see "Appendix A — Certain Definitions" and for the location of the definitions of those and other terms, see "Index of Defined Terms." For a discussion of certain factors to be considered in connection with an investment in the Securities, see "Risk Factors."

The Issuers G Street Finance Ltd. (the "Issuer") is an exempted company incorporated under the laws of the Cayman Islands for the sole purpose of acquiring the Collateral Assets, Eligible Investments, entering into Hedge Agreements, the CP Put Agreement, co-issuing the Notes (other than the Class E Notes) and the CP Notes, issuing the Class E Notes, the Class X Notes and the Preferred Shares and engaging in certain related transactions.

The Issuer will not have any assets other than the portfolio consisting primarily of Residential Mortgage-Backed Securities, Commercial Mortgage-Backed Securities, CDO Securities and Asset-Backed Securities as described herein (collectively, "Collateral Assets"), Eligible Investments, various interest rate swap agreements and cashflow swap agreements (the "Rate Swap Agreements" or the "Hedge Agreements"), the CP Put Agreement, the Collateral Management Agreement, the Collateral Advisory Agreement and certain other assets. The Collateral Assets, the Eligible Investments and certain other assets of the Issuer will be pledged by the Issuer to the Trustee under the Indenture, for the benefit of the Secured Parties, as security for, among other obligations, the Issuers' obligations under the Notes and the CP Notes.

G Street Finance (Delaware) Corp. (the "Co-Issuer" and, together with the Issuer, the "Issuers") is a corporation formed under the laws of the State of Delaware for the sole purpose of co-issuing the Notes (other than the Class E Notes) and the CP Notes.

The Co-Issuer will not have any assets (other than U.S.\$10 of equity capital) and will not pledge any assets to secure the Notes or the CP Notes. The Co-Issuer will have no claim against the Issuer in respect of the Collateral Assets or otherwise.

The authorized share capital of the Issuer consists of (i) 1,000 Preferred Shares, par value U.S.\$0.01 per share, which will be issued on the Closing Date and (ii) 250 ordinary shares, par value U.S.\$1.00 per share ("Issuer Ordinary Shares"), which will be issued on or prior to the Closing Date. The Issuer Ordinary Shares and all of the outstanding common equity of the Co-Issuer will be held by Maples Finance Limited, a licensed trust company incorporated in the Cayman Islands (the "Issuer Administrator") as the trustee pursuant to the terms of a charitable trust (the "Share Trustee").

The Collateral Manager Wharton Asset Management Bermuda Limited, a private limited company incorporated under the laws of Bermuda ("Wharton Asset Management"), will perform certain monitoring functions with respect to the Collateral Assets pursuant to a collateral management agreement to be dated as of the Closing Date (the "Collateral Management Agreement") between the Issuer and Wharton Asset Management, as Collateral Manager (in such capacity, the "Collateral Manager"). In addition, the Collateral Manager will, subject to the terms of the Collateral Management Agreement, monitor the issuance and sale of the CP Notes. Wharton Asset Management is not a registered investment adviser under the United States Investment Advisers Act of 1940, as amended. See "The Collateral Manager."

The Collateral Adviser Wharton Asset Management UK Limited, a private limited company incorporated in England and Wales (registered number 04012461), with offices located in London (the "Collateral Adviser"), will perform certain advisory, credit analysis and execution functions with respect to the Collateral Assets on behalf of the Collateral Manager in respect of this transaction pursuant to a collateral advisory agreement, dated as of the Closing Date (the "Collateral Advisory Agreement"), between the Issuer, the Collateral Adviser and the Collateral Manager.

In addition to its activities on behalf of the Collateral Manager in respect of this transaction, the Collateral Adviser anticipates providing investment advisory services to the Collateral Manager and other companies investing in collateral debt obligations and investment funds and individual clients with specialized investment programs, some of which may utilize strategies similar to that of the Issuer. The Collateral Adviser will not be responsible for providing any services to the Issuer.

Securities Offered..... On the Closing Date, the Issuer and the Co-Issuer will issue U.S.\$266,000,000 principal amount of Class A-1LT-a Floating Rate Notes Due 2041 (the "Class A-1LT-a Notes"), U.S.\$50,900,000 principal amount of Class A-2 Floating Rate Notes Due 2041 (the "Class A-2 Notes" and, together with the Class A-1LT-a Notes and the Class A-1LT-b Notes (as defined below), the "Class A Notes"), U.S.\$57,000,000 principal amount of Class B Floating Rate Notes Due 2041 (the "Class B Notes"), U.S.\$30,000,000 principal amount of Class C Floating Rate Notes Due 2041 (the "Class C Notes") and U.S.\$24,000,000 principal amount of Class D Floating Rate Notes Due 2041 (the "Class D Notes") and the Issuer is authorized to issue on any Payment Date up to U.S.\$5,000,000 principal amount of Class E Floating Rate Notes Due 2041 under the circumstances described herein (the "Class E Notes," and, together with the Class A Notes, Class B Notes, Class C Notes and Class D Notes, the "Notes") and U.S.\$1,500,900,000 Notional Principal Balance

of Class X Notes Due 2041 (the "Class X Notes") pursuant to an Indenture (the "Indenture") dated on or about October 20, 2005 among the Issuers and LaSalle Bank National Association, as trustee and as securities intermediary (the "Trustee" and the "Securities Intermediary," respectively). Under the Indenture, LaSalle Bank National Association will also act as principal paying agent for the Notes (the "Principal Note Paying Agent"), as registrar (the "Note Registrar"), as calculation agent (the "Note Calculation Agent"), as transfer agent (the "Note Transfer Agent") and as paying agent for the Notes (the "Note Paying Agent" and, together with the Principal Note Paying Agent, the Note Registrar, the Note Calculation Agent, the Note Transfer Agent and the Listing and Paying Agent, the "Note Agents").

On the Closing Date, the Issuer will also issue 1,000 Preferred Shares, which have a par value of U.S.\$0.01 per share and an Initial Stated Amount of approximately U.S.\$9,000 per share (the "Preferred Shares" and, together with the Notes, the "Securities"), pursuant to its amended and restated memorandum and articles of association (the "Memorandum and Articles of Association") as part of its issued share capital and certain resolutions of the board of directors passed at a meeting of the directors on or before the issue of the Preferred Shares as memorialized in the minutes thereof (the "Resolutions"). Only the Notes (other than the Class A-1LT-b Notes and the Class E Notes), the Class X Notes and the Preferred Shares (collectively, the "Offered Securities") are offered hereby.

The Preferred Shares will be subject to the Preferred Share Paying and Transfer Agency Agreement (the "Preferred Share Paying and Transfer Agency Agreement") dated as of the Closing Date among the Issuer, ABN AMRO Bank N.V. (London Branch), as paying agent and transfer agent for the Preferred Shares (in such respective capacities, the "Preferred Share Paying Agent" and the "Preferred Share Transfer Agent," together the "Preferred Share Paying and Transfer Agent"), and Maples Finance Limited, as share registrar for the Preferred Shares (the "Share Registrar" and, together with the Preferred Share Paying Agent and the Preferred Share Transfer Agent, the "Preferred Share Agents", and, together with the Note Agents, the "Agents"). The Note Paying Agent, the Principal Note Paying Agent and any other Note paying agents appointed from time to time under the Indenture are collectively referred to as the "Note Paying Agents." The Note Paying Agents and the Preferred Share Paying Agent are collectively referred to as the "Paying Agents." The Note Transfer Agent and the Preferred Share Transfer Agent are collectively referred to as the "Transfer Agents." The Indenture, the Collateral Management Agreement, the Collateral Advisory Agreement, the Hedge Agreements, the Collateral Administration Agreement, the CP Issuing and Paying Agency Agreement, the CP Put Agreement, the CP Note Placement Agreement,

the Administration Agreement and the Preferred Share Paying and Transfer Agency Agreement are collectively referred to as the "Transaction Documents."

Other Securities.....

The Issuers will also issue on the Closing Date and from time to time thereafter U.S.\$1,064,000,000 of commercial paper notes (the "CP Notes") with maturities of no more than 270 days from the date of issuance. The CP Notes (including any LIBOR CP Notes as described herein) will be issued pursuant to an issuing and paying agency agreement (the "CP Issuing and Paying Agency Agreement"), dated as of the Closing Date, among the Issuer, LaSalle Bank National Association, as CP Issuing and Paying Agent (the "CP Issuing and Paying Agent") and the Collateral Manager. The maturity date of any CP Note will be extendable by up to three Business Days in the event the CP Put Option is exercised in accordance with the CP Put Agreement. See "Security for the Notes-CP Put Agreement" herein. If the CP Put Option under the CP Put Agreement is exercised in whole or in part, the Issuers will issue the Class A-1LT-b-1 Notes (the "Class A-1LT-b-1 Notes") or the Class A-1LT-b-2 Notes (the "Class A-1LT-b-2 Notes" and, together with the Class A-1LT-b-1 Notes, the "Class A-1LT-b Notes") in one or more placements to the CP Put Counterparty which will have an aggregate principal amount equal to the face amount of CP Notes to be retired as of the date of the exercise of such CP Put Option. The CP Notes and the Class A-1LT-b Notes are not offered hereby.

On any Quarterly Payment Date, the principal balance of the Class E Notes may be increased up to the Maximum Issuance Amount if the Class E Issuance Option is exercised by the Holders of a Majority of the Preferred Shares as described herein. See "Description of the Securities-Class E Issuance Option" herein.

Closing Date.....

The Issuer will issue the Class E Notes (with an initial zero principal balance), the Class X Notes and the Preferred Shares and the Issuers will issue the CP Notes and the other Notes on or about October 20, 2005 (the "Closing Date").

Status of the Securities

The Notes (other than the Class E Notes) and the CP Notes will be limited recourse obligations of the Issuers and the Class E Notes and the Class X Notes will be limited recourse obligations of the Issuer. The Preferred Shares will be part of the issued share capital of the Issuer, will not be secured obligations of the Issuer and will only be entitled to receive amounts available for distribution on any Quarterly Payment Date after payment of all amounts payable prior thereto under the Priority of Payments and only out of funds legally available therefor. Interest on the Class A-1LT-a Notes will be *pro rata* with interest on the Class A-2 Notes. Principal on the Class A-1LT-a Notes and the Class A-2 Notes will be paid either *pro rata* or first to the Class A-1LT-a Notes and second to the Class A-2 Notes depending on the

circumstances as more fully described in the Priority of Payments. Payments with respect to the CP Notes and the Class A-1LT-b Notes will be paid *pari passu* with the payments on the Class A-1LT-a Notes. The Class X Notes will be senior in right of payment on each Payment Date to the Class A Notes, the CP Notes and the Class B Notes and will be senior in right of payment on each Quarterly Payment Date to the Class A Notes, the CP Notes, the Class B Notes, the Class C Notes, the Class D Notes, the Class E Notes and the Preferred Shares. The Class A Notes and the CP Notes will be senior in right of payment on each Payment Date to the Class B Notes and will be senior in right of payment on each Quarterly Payment Date to the Class B Notes, the Class C Notes, the Class D Notes, the Class E Notes and the Preferred Shares. The Class B Notes will be senior in right of payment on each Quarterly Payment Date to the Class C Notes, the Class D Notes, the Class E Notes and the Preferred Shares. The Class C Notes will be senior in right of payment on each Quarterly Payment Date to the Class D Notes, the Class E Notes and the Preferred Shares. The Class D Notes will be senior in right of payment on each Quarterly Payment Date to the Class E Notes and the Preferred Shares. The Class E Notes will be senior in right of payment on each Quarterly Payment Date to the Preferred Shares. See "Description of the Securities—Status and Security" and "—Priority of Payments."

Use of Proceeds.....

The net proceeds associated with the offering of the Securities and the CP Notes issued on the Closing Date, after the payment of applicable fees and expenses, are expected to equal approximately U.S.\$1,499,812,016. The net proceeds will be used by the Issuer to purchase on the Closing Date or thereafter pursuant to agreements to purchase entered into on or prior to the Closing Date, the portfolio of Collateral Assets described herein having an aggregate Principal Balance of approximately U.S.\$ 1,500,900,000. To the extent any payments of principal are received on the Collateral Assets prior to October 31, 2005, up to U.S.\$15,000,000 of such Principal Proceeds may be invested in a specified Residential Mortgage-Backed Security as described herein. See "Security for the Notes—Disposition of Collateral Assets" and "Use of Proceeds."

The Collateral Assets

The Collateral Assets initially will be comprised of:

- i. 230 issues of Residential Mortgage-Backed Securities across 4 categories, constituting approximately 87.8% of the Collateral Assets (by principal balance),
- ii. 9 issues of Commercial Mortgage-Backed Securities across 3 categories, constituting approximately 3.3% of the Collateral Assets (by principal balance),

iii. 19 issues of CDO Securities across 4 categories, constituting approximately 8.2% of the Collateral Assets (by principal balance), and

iv. 3 issues of Asset-Backed Securities across one category, constituting approximately 0.7% of the Collateral Assets (by principal balance).

See "Security for the Notes—The Collateral Assets." Certain summary information about the Collateral Assets (other than those Collateral Assets which have not yet been issued) is set forth in Appendix B to this Offering Circular. In addition, certain of the offering documents, term sheets, trustee reports and remittance reports relating to each of the Collateral Assets are set forth on the CD-ROM attached to this Offering Circular.

Interest Payments and Certain Distributions

The Notes (other than the Class A-1LT-b Notes and the Class E Notes) will accrue interest from the Closing Date, the Class A-1LT-b Notes will accrue interest from the date of their issuance and the Class E Notes will accrue interest from the date of the exercise of the Class E Issuance Option and such interest will be payable, in the case of the Class A Notes and the Class B Notes, on the 8th day of each calendar month, or if any such date is not a Business Day, the immediately following Business Day (each such date, a "Payment Date") commencing on January 9, 2006 and, in the case of the Class C Notes, the Class D Notes and the Class E Notes, on January 8, April 8, July 8 and October 8 of each year, or if any such date is not a Business Day, the immediately following Business Day (each such date, a "Quarterly Payment Date") commencing on January 9, 2006. The Class X Payment will be payable to the Holders of the Class X Notes on each Payment Date. Dividends on the Preferred Shares will be payable in arrears on each Quarterly Payment Date out of funds legally available therefor. All payments on the Securities and the CP Notes will be made from Proceeds (and, with respect to the CP Notes, amounts on deposit in the CP Reserve Accounts and the CP Account) in accordance with the Priority of Payments and, in the case of the CP Notes, in accordance with the CP Issuing and Paying Agency Agreement.

The Class A-1LT-a Notes will bear interest during each Interest Accrual Period at a per annum rate (the "Class A-1LT-a Note Interest Rate") equal to LIBOR for such Interest Accrual Period *plus* 0.32% from the Closing Date to the November 2008 Payment Date and 0.34% thereafter.

The Class A-1LT-b-1 Notes will bear interest during each Interest Accrual Period at a per annum rate (the "Class A-1LT-b-1 Note Interest Rate") equal to LIBOR for such Interest Accrual Period *plus* 0.27% before the November 2008 Payment Date (accruing up to the November 2008 Payment Date) and *plus* 0.31% thereafter.

The Class A-1LT-b-2 Notes will bear interest during each Interest Accrual Period at a per annum rate (the "Class A-1LT-b-2 Note Interest Rate") equal to LIBOR for such Interest Accrual Period *plus* 0.25%.

The Class A-2 Notes will bear interest during each Interest Accrual Period at a per annum rate (the "Class A-2 Note Interest Rate") equal to LIBOR for such Interest Accrual Period *plus* 0.40%.

The Class B Notes will bear interest during each Interest Accrual Period at a per annum rate (the "Class B Note Interest Rate") equal to LIBOR for such Interest Accrual Period *plus* 0.58%.

The Class C Notes will bear interest during each Interest Accrual Period at a per annum rate (the "Class C Note Interest Rate") equal to LIBOR for such Interest Accrual Period *plus* 1.40%.

The Class D Notes will bear interest during each Interest Accrual Period at a per annum rate (the "Class D Note Interest Rate") equal to LIBOR for such Interest Accrual Period *plus* 3.00%.

The Class E Notes, after the Class E Issuance Option has been exercised, will bear interest during each Interest Accrual Period at a per annum rate (the "Class E Note Interest Rate") equal to LIBOR for such Interest Accrual Period *plus* a margin equal to or less than 3.00% (the "Maximum Coupon") as determined on the date such option is exercised.

The CP Notes (other than the LIBOR CP Notes as described herein) will be issued at a discount based on LIBOR. To the extent CP Notes are issued with an equivalent LIBOR-based interest rate (the "LIBOR CP Notes"), they will mature on a Payment Date and will have a maturity that is equal to or more than one month but no more than 270 days from their issuance. CP Notes issued with a maturity greater than three months after their issuance are required to be LIBOR CP Notes. The LIBOR CP Notes will bear interest during each Interest Accrual Period at a per annum rate equal to LIBOR (or, for a designated initial payment period of less than 25 days, the linear interpolation thereof, calculated in accordance with generally accepted methodology) for such Interest Accrual Period, commencing on their date of issuance (the "LIBOR CP Note Interest Rate"). Payments of interest on the LIBOR CP Notes and principal at maturity will be made only on a Payment Date (subject to early redemption as provided herein). Principal payments at maturity will be made through deposit to the CP Principal Reserve Account in accordance with the Priority of Payments. The maturity date of any CP Note is extendable

by up to three Business Days if the CP Put Option is exercised in accordance with the CP Put Agreement. See "Security for the Notes-CP Put Agreement" herein. If the maturity date of a CP Note is so extended, the holder thereof will be entitled to receive accrued interest for the period of such extension at a per annum rate equal to LIBOR *plus* 0.09%. Payment of such accrued interest will be made first from the CP Interest Reserve Account and, then, to the extent of any shortfall, from the Collection Account in accordance with the Indenture.

The Class A-1LT-a Note Interest Rate, the Class A-1LT-b-1 Note Interest Rate, the Class A-1LT-b-2 Note Interest Rate, the Class A-2 Note Interest Rate, the Class B Note Interest Rate, the Class C Note Interest Rate, the Class D Note Interest Rate, the Class E Note Interest Rate and the LIBOR CP Note Interest Rate are collectively referred to herein as the "Note Interest Rates."

To the extent interest that is due is not paid on the Class C Notes on any Quarterly Payment Date ("Class C Deferred Interest"), such unpaid amounts will be added to the principal amount of the Class C Notes, and shall accrue interest at the Class C Note Interest Rate to the extent lawful and enforceable. So long as any CP Notes, Class A Notes or Class B Notes are outstanding, the failure to pay any interest on the Class C Notes on any Quarterly Payment Date will not be an Event of Default under the Indenture. To the extent interest that is due is not paid on the Class D Notes on any Quarterly Payment Date ("Class D Deferred Interest"), such unpaid amounts will be added to the principal amount of the Class D Notes, and shall accrue interest at the Class D Note Interest Rate to the extent lawful and enforceable. So long as any CP Notes, Class A Notes, Class B Notes or Class C Notes are outstanding, the failure to pay any interest on the Class D Notes on any Quarterly Payment Date will not be an Event of Default under the Indenture. To the extent interest that is due is not paid on the Class E Notes on any Quarterly Payment Date ("Class E Deferred Interest"), such unpaid amounts will be added to the principal amount of the Class E Notes, and shall accrue interest at the Class E Note Interest Rate to the extent lawful and enforceable. So long as any CP Notes, Class A Notes, Class B Notes, Class C Notes or Class D Notes are outstanding, the failure to pay any interest on the Class E Notes on any Quarterly Payment Date will not be an Event of Default under the Indenture.

See "Description of the Securities – Interest and Dividends" and "—Priority of Payments."

LIBOR for the first Interest Accrual Period with respect to each Class of Notes will be determined as of the second Business Day preceding the Closing Date (or, with respect to the Class A-1LT-b Notes, the issuance date thereof, and with respect to the Class E Notes, the date of the exercise of the

Class E Issuance Option). Calculations of interest on each Class of the Notes will be made on the basis of a 360-day year and the actual number of days in each Interest Accrual Period.

The "Interest Accrual Period" with respect to the Class A-1LT Notes, the Class A-2 Notes, the Class B Notes and the LIBOR CP Notes and any Payment Date, is the period commencing on and including the immediately preceding Payment Date (or the Closing Date in the case of the first Interest Accrual Period, or the date of issuance in the case of the first Interest Accrual Period and the Class A-1LT-b Notes and the LIBOR CP Notes) and ending on and including the day immediately preceding such Payment Date and with respect to the Class C Notes, the Class D Notes and the Class E Notes and any Quarterly Payment Date, the period commencing on and including the immediately preceding Quarterly Payment Date (or the Closing Date in the case of the first Interest Accrual Period, or the date of exercise of the Class E Issuance Option in the case of the first Interest Accrual Period and the Class E Notes) and ending on and including the day immediately preceding such Quarterly Payment Date.

On each Payment Date, the Holders of the Class X Notes will be entitled to receive the Class X Payment, after payment of items ranking higher in accordance with the Priority of Payments. The Class X Payment will be calculated on the basis of a 360 day year consisting of twelve 30-day months.

The Holders of the Preferred Shares will be entitled to receive, on each Quarterly Payment Date, all cash remaining after the payment of all other amounts required to be paid in accordance with the Priority of Payments to the extent of funds legally available therefor.

Principal Payments.....

The Notes and the Class X Notes will mature on the Payment Date in January 2041 (each such date the "Stated Maturity" with respect to the Notes and the Class X Notes) and the Preferred Shares are scheduled to receive their final distributions and be redeemed by the Issuer on the Payment Date in January 2041 (the "Scheduled Preferred Share Redemption Date"), unless redeemed or retired prior thereto. The average life of the Notes and the Class X Notes is expected to be substantially shorter than the number of years from issuance until Stated Maturity for each Class of Notes and the Class X Notes. See "Description of the Securities—Principal" and "Risk Factors—Securities—Average Lives, Duration and Prepayment Considerations."

Principal will be payable on the Notes in accordance with the Priority of Payments on each Payment Date or Quarterly Payment Date commencing on the Quarterly Payment Date occurring in January 2006 (or the first Payment Date following the date of issuance in the case of the Class A-1LT-

b Notes and the first Quarterly Payment Date after the date of the exercise of the Class E Issuance Option in the case of the Class E Notes) as described in the Priority of Payments.

As a result of the Priority of Payments, notwithstanding the subordination of the Securities described under "Status of the Securities" above, the Class B Notes may be entitled to receive certain payments of principal while the Class X Notes, the CP Notes and the Class A Notes are outstanding, the Class C Notes may be entitled to receive certain payments of principal while the Class X Notes, the CP Notes, the Class A Notes and the Class B Notes are outstanding, the Class D Notes may be entitled to receive certain payments of principal while the Class X Notes, the CP Notes, the Class A Notes, the Class B Notes and the Class C Notes are outstanding and the Class E Notes may be entitled to receive certain payments of principal while the Class X Notes, the CP Notes, the Class A Notes, the Class B Notes, the Class C Notes and the Class D Notes are outstanding. In addition, the Preferred Shares may be entitled to receive certain payments while the Securities are outstanding. See "Description of the Securities—Priority of Payments."

In addition, to the extent funds are available therefor in accordance with the Priority of Payments, certain of the Notes (other than the Class X Notes and the Class E Notes) will be subject to mandatory redemption and the CP Notes will be subject to defeasance on any Payment Date or Quarterly Payment Date, as applicable, if the Coverage Tests are not satisfied as described herein. See "Description of the Securities—Principal" and "—Mandatory Redemption."

The Class X Notes are not entitled to payments of principal, but will be entitled to receive the Class X Payment on each Payment Date, to the extent Proceeds are available therefor in accordance with the Priority of Payments.

Tax Redemption

Subject to certain conditions described herein, the Notes and the Class X Notes will be redeemed and the CP Notes defeased from Liquidation Proceeds, in whole but not in part, on the 90th day (which 90-day period may be extended an additional 90 days, as described under "Description of the Securities—Tax Redemption") following the Issuers becoming aware of the occurrence of a Tax Event, at the written direction of, or with the written consent of, Holders of at least 66-2/3% of the affected Preferred Shares or the Controlling Class which, as a result of the occurrence of such Tax Event, have not received 100% of the aggregate amount of principal and interest or other amounts due and payable to such Holders (such redemption, a "Tax Redemption"). No such Tax Redemption will occur unless the expected Liquidation Proceeds equal or exceed the Total Redemption Amount. Upon the occurrence of a Tax Redemption, the Preferred Shares will be simultaneously redeemed.

With respect to a Tax Redemption as described above, the Notes and the Class X Notes will be redeemed and the CP Notes will be defeased at their Note Redemption Prices, respectively, as described herein. The amount distributable as the final distribution on the Preferred Shares following any Tax Redemption will equal the amount of the Liquidation Proceeds remaining after the redemption of the Notes and the Class X Notes and defeasance of the CP Notes in full together with the payment of all other amounts required to be paid in accordance with the Priority of Payments.

See "Description of the Securities—Tax Redemption."

Auction

Sixty days prior to the Payment Date occurring in January of each year (the "Auction Date"), commencing on the January 2014 Payment Date, the Collateral Manager shall take steps to conduct an auction (the "Auction") of the Collateral Assets in accordance with the procedures specified in the Indenture. If the Collateral Manager receives one or more bids from Eligible Bidders not later than ten Business Days prior to the Auction Date equal to or greater than the Minimum Bid Amount, it will sell the Collateral Assets for settlement on or before the fifth Business Day prior to such Auction Date and the Notes and the Class X Notes will be redeemed and the CP Notes will be defeased in whole on such Auction Date (any such date, the "Auction Payment Date"). If a successful Auction occurs, the Preferred Shares will also be redeemed in full. If any single bid, or the aggregate amount of multiple bids, does not equal or exceed the aggregate Minimum Bid Amount or if there is a failure at settlement, the Collateral Assets will not be sold and no redemption of Notes, Class X Notes or Preferred Shares or defeasance of the CP Notes on the related Auction Date will be made.

Optional Redemption.....

The Notes and the Class X Notes may be redeemed and the CP Notes may be defeased by the Issuers from Liquidation Proceeds, in whole but not in part, on any Payment Date on or after the Payment Date occurring in January 2009 (the "Optional Redemption Date"), at the written direction of, or with the written consent of the Holders of at least a Majority of the Preferred Shares (an "Optional Redemption"). If the Holders of the Preferred Shares so elect to cause an Optional Redemption, the Preferred Shares will also be redeemed in full.

In the event of an Optional Redemption, the Notes and the Class X Notes will be redeemed and the CP Notes will be defeased at their Note Redemption Prices as described herein.

No Securities shall be redeemed and no CP Notes shall be defeased pursuant to an Optional Redemption and a final distribution to the Preferred Shares shall not be made unless the Collateral Manager furnishes certain assurances that the Total Redemption Amount will be available for distribution on the related Optional Redemption Date.

See "Description of the Securities—Optional Redemption."

Mandatory Redemption On any Payment Date on which any Overcollateralization Test is not satisfied as of the preceding Determination Date and on any Quarterly Payment Date on which any Interest Coverage Test is not satisfied as of the preceding Determination Date, certain of the Securities (other than the Class X Notes, the Class E Notes and the Preferred Shares) will be subject to mandatory redemption and the CP Notes will be subject to defeasance in accordance with the Priority of Payments, until the applicable Notes or CP Notes have been paid or defeased in full (a "Mandatory Redemption"). The Class A Notes and the Class B Notes are also subject to mandatory redemption and the CP Notes are subject to defeasance in accordance with the Priority of Payments on any Payment Date if the Class D Overcollateralization Ratio is less than 75% on the related Determination Date and the Class A Notes, the Class B Notes and the Class C Notes are subject to mandatory redemption and the CP Notes are subject to defeasance in accordance with the Priority of Payments on Payment Dates, or, in the case of the Class C Notes, Quarterly Payment Dates, if the Class D Overcollateralization Ratio is less than 90%. The Collateral Manager is not permitted to sell Collateral Assets to generate additional Proceeds to be applied to redeem the Notes or to defease the CP Notes except to the extent such Collateral Assets may, at the discretion of the Collateral Manager, be otherwise sold as Credit Risk Obligations, equity securities or Defaulted Obligations. The Class E Notes, the Class X Notes and the Preferred Shares are not subject to mandatory redemption as a result of the failure of any Coverage Test. See "Description of the Securities—Mandatory Redemption" and "—Priority of Payments."

Class E Issuance Option On any Quarterly Payment Date, at the written direction of, or with the written consent of, the Holders of at least a Majority of the Preferred Shares, the option to issue the Class E Notes will be exercised (the "Class E Issuance Option") and the Issuer will sell up to U.S.\$5,000,000 face amount of Class E Notes (the "Maximum Issuance Amount"). The Class E Notes may not be sold at a price less than 80% of their face amount. The net proceeds of the exercise of the Class E Issuance Option will be remitted to the Preferred Share Paying Agent for distribution to the Holders of the Preferred Shares and the interest and principal payments on the Class E Notes will be subordinate to interest and principal payments on the other Notes, but senior to any distributions to Preferred Shares as described in the Priority of Payments. The Class E Issuance Option is a single option and may only be exercised one time. See "Description of the Notes and Preferred Shares—Class E Issuance Option".

The Class E Notes will be issued on the Closing Date with an initial principal balance of zero and the principal balance of the Class E Notes will only ever be increased if the Class E Issuance Option is exercised.

CP Put Agreement	On or prior to the Closing Date, the Issuer will enter into a put agreement (together with the related schedule and confirmation, the "CP Put Agreement") with Société Générale, acting through its New York branch (the "CP Put Counterparty"). Under the CP Put Agreement, subject to certain conditions to exercise, if the Trustee gives the CP Put Counterparty notice in accordance with the CP Put Agreement of the occurrence of certain events, the CP Put Counterparty will on or before the third Business Day after such exercise notice was delivered, but in any event, not later than the third Business Day after such CP Notes initially mature, provide the Issuer with sufficient funds (together with amounts on deposit in the CP Principal Reserve Account) to enable the Issuers to repay maturing CP Notes in accordance with the CP Put Agreement. In exchange for such funds, the Issuer will, at the direction of the CP Put Counterparty, deliver to the CP Put Counterparty the Class A-1LT-b Notes in an equivalent amount. See "Security for the Notes—CP Put Agreement."
CP Interest Reserve Facility	<p>The Issuer will enter into a Cashflow Swap Agreement with AIG Financial Products Corp. On the Closing Date, the Class A/B Overcollateralization Ratio is expected to be 104.4%, the Class A/B Interest Coverage Ratio is expected to be 108.2%, the Class C Overcollateralization Ratio is expected to be 102.2%, the Class C Interest Coverage Ratio is expected to be 105.4%, the Class D Overcollateralization Ratio is expected to be 100.6% and the Class D Interest Coverage Ratio is expected to be 102.7%.

The Offering The Offered Securities are being offered to non-U.S. Persons in offshore transactions in reliance on Regulation S, and in the United States to persons who are Qualified Institutional Buyers purchasing in reliance on the exemption from registration under Rule 144A or, with respect to the Class X Notes and the Preferred Shares only, Accredited Investors

purchasing in transactions exempt from registration under the Securities Act. Each purchaser who is a U.S. Person must also be a Qualified Purchaser. Each Accredited Investor must have a net worth of at least U.S.\$10 million. See "Description of the Securities—Form of the Securities," "Underwriting" and "Notice to Investors."

Minimum Denominations

The Notes will be issued in minimum denominations of U.S.\$250,000 (in the case of the Rule 144A Notes) and U.S.\$100,000 (in the case of the Regulation S Notes) and integral multiples of U.S.\$1 in excess thereof for each Class of Notes. The Preferred Shares will be issued in minimum lots of 25 Preferred Shares per investor and integral multiples of one Preferred Share in excess thereof.

Form of the Securities

Each Class of Notes sold in offshore transactions in reliance on Regulation S will initially be represented by one or more temporary global notes (each, a "Temporary Regulation S Global Note"). Each Temporary Regulation S Global Note will be deposited on the Closing Date with LaSalle Bank National Association as custodian for, and registered in the name of Cede & Co. as nominee of The Depository Trust Company ("DTC"), for the respective accounts of Euroclear Bank S.A./N.V., as operator of the Euroclear System ("Euroclear"), and Clearstream Banking, société anonyme ("Clearstream"). Beneficial interests in a Temporary Regulation S Global Note may be held only through Euroclear or Clearstream and may not be held at any time by a U.S. Person ("U.S. Person") (as such term is defined in Regulation S under the Securities Act).

Each Class of Rule 144A Notes (other than the Class E Notes) will be issued in the form of one or more global notes in fully registered form (the "Rule 144A Global Notes" and, together with the Temporary Regulation S Global Notes and the Regulation S Global Notes, the "Global Notes"), deposited with LaSalle Bank National Association as custodian for, and registered in the name of Cede & Co. as nominee of, DTC, which will credit the account of each of its participants with the principal amount of Notes being purchased by or through such participant. Beneficial interests in the Rule 144A Global Notes will be shown on, and transfers thereof will be effected only through, records maintained by DTC and its direct and indirect participants.

The Class E Notes (other than the Regulation S Class E Notes) and the Class X Notes will be evidenced by one or more notes in definitive, fully registered form, registered in the name of the owner thereof (each, a "Definitive Note").

Beneficial interests in the Global Notes and the Definitive Notes may not be transferred except in compliance with the transfer restrictions described herein. See "Description of the Securities—Form of the Securities" and "Notice to Investors."

The Regulation S Preferred Shares will be represented by one or more global certificates in fully registered form deposited on the Closing Date with a custodian for DTC for the respective accounts of Euroclear and Clearstream. The Preferred Shares (other than the Regulation S Preferred Shares) will be evidenced by one or more certificates in definitive, fully registered form, registered in the name of the owner thereof (each, a "Preferred Share Certificate"). The Preferred Shares may not be transferred except in compliance with the transfer restrictions described herein. See "Description of the Securities—Form of the Securities" and "Notice to Investors."

Governing Law	The Indenture, the Notes, the Preferred Share Paying and Transfer Agency Agreement, the CP Put Agreement, the Hedge Agreements, the Collateral Management Agreement and the Collateral Advisory Agreement will be governed by the laws of the State of New York. The rights and privileges of the Preferred Shares (as set forth in the Issuer's Memorandum and Articles of Association) will be governed by the laws of the Cayman Islands.
Listing and Trading	There is currently no market for the Securities and there can be no assurance that such a market will develop. See "Risk Factors—Securities—Limited Liquidity and Restrictions on Transfer." Application may be made to admit the Securities on a stock exchange of the Issuer's choice, if practicable. There can be no assurance that such admission will be sought or granted. See "Listing and General Information."
Ratings	It is a condition of the issuance of the Securities that the Class A-1LT-a Notes, the Class A-1LT-b Notes and the Class A-2 Notes be rated "Aaa" by Moody's and "AAA" by S&P, that the Class B Notes be rated at least "Aa2" by Moody's and at least "AA" by S&P, that the Class C Notes be rated at least "A2" by Moody's and at least "A" by S&P, that the Class D Notes be rated at least "Baa2" by Moody's and at least "BBB" by S&P and that the Class E Notes will be issued with an initial rating on the Closing Date of at least "Ba3" by Moody's and at least "BB+" by S&P assuming the Maximum Issuance Amount and the Maximum Coupon for the Class E Notes. RISK FACTORS

Prior to making an investment decision, prospective investors should carefully consider, in addition to the matters set forth elsewhere in this Offering Circular, the following factors:

Securities

Limited Liquidity and Restrictions on Transfer. There is currently no market for the Securities. Although the Initial Purchaser has advised the Issuers that it intends to make a market in the Offered Securities, the Initial Purchaser is not obligated to do so, and any such market making with respect to the Offered Securities may be discontinued at any time without notice. There can be no assurance that any secondary market for any of the Notes will develop or, if a secondary market does develop, that it will provide the Holders of the Notes with liquidity of investment or that it will continue for the life of such Notes and consequently a purchaser must be prepared to hold the Notes until maturity. Consequently, a purchaser must be prepared to hold the Notes for an indefinite period of time or until Stated Maturity. Since it is likely that there will never be a secondary market for the Class X Notes or the Preferred Shares, a purchaser must be prepared to hold its Class X Notes or Preferred Shares, as applicable, until their Stated Maturity or the Scheduled Preferred Share Redemption Date, as applicable.

In addition, no sale, assignment, participation, pledge or transfer of the Securities may be effected if, among other things, it would require any of the Issuer, the Co-Issuer or any of their officers or directors to register under, or otherwise be subject to the provisions of, the Investment Company Act or any other similar legislation or regulatory action. Furthermore, the Securities will not be registered under the Securities Act or any state securities laws or the laws of any other jurisdiction, and the Issuer has no plans, and is under no obligation, to register the Securities under the Securities Act or any state securities laws or under the laws of any other jurisdiction. The Securities are subject to certain transfer restrictions and can be transferred only to certain transferees as described herein under "Description of the Securities—Form of the Securities" and "Notice to Investors." Such restrictions on the transfer of the Securities may further limit their liquidity. See "Description of the Securities—Form of the Securities." Application may be made to admit the Securities on a stock exchange of the Issuer's choice, if practicable. There can be no assurance that such admission will be sought or granted.

Limited Recourse Obligations. The Class E Notes and the Class X Notes will be limited recourse obligations of the Issuer and the CP Notes, Class A Notes, Class B Notes, Class C Notes and Class D Notes will be limited recourse obligations of the Issuers payable solely from the Collateral pledged by the Issuer to secure the Notes and the CP Notes. The Preferred Shares are equity of the Issuer and are not secured by the Collateral Assets or the other collateral securing the Notes, the Class X Notes and the CP Notes. None of the Collateral Manager, the Collateral Adviser, the Holders of the Securities, the Holders of the CP Notes, the Initial Purchaser, the CP Put Counterparty (except to the extent required under the CP Put Agreement), the CP Note Placement Agents, the Trustee, the Issuer Administrator, the Share Trustee, the Agents, the Hedge Counterparties or any affiliates of any of the foregoing or the Issuers' affiliates or any other person or entity will be obligated to make payments on the Securities or the CP Notes. Consequently, Holders of the Notes and the Class X Notes must rely solely on distributions on the Collateral pledged to secure the Notes, the Class X Notes and the CP Notes for the payment of principal, interest and premium, if any, thereon and payment of the Class X Payment to the Holders of the Class X Notes. If distributions on the Collateral are insufficient to make payments on the Notes or the Class X Notes, no other assets (and, in particular, no assets of the Collateral Manager, the Collateral Adviser, the CP Put Counterparty, the CP Note Placement Agents, the Holders of the Securities, the Initial Purchaser, the Trustee, the Issuer Administrator, the Share Trustee, the Agents, the Hedge Counterparties or any affiliates of any of the foregoing) will be available for payment of the deficiency, and following realization of the Collateral pledged to secure the Notes, the Class X Notes and the CP Notes, the obligations of the Issuers to pay such deficiency shall be extinguished.

Subordination of the Notes, the Class X Notes and the Preferred Shares. Payments of principal on the Class A-1LT-a Notes and the Class A-2 Notes will be paid either *pro rata* or first to the Class A-1LT-a Notes and second to the Class A-2 Notes depending on the circumstances as more fully described

in the Priority of Payments and will be senior to payments of principal of the Class B Notes, Class C Notes, Class D Notes and Class E Notes and senior to the distribution of Proceeds to the Holders of the Preferred Shares on each Payment Date or Quarterly Payment Date, as applicable. Payments with respect to the CP Notes and the Class A-1LT-b Notes, if any, will be paid *pari passu* with payments on the Class A-1LT-a Notes. Payments of principal on the Class B Notes due on any Quarterly Payment Date will be senior to payments of principal on the Class C Notes, the Class D Notes and the Class E Notes and senior to distributions of Proceeds to the Holders of the Preferred Shares on such Quarterly Payment Date. Payments of principal on the Class C Notes due on any Quarterly Payment Date will be senior to payments of principal on the Class D Notes and the Class E Notes and senior to distributions of Proceeds to the Holders of the Preferred Shares on such Quarterly Payment Date. Payments of principal on the Class D Notes due on any Quarterly Payment Date will be senior to payments of principal due on the Class E Notes and senior to distributions of Proceeds to the Holders of the Preferred Shares on such Quarterly Payment Date. Payments of principal due on the Class E Notes will be senior to distributions of Proceeds to the Holders of the Preferred Shares on such Quarterly Payment Date. As a result of the Priority of Payments, notwithstanding the subordination of the Securities described under "Description of the Securities—Status and Security," the Class B Notes will be entitled to receive certain payments of principal while the Class X Notes, the CP Notes and the Class A Notes are outstanding, the Class C Notes will be entitled to receive certain payments of principal while the Class X Notes, the CP Notes, the Class A Notes and the Class B Notes are outstanding and the Class D Notes will be entitled to receive certain payments of principal while the Class X Notes, the CP Notes, the Class A Notes, the Class B Notes and the Class C Notes are outstanding. In addition, the Preferred Shares will be entitled to receive certain payments while the Notes and the Class X Notes are outstanding. See "Description of the Securities—Priority of Payments." To the extent that any losses are incurred by the Issuer in respect of any Collateral, such losses will be borne first by Holders of the Preferred Shares; then, by Holders of the Class E Notes; then, by Holders of the Class D Notes; then, by Holders of the Class C Notes; then, by Holders of the Class B Notes; then, by Holders of the Class A-2 Notes; and finally, by Holders of the Class A-1LT Notes. The Class X Notes are not entitled to payments of principal, but will be entitled to receive the Class X Payment on each Payment Date, to the extent Proceeds are available therefor in accordance with the Priority of Payments.

Payments of interest on the CP Notes, the Class A-1LT-a Notes, the Class A-1LT-b Notes and the Class A-2 Notes due on any Payment Date will generally be paid *pro rata* and will be senior to payments of interest on the Class B Notes on such Payment Date. Payments of interest on the CP Notes, the Class A-1LT-a Notes, the Class A-1LT-b Notes and the Class A-2 Notes due on any Quarterly Payment Date will be paid *pro rata* and will be senior to payments of interest on the Class B Notes, Class C Notes, Class D Notes and Class E Notes and senior to the distributions of Proceeds to the Holders of the Preferred Shares on such Quarterly Payment Date. Payments of interest on the Class B Notes due on any Quarterly Payment Date will be senior to payments of interest on the Class C Notes, the Class D Notes and the Class E Notes and senior to the distributions of Proceeds to the Holders of the Preferred Shares on such Quarterly Payment Date. Payments of interest on the Class C Notes due on any Quarterly Payment Date will be senior to payments of interest on the Class D Notes and the Class E Notes and senior to the distributions of Proceeds to the Holders of the Preferred Shares on such Quarterly Payment Date. Payments of interest on the Class D Notes due on any Quarterly Payment Date will be senior to payments of interest on the Class E Notes and senior to the distributions of Proceeds to the Holders of the Preferred Shares on such Quarterly Payment Date. Payments of interest on the Class E Notes due on any Quarterly Payment Date will be senior to the distributions of Proceeds to the Holders of the Preferred Shares on such Quarterly Payment Date. The Class X Notes are not entitled to payments of interest, but will be entitled to receive the Class X Payment on each Payment Date, to the extent Proceeds are available therefor in accordance with the Priority of Payments. See "Description of the Securities."

On any Quarterly Payment Date on which certain conditions are satisfied and funds are available therefor, the "shifting principal" method in clause (xiii) of the Priority of Payments may permit Holders of the Class B Notes, Class C Notes and Class D Notes to receive payments of principal in accordance with the Priority of Payments while more senior Classes of Notes, the Class X Notes and the CP Notes remain outstanding and may permit distributions of Principal Proceeds to the Holders of the Class E Notes and

the Preferred Shares, to the extent funds are available in accordance with the Priority of Payments after the Class D Notes have been paid in full, but while the more senior Notes, Class X Notes and the CP Notes are outstanding. Amounts properly paid pursuant to the Priority of Payments to a junior Class of Notes or to the Preferred Shares will not be recoverable in the event of a subsequent shortfall in the amount required to pay a more senior Class of Notes, the Class X Notes or the CP Notes.

Holders of the Controlling Class may not be able to effect a liquidation of the Collateral in an Event of Default; Holders of other Classes of Notes and the Class X Notes may be Adversely Affected by Actions of the Controlling Class. If an Event of Default occurs and is continuing, a Majority of the Controlling Class will be entitled to determine the remedies to be exercised under the Indenture; however, the Majority of the Controlling Class will not be able to direct a sale or liquidation of the Collateral unless, among other things, the Trustee determines that the anticipated proceeds of such sale or liquidation (after deducting the reasonable expenses of such sale or liquidation) would be sufficient to pay in full the sum of (A) the principal (including any Class C Deferred Interest, Class D Deferred Interest and Class E Deferred Interest) and accrued interest (including all Defaulted Interest, and interest thereon) and any other amounts due with respect to all the outstanding Notes and CP Notes, (B) unpaid Administrative Expenses, (C) all amounts payable by the Issuer to any Hedge Counterparty (including any applicable termination payments other than Defaulted Hedge Termination Payments), net of all amounts payable to the Issuer by any Hedge Counterparty, (D) all amounts payable by the Issuer to the CP Put Counterparty and each CP Note Placement Agent, net of all amounts payable to the Issuer by the CP Put Counterparty and each CP Note Placement Agent, and (E) all other items in the Priority of Payments ranking prior to payments on the Notes and the CP Notes. There can be no assurance that proceeds of a sale and liquidation, together with all other available funds, will be sufficient to pay in full such amount. In addition, even if the anticipated proceeds of such sale or liquidation would not be sufficient to pay in full such amount, the Holders of a SupraMajority of the Controlling Class, any Hedge Counterparty (unless any such Hedge Counterparty will be paid in full the amounts due to it other than any Defaulted Hedge Termination Payments at the time of distribution of the proceeds of any sale or liquidation of the Collateral), the CP Put Counterparty (unless the CP Put Agreement has expired by its terms or a CP Put Counterparty Default has occurred) and the CP Note Placement Agents may direct the sale and liquidation of the Collateral.

Remedies pursued by the Holders of the Class A Notes and the CP Put Counterparty (for so long as the CP Put Agreement is in effect and no CP Put Counterparty Default has occurred and is continuing) for the Holders of the CP Notes could be adverse to the interests of the Holders of the Class B Notes, the Class C Notes, the Class D Notes, the Class E Notes, the Class X Notes and the Preferred Shares. After the Class A Notes and the CP Notes are no longer outstanding, the Holders of the Class B Notes will be entitled to determine the remedies to be exercised under the Indenture (except as noted above) if an Event of Default occurs. After the Class A Notes, the CP Notes and the Class B Notes are no longer outstanding, the Holders of the Class C Notes will be entitled to determine the remedies to be exercised under the Indenture (except as noted above) if an Event of Default occurs. After the Class A Notes, the CP Notes, the Class B Notes and the Class C Notes are no longer outstanding, the Holders of the Class D Notes will be entitled to determine the remedies to be exercised under the Indenture (except as noted above) if an Event of Default occurs. After the Class A Notes, the CP Notes, the Class B Notes, the Class C Notes and the Class D Notes are no longer outstanding, the Holders of the Class E Notes will be entitled to determine the remedies to be exercised under the Indenture (except as noted above) if an Event of Default occurs. See "Description of the Securities—The Indenture and the Preferred Share Paying and Transfer Agency Agreement—Events of Default."

Equity Status of the Preferred Shares. The Preferred Shares are equity in the Issuer and are not secured by the Collateral Assets or the other Collateral securing the Notes and the CP Notes. As such, the Holders of the Preferred Shares will rank behind all of the creditors, whether secured or unsecured and known or unknown, of the Issuer, including, without limitation, the Holders of the Notes and the CP Notes, the Collateral Manager, the Collateral Adviser, the CP Put Counterparty, the CP Note Placement Agent, and the Hedge Counterparties. No person or entity other than the Issuer will be required to make any distributions on the Preferred Shares. Except with respect to the obligations of the Issuer to make payments pursuant to the Priority of Payments, the Issuer does not expect to have any creditors. Any

amounts paid by the Preferred Share Paying Agent as dividends or other distributions on the Preferred Shares in accordance with the Priority of Payments will be payable only to the extent of the Issuer's distributable profits or share premium (determined in accordance with Cayman Islands law). The funds available to be paid to the Preferred Share Paying Agent will depend in part on the weighted average of the Note Interest Rates. In addition, such distributions will be payable only to the extent that the Issuer is solvent on the applicable Quarterly Payment Date and the Issuer will not be insolvent after such distributions are paid. Under Cayman Islands law, a company is generally deemed to be solvent if it is able to pay its debts as they fall due.

To the extent the requirements under Cayman Islands law described in the preceding paragraph are not met, amounts otherwise payable to the Holders of the Preferred Shares will be retained in the Preferred Share Payment Account until, in the case of any payment of Proceeds by way of dividend, the next succeeding Quarterly Payment Date or (in the case of any payment which would otherwise be payable on a redemption date of the Preferred Shares) the next succeeding Business Day on which the Issuer notifies the Preferred Share Paying Agent that such requirements are met and, in the case of any payment of Principal Proceeds on redemption of the Preferred Shares, the next succeeding Business Day on which the Issuer notifies the Preferred Share Paying Agent that such requirements are met. Amounts on deposit in the Preferred Share Payment Account will not be available to pay amounts due to the Holders of the Notes, the CP Notes, the Trustee, the Collateral Manager, the Collateral Adviser, the CP Put Counterparty, the CP Note Placement Agents, the Hedge Counterparties or any other creditor of the Issuer whose claim is limited in recourse to the Collateral. However, amounts on deposit in the Preferred Share Payment Account may be subject to the claims of creditors of the Issuer that have not contractually limited their recourse to the Collateral. The Indenture, the Preferred Share Paying and Transfer Agency Agreement and the Memorandum and Articles of Association will limit the Issuer's activities to the issuance and sale of the Securities and the CP Notes, the acquisition and disposition of the Collateral Assets, the acquisition and disposition of, and investment and reinvestment in, the Eligible Investments and the other activities related to the issuance and the sale of the Securities and the CP Notes described under "The Issuers". The Issuer does not expect to have any significant full recourse liabilities that would be payable out of amounts on deposit in the Preferred Share Payment Account.

Leveraged Investment. The Preferred Shares, the Class X Notes and, to a lesser extent and if the Class E Issuance Option is exercised, the Class E Notes, represent a leveraged investment in the underlying Collateral Assets. The use of leverage generally magnifies an investor's opportunities for gain and risk of loss. Therefore, changes in the market value of the Preferred Shares, the Class X Notes and the Class E Notes can be expected to be greater than changes in the market value of the underlying assets included in the Collateral Assets, which are also subject to credit, liquidity and interest rate risk.

Optional Redemption and Tax Redemption of Securities. Subject to the satisfaction of certain conditions, the Securities and the CP Notes may be optionally redeemed in whole and not in part (i) on any Payment Date on or after the January 2009 Payment Date at the written direction of, or with the written consent of, Holders of at least a Majority of the Preferred Shares or (ii) on the date that is 90 days from the date on which the Issuers first become aware of the occurrence of a Tax Event (provided that such 90-day period shall be extended by another 90 days if, during the initial 90-day period, the Issuers have notified the Holders of the Securities and the CP Notes that the related Issuer expects that it shall have changed its place of residence by the end of the later 90-day period), at the written direction of, or with the written consent of, Holders of at least 66-2/3% of the Preferred Shares or the Controlling Class which, as a result of the occurrence of such Tax Event, have not received 100% of the aggregate amount of principal and interest or other amounts due and payable to such Holders. If an Optional Redemption or Tax Redemption occurs, the Preferred Shares will be redeemed simultaneously.

There can be no assurance that after payment of the redemption prices for the Securities and the CP Notes and all other amounts payable in accordance with the Priority of Payments, any additional Proceeds will remain to distribute to the Holders of the Preferred Shares upon redemption. See "Description of the Securities—Optional Redemption" and "—Tax Redemption." An Optional Redemption or Tax Redemption of the Securities and the CP Notes could require the Collateral Manager to liquidate positions more rapidly than would otherwise be desirable, which could adversely affect the realized value

of the Collateral Assets sold. In addition, the redemption procedures in the Indenture may require the Collateral Manager to aggregate securities to be sold together in one block transaction, thereby possibly resulting in a lower aggregate realized value for the Collateral Assets sold. In any event, there can be no assurance that the market value of the Collateral Assets will be sufficient for the Holders of the Preferred Shares to direct an Optional Redemption or, in the case of a Tax Redemption, for the Holders of the affected Class of Notes, CP Notes or Preferred Shares to direct a Tax Redemption. A decrease in the market value of the Collateral Assets would adversely affect the proceeds that could be obtained upon a sale of the Collateral Assets; consequently, the conditions precedent to the exercise of an Optional Redemption or a Tax Redemption may not be met. The interests of the Holders of the Preferred Shares in determining whether to elect to effect an Optional Redemption and the interests of the Holders of the affected Class of Notes, CP Notes and the Preferred Shares with respect to a Tax Redemption may be different from the interests of the Holders of the other Classes of Securities in such respect. The Holders of the Securities also may not be able to invest the proceeds of the redemption of the Securities in one or more investments providing a return equal to or greater than the Holders of the Securities expected to obtain from their investment in the Securities. An Optional Redemption or a Tax Redemption will shorten the average lives of the Securities and the duration of the Securities and may reduce the yield to maturity of the Notes.

Auction. There can be no assurance that an Auction of the Collateral Assets on any Auction Date will be successful. The failure of an Auction may lengthen the expected average lives of the Notes and the expected duration of the Class X Notes and the Preferred Shares and may reduce the yield to maturity of the Notes and may adversely affect the yield on the Class X Notes and the Preferred Shares. A successful Auction of the Collateral Assets is not required to result in any proceeds for distribution to the holders of the Class X Notes and the Preferred Shares. Accordingly, in the event of an Auction, Holders of the Class X Notes and the Preferred Shares may have their Class X Notes and/or Preferred Shares, as applicable, redeemed without receiving any distributions on such Class X Notes and/or Preferred Shares, as applicable. In addition, the success of an Auction will shorten the average lives of the Notes and the duration of the Securities and may reduce the yield to maturity of the Notes.

Special Considerations with respect to the Class X Notes. The Class X Notes are not entitled to payments of principal or periodic interest, but will be entitled to receive the Class X Payment on each Payment Date in accordance with the Priority of Payments. To the extent the Class X Payment is not paid on any Payment Date, the Holders of the Class X Notes will be entitled to receive the amount of such deficiency on any subsequent Payment Date. The Class X Notes will therefore be highly sensitive to the availability of Interest Proceeds and may also be highly sensitive to prepayments on the Collateral Assets. In addition, the Notional Principal Balance of the Class X Notes on any date of determination will equal the Aggregate Principal Amount. As a result, the yield on the Class X Notes will be highly sensitive to the rate, timing and amount of defaults, delinquencies, interest deferrals and losses on the Collateral Assets. In addition, the yield on the Class X Notes will be affected by any Optional Redemption, Tax Redemption, Auction or redemption due to an Event of Default resulting in acceleration of the Securities and liquidation of the Collateral. The Class X Notes have very limited voting rights under the Indenture. The Class X Notes are not part of the Controlling Class and have no voting rights with respect to remedies upon the occurrence of an Event of Default.

Mandatory Redemption of Notes. If the Class A/B Overcollateralization Test is not met on the Determination Date immediately preceding a Payment Date or the Class A/B Interest Coverage Test is not met on the Determination Date immediately preceding a Quarterly Payment Date, Proceeds that otherwise might have been distributed to the Holders of the Preferred Shares and paid as interest to the Holders of the Class C Notes, Class D Notes and Class E Notes will be used to redeem the Class A Notes and the Class B Notes in full and to Defeasé the CP Notes in the order described in the Priority of Payments. If the Class D Overcollateralization Ratio is not at least 75% on the Determination Date immediately preceding a Payment Date, Proceeds that otherwise might have been distributed to the Holders of the Class C Notes, the Class D Notes, the Class E Notes and the Preferred Shares will be used to redeem the Class A Notes and the Class B Notes in full and to Defeasé the CP Notes in full in the order described in the Priority of Payments. If the Class C Overcollateralization Test is not met on the Determination Date immediately preceding a Payment Date, the Class C Interest Coverage Test is not

met on the Determination Date immediately preceding a Quarterly Payment Date or the Class D Overcollateralization Ratio is not at least 90% on the Determination Date immediately preceding a Payment Date, Proceeds that otherwise might have been distributed to the Holders of the Class D Notes, the Class E Notes and/or the Holders of the Preferred Shares will be used to redeem the Class A Notes, the Class B Notes and the Class C Notes in full and to Defease the CP Notes in full in the order described in the Priority of Payments. If the Class D Overcollateralization Test is not met on the Determination Date immediately preceding a Payment Date or the Class D Interest Coverage Test is not met on the Determination Date immediately preceding a Quarterly Payment Date, Proceeds that otherwise might have been distributed to the Holders of the Class D Notes, the Class E Notes and/or the Holders of the Preferred Shares will be used to redeem the Class A Notes, the Class B Notes, the Class C Notes and the Class D Notes in full and to Defease the CP Notes in full in the order described in the Priority of Payments. The foregoing redemptions could result in an elimination, deferral or reduction in the amounts available to make payments to the Holders of the Class C Notes, the Class D Notes, the Class E Notes and distributions to Holders of the Preferred Shares. See "Security for the Notes—The Coverage Tests." Any such redemptions will shorten the average life of the redeemed Notes, may lower the yield to maturity of the Notes and may adversely affect the yield on the Preferred Shares. If a Class C Coverage Test or a Class D Coverage Test is not satisfied or the Class D Overcollateralization Ratio is less than 90% on any Determination Date related to a Payment Date other than a Quarterly Payment Date, no amounts will be distributed to the Holders of the Class C Notes or the Class D Notes and certain amounts based on the principal balance of such Notes will instead be deposited to the Collection Account for distribution in accordance with the Priority of Payments on the next Payment Date.

Collateral Accumulation. In anticipation of the issuance of the Securities, Y2K Finance Inc., a fund, the portfolio of which was managed by the Collateral Manager (and in relation to which the Collateral Adviser provided collateral advisory services), has agreed to "warehouse" up to \$1,007,500,000 aggregate principal amount of Collateral Assets and an affiliate of Goldman, Sachs & Co. has agreed to "warehouse" up to \$493,500,000 aggregate principal amount of Collateral Assets, both such portfolios selected by the Collateral Manager for resale to the Issuer pursuant to the terms of forward purchase agreements. Of such amount, it is expected that a portion will be purchased from affiliates of Goldman, Sachs & Co. and a portion will be purchased from third parties. Pursuant to the terms of each of the forward purchase agreements, the Issuer will be obligated to purchase the "warehoused" assets provided such Collateral Assets satisfy certain eligibility criteria on the Closing Date for a predetermined purchase price designed to reflect the yields or spreads at which the Collateral Assets were purchased (using the prepayment speed and other assumptions used to set the initial price of each individual asset), as adjusted for any hedging gain or loss and any loss or gain on any Collateral Assets sold to a party other than the Issuer during the warehousing period. Consequently, the market values of "warehoused" Collateral Assets at the Closing Date may be less than or greater than the formula purchase price paid by the Issuer. In addition, if a Collateral Asset becomes ineligible during the warehousing period and is not purchased by the Issuer on the Closing Date, or if a Collateral Asset is otherwise sold at the direction of the Collateral Manager or Goldman, Sachs & Co. (which sale may only occur with the consent of Goldman, Sachs & Co.'s affiliate), the Issuer will bear the loss or receive the gain on the sale of such Collateral Asset to a third party.

Disposition of Collateral Assets by the Collateral Manager Under Certain Circumstances. Under the Indenture, the Collateral Manager has the right, but is not obligated, to direct the Issuer to sell, at a price equal to the fair market value, Collateral Assets meeting the definition of Credit Risk Obligations, Defaulted Obligations or equity securities subject to satisfaction of the conditions described herein. Such sales of Collateral Assets may result in losses by the Issuer, which losses may result in the reduction or withdrawal of the rating of any or all of the Notes by any of the Rating Agencies. On the other hand, circumstances may exist under which it is in the best interests of the Issuer or the Holders of the Securities to dispose of Collateral Assets, but the Collateral Manager does not direct the Issuer or the Issuer does not otherwise sell such Collateral Assets. Neither the Collateral Manager nor the Collateral Adviser has any liability or obligation to the Holders of the Securities as to the amount or value of, or decrease in the value of, the Collateral Assets from time to time.

Average Lives, Duration and Prepayment Considerations. The average lives of the Notes and the duration of the Class X Notes and the Preferred Shares are expected to be shorter than the number of years until their Stated Maturity or the Scheduled Preferred Share Redemption Date, as applicable. See "Weighted Average Life and Yield Considerations."

The average lives of the Notes and the duration of the Class X Notes and the Preferred Shares will be affected by the financial condition of the obligors on or issuers of the Collateral Assets and the characteristics of the Collateral Assets, including the existence and frequency of exercise of any prepayment, optional redemption or sinking fund features, the prepayment speed, the occurrence of any early amortization events, the prevailing level of interest rates, the redemption price, the actual default rate and the actual level of recoveries in respect of any Defaulted Obligations, the frequency of tender or exchange offers for the Collateral Assets and the tenor of any sales of Collateral Assets.

Some or all of the loans underlying the RMBS or CMBS may be prepaid at any time (although certain of such mortgage loans may have "lockout" periods, defeasance provisions, prepayment penalties or other disincentives to prepayment). Defaults on and liquidations of the loans and other collateral underlying the RMBS, CMBS, Asset-Backed Securities or CDO Securities may also lead to early repayment thereof. Prepayments on loans are affected by a number of factors. If prevailing rates for similar loans fall below the interest rates on such loans, prepayment rates would generally be expected to increase. Conversely, if prevailing rates for similar loans rise above the interest rates on such loans, prepayment rates would generally be expected to decrease. The existence and frequency of such prepayments, optional redemptions, defaults and liquidations will affect the average lives of, and credit support for, the Notes and the duration of the Class X Notes and the Preferred Shares. See "Collateral Assets," "Weighted Average Life and Yield Considerations" and "Security for the Notes."

Projections, Forecasts and Estimates. Estimates of the weighted average lives of, and returns on, the Notes included herein, together with any other projections, forecasts and estimates provided to prospective purchasers of the Notes, are forward looking statements. Such statements are necessarily speculative in nature, as they are based on certain assumptions. It can be expected that some or all of the assumptions underlying such statements will not reflect actual conditions. Accordingly, there can be no assurance that any estimated projections, forecasts or estimates will be realized or that the forward looking statements will materialize, and actual results may vary from the projections, and the variations may be material.

Some important factors that could cause actual results to differ materially from those in any forward looking statements include changes in interest rates, market, financial or legal uncertainties, the timing of acquisitions of the Collateral Assets, differences in the actual allocation of the Collateral Assets among asset categories from those assumed, mismatches between the timing of accrual and receipt of Proceeds from the Collateral Assets and the effectiveness of the Hedge Agreements, among others.

None of the Issuer, the Co-Issuer, the Collateral Manager, the Initial Purchaser or any of their respective affiliates has any obligation to update or otherwise revise any projections, including any revisions to reflect changes in economic conditions or other circumstances arising after the date hereof or to reflect the occurrence of unanticipated events, even if the underlying assumptions do not come to fruition.

Dependence of the Issuer on the Collateral Manager and the Collateral Adviser. The Issuer has no employees and is dependent on the employees of the Collateral Manager to advise the Issuer in accordance with the terms of the Indenture and the Collateral Management Agreement. The Collateral Manager has, in turn, delegated (as permitted by the Collateral Management Agreement) certain of its obligations with respect thereunder to the Collateral Adviser pursuant to the Collateral Advisory Agreement. Consequently, the loss of one or more of the individuals employed by the Collateral Manager or the Collateral Adviser to administer the Collateral Assets or to provide disposition related services in respect of the Collateral Assets could have an adverse effect, which effect may be material, on the performance of the Issuer. See "The Collateral Manager," "The Collateral Management Agreement" and "The Collateral Adviser and the Collateral Advisory Agreement. "

Collateral Assets

General. The following description of the Collateral Assets and the underlying documents and the risks related thereto is general in nature, and prospective purchasers of the Securities should review the descriptions and risk factors relating to each of the Collateral Assets set forth in the related Disclosure Documents on the CD-ROM attached to this Offering Circular and the summaries set forth in Appendix B to this Offering Circular. The Disclosure Documents were completed as of the date of the original offering of each of the Collateral Assets and the information contained in such Disclosure Documents may now be outdated and less relevant to the Collateral Assets. None of the Issuers, the Collateral Manager, the Trustee, the Collateral Administrator, the CP Put Counterparty, the Hedge Counterparty (or any guarantor thereof) or the Initial Purchaser has independently verified any of the information contained in the Disclosure Documents or is making any representation or warranty regarding, or assumes any responsibility for the accuracy, completeness or applicability of, the information contained therein.

Nature of Collateral. The Collateral is subject to credit, liquidity, prepayment and interest rate risks. The amount and nature of collateral securing the Notes has been established to withstand certain assumed deficiencies in payment occasioned by defaults in respect of the Collateral Assets. See "Ratings of the Notes." If any deficiencies exceed such assumed levels, however, payment of the Notes could be adversely affected. To the extent that a default occurs with respect to any Collateral Asset securing the Notes and the Collateral Manager exercises its right to cause the sale or other disposition of such Collateral Asset, it is not likely that the proceeds of such sale or other disposition will be equal to the amount of principal and interest owing to the Issuer in respect of such Collateral Asset.

The market value of the Collateral Assets generally will fluctuate with, among other things, the financial condition of the obligors on or issuers of the Collateral Assets, the credit quality of the underlying pool of assets in any Collateral Asset, general economic conditions, the condition of certain financial markets, political events, developments or trends in any particular industry and changes in prevailing interest rates. None of the Issuer, the Co-Issuer, the Initial Purchaser, the Collateral Manager, the Collateral Adviser, the Collateral Administrator, the CP Put Counterparty, the Hedge Counterparty (or any guarantor thereof) or the Trustee has any liability or obligation to the Holders of Securities as to the amount or value of, or decrease in the value of, the Collateral Assets from time to time, or makes any representation or warranty as to the performance of the Collateral Assets.

If a Collateral Asset becomes a Credit Risk Obligation or a Defaulted Obligation, the Collateral Manager may direct the Issuer to sell the affected Collateral Asset. There can be no assurance as to the timing of the Issuer's sale of the affected Collateral Asset, or as to the rates of recovery on such affected Collateral Asset. The inability to realize immediate recoveries at the recovery levels assumed herein may result in lower cash flow and a lower yield to maturity of the Notes and may adversely affect the yield on the Class X Notes and the Preferred Shares.

Commercial Mortgage-Backed Securities. Approximately 3.3% of the Collateral Assets (by principal balance) will consist of Commercial Mortgage-Backed Securities ("CMBS") as of the Closing Date. The types of Commercial Mortgage Backed Securities that the Issuer will acquire on the Closing Date are expected to consist of CMBS Conduit Securities, CMBS Credit Tenant Lease Securities, CMBS Large Loan Securities and CMBS Repackaging Securities.

Holders of CMBS bear various risks, including credit, market, interest rate, structural and legal risks. CMBS are securities backed by obligations (including certificates of participation in obligations) that are principally secured by mortgages on real property or interests therein having a multifamily or commercial use, such as regional malls, other retail space, office buildings, industrial or warehouse properties, hotels, nursing homes and senior living centers. CMBS have been issued in public and private transactions by a variety of public and private issuers using a variety of structures, including senior and subordinated classes. Risks affecting real estate investments include general economic conditions, the condition of financial markets, political events, developments or trends in any particular industry and changes in prevailing interest rates. The cyclicity and leverage associated with real estate-related investments have historically resulted in periods, including significant periods, of adverse performance,

including performance that may be materially more adverse than the performance associated with other investments. In addition, commercial mortgage loans generally lack standardized terms, tend to have shorter maturities than residential mortgage loans and may provide for the payment of all or substantially all of the principal only at maturity. Additional risks may be presented by the type and use of a particular commercial property. For instance, commercial properties that operate as hospitals and nursing homes may present special risks to lenders due to the significant governmental regulation of the ownership, operation, maintenance and financing of health care institutions. Hotel and motel properties are often operated pursuant to franchise, management or operating agreements which may be terminable by the franchisor or operator; and the transferability of a hotel's operating, liquor and other licenses upon a transfer of the hotel, whether through purchase or foreclosure, is subject to local law requirements. All of these factors increase the risks involved with commercial real estate lending. Commercial properties tend to be unique and are more difficult to value than single-family residential properties. Commercial lending is generally viewed as exposing a lender to a greater risk of loss than residential one-to-four family lending since it typically involves larger loans to a single borrower than residential one-to-four family lending.

Commercial mortgage lenders typically look to the debt service coverage ratio of a loan secured by income-producing property as an important measure of the risk of default on such a loan. Commercial property values and net operating income are subject to volatility, and net operating income may be sufficient or insufficient to cover debt service on the related mortgage loan at any given time. The repayment of loans secured by income-producing properties is typically dependent upon the successful operation of the related real estate project rather than upon the liquidation value of the underlying real estate. Furthermore, the net operating income from and value of any commercial property may be adversely affected by risks generally incident to interests in real property, including events which the borrower or manager of the property, or the issuer or servicer of the related issuance of commercial mortgage-backed securities, may be unable to predict or control, such as changes in general or local economic conditions and/or specific industry segments; declines in real estate values; declines in rental or occupancy rates; increases in interest rates, real estate tax rates and other operating expenses; changes in governmental rules, regulations and fiscal policies; acts of God; and social unrest and civil disturbances. The value of commercial real estate is also subject to a number of laws, such as laws regarding environmental clean-up and limitations on remedies imposed by bankruptcy laws and state laws regarding foreclosures and rights of redemption. Any decrease in income or value of the commercial real estate underlying an issue of CMBS could result in cash flow delays and losses on the related issue of CMBS.

A commercial property may not readily be converted to an alternative use in the event that the operation of such commercial property for its original purpose becomes unprofitable. In such cases, the conversion of the commercial property to an alternative use would generally require substantial capital expenditures. Thus, if the borrower becomes unable to meet its obligations under the related commercial mortgage loan, the liquidation value of any such commercial property may be substantially less, relative to the amount outstanding on the related commercial mortgage loan, than would be the case if such commercial property were readily adaptable to other uses. The exercise of remedies and successful realization of liquidation proceeds may be highly dependent on the performance of CMBS servicers or special servicers, of which there may be a limited number and which may have conflicts of interest in any given situation. The failure of the performance of such CMBS servicers or special servicers could result in cash flow delays and losses on the related issue of CMBS.

Fixed rate CMBS, like all fixed-income securities, generally decline in value as interest rates rise. Moreover, although generally the value of fixed-income securities increases during periods of falling interest rates, this inverse relationship may not be as marked in the case of CMBS due to the increased likelihood of prepayments during periods of falling interest rates. This effect is mitigated to some degree for mortgage loans providing for a period during which no prepayments may be made. However, prepayments on the underlying commercial mortgage loans may still result in a reduction of the yield on the related issue of CMBS.

Mortgage loans underlying a CMBS issue may provide for no amortization of principal or may provide for amortization based on a schedule substantially longer than the maturity of the mortgage loan, resulting in a "balloon" payment due at maturity. If the underlying mortgage borrower experiences business problems, or other factors limit refinancing alternatives, such balloon payment mortgages are likely to experience payment delays or even default. As a result, the related issue of CMBS could experience delays in cash flow and losses.

In addition, structural and legal risks include the possibility that, in a bankruptcy or similar proceeding involving the originator or the servicer (often the same entity or affiliates), the assets of the issuer could be treated as never having been truly sold by the originator to the issuer and could be substantively consolidated with those of the originator, or the transfer of such assets to the Issuer could be voided as a fraudulent transfer. Challenges based on such doctrines could result also in cash flow delays and losses on the related issue of CMBS.

None of the CMBS included in the Collateral Assets will be guaranteed or insured by any governmental agency or instrumentality or by any other person. Distributions on CMBS will depend solely upon the amount and timing of payments and other collections on the related underlying mortgage loans.

Realized losses and trust expenses generally will be allocated to the most subordinated class of securities of the related series. Accordingly, to the extent any CMBS becomes the most subordinated class of securities of the related series, any delinquency or default on any underlying mortgage loan may result in shortfalls, realized loss allocations or extensions of its weighted average life and will have a more immediate and disproportionate effect on the related CMBS than on the related more senior securities. Certain of the Underlying CMBS Series have experienced delinquencies, defaults and losses on the underlying commercial mortgage loans. See "Appendix B."

In addition, in the case of certain CMBS, no distributions of principal will generally be made until the aggregate principal balance of the corresponding more senior securities has been reduced to zero and, in other cases, all or a disproportionate amount of principal distributions will be made to the holders of the more senior securities for a specified period of time. The holders of classes of securities that are subordinate to the classes of CMBS owned by the Issuer will generally control the exercise of remedies in connection with such CMBS. Such exercise of remedies by a holder of subordinate classes may be in conflict with the interests of the more senior securities. See "—Other Considerations—Certain Conflicts of Interest."

As of the Closing Date, none of the CMBS will be the "controlling class" with respect to any Underlying CMBS Series. The inability of the Issuer or the Collateral Manager to exercise such discretion with respect to a CMBS may adversely affect the realization on such CMBS.

Residential Mortgage-Backed Securities. Approximately 87.8% of the Collateral Assets (by principal balance) will consist of Residential Mortgage-Backed Securities ("RMBS") as of the Closing Date. The types of Residential Mortgage Backed Securities that the Issuer will acquire on the Closing Date are expected to consist of RMBS Alt-A Mortgage Securities, RMBS Residential A Mortgage Securities, RMBS Residential B/C Mortgage Securities and RMBS Home Equity Loan Securities.

Holders of RMBS bear various risks, including credit, market, interest rate, structural and legal risks. RMBS represent interests in pools of residential mortgage loans secured by one- to four-family residential mortgage loans. Such loans may be prepaid at any time. Residential mortgage loans are obligations of the borrowers thereunder only and are not typically insured or guaranteed by any other person or entity, although such loans may be securitized by agencies and the securities issued are guaranteed. The rate of defaults and losses on residential mortgage loans will be affected by a number of factors, including general economic conditions and those in the area where the related mortgaged property is located, the borrower's equity in the mortgaged property and the financial circumstances of the borrower. If a residential mortgage loan is in default, foreclosure of such residential mortgage loan may be a lengthy and difficult process, and may involve significant expenses. Furthermore, the market for defaulted residential mortgage loans or foreclosed properties may be very limited.

At any one time, a portfolio of RMBS may be backed by residential mortgage loans with disproportionately large aggregate principal amounts secured by properties in only a few states or regions. As a result, the residential mortgage loans may be more susceptible to geographic risks relating to such areas, such as adverse economic conditions, adverse events affecting industries located in such areas and natural hazards affecting such areas, than would be the case for a pool of mortgage loans having more diverse property locations. In addition, the residential mortgage loans may include so-called "jumbo" mortgage loans, having original principal balances that are higher than is generally the case for residential mortgage loans. As a result, such portfolio of RMBS may experience increased losses.

Each underlying residential mortgage loan in an issue of RMBS may have a balloon payment due on its maturity date. Balloon residential mortgage loans involve a greater risk to a lender than self-amortizing loans, because the ability of a borrower to pay such amount will normally depend on its ability to obtain refinancing of the related mortgage loan or sell the related mortgaged property at a price sufficient to permit the borrower to make the balloon payment, which will depend on a number of factors prevailing at the time such refinancing or sale is required, including, without limitation, the strength of the residential real estate markets, tax laws, the financial situation and operating history of the underlying property, interest rates and general economic conditions. If the borrower is unable to make such balloon payment, the related issue of RMBS may experience losses.

Prepayments on the underlying residential mortgage loans in an issue of RMBS will be influenced by the prepayment provisions of the related mortgage notes and may also be affected by a variety of economic, geographic and other factors, including the difference between the interest rates on the underlying residential mortgage loans (giving consideration to the cost of refinancing) and prevailing mortgage rates and the availability of refinancing. In general, if prevailing interest rates fall significantly below the interest rates on the related residential mortgage loans, the rate of prepayment on the underlying residential mortgage loans would be expected to increase. Conversely, if prevailing interest rates rise to a level significantly above the interest rates on the related mortgages, the rate of prepayment would be expected to decrease. Prepayments could reduce the yield received on the related issue of RMBS.

Structural and Legal Risks of RMBS. Residential mortgage loans in an issue of RMBS may be subject to various federal and state laws, public policies and principles of equity that protect consumers, which among other things may regulate interest rates and other charges, require certain disclosures, require licensing of originators, prohibit discriminatory lending practices, regulate the use of consumer credit information and regulate debt collection practices. Violation of certain provisions of these laws, public policies and principles may limit the servicer's ability to collect all or part of the principal or interest on a residential mortgage loan, entitle the borrower to a refund of amounts previously paid by it, or subject the servicer to damages and sanctions. Any such violation could result also in cash flow delays and losses on the related issue of RMBS.

RMBS may have structural characteristics that distinguish them from other asset-backed securities. The rate of interest payable on RMBS may be set or effectively capped at the weighted average net coupon of the underlying mortgage loans themselves. As a result of this cap, the return to investors is dependent on the relative timing and rate of delinquencies and prepayments of mortgage loans bearing a higher rate of interest. In general, early prepayments will have a greater impact on the yield to investors. Federal and state law may also affect the return to investors by capping the interest rates payable by certain mortgagors. The Servicemembers' Civil Relief Act of 2003 (the "Relief Act") provides relief for soldiers and members of the reserve called to active duty by capping the interest rates on their mortgage loans at 6% per annum. Certain RMBS may provide for the payment of only interest for a stated period of time.

In addition, structural and legal risks of RMBS include the possibility that, in a bankruptcy or similar proceeding involving the originator or the servicer (often the same entity or affiliates), the assets of the issuer could be treated as never having been truly sold by the originator to the issuer or could be substantively consolidated with those of the originator or the servicer, or the transfer of such assets to the issuer could be voided as a fraudulent transfer. Challenges based on such doctrines could result also in cash flow delays and losses on the related issue of RMBS.

It is not expected that the RMBS will be guaranteed or insured by any governmental agency or instrumentality or by any other person. Distributions on RMBS will depend solely upon the amount and timing of payments and other collections on the related underlying mortgage loans.

CDO Securities. Approximately 8.2% of the Collateral Assets (by principal balance) will consist of CDO Securities as of the Closing Date. The types of CDO Securities that the Issuer will acquire on the Closing Date are expected to consist of CDO Structured Product Securities, CDO RMBS Securities, Collateralized Loan Securities and CDO Trust Preferred Securities.

CDO Securities generally are limited recourse obligations of the issuer thereof payable solely from the underlying assets of the issuer ("CDO Collateral") or proceeds thereof. Consequently, holders of CDO Securities must rely solely on distributions on the underlying CDO Collateral or proceeds thereof for payment in respect thereof. If distributions on the underlying CDO Collateral are insufficient to make payments on the CDO Securities, no other assets will be available for payment of the deficiency and following realization of the underlying assets, the obligations of the issuer to pay such deficiency shall be extinguished. Many subordinate classes of CDO Securities provide that a deferral of interest thereon or a write-down does not constitute an event of default and the holders of such securities will not have available to them any associated default remedies. During such periods of non-payment or partial non-payment, such non-paid interest will generally be capitalized and added to the outstanding principal balance of the related security. Any such deferral will reduce the amount of current payments made on such CDO Securities.

CDO Securities are subject to credit, liquidity and interest rate risks. The assets backing CDO Securities may consist of high yield debt securities, loans, structured finance securities and other debt instruments. High yield debt securities are generally unsecured (and loans may be unsecured) and may be subordinated to certain other obligations of the issuer thereof. An increase in the default rates of high yield corporate debt securities or loans could increase the likelihood that payments may not be made to holders of CDO Securities which are secured by high yield corporate debt securities and loans.

Issuers of CDO Securities may acquire interests in loans and other debt obligations by way of assignment or participation. The purchaser of an assignment typically succeeds to all the rights and obligations of the assigning institution and becomes a lender under the credit agreement with respect to the debt obligation; however, its rights can be more restricted than those of the assigning institution.

In purchasing participations, an issuer of CDO Securities will usually have a contractual relationship only with the selling institution, and not the borrower. The issuer generally will have no right directly to enforce compliance by the borrower with the terms of the loan agreement, nor any rights of set-off against the borrower, nor have the right to object to certain changes to the loan agreement agreed to by the selling institution. The issuer may not directly benefit from the collateral supporting the related loan and may be subject to any rights of set-off the borrower has against the selling institution. In addition, in the event of the insolvency of the selling institution, under the laws of the United States of America and the states thereof, the issuer may be treated as a general creditor of such selling institution, and may not have any exclusive or senior claim with respect to the selling institution's interest in, or the collateral with respect to, the loan. Consequently, the issuer may be subject to the credit risk of the selling institution as well as of the borrower.

CDO Securities are subject to interest rate risk and day count basis risk. The CDO Collateral of an issuer of CDO Securities may bear interest at a fixed (floating) rate while the CDO Securities issued by such issuer may bear interest at a floating (fixed) rate. As a result, there could be a floating/fixed rate or basis mismatch between such CDO Securities and CDO Collateral which bears interest at a fixed rate and there may be a timing mismatch between the CDO Securities and assets that bear interest at a floating rate as the interest rate on such assets bearing interest at a floating rate may adjust more frequently or less frequently, on different dates and based on different indices than the interest rates on the CDO Securities. As a result of such mismatches, an increase or decrease in the level of the floating

rate indices could adversely impact the ability to make payments on the CDO Securities. In addition, hedges may have been acquired to manage the interest rate risk of such CDO Securities, making such CDO Securities also subject to the credit risk of the applicable hedge counterparty.

Asset-Backed Securities. Approximately 0.7% of the Collateral Assets (by principal balance) will consist of Asset-Backed Securities as of the Closing Date. Asset-Backed Securities entitle the holders thereof to receive payments that depend (except for rights or other assets designed to assure the servicing or timely distribution of proceeds to holders of such Asset-Backed Securities) on the cash flow loans arising from certain shipping loans.

The structure of an Asset-Backed Security and the terms of the investors' interest in the collateral can vary widely depending on the type of collateral, the desires of investors and the use of credit enhancements. Individual transactions can differ markedly in both structure and execution. Important determinants of the risk associated with issuing or holding Asset-Backed Securities include the relative seniority or subordination of the class of Asset-Backed Securities held by an investor, the relative allocation of principal and interest payments in the priorities by which such payments are made under the governing documents, how credit losses affect the issuing vehicle and the return to investors, whether collateral represents a fixed set of specific assets or accounts, whether the underlying collateral assets are revolving or closed end, under what terms (including maturity of the asset backed instrument) any remaining balance in the accounts may revert to the issuing company and the extent to which the company that is the actual source of the collateral assets is obligated to provide support to the issuing vehicle or to the investors. With respect to some types of Asset-Backed Securities, the risk is more closely correlated with the default risk on corporate bonds of similar terms and maturities than with the performance of a pool of receivables. In addition, certain Asset-Backed Securities (particularly subordinated Asset-Backed Securities) provide that the non payment of interest in cash on such securities will not constitute an event of default in certain circumstances and the holders of such securities will not have available to them any associated default remedies. Interest not paid in cash will generally be capitalized and added to the outstanding principal balance of the related security. Any such deferral will reduce the yield on such Asset-Backed Securities.

Holders of Asset-Backed Securities bear various risks, including credit risks, liquidity risks, interest rate risks, market risks, operations risks, structural risks and legal risks. Credit risk arises from losses due to defaults by the borrowers in the underlying collateral and the issuer's or servicer's failure to perform. These two elements may be related, as, for example, in the case of a servicer which does not provide adequate credit review scrutiny to the serviced portfolio, leading to higher incidence of defaults. Market risk arises from the cash flow characteristics of the security, which for most Asset-Backed Securities tend to be predictable. The greatest variability in cash flows comes from credit performance, including the presence of wind down or acceleration features designed to protect the investor in the event that credit losses in the portfolio rise well above expected levels. Interest rate risk arises for the issuer from the relationship between the pricing terms on the underlying collateral and the terms of the rate paid to holders of securities and from the need to mark to market the excess servicing or spread account proceeds carried on the balance sheet. For the holder of the security, interest rate risk depends on the expected life of the Asset-Backed Securities which may depend on prepayments on the underlying assets or the occurrence of wind down or termination events.

If the servicer becomes subject to financial difficulty or otherwise ceases to be able to carry out its functions, it may be difficult to find other acceptable substitute servicers and cash flow disruptions or losses may occur, particularly with non standard receivables or receivables originated by private retailers who collect many of the payments at their stores. Structural and legal risks include the possibility that, in a bankruptcy or similar proceeding involving the originator or the servicer (often the same entity or affiliates), the assets of the Issuer could be treated as never having been truly sold by the originator to the Issuer or could be substantively consolidated with those of the originator or the servicer, or the transfer of such assets to the issuer could be voided as a fraudulent transfer. Challenges based on such doctrines could result also in cash flow delays and reductions. Other similar risks relate to the degree to which cash flows on the assets of the Issuer may be commingled with those on the originator's or the servicer's other assets.

Subordination of Collateral Assets. All of the Collateral Assets to be acquired by the Issuer are investment grade as of the Closing Date. Some of the Collateral Assets owned by the Issuer will be subordinated to one or more other classes of securities of the same series for purposes of, among other things, offsetting losses and other shortfalls with respect to the related underlying loans. The subordinate classes are more sensitive to risk of loss and writedowns than senior classes of such securities.

PROSPECTIVE PURCHASERS OF THE NOTES AND THE PREFERRED SHARES SHOULD CONSIDER AND ASSESS FOR THEMSELVES THE LIKELY LEVEL OF DEFAULTS ON THE COLLATERAL ASSETS, AS WELL AS THE LIKELY LEVEL AND TIMING OF RECOVERIES ON THE COLLATERAL ASSETS.

Insolvency Considerations with Respect to Issuers of Collateral Assets. Various laws enacted for the protection of creditors may apply to the Collateral Assets. If a court in a lawsuit brought by an unpaid creditor or representative of creditors of an issuer of a Collateral Asset, such as a trustee in bankruptcy, were to find that the issuer did not receive fair consideration or reasonably equivalent value for incurring the indebtedness constituting the Collateral Asset or for granting a lien securing the Collateral Asset and, after giving effect to such indebtedness or such lien, the issuer (i) was insolvent, (ii) was engaged in a business for which the remaining assets of such issuer constituted unreasonably small capital or (iii) intended to incur, or believed that it would incur, debts beyond its ability to pay such debts as they mature, such court could determine to invalidate, in whole or in part, such indebtedness or such lien as a fraudulent conveyance, to subordinate such indebtedness or such lien to existing or future creditors of such issuer, or to recover amounts previously paid by such issuer in satisfaction of such indebtedness. The measure of insolvency for purposes of the foregoing will vary. Generally, an issuer would be considered insolvent at a particular time if the sum of its debts were then greater than all of its property at a fair valuation, or if the present fair saleable value of its assets was then less than the amount that would be required to pay its probable liabilities on its existing debts as they became absolute and matured. There can be no assurance as to what standard a court would apply in order to determine whether the issuer was "insolvent" after giving effect to the incurrence of the indebtedness constituting the Collateral Asset or the grant of a lien securing the Collateral Asset or that, regardless of the method of valuation, a court would not determine that the issuer was "insolvent" upon giving effect to such incurrence or grant. In addition, in the event of the insolvency of an issuer of a Collateral Asset, payments made on such Collateral Asset or a lien securing such Collateral Asset could be subject to avoidance as a "preference" if made within a certain period of time (which may be as long as one year or longer) before insolvency. Payments made under loans underlying Collateral Assets may also be subject to avoidance in the event of the bankruptcy of the borrower.

In general, if payments on a Collateral Asset are avoidable, whether as fraudulent conveyances or preferences, such payments can be recaptured.

Illiquidity of Collateral Assets; Certain Restrictions on Transfer. There may be a limited trading market for many of the Collateral Assets purchased by the Issuer, and in certain instances there may be effectively no trading market therefor.

In addition, it is expected that substantially all of the Collateral Assets will generally not have been registered or qualified under the Securities Act, or the securities laws of any other jurisdiction, and no person or entity will be obligated to register or qualify any such Collateral Assets under the Securities Act or any other securities law. Consequently, the Issuer's transfer of such Collateral Assets will be subject to satisfaction of legal requirements applicable to transfers that do not require registration or qualification under the Securities Act or any applicable state securities laws and upon satisfaction of certain other provisions of the respective agreements pursuant to which the Collateral Assets were issued. It is expected that such transfers will also be subject to satisfaction of certain other restrictions regarding the transfer thereof to, for the benefit of or with assets of, a Plan, as well as certain other transfer restrictions. The existence of such transfer restrictions will negatively affect the liquidity of, and consequently the price that may be realized upon a sale of, such securities.

The Issuer's investment in illiquid Collateral Assets may affect the Issuer's right to sell such investments if they become Credit Risk Obligations or Defaulted Obligations and the timing and price thereof. The value of illiquid Collateral Assets may be less than comparable, more liquid investments. The illiquidity of Collateral Assets and the restrictions on transfer of Collateral Assets, in each case as described above, may also affect the ability of the Issuer to conduct a successful Auction, to exercise redemptions and may also affect the amount and timing of receipt of proceeds from the sale of Collateral Assets in connection with the exercise of remedies following an Event of Default.

Volatility of Market Value of Collateral Assets. The market value of the Collateral Assets will generally fluctuate with, among other things, changes in prevailing interest rates, general economic conditions, the condition of certain financial markets, developments or trends in any particular industry and the financial condition of the issuers of the Collateral Assets. A decrease in the market value of the Collateral Assets would adversely affect the proceeds that could be obtained upon the sale of the Collateral Assets and could ultimately affect the ability of the Issuer to effect an Auction, an Optional Redemption or a Tax Redemption, or to pay the principal of the Notes, the Class X Payment or make distributions on the Preferred Shares, upon a liquidation of the Collateral Assets following the occurrence of an Event of Default. None of the Collateral Manager, the Collateral Adviser, the Trustee or the Initial Purchaser or any of their affiliates shall have any liability to the Holders of the Securities as to the amount or value of, or any decrease in the value of, the Collateral Assets from time to time.

Interest Rate Risk; Hedge Agreements. There will be a floating/fixed rate or basis mismatch between the Notes and those underlying Collateral Assets that bear interest at a fixed rate and there will be a basis and timing mismatch between such Notes and the Collateral Assets which bear interest at a floating rate, since the interest rates on such Collateral Assets bearing interest at a floating rate may adjust more frequently or less frequently, on different dates and based on different indices, than the interest rate on the Notes. The fixed rates and the margins over LIBOR or other floating rates borne by Collateral Assets may be lower than those on sold or amortized Collateral Assets which could cause a significant decline in interest coverage for the Notes. An increase in LIBOR, and therefore in the interest rate borne by the Notes, could adversely impact the interest coverage for the Notes, and a decrease in LIBOR, although also a decrease in the interest rate borne by the Notes, could also adversely impact the interest coverage for the Notes because under the Rate Swap Agreements the Issuer will generally be paying a fixed rate to the Interest Rate Swap Counterparty determined at closing and the fixed rates and spreads of the Collateral Assets may be lower.

On the Closing Date, the Issuer will enter into Rate Swap Agreements to reduce the impact of the interest rate mismatch, and one or more Cashflow Swap Agreements to reduce the impact of the timing mismatches between the payments on the Notes and the LIBOR CP Notes and the receipt of payments on the Collateral Assets. After the Closing Date, subject to the terms of the Indenture and the Collateral Management Agreement including the requirement to satisfy the Rating Agency Condition, and subject to the constraints imposed by AIG Financial Products Corp., as the initial Interest Rate Swap Counterparty (the "Interest Rate Swap Counterparty"), the Collateral Manager may on behalf of the Issuer, employ a variety of hedging strategies, which strategies may vary during the life of the transaction. After the Closing Date, even if the Collateral Manager or the Collateral Adviser believes (each in its sole discretion) that engaging in a hedging technique (or replacing an existing Hedge Agreement that is terminated) would be beneficial, the Collateral Manager may be unable to do so because (among other reasons) such technique will not satisfy the Rating Agency Condition, the initial Interest Rate Swap Counterparty's consent may be required and not given, such technique may be too costly or insufficient funds may be available for such purpose or the Issuer may be unable to find a counterparty satisfying the requirements of the Indenture and a counterparty that is willing to receive payments from the Issuer subject to the other prior applications set forth in the Priority of Payments and in accordance with the terms of the Indenture. Accordingly, the Issuer may be unable, as a practical matter, to use hedging techniques to protect against interest rate risk. Despite the Issuer having the benefit of Hedge Agreements, there can be no assurance that the Collateral Assets and the Eligible Investments will in all circumstances generate sufficient Proceeds to make timely payments of stated interest on the Notes and the LIBOR CP Notes or amounts subordinated thereto. There is no assurance that any interest rate hedge will provide the necessary interest rate protection to the Notes and the LIBOR CP Notes or that the Cash Flow Swap Agreement will solve all timing mismatches.

The notional amounts in the Rate Swap Agreements will be based on amortization schedules derived from the anticipated amortization of those Collateral Assets that bear interest at a fixed rate that the Issuer expects to own as of the Closing Date. The amortization schedules will be designed such that on the Closing Date and thereafter on each Determination Date, the aggregate notional amount under such Rate Swap Agreements will be approximately equal to (i) the outstanding scheduled principal amount of the Notes scheduled to be outstanding on the related trade date less (ii) the outstanding principal amount of Collateral Assets that pay interest pursuant to a floating rate on such date. There can be no assurance that the actual amortization of the Collateral Assets will correspond to the anticipated amortization on which the Rate Swap Agreements will be based. The Collateral Assets are subject to prepayment and extension risk which may result in a further mismatch between the cash flow anticipated on the Collateral Assets and any Hedge Agreements.

The Issuer may only enter into or terminate a Hedge Agreement if the Rating Agency Condition is satisfied. In the event a Hedge Agreement is terminated, the Issuer has agreed to use reasonable efforts to enter into a substitute Hedge Agreement unless the Rating Agency Condition would not be satisfied by a substitute Hedge Agreement, but there is no assurance that a substitute will be found or that the Rating Agency Condition will be satisfied. Any termination of a Hedge Agreement, whether in whole or in part, may require the Issuer to pay termination payments to the Hedge Counterparty, which amounts are payable in accordance with the Priority of Payments prior to any payments on the Notes and the CP Notes unless such payments are Defaulted Hedge Termination Payments.

Because the Collateral Assets are subject to prepayment and extension risk, the notional amounts under the Rate Swap Agreements from time to time may be greater or lower than the outstanding principal amount of Collateral Assets that the Rate Swap Agreements were intended to hedge. Such an imbalance could require the Issuer to make payments to the Interest Rate Swap Counterparties that exceed the amounts earned from the Collateral Assets unless the Rate Swap Agreements are partially terminated. A partial termination of a Rate Swap Agreement may require that the Issuer pay a termination payment to the Interest Rate Swap Counterparty, which would reduce the Proceeds available for payment on the Notes and the CP Notes and may prevent the Rating Agency Condition from being satisfied, which would prevent the Issuer from effecting a partial termination. The Issuer may also enter into offsetting Rate Swap Agreements, subject to satisfaction of the Rating Agency Condition and subject to the constraints imposed by AIG Financial Products Corp., as the initial Interest Rate Swap Counterparty, pursuant to which the Interest Rate Swap Counterparty will agree to pay to the Issuer an amount equal to interest on the notional amount at a fixed interest rate specified therein and the Issuer will agree to pay the Interest Rate Swap Counterparty an amount equal to interest on the notional amount at LIBOR. To the extent the fixed rate received under the offsetting Rate Swap Agreement is lower than the fixed rate paid under the initial Rate Swap Agreement, there will be less Proceeds available for payments on the Notes and the Preferred Shares.

The Issuer's ability to meet its obligations on the Notes will largely depend on the ability of the Hedge Counterparties to meet their respective obligations under the Hedge Agreements. In the event a Hedge Counterparty defaults or a Hedge Agreement is terminated, there can be no assurance that the amounts received from the Collateral Assets will be sufficient to provide for full payments due and payable on the Notes, or that amounts otherwise distributable to the Holders of the Preferred Shares and the Class X Notes will not be reduced.

In the event of the insolvency of a Hedge Counterparty, the Issuer will be treated as a general creditor of such Hedge Counterparty. Consequently, the Issuer will be subject to the credit risk of each Hedge Counterparty. As a result, concentrations of Hedge Agreements in any one Hedge Counterparty subject the Notes to an additional degree of risk with respect to defaults by such Hedge Counterparty.

American International Group, Inc. AIG Financial Products Corp. will be the initial Interest Rate Swap Counterparty and the initial Cashflow Swap Counterparty and American International Group, Inc. ("AIG") will guarantee to the Issuer the payment obligations of AIG FP under the Hedge Agreements.

PROSPECTIVE PURCHASERS OF THE NOTES SHOULD CONSIDER AND ASSESS FOR THEMSELVES THE LIKELIHOOD OF A DEFAULT BY A HEDGE COUNTERPARTY OR A GUARANTOR OF ITS OBLIGATIONS, AS WELL AS THE OBLIGATIONS OF THE ISSUER UNDER THE HEDGE AGREEMENTS, INCLUDING THE OBLIGATION TO MAKE TERMINATION PAYMENTS TO ANY HEDGE COUNTERPARTY, AND THE LIKELY ABILITY OF THE ISSUER TO TERMINATE OR REDUCE ANY HEDGE AGREEMENTS OR ENTER INTO ADDITIONAL HEDGE AGREEMENTS.

Concentration Risk. The Issuer will invest in the portfolio of Collateral Assets described in Appendix B hereto. Payments on the Securities could be adversely affected by the concentration in the portfolio of any one issuer or any one servicer if such issuer or servicer were to default.

No single issuer will represent as of the Closing Date more than approximately 2.1% of the Collateral Assets by outstanding principal balance. For this purpose, trust issuers for CMBS with common or affiliated depositors are treated as different issuers. See "Security for the Notes—The Collateral Assets."

Other Considerations

Failure to issue and sell replacement CP Notes. The Issuer may fail to sell replacement CP Notes with a CP Face Amount sufficient (together with amounts in the CP Principal Reserve Account and the CP Interest Reserve Account) to repay maturing CP Notes for many reasons, including general market or economic conditions, a decline in the creditworthiness or rating of the CP Put Counterparty or the Cashflow Swap Counterparty, a reduction in the rating (or the placement on credit watch with negative implications) of any securities issued by the Issuer, a failure of a purchaser of a replacement CP Note to pay the purchase price therefor, the resignation of a CP Note Placement Agent, the inability of a CP Note Placement Agent to place CP Notes, the decision of a CP Note Placement Agent to not attempt to place CP Notes, the occurrence of an Event of Default or a decline in the performance or credit quality of the Issuer's portfolio of Collateral Debt Securities. In order for the Issuer to sell, and for the CP Note Placement Agents to place, replacement CP Notes, the Issuer must prepare and issue a CP Note private placement memorandum from time to time, which discloses all information material to an investment in the CP Notes, including information on the Issuer and the CP Put Counterparty. The Issuer has covenanted to do this in the CP Note Placement Agreement but there are no assurances that the Issuer will do so in a timely manner. No other party has undertaken to prepare the CP Note private placement memorandum on behalf of the Issuer. If the Issuer does not maintain at all times a CP Note private placement memorandum which describes all information material to a purchaser of a CP Note, the Issuer will not be able to issue, and the CP Note Placement Agents will decline to place, replacement CP Notes. In the event that the Issuer is not able to issue replacement CP Notes, the Trustee will, on behalf of the Issuer (if the conditions to exercise specified under "Security for the Notes—CP Put Agreement" are satisfied), exercise the CP Put Option. If the CP Put Counterparty fails to purchase Class A-1LT-b Notes, an Event of Default will occur under the Indenture.

The CP Put Agreement; Conditions to Exercise of CP Put Option. The CP Put Option in respect of the CP Notes will be exercised on the date when:

(i) the Issuers are not able to issue, sell or place new CP Notes having maturities of no more than 270 days, at a discount amount, if any, less than or equal to any amounts in the CP Interest Reserve Account (including amounts deposited to the CP Interest Reserve Account directly from the Collection Account) *plus* any CP Interest Deposit Amounts held by the Trustee for the following Interim Payment Date (including the original amount of any CP Put Counterparty Deposit Amount (as defined below) but excluding any withdrawals made or to be made from the CP Interest Reserve Account on such date) and a discount rate less than or equal to the Maximum CP Put Option Strike Rate in a face amount at least equal to the face amount of maturing CP Notes less amounts on deposit in the CP Principal Reserve Account,

(ii) the short-term senior unsecured debt rating of the CP Put Counterparty is downgraded below "A-1" or "P-1" by S&P or Moody's, respectively, collateral is not posted in accordance with the CP Put Agreement, the CP Put Counterparty is not replaced in accordance with the CP Put Agreement and Goldman, Sachs & Co., is a CP Note Placement Agent (it being agreed that there is no obligation of the CP Put Counterparty to post collateral or be replaced),

(iii) a payment default under the Indenture has occurred with respect to the Class A Notes, the CP Notes, a required deposit to the CP Principal Reserve Account or the Class B Notes solely as a result of a failure by a Hedge Counterparty to make a payment under a Hedge Agreement,

(iv) the CP Put Counterparty has notified the Issuer or the Issuer has notified the CP Put Counterparty that it elects to terminate the CP Put Agreement as a consequence of the occurrence of an event of default or termination event thereunder,

(v) the CP Put Agreement is scheduled to terminate as the result of the occurrence of an Event of Default under the Indenture and acceleration under the Indenture and the commencement of the liquidation of Collateral thereunder,

(vi) the CP Put Agreement is scheduled to terminate as the result of an early redemption in full of the Notes and Defeasance of the CP Notes in full under the Indenture (with such Put Option termination not in any case becoming effective prior to the earlier of the date on which no CP Notes remain outstanding and the date on which all outstanding CP Notes have been Defeased in full under the Indenture),

(vii) on or after October 19, 2006 the CP Put Counterparty elects to terminate the CP Put Agreement in whole or in part, or

(viii) a prospective purchaser of CP Notes to be placed on any date fails in its obligation to pay the cash purchase price for such CP Notes it was obligated to purchase on such date.

In addition to the occurrence of one or more of the events described above, for the CP Put Option to be exercised none of the following events may have occurred on or prior to the applicable initial maturity date of the applicable CP Notes or, in the case of clause (viii) above, the settlement date: (1) a bankruptcy or insolvency default under the Indenture has occurred with respect to either of the Issuers, (2) the CP Put Premium due to be paid to the CP Put Counterparty by the Issuer under the CP Put Agreement has not been paid, (3) there are any payment defaults on the Class A Notes, the CP Notes or with respect to a required deposit to the CP Principal Reserve Account and all CP Notes which were Outstanding on the date such Event of Default originally occurred have matured (unless such payment default is due solely to a failure by a Hedge Counterparty to make payments required to be made under any of the Hedge Agreements) or (4) the Class A Overcollateralization Ratio is less than 100%. Notwithstanding the foregoing, the CP Put Option will not be exercised if, upon the occurrence of either condition described in clause (i) or (viii) above, the Issuer is able to issue CP Notes with maturities of no more than 270 days and a discount rate that is less than or equal to the discount equivalent of the Maximum CP Put Option Strike Rate on or before the date of settlement of such CP Put Option. The CP Put Counterparty will be permitted to (but is not obligated to) make deposits to the CP Interest Reserve Account in an amount (the "CP Put Counterparty Deposit Amount") sufficient to prevent the CP Put Option from being exercised under certain conditions. If the CP Put Counterparty does make such a deposit, discount on the issued CP may in certain cases, exceed the Maximum CP Put Option Strike Rate. The CP Put Counterparty is not entitled to be reimbursed for any such deposits. The CP Put Agreement is subject to typical ISDA default and termination provisions and if any event has occurred which would give rise to a default or termination of the CP Put Agreement, the CP Put Counterparty will not be obligated to perform under the CP Put Option. If the conditions to exercise the CP Put Option are not satisfied or the CP Put Counterparty does not, or is not able to, perform its obligations under the CP Put Option, the sole source that the Issuers may use to make payments on maturing CP Notes will be proceeds from the Collateral Assets, Eligible Investments, the Cashflow Swap and amounts on deposit in the Collection Account and the CP Reserve Accounts. If the CP Put Counterparty is downgraded, it has no obligation to replace itself or collateralize under the CP Put Agreement.

Ratings of the CP Notes. The CP Notes are expected to be rated "A-1+" by S&P and "P-1" by Moody's on the Closing Date. The ratings assigned to the CP Notes by S&P are linked to the rating of the CP Put Counterparty and any such ratings can be expected to be downgraded by S&P and Moody's if the rating of the CP Put Counterparty is downgraded.

Voting Rights Held by CP Put Counterparty. The terms of the various Transaction Documents entitle the CP Put Counterparty to exercise certain voting rights with respect to the CP Notes, pertaining to, among other things, the Collateral as described herein, subject to any applicable provision of law and any applicable provisions of such Transaction Documents.

Changes in Tax Law; No Gross-Up. Payments on the Collateral Assets generally are exempt under current United States tax law from the imposition of United States withholding tax. See "Income Tax Considerations—U.S. Federal Income Tax Consequences to the Issuer." However, there can be no assurance that, as a result of any change in any applicable law, treaty, rule or regulation or interpretation thereof, the payments on the Collateral Assets would not in the future become subject to withholding taxes imposed by the United States of America or another jurisdiction. In that event, if the obligors of such Collateral Assets were not then required to make "gross-up" payments that cover the full amount of any such withholding taxes, the amounts available to make payments on, or distributions to, the Holders of the Securities would accordingly be reduced. No "gross-up" payments are required with respect to CMBS. There can be no assurance that remaining payments on the Collateral would be sufficient to make timely payments of interest on and payment of principal at the Stated Maturity of each Class of the Notes and, consequently, to pay the Class X Payment and to make any distributions on the Preferred Shares on the Scheduled Preferred Share Redemption Date.

In the event that any withholding tax is imposed on payments on the Securities, the Holders of such Securities will not be entitled to receive "grossed-up" amounts to compensate for such withholding tax. In addition, 90 days following the Issuers becoming aware of the occurrence of a Tax Event (which 90-day period may be extended by 90 days), the Issuer will redeem in whole but not in part, at applicable Note Redemption Prices specified herein, the Notes and the CP Notes in accordance with the procedures described under "Description of the Securities—Tax Redemption," "—Optional Redemption—Optional Redemption/Tax Redemption Procedures" herein.

Lack of Operating History. Each Issuer is a newly organized entity and has no prior operating history. Accordingly, neither Issuer has a performance history for a prospective investor to consider.

Investment Company Act. Neither of the Issuers has registered with the United States Securities and Exchange Commission (the "SEC") as an investment company pursuant to the Investment Company Act. The Issuer has not so registered in reliance on an exception for investment companies organized under the laws of a jurisdiction other than the United States whose investors resident in the United States are solely Qualified Purchasers and which do not make a public offering of their securities in the United States. Counsel for the Issuers will opine, in connection with the sale of the Securities by the Initial Purchaser, that neither the Issuer nor the Co-Issuer is on the Closing Date an investment company required to be registered under the Investment Company Act (assuming, for the purposes of such opinion, that the Securities are sold by the Initial Purchaser in accordance with the terms of the Purchase Agreement). No opinion or no-action position has been requested of the SEC.

If the SEC or a court of competent jurisdiction were to find that the Issuer or the Co-Issuer is required, but in violation of the Investment Company Act had failed, to register as an investment company, possible consequences include, but are not limited to, the following: (i) the SEC could apply to a district court to enjoin the violation; (ii) investors in the Issuer or the Co-Issuer could sue the Issuer or the Co-Issuer, as the case may be, and recover any damages caused by the violation; and (iii) any contract to which the Issuer or the Co-Issuer, as the case may be, is a party that is made in, or whose performance involves a violation of the Investment Company Act would be unenforceable by any party to the contract unless a court were to find that under the circumstances enforcement would produce a more

equitable result than non-enforcement and would not be inconsistent with the purposes of the Investment Company Act. Should the Issuer or the Co-Issuer be subjected to any or all of the foregoing, the Issuer or the Co-Issuer, as the case may be, would be materially and adversely affected.

The Securities are only permitted to be transferred to Qualified Institutional Buyers in transactions meeting the requirements of Rule 144A and, solely in the case of the Class X Notes and the Preferred Shares, to Accredited Investors having a net worth of not less than U.S.\$10 million in transactions exempt from registration under the Securities Act, or in an offshore transaction, to a non-U.S. Person, complying with Rule 903 or Rule 904 of Regulation S. The Securities being offered in the United States are being offered only to persons that are also Qualified Purchasers. Any non-permitted transfer will be voided and the Issuers can require the transferee to sell its Securities to a permitted transferee, with such sale to be effected within 30 days after notice of such sale requirement is given. If such sale is not effected within such 30 day period, upon written direction from the Issuer, the Trustee will be authorized to conduct a commercially reasonable sale of such Securities to a permitted transferee and pending such transfer, no further payments will be made in respect of such Securities or any beneficial interest therein. See "Description of the Securities—Form of the Securities" and "Notice to Investors."

Credit Ratings. Credit ratings of debt securities represent the rating agencies' opinions regarding their credit quality and are not a guarantee of quality. Rating agencies attempt to evaluate the safety of principal and interest payments and do not evaluate the risks of fluctuations in market value, therefore, they may not fully reflect the true risks of an investment. Also, rating agencies may fail to make timely changes in credit ratings in response to subsequent events, so that an issuer's current financial condition may be better or worse than a rating indicates.

Document Repository. Pursuant to the Indenture, the Issuer will consent to the posting of this Confidential Offering Circular, the Indenture and certain periodic reports required to be delivered pursuant to the Transaction Documents, together with any amendments or modifications thereto, to the internet-based password protected electronic repository of transaction documents relating to privately offered and sold collateralized debt obligation securities located at "www.cdolibrary.com".

Emerging Requirements of the European Community. As part of the harmonization of securities markets in Europe, the European Commission has adopted directives known as the Prospectus Directive and the Transparency Obligations Directive that, among other things, will regulate issuers of securities that are offered to the public or admitted to trading on a European Union regulated market. The European Commission also is expected to consider other directives, including a directive known as the Market Abuse Directive, which would affect issuers of securities listed on a European Union stock exchange. The listing of Notes or Preferred Shares on any European Union stock exchange would subject the Issuer to regulation under these directives, although the requirements applicable to the Issuer are not yet fully clarified. The Indenture will not require the Issuer to apply for, list or maintain a listing for any Class of Notes or the Preferred Shares on a European Union stock exchange if compliance with these directives (or other requirements adopted by the European Commission or a relevant member state) becomes burdensome. Should the Notes or Preferred Shares be delisted from any exchange, the ability of the holders of such Securities to sell such Securities in the secondary market may be negatively impacted.

Certain Conflicts of Interest. Various potential and actual conflicts of interest may arise from the overall advisory, investment and other activities of the Collateral Manager, its affiliates and their respective clients and employees and from the overall investment activity of the Initial Purchaser, including in other transactions with the Issuer, including, without limitation, acting as counterparty with respect to any Hedge Agreements. The following briefly summarizes some of these conflicts, but is not intended to be an exhaustive list of all such conflicts.

The Collateral Manager and the Collateral Adviser. Various potential and actual conflicts of interest may arise from the overall advisory, investment and other activities of the Collateral Manager, the Collateral Adviser, their affiliates and their clients. The following briefly summarizes some of these conflicts, but is not intended to be an exhaustive list of all such conflicts.

The Collateral Manager, the Collateral Adviser and/or their affiliates may have ongoing relationships with, render service to, finance and engage in transactions with, and may own debt or equity securities issued by issuers of certain of the Collateral Assets. The Collateral Manager, the Collateral Adviser, their affiliates and/or their clients may invest in securities that are senior or subordinated to, or have interests different from or adverse to, the Collateral Assets. The interests of such parties may be different than or adverse to the interest of the holders of the Securities. In addition, such persons may possess information relating to the Collateral Assets which is not known to the individuals at the Collateral Manager or the Collateral Adviser responsible for monitoring the Collateral Assets and performing the other obligations under the Collateral Management Agreement or the Collateral Advisory Agreement, as the case may be. Such persons will not be required (and may not be permitted) to share such information or pass it along to the Issuer, the Collateral Manager, the Collateral Adviser or any holder of any Security. None of the Collateral Manager, the Collateral Adviser or any of such persons will have liability to the Issuer or any holder of any Security for failure to disclose such information or for taking, or failing to take, any action based upon such information.

In addition, the Collateral Manager, the Collateral Adviser and/or any of their affiliates may engage in any other business and furnish investment management and advisory services to others which may include, without limitation, serving as consultant or servicer for, investing in, lending to, being affiliated with or have other ongoing relationships with, other entities organized to issue collateralized debt obligations secured by assets similar to the Collateral Assets, and other trusts and pooled investments vehicles that acquire interests in, provide financing to, or otherwise deal with securities issued by issuers that would be suitable investments for the Issuer. In the course of monitoring the Collateral Assets held by the Issuer, the Collateral Manager may consider its relationships with other clients (including entities whose securities (or those of its affiliates) are pledged to secure the Notes) and its affiliates (including the Collateral Adviser). In providing services to other clients, the Collateral Manager, the Collateral Adviser and their affiliates may recommend activities that would compete with or otherwise adversely affect the Issuer. In addition, the Collateral Manager and the Collateral Adviser will be free, each in its sole discretion, to make recommendations to others, or effect transactions on behalf of itself or for others, that may be the same as or different from those effected on behalf of the Issuer, and the Collateral Manager and the Collateral Adviser may furnish advisory services to others who may have investment policies similar to those followed by the Issuer and who may own securities of the same class, or which are the same type as, the Collateral Assets. Under the terms of the Collateral Management Agreement and the Collateral Advisory Agreement, each of the Collateral Manager and the Collateral Adviser will be permitted to take whatever action is in the Collateral Manager's or the Collateral Adviser's, respectively, best interest regardless of the impact on the Collateral Assets. In addition, under certain circumstances the Collateral Manager may direct the Issuer to sell certain Collateral Assets. Such sales of Collateral Assets may result in losses by the Issuer, which losses may result in the reduction or withdrawal of the rating of any or all of the Securities by any of the Rating Agencies. In determining whether to exercise such right, the Collateral Manager and the Collateral Adviser need not take into account the interests of the Issuers, the Noteholders, the Preferred Shareholders or any other party.

Each of the Collateral Manager, the Collateral Adviser and/or their affiliates may at certain times be simultaneously seeking to purchase or dispose of investments for their respective accounts or for another entity, including other collateralized debt obligation vehicles, at the same time as the Collateral Manager is disposing of investments for the Issuer. Accordingly, conflicts may arise regarding the allocation of sale opportunities. The Collateral Manager may aggregate sales of securities placed with respect to the Collateral Assets with similar sales being made simultaneously for other clients or other accounts managed by the Collateral Manager or the Collateral Adviser or with accounts of their affiliates, if in the Collateral Manager's or the Collateral Adviser's reasonable business judgment such aggregation will result in an overall economic benefit to the Issuer, taking into consideration the advantageous selling price, brokerage commission and other expenses. However, no provision of the Collateral Management Agreement requires the Collateral Manager or its affiliates to execute orders as part of concurrent authorizations or to aggregate sales. Nevertheless, the Collateral Manager may, in the allocation of business, take into consideration research and other brokerage services furnished to the Collateral Manager, the Collateral Adviser or their affiliates by brokers and dealers. Such services may be used by the Collateral Manager or the Collateral Adviser in connection with the Collateral Manager's and the Collateral Adviser's other advisory services or investment operations.

No provision in the Collateral Management Agreement or the Collateral Advisory Agreement prevents the Collateral Manager, the Collateral Adviser or any of their affiliates from rendering services of any kind to the issuer of any Collateral Assets and its affiliates, the Trustee, the holders of the Securities, the Hedge Counterparty or any other entity. Without prejudice to the generality of the foregoing, the Collateral Manager, the Collateral Adviser and their affiliates, directors, officers, employees and agents may, among other things: (a) serve as directors, partners, officers, employees, agents, nominees or signatories for an issuer of any Collateral Assets; (b) receive fees for services rendered to the issuer of any Collateral Assets or any affiliate thereof; (c) be a secured or unsecured creditor of, or hold an equity interest in, any issuer of any Collateral Assets; (d) serve as a member of any "creditors' board" or "creditors' committee" with respect to any Collateral Assets which has become or may become a Defaulted Obligation or with respect to any commercial mortgage loan securing any Collateral Assets or the respective borrower for any such commercial mortgage loan; and (e) own or make loans to, or otherwise transact with, any borrower or affiliate of any borrower on any of the commercial mortgage loans securing the Collateral Assets. Under the terms of the Collateral Management Agreement and the Collateral Advisory Agreement, the Collateral Manager and the Collateral Adviser, respectively, will be permitted to take whatever action is in the Collateral Manager's or the Collateral Adviser's best interest regardless of the impact on the Collateral Assets.

On the Closing Date it is expected that the Collateral Manager or one or more affiliates or clients of the Collateral Manager will purchase up to U.S.\$1,000,000 in notional amount of the Preferred Shares and may purchase Notes and/or Preferred Shares on or after the Closing Date. The Collateral Manager or such affiliates or clients may at times also own other Securities. There is no assurance that the Collateral Manager or any of such affiliates or clients will continue to hold any or all of the Notes or the Preferred Shares (including the Preferred Shares purchased on the Closing Date) or that they will continue to hold interests in any securities related to the Collateral Assets.

Wharton Asset Management or any of its affiliates or subsidiaries will be permitted to exercise all voting rights with respect to any Securities which they may acquire (other than with respect to a vote regarding the removal of the Collateral Manager or the termination or assignment of the Collateral Management Agreement). The interests of the Preferred Shares may be different from or adverse to the interests of the Notes.

The Collateral Manager will, as an agent of the Issuer, monitor the issuance, sale and payment of the CP Notes. Pursuant to the Collateral Advisory Agreement, the Collateral Adviser will agree to monitor the issuance, sale and payment of the CP Notes on behalf of the Collateral Manager. Such activities may give rise to conflicts of interest with respect to the Collateral Manager or the Collateral Adviser.

Neither the Collateral Manager nor the Collateral Adviser has previously been involved in a collateralized debt obligation transaction involving the issuance and sale of commercial paper notes such as the CP Notes. Accordingly, there is no operating history from which potential purchasers of the Offered Securities may evaluate the likelihood of successful performance of the Collateral Manager (or the Collateral Adviser on its behalf) with respect to its duties of monitoring, and advising the Issuer with respect to, the issuance, sale and payment of the CP Notes. In addition, only a limited number of individuals employed by the Collateral Manager and the Collateral Adviser are involved in (and have expertise relevant to) the monitoring, issuance, sale and payment of commercial paper notes. Consequently, the loss of one or more of the individuals employed by the Collateral Manager to provide services to the Issuer with respect to the CP Notes could have a significant adverse effect on the performance of the Issuer and the Offered Securities.

The Initial Purchaser. Various potential and actual conflicts of interest may arise from the conduct by the Initial Purchaser and its affiliates in other transactions with the Issuer, including, without limitation, acting as counterparty with respect to any Hedge Agreements. The Initial Purchaser will initially act as a CP Note Placement Agent under a CP Note Placement Agreement. The following briefly summarizes some of these conflicts, but is not intended to be an exhaustive list of all such conflicts.

It is expected that Goldman, Sachs & Co. and/or its affiliates and selling agent will have placed or underwritten certain of the Collateral Assets at original issuance, will own equity or other securities of issuers of or obligors on Collateral Assets and will have provided investment banking services, advisory, banking and other services to issuers of Collateral Assets. The Issuer may invest in the securities of companies affiliated with Goldman, Sachs & Co. and/or any of its affiliates (collectively, "Goldman Sachs") and/or any of its respective affiliates or in which Goldman Sachs and/or any of their respective affiliates have an equity or participation interest. The purchase, holding and sale of such investments by the Issuer may enhance the profitability of Goldman Sachs' and/or any of its affiliates' own investments in such companies. The Issuer may invest in money market funds that are managed by Wharton Asset Management or Goldman Sachs or their respective affiliates; provided that such money market funds otherwise qualify as Eligible Investments. Goldman Sachs and/or a consolidated entity controlled by Goldman Sachs or an affiliate thereof is providing "warehouse" financing to the Issuer prior to the Closing Date. See "-Collateral Accumulation."

There is no limitation or restriction on the Initial Purchaser or any of its affiliates with regard to acting as investment advisor, initial purchaser or placement agent (or in a similar role) to other parties or persons. This and other future activities of the Initial Purchaser and/or its respective affiliates may give rise to additional conflicts of interest.

CP Note Placement Agents are under no Obligation to Place CP Notes. Under the CP Note Placement Agreement, the CP Note Placement Agents may, in their sole discretion, assist the Issuer in placing the CP Notes. However, the CP Note Placement Agents are not obligated to do so at any time. If the CP Note Placement Agents are unwilling or unable to place CP Notes, the Issuer will not be able to place replacement CP Notes, and the Trustee will, on behalf of the Issuer (if the conditions to exercise specified under "Security for the Notes—CP Put Agreement" are satisfied), exercise the CP Put Option. If the CP Put Counterparty fails to purchase Class A-1LT-b Notes, an Event of Default will occur under the Indenture.

Conflicts of Interest Involving the CP Put Counterparty. SG Americas Securities, L.L.C. will act as a CP Note Placement Agent in connection with the issuance of the CP Notes, and its affiliate, Société Générale, acting through its New York branch, will act as CP Put Counterparty and will be an investor in the senior Notes, and may be holder of the CP Notes or other Notes. SG Americas Securities, L.L.C.'s interests as a CP Note Placement Agent, Société Générale's, acting through its New York branch, interests as CP Put Counterparty, as a senior Notes investor and/or as a holder of CP Notes or other Notes and the interests of the other Holders of Securities may, in certain circumstances, be conflicted.

There is no limitation or restriction on the CP Put Counterparty or SG Americas Securities, L.L.C. or any of its affiliates with regard to acting as a put counterparty or a note placement agent to other parties or persons or as an investor in commercial paper notes or other notes (except as otherwise described herein). This and other future activities of the CP Put Counterparty and SG Americas Securities, L.L.C. and/or their respective affiliates may give rise to additional conflicts of interest.

SG Americas Securities, L.L.C. as CP Note Placement Agent, is not obligated or required to place CP Notes and may cease doing so at any time.

Anti Money Laundering Provisions. Uniting and Strengthening America By Providing Appropriate Tools Required to Intercept and Obstruct Terrorism Act of 2001 (the "USA PATRIOT Act"), signed into law on and effective as of October 26, 2001, imposes anti money laundering obligations on different types of financial institutions, including banks, broker dealers and investment companies. The USA PATRIOT Act requires the Secretary of the United States Department of the Treasury (the "Treasury") to prescribe regulations to define the types of investment companies subject to the USA PATRIOT Act and the related anti money laundering obligations. It is not clear whether Treasury will require entities such as the Issuer to enact anti money laundering policies. It is possible that Treasury will promulgate regulations requiring the Issuers or the Initial Purchaser or other service providers to the Issuers, in connection with the establishment of anti money laundering procedures, to share information with governmental authorities with respect to investors in the Notes and/or the Preferred Shares. Such legislation and/or regulations

could require the Issuers to implement additional restrictions on the transfer of the Notes and/or the Preferred Shares. As may be required, the Issuer reserves the right to request such information and take such actions as are necessary to enable it to comply with the USA PATRIOT Act.

The Issuer. The Issuer is a recently incorporated Cayman Islands exempted limited liability company and has no substantial prior operating history. The Issuer will have no significant assets other than the Collateral Assets, Eligible Investments, rights under the Hedge Agreements, the CP Put Agreement and certain other accounts and agreements entered into as described herein, and proceeds thereof, all of which have been pledged to the Trustee to secure the Issuer's obligations to the Holders of the Notes, the Holders of the CP Notes, the CP Put Counterparty, the CP Note Placement Agents and the Hedge Counterparties. The Issuer will not engage in any business activity other than the issuance and sale of the Notes, the CP Notes and the Preferred Shares as described herein, the issuance of the Ordinary Shares, the acquisition and disposition of the Collateral Assets and Eligible Investments as described herein, the entering into of, and the performance of its obligations under, the Indenture, the Hedge Agreements, the CP Put Agreement, the Account Control Agreement, the Collateral Management Agreement, the Collateral Advisory Agreement, the Collateral Administration Agreement, the CP Note Placement Agreement, any other applicable Transaction Document, the pledge of the Collateral as security for its obligations in respect of the Notes and the CP Notes and otherwise for the benefit of the Secured Parties, certain activities conducted in connection with the payment of amounts in respect of the Notes, the CP Notes and the Preferred Shares and the management of the Collateral and other activities incidental to the foregoing. Income derived from the Collateral Assets and other Collateral will be the Issuer's only source of cash.

The Co-Issuer. The Co-Issuer is a newly incorporated Delaware corporation and has no prior operating history. The Co-Issuer does not have and will not have any significant assets. The Co-Issuer will not engage in any business activity other than the co-issuance of the Class A Notes, the Class B Notes, the Class C Notes, the Class D Notes and the CP Notes.

Tax. See "Income Tax Considerations."

ERISA. See "Certain ERISA Considerations."

DESCRIPTION OF THE SECURITIES

The Class E Notes and the Class X Notes will be issued by the Issuer and the other Notes will be issued by the Issuers pursuant to the Indenture. The Preferred Shares will be issued pursuant to the Issuer's Memorandum and Articles of Association and the Resolutions and will be subject to the Preferred Share Paying and Transfer Agency Agreement. The following summary describes certain provisions of the Securities, the Indenture, the Preferred Share Paying and Transfer Agency Agreement and the Issuer's Memorandum and Articles of Association. This summary does not purport to be complete and is subject to, and qualified in its entirety by reference to, the provisions of the Securities, the Indenture, the Preferred Share Paying and Transfer Agency Agreement and the Issuer's Memorandum and Articles of Association. Copies of the Indenture may be obtained by prospective purchasers of the Notes upon request in writing to the Trustee at LaSalle Bank National Association, 135 South LaSalle Street, Suite 1511, Chicago, IL 60603, Attention: CDO Trust Services Group, G Street Finance Ltd. (telephone number (312) 904-7815), and, so long as any Notes are listed on a stock exchange, the Indenture will be available for inspection free of charge from the office of the Listing and Paying Agent. Copies of the Preferred Share Paying and Transfer Agency Agreement and the Issuer's Memorandum and Articles of Association may be obtained by prospective purchasers of Preferred Shares upon request in writing to the Preferred Share Paying Agent at ABN AMRO Bank N.V. (London Branch), 82 Bishopsgate, London, England EC2N 4BN, Attention: Global Trust Services Group—G Street Finance Ltd. (telephone number (44 207-678-2015)).

Status and Security

The Notes (other than the Class E Notes) will be limited recourse obligations of the Issuers and the Class E Notes and the Class X Notes will be limited recourse obligations of the Issuer, secured as described below. The Preferred Shares will be part of the issued share capital of the Issuer, will not be secured obligations of the Issuer and will only be entitled to receive amounts available for distribution to the Holders of the Preferred Shares after payment of all amounts payable prior thereto under the Priority of Payments. The Class X Notes will be senior in right of payment on each Payment Date to the Class A Notes, the CP Notes and the Class B Notes and will be senior in right of payment on each Quarterly Payment Date to the Class A Notes, the CP Notes, the Class B Notes, the Class C Notes, the Class D Notes, the Class E Notes and the Preferred Shares. The Class A Notes and the CP Notes will be senior in right of payment on each Payment Date to the Class B Notes and will be senior in right of payment on each Quarterly Payment Date to the Class B Notes, the Class C Notes, the Class D Notes, the Class E Notes and the Preferred Shares. Interest on the Class A-1LT-a Notes will be *pro rata* with interest on the Class A-2 Notes. Principal on the Class A-1LT-a Notes and the Class A-2 Notes will be paid either *pro rata* or first to the Class A-1LT-a Notes and second to the Class A-2 Notes depending on the circumstances as more fully described in the Priority of Payments. Payments with respect to the CP Notes and the Class A-1LT-b Notes will be paid *pari passu* with the payments on the Class A-1LT-a Notes. The Class B Notes will be senior in right of payment on each Quarterly Payment Date to the Class C Notes, the Class D Notes, the Class E Notes and the Preferred Shares. The Class C Notes will be senior in right of payment on each Quarterly Payment Date to the Class D Notes, the Class E Notes and the Preferred Shares. The Class D Notes will be senior in right of payment on each Quarterly Payment Date to the Class E Notes and the Preferred Shares. The Class E Notes will be senior in right of payment on each Quarterly Payment Date to the Preferred Shares. See "—Priority of Payments."

Under the terms of the Indenture, the Issuer will grant to the Trustee, for the benefit and security of the Trustee on behalf of the Notes, the CP Notes, the Preferred Share Paying Agent, the Collateral Manager, the Collateral Adviser, the CP Put Counterparty, the CP Note Placement Agents, the CP Issuing and Paying Agent and the Hedge Counterparty (collectively, the "Secured Parties"), a first priority security interest in (i) the Collateral Assets; (ii) the Collection Account; (iii) the Payment Account; (iv) the Hedge Termination Receipts Account, the Hedge Replacement Account and the Hedge Collateral Account (subject, in each case, to the rights of the Hedge Counterparty); (v) the Expense Reserve Account; (vi) the Collateral Account; (vii) the CP Interest Reserve Account (pledged only for the benefit of the Holders of the CP Notes); (viii) the CP Principal Reserve Account (pledged only for the benefit of the Holders of the CP Notes); (ix) CP Put Collateral Account (subject to the rights of the CP Put Counterparty)

(items (ii) through (ix), the "Accounts"); (x) Eligible Investments; (xi) the Issuer's rights under the Hedge Agreements; (xii) the Issuer's rights under the Collateral Management Agreement and the Collateral Advisory Agreement; (xiii) the Issuer's rights under the CP Put Agreement; (xiv) the Issuer's rights under the CP Note Placement Agreement; (xv) the Issuer's rights under the CP Issuing and Paying Agency Agreement and (xvi) certain other property (collectively, the "Collateral").

Payments due on the CP Notes, payments of interest on and principal of the Notes, and distributions to the Holders of the Class X Notes and the Preferred Shares, will be made solely from the proceeds of the Collateral in accordance with the Priority of Payments; *provided* that the CP Notes will also be entitled to certain payments from the CP Reserve Accounts and the CP Account.

The aggregate amount that will be available for payments required or permitted to be made on the Notes and the CP Notes and of certain expenses of the Issuers, the Trustee and the Agents on any Payment Date will be the total amount of payments and collections in respect of the Collateral (including the proceeds of the sale of any Collateral) received during the period (a "Due Period") ending on (and including) the fifth Business Day prior to such Payment Date (or, in the case of a Due Period that is applicable to the Payment Date relating to the Stated Maturity of any Note, ending on (and including) the day preceding such Payment Date) and commencing immediately following the fifth Business Day prior to the preceding Payment Date (or, in the case of the Due Period relating to the first Payment Date, on the Closing Date) and any such amounts received in prior Due Periods that were not disbursed on a previous Payment Date and any amounts released from the CP Interest Reserve Account that is not due to the Cashflow Swap Counterparty and, in the case of the CP Notes, purchase proceeds of newly issued CP Notes, any amount paid pursuant to the CP Put Agreement and certain amounts on deposit in the CP Reserve Accounts.

Interest and Dividends

The Class A-1LT-a Notes will bear interest during each Interest Accrual Period at the Class A-1LT-a Note Interest Rate for such Interest Accrual Period. The Class A-1LT-b-1 Notes will bear interest during each Interest Accrual Period at the Class A-1LT-b-1 Note Interest Rate. The Class A-1LT-b-2 Notes will bear interest during each Interest Accrual Period at the Class A-1LT-b-2 Note Interest Rate. The Class A-2 Notes will bear interest during each Interest Accrual Period at the Class A-2 Note Interest Rate for such Interest Accrual Period. The Class B Notes will bear interest during each Interest Accrual Period at the Class B Note Interest Rate for such Interest Accrual Period. The Class C Notes will bear interest during each Interest Accrual Period at the Class C Note Interest Rate for such interest Accrual Period. The Class D Notes will bear interest during each Interest Accrual Period at the Class D Note Interest Rate for such Interest Accrual Period. After the Class E Issuance Option has been exercised, the Class E Notes will bear interest during each Interest Accrual Period at the Class E Note Interest Rate for such Interest Accrual Period. Interest with respect to the Class A Notes and the Class B Notes will be payable monthly in arrears on each Payment Date commencing on January 9, 2006 or, with respect to the Class A-1LT-b Notes, on the first Payment Date following the date of issuance thereof and interest on the Class C Notes, the Class D Notes and the Class E Notes will be payable quarterly in arrears, commencing on January 9, 2006 or, with respect to the Class E Notes, on the first Quarterly Payment Date following the date of the exercise of the Class E Issuance Option. LIBOR for the first Interest Accrual Period with respect to the Notes will be determined as of the second Business Day preceding the Closing Date or, with respect to the Class A-1LT-b Notes, the issuance date thereof and, with respect to the Class E Notes, the date of the exercise of the Class E Issuance Option. Calculations of interest on the Notes will be made based on a 360-day year and the actual number of days in each Interest Accrual Period. The Class X Notes will be entitled to receive the Class X Payment on each Payment Date. The Class X Payment will be calculated on the basis of a 360-day year consisting of twelve 30-day months. The Holders of the Preferred Shares will, to the extent of lawfully available funds, receive on each Quarterly Payment Date any amount of Proceeds that are available for distribution thereon in accordance with the Priority of Payments on such Quarterly Payment Date subject to certain restrictions under Cayman Islands law. The "Interest Accrual Period," is with respect to the Class A-1LT Notes, the Class A-2 Notes, the Class B Notes and the LIBOR CP Notes and any Payment Date, the period commencing on and including the immediately preceding Payment Date (or the Closing Date in the case of the first

Interest Accrual Period, or the date of issuance in the case of the first Interest Accrual Period and Class A-1LT-b Notes and the LIBOR CP Notes) and ending on and including the day immediately preceding such Payment Date and (b) with respect to the Class C Notes, the Class D Notes and the Class E Notes and any Quarterly Payment Date, the period commencing on and including the immediately preceding Quarterly Payment Date (or the Closing Date in the case of the first Interest Accrual Period, or the date of exercise of the Class E Issuance Option in the case of the first Interest Accrual Period and the Class E Notes) and ending on and including the day immediately preceding such Quarterly Payment Date.

If funds are not available on any Quarterly Payment Date to pay the full amount of interest on the Class C Notes, or to the extent interest that is due on such Notes is not paid in order to satisfy certain Coverage Tests, the interest not paid (the "Class C Deferred Interest"), will not be due and payable on such Quarterly Payment Date, but will be added to the principal amount of the Class C Notes and, to the extent lawful and enforceable, thereafter shall accrue interest at the Class C Note Interest Rate. If funds are not available on any Quarterly Payment Date to pay the full amount of interest on the Class D Notes, or to the extent interest that is due on such Notes is not paid in order to satisfy certain Coverage Tests, the interest not paid (the "Class D Deferred Interest"), will not be due and payable on such Quarterly Payment Date, but will be added to the principal amount of the Class D Notes and, to the extent lawful and enforceable, thereafter shall accrue interest at the Class D Note Interest Rate. If funds are not available on any Quarterly Payment Date to pay the full amount of interest on the Class E Notes, or to the extent interest that is due on such Notes is not paid in order to satisfy certain Coverage Tests, the interest not paid (the "Class E Deferred Interest"), will not be due and payable on such Quarterly Payment Date, but will be added to the principal amount of the Class E Notes and, to the extent lawful and enforceable, thereafter shall accrue interest at the Class E Note Interest Rate. So long as any CP Notes, Class A Notes or Class B Notes are outstanding, the failure to pay interest to the Holders of the Class C Notes will not be an Event of Default under the Indenture, so long as any CP Notes, Class A Notes, Class B Notes or Class C Notes are outstanding, the failure to pay interest to the Holders of the Class D Notes will not be an Event of Default under the Indenture and so long as any CP Notes, Class A Notes, Class B Notes, Class C Notes or Class D Notes are outstanding, the failure to pay interest to the Holders of the Class E Notes will not be an Event of Default under the Indenture. See "—Priority of Payments" and "—The Indenture and the Preferred Share Paying and Transfer Agency Agreement—Events of Default."

Interest will cease to accrue on each Note from the date of repayment in full or Stated Maturity, or in the case of partial repayment, on such part, unless payment of principal is improperly withheld or unless default is otherwise made with respect to such payments of principal. See "—Principal." To the extent lawful and enforceable, interest on any Defaulted Interest on each Class of Notes entitled thereto will accrue at the interest rate applicable to such Class of Notes, until paid as provided herein. "Defaulted Interest" means any interest due and payable in respect of (i) any LIBOR CP Note, Class A Note or Class B Note or (ii) if there are no LIBOR CP Notes, Class A Notes or Class B Notes outstanding, any Class C Note or if there are no LIBOR CP Notes, Class A Notes, Class B Notes or Class C Notes outstanding, any Class D Note or if there are no LIBOR CP Notes, Class A Notes, Class B Notes, Class C Notes or Class D Notes outstanding, any Class E Note which, in any such case, is not punctually paid or duly provided for on the applicable Payment Date, Quarterly Payment Date or at Stated Maturity, as the case may be.

Determination of LIBOR

For purposes of calculating each of the Note Interest Rates, the Issuers will appoint as agent LaSalle Bank National Association (in such capacity, the "Note Calculation Agent"). LIBOR shall be determined by the Note Calculation Agent in accordance with the following provisions:

(i) On the second Business Day prior to the commencement of an Interest Accrual Period (each such day, a "LIBOR Determination Date"), LIBOR ("LIBOR") shall equal the rate, as obtained by the Note Calculation Agent, for Eurodollar deposits for, with respect to the Class A-1L Notes, the LIBOR CP Notes and the Class B Notes, a one-month period (or, in the case of a designated initial payment period of less than 25 days or, in the case of the first Interest Accrual Period, the linear interpolation thereof, calculated in accordance with generally acceptable methodology, and, for the Class C Notes, the Class D Notes and the Class E Notes, a three-month period (or, in the case of the first Interest Accrual Period, the

linear interpolation thereof, calculated in accordance with generally acceptable methodology), which appears on Bridge Telerate Page 3750 (as Telerate is defined in the International Swaps and Derivatives Association, Inc. Annex to the 2000 ISDA Definitions (June 2000 version)), or such page as may replace Bridge Telerate Page 3750, as of 11:00 a.m. (London time) on such LIBOR Determination Date.

(ii) If, on any LIBOR Determination Date, such rate does not appear on Bridge Telerate Page 3750, or such page as may replace Bridge Telerate Page 3750, the Note Calculation Agent shall determine the arithmetic mean of the offered quotations of the Reference Banks to leading banks in the London interbank market for Eurodollar deposits for, with respect to the Class A-1L Notes, the LIBOR CP Notes and the Class B Notes, a one month period (or, in the case of a designated initial payment period of less than 25 days or, in the case of the first Interest Accrual Period, the linear interpolation thereof, calculated in accordance with generally acceptable methodology, and, for the Class C Notes, the Class D Notes and the Class E Notes, a three-month period (or, in the case of the first Interest Accrual Period, the linear interpolation thereof, calculated in accordance with generally acceptable methodology) in an amount determined by the Note Calculation Agent by reference to requests for quotations as of approximately 11:00 a.m. (London time) on the LIBOR Determination Date made by the Note Calculation Agent to the Reference Banks. If, on any LIBOR Determination Date, at least two of the Reference Banks provide such quotations, LIBOR shall equal such arithmetic mean of such quotations. If, on any LIBOR Determination Date, only one or none of the Reference Banks provide such quotations, LIBOR shall be deemed to be the arithmetic mean of the offered quotations that leading banks in the City of New York selected by the Note Calculation Agent (after consultation with the Issuer or the Collateral Manager on behalf of the Issuer) are quoting on the relevant LIBOR Determination Date for Eurodollar deposits for the applicable period in an amount determined by the Note Calculation Agent (after consultation with the Issuer or the Collateral Manager on behalf of the Issuer) by reference to the principal London offices of leading banks in the London interbank market; *provided, however*, that if the Note Calculation Agent is required but is unable to determine a rate in accordance with at least one of the procedures provided above, LIBOR shall be LIBOR as determined on the most recent date LIBOR was available. As used herein, "Reference Banks" means four major banks in the London interbank market selected by the Note Calculation Agent (after consultation with the Issuer or the Collateral Manager on behalf of the Issuer).

As soon as possible after 11:00 a.m. (New York time) on each LIBOR Determination Date, but in no event later than 11:00 a.m. (New York time) on the Business Day immediately following each LIBOR Determination Date, the Note Calculation Agent will cause notice of each of the Note Interest Rates for the next Interest Accrual Period and the amount of interest for such Interest Accrual Period payable in respect of each \$1,000 principal amount of the Class A-1LT-a Notes (the "Class A-1LT-a Note Interest Amount"), of the Class A-1LT-b-1 Notes (the "Class A-1LT-b-1 Note Interest Amount"), of the Class A-1LT-b-2 Notes (the "Class A-1LT-b-2 Note Interest Amount"), of the LIBOR CP Notes (the "LIBOR CP Note Interest Amount"), of the Class A-2 Notes (the "Class A-2 Note Interest Amount"), of the Class B Notes (the "Class B Note Interest Amount"), of the Class C Notes (the "Class C Note Interest Amount"), of the Class D Notes (the "Class D Note Interest Amount") and of the Class E Notes (the "Class E Note Interest Amount") (collectively, the "Note Interest Amounts") (each rounded to the nearest cent, with half a cent being rounded upward) on the related Payment Date or Quarterly Payment Date, as applicable, to be communicated to the Issuers, DTC, Euroclear, Clearstream, the Note Paying Agents, the Trustee, the Collateral Manager, the Securities Intermediary and the Listing and Paying Agent for further delivery to any stock exchange so long as any of the Notes are listed thereon. In the last case, the Note Calculation Agent will furnish such information as soon as possible after its determination to the Listing and Paying Agent as long as any Notes are listed on any stock exchange. The Note Calculation Agent will also specify to the Issuers and the Collateral Manager the quotations upon which each of the Note Interest Rates are based. The Note Calculation Agent shall notify the Issuers and the Collateral Manager before 12:00 p.m. (New York time) on any LIBOR Determination Date if it has not determined and is not in the process of determining the applicable Note Interest Rates and Note Interest Amounts (collectively, the "Interest Calculations"), together with its reasons therefor. With respect to the Notes, "Business Day" means any day other than (x) Saturday or Sunday or (y) a day on which commercial banking institutions are authorized or obligated by law, regulation or executive order to close in New York, New York or Chicago, Illinois; *provided, however*, that for the sole purpose of determining LIBOR, "Business Day" shall be defined as any day on which dealings in deposits in U.S. Dollars are transacted in the London

interbank market and *provided further*, that to the extent action is required of the Listing and Paying Agent, the location of the Listing and Paying Agent shall be considered in determining the "Business Day" for purposes of determining when such Listing and Paying Agent action is required.

The Note Calculation Agent may be removed by the Issuers at the direction of the Collateral Manager at any time. If the Note Calculation Agent is unable or unwilling to act as such or is removed by the Issuers, or if the Note Calculation Agent fails to determine the applicable Interest Calculations for any Interest Accrual Period, the Issuers will promptly appoint as a replacement Note Calculation Agent a leading bank which is engaged in transactions in Eurodollar deposits in the international Eurodollar market and which does not control or is not controlled by or under common control with the Issuers or their affiliates. The Note Calculation Agent may not resign its duties without a successor having been duly appointed. In addition, for so long as any Notes are listed on any stock exchange and the rules of such exchange so require, notice of the appointment of any Note Calculation Agent will be furnished to such stock exchange. For so long as any of the Notes or LIBOR CP Notes remain outstanding, there will at all times be a Note Calculation Agent for the purpose of calculating the applicable Interest Calculations. The determination of the applicable Interest Calculations by the Note Calculation Agent shall (in the absence of manifest error) be final and binding upon all parties.

Distributions on Preferred Shares

On each Quarterly Payment Date, the Holders of the Preferred Shares will be entitled to receive, after payment of items ranking higher in accordance with the Priority of Payments, and to the extent of funds legally available therefor, a distribution (if available) equal to amounts remaining after payment of all other senior amounts payable in accordance with the Priority of Payments.

Legal Provisions Applicable to Distributions on the Preferred Shares

Any amounts paid by the Preferred Share Paying Agent as dividends or other distributions on the Preferred Shares in accordance with the Priority of Payments and pursuant to the Preferred Shares Documents will be payable only to the extent of the Issuer's distributable profits and/or share premium (determined in accordance with Cayman Islands law). In addition, such distributions will be payable only to the extent that the Issuer will not be insolvent after such distributions are paid on the applicable Quarterly Payment Date. Under Cayman Islands law, a company is generally deemed to be solvent if it is able to pay its debts as they come due. To the extent that any amounts received by the Preferred Share Paying Agent for the Holders of the Preferred Shares cannot legally be distributed to the Holders of the Preferred Shares on any Quarterly Payment Date, the Preferred Share Paying Agent will, at the direction of the Issuer, distribute such amounts to the Holders of the Preferred Shares on the next Quarterly Payment Date on which such distribution can legally be made. Amounts paid by the Preferred Share Paying Agent on behalf of the Issuer to the Holders of the Preferred Shares will be made *pro rata*.

Payments to the Holders of the Class X Notes

On each Payment Date, the Holders of the Class X Notes will be entitled to receive, after payment of items ranking higher in accordance with the Priority of Payments, and to the extent of funds legally available therefor, the Class X Payment. The Class X Payment will be calculated based on the Notional Principal Balance of the Class X Notes, which will at any time be equal to the Aggregate Principal Amount (the "Notional Principal Balance"), measured as of the beginning of the Due Period preceding such Payment Date. The Class X Notes are not entitled to payments of principal or interest.

Principal

The Notes and the Class X Notes will mature on the Payment Date in January 2041 (the "Stated Maturity" with respect to such Securities). The Preferred Shares are scheduled to receive their final distributions and be retired by the Issuer on the Payment Date in January 2041 (the "Scheduled Preferred Share Redemption Date"), in each case unless redeemed or retired prior thereto. The average life of

each Class of Securities is expected to be substantially shorter than the number of years from issuance until the Stated Maturity for such Class of Securities. See "Risk Factors—Securities—Average Lives, Duration and Prepayment Considerations."

Principal will be payable on certain of the Notes on each Payment Date and Quarterly Payment Date, as applicable, in accordance with the Priority of Payments.

On any Payment Date or Quarterly Payment Date, as applicable, on which certain conditions are satisfied, principal will be paid to the CP Principal Reserve Account and to the Holders of the Class A Notes, *pro rata*, only in an amount required to increase (or maintain) the Class A Adjusted Overcollateralization Ratio to a specified target of 109.6%; *provided*, that the first \$100,000,000 of principal otherwise payable to the CP Notes, the Class A-1LT-a Notes and the Class A-1LT-b Notes will be paid to the Class A-1LT-a Notes and the Class A-1LT-b Notes, *pro rata*, only. After achieving and maintaining such target and minimum, the payment of remaining principal will shift to the Holders of the Class B Notes until such Holders have been paid an amount required to increase (or maintain) the Class B Adjusted Overcollateralization Ratio to the specified target of 104.8%. After achieving and maintaining such target level, the payment of remaining principal shifts to the Holders of the Class C Notes which will receive principal only in an amount required to increase (or maintain) the Class C Adjusted Overcollateralization Ratio to a specified target of 102.5%. After achieving and maintaining such target level, the payment of remaining principal shifts to the Holders of the Class D Notes which will receive principal until such Notes are paid in full. However, if the Net Outstanding Portfolio Collateral Balance is less than U.S.\$450,000,000, then only the amount described above to be paid to the Class A Notes and the CP Notes will be paid, such amount to be allocated, first, *pro rata*, (1) to the payment of principal of all outstanding Class A-1LT-a Notes, (2) to the payment of principal of all outstanding Class A-1LT-b Notes, (3) to the payment to the CP Principal Reserve Account in an amount equal to the full amount of the CP Principal Reserve Required Amount, and (4) to the payment of principal of all outstanding Class A-2 Notes, second, to the payment of principal of all outstanding Class B Notes, third, on Quarterly Payment Dates only, to the payment of principal of all outstanding Class C Notes, and fourth, on Quarterly Payment Dates only, to the payment of all outstanding Class D Notes. The foregoing "shifting principal" method permits Holders of the Class B Notes, the Class C Notes and the Class D Notes to receive payments of principal in accordance with the Priority of Payments while more senior Classes of Notes and the CP Notes remain outstanding and permits distributions of Principal Proceeds to the Holders of the Class E Notes and the Preferred Shares, to the extent funds are available in accordance with the Priority of Payments and the Class D Notes have been paid in full, while more senior Notes and the Class X Notes are outstanding. Amounts properly paid pursuant to the Priority of Payments to a junior Class of Notes or to the Preferred Shares will not be recoverable in the event of a subsequent shortfall in the amount required to pay a more senior Class of Notes, the Class X Notes or the CP Notes.

Subject to the availability of funds therefor in accordance with the Priority of Payments, if any of the Coverage Tests are not satisfied on any applicable Determination Date, the Notes (other than the Class E Notes) will be subject to mandatory redemption and the CP Notes will be subject to Defeasance on the related Payment Date or, in the case of the Class C Notes, on the related Quarterly Payment Date, until paid in full. See "—Mandatory Redemption" and the Priority of Payments for a description of the order in which such Notes and CP Notes are paid in connection with the failure of a Coverage Test.

The Class X Notes are not entitled to payments of principal, but will be entitled to receive the Class X Payment on each Payment Date, to the extent Proceeds are available therefor in accordance with the Priority of Payments.

Scheduled Redemption of Preferred Shares

On or prior to the date that is one Business Day prior to the end of the Due Period applicable to the Scheduled Preferred Share Redemption Date, the Collateral Manager will sell all remaining Collateral Assets. The settlement dates for any such sales shall be no later than one Business Day prior to the end of such Due Period. The proceeds of such sales will be paid to the Preferred Share Paying Agent after the payment of amounts senior to the Holders of the Preferred Shares in the Priority of Payments for

deposit into the account maintained therefore by the Preferred Share Paying Agent (the "Preferred Share Payment Account") and payment to the Holders of the Preferred Shares as the redemption price for the Preferred Shares upon such payment subject to certain restrictions under Cayman Islands law. Upon such payment, the Issuer shall redeem the Preferred Shares.

CP Notes and Defeasance

The CP Notes (other than the LIBOR CP Notes as described herein) will be issued at a discount. To the extent CP Notes are issued with a LIBOR based interest rate (the "LIBOR CP Notes"), they will mature on a Payment Date and will have a maturity that is equal to or more than one month but no more than 270 days from their issuance. Any CP Note with a maturity that is more than three months must be a LIBOR CP Note. The LIBOR CP Notes will bear interest during each Interest Accrual Period at a per annum rate equal to LIBOR (or, for a designated initial Interest Accrual Period of less than 25 days, the linear interpolation thereof, calculated in accordance with generally acceptable methodology) for such Interest Accrual Period, commencing on their date of issuance (the "LIBOR CP Note Interest Rate") and will be payable on each Payment Date *pari passu* with interest on the Class A-1LT-a Notes and the Class A-1LT-b Notes, if any, as described in the Priority of Payments. Payments of interest on the LIBOR CP Notes and principal at maturity will be made only on a Payment Date (subject to early redemption as provided herein). Principal payments at maturity will be made through deposit to the CP Principal Reserve Account in accordance with the Priority of Payments. The maturity date of any CP Note will be extendable by up to three Business Days if the CP Put Option is exercised in accordance with the CP Put Agreement. See "Security for the Notes-CP Put Agreement" herein. If the maturity date of a CP Note is so extended, the holder thereof will be entitled to receive accrued interest for the period of such extension at a per annum rate equal to LIBOR *plus* 0.09%. Payments of interest accrued during any such extension will be made first from the CP Interest Reserve Account and, then, to the extent of any shortfall, from the Collection Account even if such date is not a Payment Date.

The LIBOR CP Notes will be subject to early redemption, in part or in whole, and to acceleration and amortization under the following circumstances as described herein: (i) a successful Auction has occurred, (ii) an Optional Redemption has occurred, (iii) a Tax Redemption has occurred, (iv) a Coverage Test was not satisfied or the Class D Overcollateralization Ratio was less than 75% or 90%, as tested in different subclauses of the Priority of Payments, as of any Determination Date related to a Payment Date, (v) an Event of Default has occurred under the Indenture and the Notes and the CP Notes have been accelerated. If the LIBOR CP Notes are being redeemed and Defeased in full, an amount necessary to pay the holders of the LIBOR CP Notes par will be deposited to the CP Principal Reserve Account and an amount equal to any accrued interest thereon will be paid to the holders of the LIBOR CP Notes directly and such LIBOR CP Notes will not continue to accrue interest beyond their respective Redemption Dates, Auction Payment Dates, dates of Mandatory Redemption in full or on the Final Payment Date, as applicable. Any amounts deposited to the CP Principal Reserve Account will be applied by the CP Issuing and Paying Agent on the applicable Redemption Date, date of Mandatory Redemption in full or on the Final Payment Date to the Defeasance of such LIBOR CP Notes. In the event of a Mandatory Redemption or partial amortization of the CP Notes under the Indenture, the Defeasance of the CP Notes may not be in whole. The CP Issuing and Paying Agent, at the direction of the Collateral Manager upon consultation with the Lead CP Note Placement Agent, will cause CP Notes to be Defeased in the order of their choice; *provided* that, if the liquidation proceeds available following an Event of Default and acceleration are not sufficient to pay the CP Notes in full or in any situation where the CP Notes would not receive payment in full (including in connection with a Mandatory Redemption or amortization on a Payment Date) the CP Notes would be Defeased *pro rata*.

When used herein, the term "Defeasance" or "Defeasance" means, and references in this Offering Circular to payments of principal of the CP Notes mean, with respect to any CP Note (other than a LIBOR CP Note), the depositing of cash into the CP Principal Reserve Account to be applied to the repayment of such CP Note on its maturity date, such maturity date set according to the terms of such CP Note, and, with respect to any LIBOR CP Note, the depositing of cash into the CP Principal Reserve Account to be applied to the repayment of the principal amount of such LIBOR CP Note on the earlier of its initial scheduled maturity date or on any Payment Date, Mandatory Redemption date, Redemption Date or Final

Payment Date where principal is paid to the CP Principal Reserve Account on account of a LIBOR CP Note. For the avoidance of doubt, accrued interest paid to the Holders of the LIBOR CP Notes upon a Mandatory Redemption, on a Payment Date, on a Redemption Date or on a Final Payment Date or otherwise will not be deposited to the CP Principal Reserve Account but will instead be paid directly to the Holders of the LIBOR CP Notes and such amounts will not be considered to Defeas the LIBOR CP Notes.

The CP Notes (other than the LIBOR CP Notes) will not be subject to early redemption or to acceleration but will instead be subject to Defeasance under circumstances that would result in early redemption or acceleration of the LIBOR CP Notes. If the CP Notes (other than the LIBOR CP Notes) are Defeased under such circumstances, the amounts deposited to the CP Principal Reserve Account will not be applied by the CP Issuing and Paying Agent to the repayment of the CP Notes (other than the LIBOR CP Notes which are subject to certain redemptions as described above) until their respective maturity dates.

Auction

Sixty days prior to the Payment Date occurring in January of each year (each, an "Auction Date") commencing on the January 2014 Payment Date, the Collateral Manager will take steps to conduct an auction (the "Auction") of the Collateral Assets in accordance with procedures specified in the Indenture. If the Collateral Manager receives one or more bids from Eligible Bidders not later than ten Business Days prior to the Auction Date equal to or greater than the Minimum Bid Amount, the Issuer will sell the Collateral Assets for settlement on or before the fifth Business Day prior to such Auction Date and the Securities will be redeemed and the CP Notes will be Defeased in whole on such Auction Date (any such date, an "Auction Payment Date"). The Collateral Manager and its affiliates shall be considered Eligible Bidders but shall not be obligated to make any bids in relation to any Auction. If any single bid, or the aggregate amount of multiple bids, does not equal or exceed the Minimum Bid Amount or if there is a failure at settlement, then the redemption of Securities and the Defeasance of the CP Notes on the related Auction Date will not occur.

The Securities will be redeemed and the CP Notes will be Defeased following a successful Auction in accordance with the Priority of Payments at the applicable Note Redemption Price. The amount distributable as the final distribution on the Preferred Shares following any such redemption will equal any amount remaining after the redemption of the Notes and Class X Notes and the Defeasance of the CP Notes, the payment of any amounts due in connection with the termination of the Hedge Agreements, any amount payable to the CP Put Counterparty and the CP Note Placement Agents in connection with the termination of the CP Put Agreement and the CP Note Placement Agreement and the payment of all expenses in accordance with the Priority of Payments.

Tax Redemption

Subject to certain conditions described herein, the Securities may be redeemed by the Issuers and the CP Notes may be Defeased at any time, in whole but not in part, 90 days following the Issuers becoming aware of the occurrence of a Tax Event (provided that such 90-day period shall be extended by another 90 days if, during the initial 90-day period, the Issuers have notified the Holders of the Securities and the CP Notes that the related Issuer expects that it shall have changed its place of residence by the end of the later 90-day period) at their Note Redemption Prices at the written direction of, or with the written consent of, (i) the Holders of at least 66-2/3% of the affected Preferred Shares or (ii) the Holders of the Controlling Class of Notes which, as a result of the occurrence of a Tax Event, has not received 100% of the aggregate amount of principal and interest or other amounts then due and payable to such Holders on any Payment Date (such redemption, a "Tax Redemption"); provided that no such redemption shall be effected unless the expected Liquidation Proceeds equal or exceed the sum of (a) all amounts due as of the Redemption Date pursuant to clauses (i), (ii), (iii), (iv), (v), (xix) and (xx) of the Priority of Payments and (b) the Note Redemption Prices (the "Total Redemption Amount"). If a Tax Redemption occurs, the Preferred Shares will be redeemed simultaneously.

In connection with a Tax Redemption, the Issuers (in the case of the Notes other than the Class E Notes and the CP Notes) and the Issuer (in the case of the Class E Notes, the Class X Notes and the Preferred Shares) shall notify the Trustee of such Tax Redemption and the Payment Date which is the date for redemption (the "Tax Redemption Date") and direct the Trustee, in writing, to sell, in the manner determined by the Collateral Manager, and in accordance with the Indenture, any Collateral Asset and upon any such sale the Trustee shall release the lien upon such Collateral Assets pursuant to the Indenture; *provided, however*, that the Issuer may not direct the Trustee to sell (and the Trustee shall not be obligated to release the lien upon) any Collateral Asset except in accordance with the procedures set forth in the Indenture including, without limitation, the requirement that the Collateral Manager shall have forwarded to the Trustee binding agreements or certificates evidencing that the Liquidation Proceeds anticipated from the disposition of the Collateral Assets and other assets of the Issuer will equal or exceed the Total Redemption Amount.

The amount payable in connection with any Tax Redemption of the Notes, the Class X Notes and the CP Notes will equal the Total Redemption Amount. The amount distributable as a redemption payment on the Preferred Shares following any redemption will equal the Proceeds, if any, remaining after the distribution of the Total Redemption Amount by the Issuer in accordance with the Priority of Payments and such payment will be subject to certain restrictions imposed under Cayman Islands law.

Optional Redemption

Subject to certain conditions described herein, the Notes (other than the Class E Notes) may be redeemed by the Issuers, the Class E Notes (if the Class E Issuance Option has been exercised), the Class X Notes and the Preferred Shares may be redeemed by the Issuer and the CP Notes may be Defeased by the Issuers, in whole but not in part at their Note Redemption Prices on any Payment Date on or after the January 2009 Payment Date, at the written direction of, or with the written consent of, the Holders of at least a Majority of the Preferred Shares (including Preferred Shares held by the Collateral Manager or any affiliate thereof) (such redemption, an "Optional Redemption"); *provided* that no Optional Redemption shall be effected unless the expected Liquidation Proceeds will equal or exceed the Total Redemption Amount. If the Holders of the Preferred Shares so elect to cause an Optional Redemption, the Preferred Shares will be redeemed simultaneously.

In connection with an Optional Redemption, the Issuers (in the case of the Notes other than the Class E Notes and the CP Notes) and the Issuer (in the case of the Class E Notes, the Class X Notes and the Preferred Shares) shall notify the Trustee of such Optional Redemption and the Optional Redemption Date and direct the Trustee, in writing, to sell, in the manner determined by the Collateral Manager, and in accordance with the Indenture, any Collateral Asset and upon any such sale the Trustee shall release the lien upon such Collateral Assets pursuant to the Indenture; *provided, however*, that the Issuer may not direct the Trustee to sell (and the Trustee shall not be obligated to release the lien upon) any Collateral Asset except in accordance with the procedures set forth in the Indenture including, without limitation, the requirement that the Collateral Manager shall have forwarded to the Trustee binding agreements or certificates evidencing that the Liquidation Proceeds anticipated from the disposition of the Collateral Assets and other assets of the Issuer will equal or exceed the Total Redemption Amount.

The amount payable in connection with any Optional Redemption of the Notes and the Class X Notes will equal the Total Redemption Amount. The amount distributable as the final distribution on the Preferred Shares following any redemption will equal the Proceeds, if any, remaining after the distribution of the Total Redemption Amount by the Issuer in accordance with the Priority of Payments.

Optional Redemption/Tax Redemption Procedures. To conduct an Optional Redemption or a Tax Redemption, the procedures set forth in the Indenture must be followed and any conditions precedent thereto must be satisfied.

If a Tax Redemption or an Optional Redemption of the Notes, the Class X Notes and the Preferred Shares is scheduled to occur on the next succeeding Payment Date, the Collateral Manager shall notify the Principal Note Paying Agent, in the case of the Notes and the Class X Notes, the CP Issuing and Paying Agent in the case of the CP Notes or the Preferred Share Paying Agent, in the case of

the Preferred Shares, and shall notify the Trustee (with a copy to the Issuer) in writing no less than thirty (30) Business Days prior to such Payment Date. Such notice shall be irrevocable. The Principal Note Paying Agent, the CP Issuing and Paying Agent and the Preferred Share Paying Agent, respectively, shall, within three (3) Business Days after receiving such notice, notify the other Holders of the Notes, Holders of the Class X Notes, Holders of the CP Notes or Holders of the Preferred Shares, as applicable, of the receipt of such notice.

The Trustee will provide notice of any Optional Redemption or Tax Redemption by first-class mail, postage prepaid, mailed not less than ten (10) Business Days prior to the scheduled Tax Redemption Date or Optional Redemption Date, as applicable, to the Principal Note Paying Agent, to the Preferred Share Paying Agent, to the CP Issuing and Paying Agent, to the CP Put Counterparty, to the CP Note Placement Agents, to each Hedge Counterparty, to each Noteholder at such Holder's address in the register maintained by the Note Registrar under the Indenture, and to each Holder of a Preferred Share at such Holder's address in the share register maintained by the Share Registrar pursuant to the Preferred Share Paying and Transfer Agency Agreement and, as long as any Notes or Preferred Shares are listed on any stock exchange, the Trustee will also give notice to the Listing and Paying Agent.

Notes, Class X Notes, CP Notes or Preferred Shares called for redemption or Defeasance must be surrendered at the office of any paying agent appointed under the Indenture in order to receive the Note Redemption Price and any final distributions on the Preferred Shares. The initial paying agents for the Notes and the Class X Notes are LaSalle Bank National Association, as Principal Note Paying Agent, and, so long as any Notes or Class X Notes are listed on a stock exchange, the Listing and Paying Agent.

Any such notice of redemption may be withdrawn in its entirety by the Issuers (with respect to the CP Notes and the Notes other than the Class E Notes) and the Issuer (with respect to the Class E Notes, the Class X Notes and the Preferred Shares) on or prior to the seventh Business Day prior to the scheduled redemption date by written notice from the Issuers to the Collateral Manager, the Trustee, each Hedge Counterparty, the CP Put Counterparty, the CP Note Placement Agents, the CP Issuing and Paying Agent, the Rating Agencies, the Holders of the Notes and the Holders of the Preferred Shares, but only if the Collateral Manager shall be unable to deliver the sale agreement or agreements or certifications, required by the Indenture, in form satisfactory to the Trustee. The Hedge Agreements and the CP Put Agreement will not terminate upon notice to the respective counterparties of redemption until the time for withdrawal of notice has expired. The Collateral Manager shall be liable only for the failure to effect an Optional Redemption or Tax Redemption due to the Collateral Manager's gross negligence or willful misconduct. Notice of any such withdrawal shall be given at the Issuer's expense by the Trustee to each Holder of a Security at the address appearing in the applicable register maintained by the Note Transfer Agent under the Indenture or the Preferred Share Transfer Agent under the Preferred Share Paying and Transfer Agency Agreement, as applicable, by overnight courier guaranteeing next day delivery sent not later than the third Business Day prior to the scheduled redemption date. The Trustee or the Preferred Share Paying Agent will also give notice to the Listing and Paying Agent of the stock exchange if any Securities are then listed on a stock exchange.

Class E Issuance Option

On any Quarterly Payment Date, at the written direction of, or with the written consent of, the Holders of at least a Majority of the Preferred Shares, the option to increase the principal balance of the Class E Notes (the "Class E Issuance Option") will be exercised and the Issuer will sell up to U.S.\$5,000,000 face amount of Class E Notes (the "Maximum Issuance Amount"). The Class E Notes may not be sold by the Issuer at a price less than 80% of their face amount. The net proceeds of the exercise of the Class E Issuance Option will, subject to applicable law (see "Legal Provisions Applicable to Distributions on the Preferred Shares"), be remitted to the Preferred Share Paying Agent for distribution to the Holders of the Preferred Shares and the interest and principal payments on the Class E Notes will be subordinate to all payments to the existing Notes, but senior to any distributions to Preferred Shares. The Class E Notes will be issued with a zero balance on the Closing Date and the principal balance of the Class E Notes will only ever be increased if the Class E Issuance Option is exercised. The Class E Issuance Option is a single option and may only be exercised one time.

Mandatory Redemption

On any Payment Date on which the Class A/B Overcollateralization Test was not satisfied on the last Business Day of the immediately preceding Due Period (such Business Day, the "Determination Date"), and on any Quarterly Payment Date on which the Class A/B Interest Coverage Test was not satisfied on the related Determination Date, the Class A Notes and the Class B Notes will be redeemed at par *plus* accrued interest and the LIBOR CP Notes will be redeemed and Defeased at par *plus* accrued interest and the other CP Notes will be Defeased or paid in full as follows:

If the Class A/B Overcollateralization Test is not satisfied on any Determination Date related to a Payment Date or the Class A/B Interest Coverage Test (together with the Class A/B Overcollateralization Test, the "Class A/B Coverage Tests") is not satisfied on any Determination Date related to a Quarterly Payment Date, Proceeds net of amounts payable under clauses (i) through (vi) of the Priority of Payments will be used, (i) if the Class A/B Overcollateralization Ratio is greater than or equal to 100% on such Determination Date, to redeem the Class A Notes and to Defease the CP Notes, *pro rata*, until the Class A Notes have been paid in full and the CP Notes have been Defeased in full, and then to redeem the Class B Notes until the Class B Notes have been paid in full and (ii) if the Class A/B Overcollateralization Ratio is less than 100% on such Determination Date, to redeem, *pro rata*, the Class A-1LT-a Notes and the Class A-1LT-b Notes and to Defease the CP Notes until the Class A-1LT-a Notes and the Class A-1LT-b Notes have been paid in full and the CP Notes have been Defeased in full, then to redeem the Class A-2 Notes until the Class A-2 Notes have been paid in full, and then to redeem the Class B Notes until the Class B Notes have been paid in full. The Class X Notes, the Class C Notes, the Class D Notes, the Class E Notes and the Preferred Shares will not be subject to mandatory redemption as a result of the failure of any Class A/B Coverage Test.

If the Class D Overcollateralization Ratio is less than 75% on any Determination Date related to a Payment Date, Proceeds net of amounts payable under clauses (i) through (vii) of the Priority of Payments will be used to redeem, *pro rata*, the Class A-1LT-a Notes, the Class A-1LT-b Notes, the Class A-2 Notes and to Defease the CP Notes, and when the Class A-1LT-a Notes, the Class A-1LT-b Notes and the Class A-2 Notes have been paid in full and the CP Notes have been Defeased in full, the Class B Notes until the Class B Notes have been paid in full.

If the Class C Overcollateralization Test is not satisfied on any Determination Date related to a Payment Date, the Class C Interest Coverage Test (together with the Class C Overcollateralization Test, the "Class C Coverage Tests") is not satisfied on any Determination Date related to a Quarterly Payment Date or the Class D Overcollateralization Ratio is less than 90% on any Determination Date related to a Payment Date, Proceeds net of amounts payable under clauses (i) through (ix) of the Priority of Payments will be used to (a) redeem or Defease, *pro rata*, from Principal Proceeds only, the Class A-1LT-a Notes, the Class A-1LT-b Notes, the Class A-2 Notes, the Class B Notes and the CP Notes and, on Quarterly Payment Dates, to redeem the Class C Notes and, on Payment Dates (other than Quarterly Payment Dates) to deposit to the Collection Account an amount equal to the outstanding principal amount of the Class C Notes and (b) on Quarterly Payment Dates, redeem from any remaining Proceeds the Class C Notes and, on Payment Dates (other than Quarterly Payment Dates), deposit to the Collection Account from any remaining Proceeds an amount equal to the outstanding principal amount of all Class C Notes taking into account amounts paid to the Collection Account in accordance with clause (a) hereof. The Class X Notes, the Class D Notes, the Class E Notes and the Preferred Shares will not be subject to mandatory redemption and the CP Notes will not be subject to Defeasance as a result of the failure of any Class C Coverage Test.

If the Class D Overcollateralization Test is not satisfied on any Determination Date related to a Payment Date or the Class D Interest Coverage Test (together with the Class D Overcollateralization Test, the "Class D Coverage Tests" and, together with the Class A/B Coverage Tests and the Class C Coverage Tests, the "Coverage Tests") is not satisfied on any Determination Date related to a Quarterly Payment Date, Proceeds net of amounts payable under clauses (i) through (xi) of the Priority of Payments will be used to (a) redeem or Defease, *pro rata*, from Principal Proceeds only, the Class A-1LT-a Notes,

the Class A-1LT-b Notes, the Class A-2 Notes, the Class B Notes and the CP Notes and, on Quarterly Payment Dates, to redeem the Class C Notes and the Class D Notes and, on Payment Dates (other than Quarterly Payment Dates) to deposit to the Collection Account an amount equal to the outstanding principal amount of the Class C Notes and the Class D Notes and (b) on Quarterly Payment Dates, redeem from any remaining Proceeds the Class D Notes and, on Payment Dates (other than Quarterly Payment Dates), deposit to the Collection Account from any remaining Proceeds an amount equal to the outstanding principal amount of all Class D Notes taking into account amounts paid to the Collection Account in accordance with clause (a) hereof. The Class X Notes, the Class E Notes and the Preferred Shares will not be subject to mandatory redemption and the CP Notes will not be subject to Defeasance as a result of the failure of any Class D Coverage Test.

If a Class C Coverage Test or a Class D Coverage test is not satisfied or the Class D Overcollateralization Ratio is less than 90% on any Determination Date related to a Payment Date other than a Quarterly Payment Date, no amounts will be distributed to the Holders of the Class C Notes or the Class D Notes and certain amounts based on the principal balance of such Notes will instead be deposited to the Collection Account for distribution in accordance with the Priority of Payments on the next Payment Date.

Cancellation

All Notes and Class X Notes that are redeemed or paid and surrendered for cancellation as described herein will forthwith be canceled and may not be reissued or resold.

Payments

Payments on any Payment Date in respect of principal of and interest on the Notes issued as Global Notes will be made to the person in whose name the relevant Global Note is registered at the close of business on the Business Day prior to such Payment Date. For the Securities issued in definitive form, payments on any Payment Date in respect of principal, interest and other distributions will be made to the person in whose name the relevant Security is registered as of the close of business 10 Business Days prior to such Payment Date. Payments on the Global Notes will be payable by wire transfer in immediately available funds to a U.S. Dollar account maintained by DTC or its nominee (in the case of the Global Notes) or each Holder (in the case of individual Definitive Notes) to the extent practicable or otherwise by U.S. Dollar check drawn on a bank in the United States sent by mail either to DTC or its nominee (in the case of the Global Notes), or to each Holder at its address appearing in the applicable register. Final payments in respect of principal on the Notes will be made only against surrender of the Notes at the office of any paying agent. None of the Issuers, the Securities Intermediary, the Trustee, the Collateral Manager, the CP Put Counterparty or any Hedge Counterparty or any paying agent will have any responsibility or liability for any aspects of the records maintained by DTC or its nominee or any of its participants relating to, or for payments made thereby on account of beneficial interests in, a Global Note.

The Issuers expect that DTC or its nominee, upon receipt of any payment of principal or interest in respect of a Global Note held by DTC or its nominee, will immediately credit participants' accounts with payments in amounts proportionate to their respective beneficial interests in such Global Notes as shown on the records of DTC or its nominee. The Issuers also expect that payments by participants to owners of beneficial interests in such Global Notes held through such participants will be governed by standing instructions and customary practices, as is now the case with securities held for the accounts of customers registered in the names of nominees for such customers. Such payments will be the responsibility of such participants.

If any payment on a Security is due on a day that is not a Business Day, then payment will not be made until the next succeeding Business Day.

For so long as the Securities are listed on any stock exchange and the rules of such exchange so require, the Issuers will have a paying agent and a transfer agent in accordance with the requirements of the rules of such exchange (which shall be the Listing and Paying Agent) for such Securities and

payments on and transfers or exchanges of interest in such Securities may be effected through the Listing and Paying Agent. In the event that the Listing and Paying Agent is replaced at any time during such period, notice of the appointment of any replacement will be given to the applicable stock exchange as long as any Securities are listed thereon.

Priority of Payments

With respect to any Payment Date (other than a Final Payment Date), all Proceeds received on the Collateral during the related Due Period will be applied by the Trustee in the priority set forth below (the "Priority of Payments"); provided that, (i) certain amounts on deposit in the Collection Account may be used to make certain payments to the CP Interest Reserve Account during the related Due Period as described herein and (ii) funds deposited in the CP Reserve Account will be used to pay CP Notes and in either case such funds will not be available to make payments in accordance with the Priority of Payments. For purposes of the Priority of Payments, amounts paid as interest, fees or distributions on the Notes on a "*pro rata*" basis shall be *pro rata* based on the amount of interest due on such Class or subclass of Notes or fees, amounts paid as principal shall be paid *pro rata* based on the amount of principal then outstanding on such Class or subclass of Notes and unless stated otherwise, Proceeds not constituting Principal Proceeds will be assumed to be applied prior to any Principal Proceeds.

On the Business Day prior to each Payment Date (other than a Final Payment Date), the Trustee will transfer all funds then on deposit in the Collection Account (other than amounts received after the end of the related Due Period) into the Payment Account. On each Payment Date (other than a Final Payment Date), amounts in the Payment Account will be applied by the Trustee in the manner and order of priority set forth below:

- i. to the payment of taxes and filing and return fees (including, without limitation, return fees) owed by the Issuers, if any;
- ii. to the payment of accrued and unpaid fees of (a) the Trustee up to a maximum amount on any Payment Date equal to the greater of U.S.\$2,083 and 0.0004167% of the Monthly Asset Amount for the related Due Period and (b) the CP Issuing and Paying Agent equal to the greater of U.S.\$1,250 and 0.000104% of the Aggregate Outstanding Amount of the CP Notes on the related Determination Date (or, in the case of the first Due Period, as such amounts are adjusted based on the number of days in such Due Period);
- iii. first, (a) to the payment of any remaining accrued and unpaid Administrative Expenses of the Issuers, excluding any indemnities (and legal expenses related thereto) payable by the Issuers first, to the Trustee, the Collateral Administrator, the CP Issuing and Paying Agent, the Preferred Share Paying Agent and the Preferred Share Transfer Agent and second, *pro rata*, to any other parties entitled thereto; second, (b) to the payment of any indemnities (and legal expenses related thereto) payable by the Issuers first, to the Trustee, the Collateral Administrator, the CP Issuing and Paying Agent, the Preferred Share Paying Agent and the Preferred Share Transfer Agent and second, *pro rata*, to any other parties entitled thereto; and third, (c) to the Expense Reserve Account the lesser of U.S.\$25,000 and the amount necessary to bring the balance of such account to U.S.\$275,000; provided, however, that the aggregate payments pursuant to subclauses (a) through (c) of this clause (iii) on any Payment Date shall not exceed U.S.\$300,000 and the aggregate payments pursuant to subclauses (a) and (b) of this clause (iii) and the prior 11 Payment Dates shall not exceed U.S.\$400,000;
- iv. to the payment of (a) first, *pro rata* (based on amounts due) and *pari passu* (i) scheduled amounts, if any, to be paid to the Hedge Counterparties pursuant to the Hedge Agreements (other than termination and partial termination

payments), including any Interim Issuer Cashflow Swap Payments due calculated on a pro forma basis, and (ii) any termination and partial termination payments (other than Defaulted Hedge Termination Payments payable under clause (xix) below), and (b) second, the CP Put Premium, if any, payable to the CP Put Counterparty;

- v. to the payment, *pari passu*, (i) to the Collateral Manager of the accrued and unpaid Collateral Management Fee, *plus* interest due on any portion of such Collateral Management Fee not paid on a prior Payment Date at a rate equal to LIBOR and (ii) to the Class X Notes of the accrued and unpaid Class X Payment;
- vi. to the payment of (a) first, *pro rata* (based upon the amount due), (i) accrued and unpaid interest on the Class A-1LT-a Notes (including any Defaulted Interest and interest thereon), (ii) accrued and unpaid interest on the Class A-1LT-b Notes, if any, (including any Defaulted Interest and interest thereon), (iii) to the payment into the CP Interest Reserve Account of the CP Interest Reserve Deposit Amount, (iv) to the holders of the LIBOR CP Notes, if any, accrued and unpaid interest on any LIBOR CP Notes then outstanding, (v) accrued and unpaid interest on the Class A-2 Notes (including any Defaulted Interest and interest thereon) and (vi) the CP Note Placement Agent Fees (to the extent not incorporated in the discount for the CP Notes), if any, payable to the CP Note Placement Agents in accordance with the CP Note Placement Agreement; and (b) second, accrued and unpaid interest on the Class B Notes (including any Defaulted Interest and any interest thereon);
- vii. if the Class A/B Overcollateralization Test is not satisfied on the Determination Date with respect to the related Payment Date after giving effect to all payments of principal on such Payment Date (without giving effect to any payments pursuant to this clause (vii)) or if the Class A/B Interest Coverage Test is not satisfied on the Determination Date with respect to the related Quarterly Payment Date, then (A) if the Class A/B Overcollateralization Ratio is greater than or equal to 100% on the Determination Date with respect to the related Payment Date, first, *pro rata*, (i) to the payment of principal of all outstanding Class A-1LT-a Notes, (ii) to the payment of principal of all outstanding Class A-1LT-b Notes, (iii) to the payment to the CP Principal Reserve Account in an amount equal to the CP Principal Reserve Required Amount and (iv) to the payment of principal of all outstanding Class A-2 Notes, until the Class A-1LT-a Notes, the Class A-1LT-b Notes, the CP Notes and the Class A-2 Notes are paid or Defeased in full, and second, to the payment of principal of all outstanding Class B Notes until the Class B Notes are paid in full and (B) if the Class A/B Overcollateralization Ratio is less than 100% on the Determination Date with respect to the related Payment Date, first, *pro rata*, (i) to the payment of principal of all outstanding Class A-1LT-a Notes, (ii) to the payment of principal of all outstanding Class A-1LT-b Notes and (iii) to the payment to the CP Principal Reserve Account in an amount equal to the CP Principal Reserve Required Amount, until the Class A-1LT-a Notes, the Class A-1LT-b Notes and the CP Notes are paid or Defeased in full, second, to the payment of principal of all outstanding Class A-2 Notes until the Class A-2 Notes are paid in full, and third, to the payment of principal of all outstanding Class B Notes until the Class B Notes are paid in full;
- viii. if the Class D Overcollateralization Ratio is less than 75% on the Determination Date with respect to the related Payment Date after giving effect to all payments of principal on such date (without giving effect to any payments pursuant to this clause (viii)), then, first, *pro rata*, (i) to the payment of principal of all outstanding Class A-1LT-a Notes, (ii) to the payment of principal of all outstanding Class A-

1LT-b Notes, (iii) to the payment to the CP Principal Reserve Account in an amount equal to the CP Principal Reserve Required Amount and (iv) to the payment of principal of all outstanding Class A-2 Notes, until the Class A-1LT-a Notes, the Class A-1LT-b Notes, the CP Notes and the Class A-2 Notes are paid or Defeased in full, and second, to the payment of principal of all outstanding Class B Notes until the Class B Notes are paid in full;

- ix. on Quarterly Payment Dates only, to the payment of accrued and unpaid interest on the Class C Notes (including Defaulted Interest and any interest thereon but not including Class C Deferred Interest);
- x. if the Class C Overcollateralization Test is not satisfied on the Determination Date with respect to the related Payment Date after giving effect to all payments of principal on such Payment Date (without giving effect to any payments pursuant to this clause (x)), if the Class C Interest Coverage Test is not satisfied on the Determination Date with respect to the related Quarterly Payment Date or if the Class D Overcollateralization Ratio is less than 90% on the Determination Date with respect to the related Payment Date after giving effect to all payments of principal on such date (without giving effect to any payments pursuant to this clause (x)), then, (a) *pro rata*, Principal Proceeds only (i) to the payment of principal of all outstanding Class A-1LT-a Notes, (ii) to the payment of principal of all outstanding Class A-1LT-b Notes, (iii) to the payment to the CP Principal Reserve Account in an amount equal to the CP Principal Reserve Required Amount, (iv) to the payment of principal of all outstanding Class A-2 Notes, (v) to the payment of principal of all outstanding Class B Notes and (vi) on Quarterly Payment Dates, to the payment of principal of all outstanding Class C Notes and, on Payment Dates (other than Quarterly Payment Dates) to the Collection Account in an amount equal to the outstanding principal amount of the Class C Notes, until the Class A-1LT Notes, the CP Notes, the Class A-2 Notes, the Class B Notes, and the Class C Notes are paid (or, in the case of the Class C Notes and Payment Dates other than Quarterly Payment Dates amounts equal thereto are paid to the Collection Account), or Defeased in full and (b) on Quarterly Payment Dates, any remaining Proceeds to the payment of principal of all outstanding Class C Notes and, on Payment Dates (other than Quarterly Payment Dates) any remaining Proceeds to the Collection Account in an amount equal to the outstanding principal amount of all Class C Notes taking into account amounts paid to the Collection account in accordance with clause (a) hereof;
- xi. on Quarterly Payment Dates only, to the payment of accrued and unpaid interest on the Class D Notes (including Defaulted Interest and any interest thereon but not including Class D Deferred Interest);
- xii. if the Class D Overcollateralization Test is not satisfied on the Determination Date with respect to the related Payment Date after giving effect to all payments of principal on such Payment Date (without giving effect to any payments pursuant to this clause (xii)) or if the Class D Interest Coverage Test is not satisfied on the Determination Date with respect to the related Quarterly Payment Date, then, (a) *pro rata*, from Principal Proceeds only (i) to the payment of principal of all outstanding Class A-1LT-a Notes, (ii) to the payment of principal of all outstanding Class A-1LT-b Notes, (iii) to the payment to the CP Principal Reserve Account in an amount equal to the CP Principal Reserve Required Amount, (iv) to the payment of principal of all outstanding Class A-2 Notes, (v) to the payment of principal of all outstanding Class B Notes, (vi) on Quarterly Payment Dates, to the payment of principal of all outstanding Class C Notes and, on Payment Dates (other than Quarterly Payment Dates) to the Collection

Account in an amount equal to the outstanding principal amount of the Class C Notes and (vii) on Quarterly Payment Dates, to the payment of principal of all outstanding Class D Notes and, on Payment Dates (other than Quarterly Payment Dates) to the Collection Account in an amount equal to the outstanding principal amount of the Class D Notes, until the Class A-1LT Notes, the CP Notes, the Class A-2 Notes, the Class B Notes, the Class C Notes and the Class D Notes (or, in the case of the Class C Notes and the Class D Notes and Payment Dates other than Quarterly Payment Dates amounts equal thereto are paid to the Collection Account) are paid or Defeased in full and, (b) on Quarterly Payment Dates, any remaining Proceeds to the payment of principal of all outstanding Class D Notes and, on Payment Dates (other than Quarterly Payment Dates) any remaining Proceeds to the Collection Account in an amount equal to the outstanding principal amount of all Class D Notes taking into account amounts paid to the Collection Account in accordance with clause (a) hereof;

- xiii. to the payment of principal of first, the Class A-1LT-a Notes, the Class A-1LT-b Notes and the Class A-2 Notes and to the payment to the CP Principal Reserve account in an amount equal to the CP Principal Reserve Required Amount, *pro rata* based on their respective principal amounts, up to the amount specified in clause (b)(1) below, provided, that the first \$100,000,000 of principal otherwise payable (or paid pursuant to clause (vii), (viii), (x) or (xii)) to the CP Notes, the Class A-1LT-a Notes and the Class A-1LT-b Notes will be paid, *pro rata*, to the Class A-1LT-a Notes and the Class A-1LT-b Notes only, second, the Class B Notes up to the amount specified in clause (b)(2) below, third, on Quarterly Payment Dates only, the Class C Notes up to the amount specified in clause (b)(3) below, and fourth, on Quarterly Payment Dates only, the Class D Notes up to the amount specified in clause (b)(4) below in an aggregate amount equal to the lesser of (a) Principal Proceeds received or held during the related Due Period less any Principal Proceeds deposited to the CP Interest Reserve Account during the related Due Period, and (b) the sum of (1) the amount necessary to increase the Class A Adjusted Overcollateralization Ratio to or maintain it at 109.6%, *plus* (2) the amount necessary to increase the Class B Adjusted Overcollateralization Ratio to or maintain it at 104.8%, *plus* (3) on Quarterly Payment Dates only, the amount necessary to increase the Class C Adjusted Overcollateralization Ratio to or maintain it at 102.5%, *plus* (4) on Quarterly Payment Dates only, the amount necessary to pay the Class D Notes in full; provided, however, that if the Net Outstanding Portfolio Collateral Balance is less than U.S.\$450,000,000, then only the amount described in sub-clause (a) of this clause (xiii) will be paid, such amount to be allocated, first, *pro rata*, (1) to the payment of principal of all outstanding Class A-1LT-a Notes, (2) to the payment of principal of all outstanding Class A-1LT-b Notes, (3) to the payment to the CP Principal Reserve Account in an amount equal to the full amount of the CP Principal Reserve Required Amount, and (4) to the payment of principal of all outstanding Class A-2 Notes, second, to the payment of principal of all outstanding Class B Notes, third, on Quarterly Payment Dates only, to the payment of principal of all outstanding Class C Notes, and fourth, on Quarterly Payment Dates only, to the payment of all outstanding Class D Notes;
- xiv. on Quarterly Payment Dates only, first, to the payment of principal of the Class C Notes in an amount equal to that portion of the principal of the Class C Notes comprised of Class C Deferred Interest unpaid after giving effect to payments under clauses (x), (xii) and (xiii) above (amounts will be considered unpaid for this purpose if the principal balance of the Class C Notes after giving effect to clauses (x), (xii) and (xiii) above exceeds any previous lowest amount outstanding) and second, to the payment of principal of the Class D Notes in an

amount equal to that portion of the principal of the Class D Notes comprised of Class D Deferred Interest unpaid after giving effect to payments under clauses (xii) and (xiii) above (amounts will be considered unpaid for this purpose if the principal balance of the Class D Notes after giving effect to clauses (xii) and (xiii) above exceeds any previous lowest amount outstanding);

- xv. on Quarterly Payment Dates only, to the payment of principal of the Class D Notes in an amount equal to the Class D Notes Amortizing Principal Amount;
- xvi. on Quarterly Payment Dates only, to the payment of accrued and unpaid interest on the Class E Notes (including Defaulted Interest and any interest thereon but not including Class E Deferred Interest);
- xvii. on Quarterly Payment Dates after the Quarterly Payment Date occurring in January 2014, first, to the payment of principal of all outstanding Class C Notes until the Class C Notes are paid in full, second, to the payment of principal of all outstanding Class D Notes until the Class D Notes are paid in full and, third, to the payment of principal of all outstanding Class E Notes until the Class E Notes are paid in full;
- xviii. on Quarterly Payment Dates only, first, to the payment of principal of the Class E Notes in an amount equal to that portion of the principal of the Class E Notes comprised of Class E Deferred Interest unpaid after giving effect to payments under clauses (xvi) and (xvii) above (amounts will be considered unpaid for this purpose if the principal balance of the Class E Notes after giving effect to clauses (xvi) and (xvii) above exceeds any previous lowest amount outstanding) and second, to the payment of principal on the Class E Notes, in an amount equal to the greater of (a) all remaining Principal Proceeds until paid in full and (b) the Class E Notes Amortizing Principal Amount;
- xix. on Quarterly Payment Dates only, to the payment of any Defaulted Hedge Termination Payments, with respect to the Hedge Agreements, *pro rata*, based on the amount owed;
- xx. on Quarterly Payment Dates only, first (a) to the payment of any remaining accrued and unpaid Administrative Expenses of the Issuers not paid pursuant to clauses (ii) and (iii) above (as the result of the limitations on amounts set forth therein) in the same order of priority set forth above in clause (iii) excluding any indemnities (and legal expenses related thereto) payable by the Issuers; second, (b) to the payment, *pro rata*, of any indemnities (and legal expenses related thereto) payable by the Issuers not paid pursuant to clause (iii) above (as the result of the limitation on amounts set forth therein) in the same order of priority set forth above in clause (iii); and third, (c) to the Expense Reserve Account until the balance of such account reaches U.S.\$275,000 (after giving effect to any deposits made therein on such Quarterly Payment Date under clause (iii) above); provided, however, that the aggregate payments pursuant to subclause (c) of this clause (xx) and subclause (c) of clause (iii) on any Payment Date shall not exceed U.S.\$25,000;
- xxi. on Quarterly Payment Dates only, any remaining amount to the payment to the Preferred Share Paying Agent for deposit into the Preferred Share Payment Account for payment to the Holders of the Preferred Shares as additional distributions (subject to certain restrictions imposed under Cayman Islands law and to the extent of funds legally available therefor); and
- xxii. on each Payment Date, any remaining amount to be deposited to the Collection Account for distribution on the next Payment Date.

On the Business Day prior to the Final Payment Date, the Trustee will transfer all funds then on deposit in the Collection Account into the Payment Account. On the Final Payment Date, amounts in the Payment Account will be applied by the Trustee in the manner and order of priority set forth below:

- i. to the payment of the amounts referred to in clauses (i) through (vi) of the Priority of Payments for Payment Dates which are not Final Payment Dates, in that order (without regard to the limitations in clause (iii)); provided that no deposit shall be made to the Expense Reserve Account pursuant to subclause (iii) and no deposit shall be made to the CP Interest Reserve Account pursuant to subclause (vi);
- ii. first, *pro rata*, to the payment to the Class A-1LT-a Notes and the Class A-1LT-b Notes and, to the CP Principal Reserve Account (in an amount equal to the CP Principal Reserve Amount) and second, to the payment to the Class A-2 Notes, in each case, the amount necessary to pay the outstanding principal amounts of such Notes, to redeem and Defeas the LIBOR CP Notes in full and to Defeas the other CP Notes in full;
- iii. to the payment to the Class B Notes, the amount necessary to pay the outstanding principal amount of such Notes in full;
- iv. to the payment to the Class C Notes, the amount necessary to pay accrued and unpaid interest on and the outstanding principal amount of such Notes (including any Deferred Interest and Defaulted Interest and any interest thereon) in full;
- v. to the payment to the Class D Notes, the amount necessary to pay accrued and unpaid interest on and the outstanding principal amount of such Notes (including any Deferred Interest and Defaulted Interest and any interest thereon) in full;
- vi. to the payment to the Class E Notes, the amount necessary to pay accrued and unpaid interest on and the outstanding principal amount of such Notes (including any Deferred Interest and Defaulted Interest and any interest thereon) in full;
- vii. to the payment of the amounts referred to in clause (xix) of the Priority of Payments for Payment Dates that are not Final Payment Dates; and
- viii. to the payment of the amounts referred to in clause (xxi) of the Priority of Payments for Payment Dates which are not Final Payment Dates.

Upon payment in full of the last outstanding Note, the Issuer (or the Collateral Manager acting pursuant to the Collateral Management Agreement on behalf of the Issuer) will liquidate any remaining Collateral Assets, Eligible Investments, the Hedge Agreements, the CP Put Agreement and any other items comprising the Collateral and deposit the proceeds thereof in the Collection Account. The net proceeds of such liquidation and all available cash (other than the U.S.\$250 of capital contributed by the owners of the Issuer Ordinary Shares in accordance with the Issuer's Memorandum and Articles of Association and U.S.\$250 representing a transaction fee to the Issuer) will be distributed in accordance with the Priority of Payments for Final Payment Dates and all amounts remaining thereafter will be distributed to the Holders of the Preferred Shares as a redemption payment, subject in the case of the Preferred Shares, to certain restrictions under Cayman Islands law, whereupon all of the Notes and the Preferred Shares will be canceled.

Preferred Shares

The final distribution on the Preferred Shares will be made by the Issuer on the Scheduled Preferred Share Redemption Date, unless redeemed or retired prior thereto in accordance with the Priority of Payments.

The Indenture and the Preferred Share Paying and Transfer Agency Agreement

The following summary describes certain provisions of the Indenture and the Preferred Share Paying and Transfer Agency Agreement. The summary does not purport to be complete and is subject to, and qualified in its entirety by reference to, the provisions of the Indenture and the Preferred Share Paying and Transfer Agency Agreement.

Indenture

Events of Default. An "Event of Default" under the Indenture includes:

- i. a default in the payment, when due and payable, of any interest on any LIBOR CP Note, Class A Note or Class B Note or, if there are no LIBOR CP Notes, Class A Notes or Class B Notes outstanding, any Class C Note or, if there are no LIBOR CP Notes, Class A Notes, Class B Notes or Class C Notes outstanding, any Class D Note or, if there are no LIBOR CP Notes, Class A Notes, Class B Notes, Class C Notes or Class D Notes outstanding, any Class E Note and a continuation of such default, in each case, for a period of 7 days (or, in the case of a default in payment resulting solely from an administrative error or omission by the Trustee, any Note Paying Agent or the Note Registrar, such default continues for a period of 7 days after the Trustee is made aware of such administrative error or omission);
- ii. a default in the payment of principal due on any Note at its Stated Maturity or on any Redemption Date, a default in the payment of the CP Face Amount of any CP Note at its Stated Maturity or on any Redemption Date or a default in the payment by the Issuer of a required deposit into the CP Principal Reserve Account on any Payment Date (or, in the case of a default in payment resulting solely from an administrative error or omission by the Trustee, any Note Paying Agent or the Note Registrar, such default continues for a period of 7 days after the Trustee is made aware of such administrative error or omission);
- iii. the failure on any Payment Date to disburse amounts (other than in payment of interest on any Note or principal of any Note at its Stated Maturity or any date set for redemption as described in (i) and (ii) above) available in the Payment Account in excess of \$500 in accordance with the Priority of Payments and a continuation of such failure for a period of 7 days after such failure has been recognized;
- iv. a circumstance in which either of the Issuers or the Collateral or any portion thereof becomes an investment company required to be registered under the Investment Company Act;
- v. a default, which has a material adverse effect on the Holders of the Notes or the CP Notes (as determined by at least 50% in aggregate principal amount of the Controlling Class), in the performance, or breach, of any covenant, representation, warranty or other agreement of either Issuer in the Indenture (it being understood that a failure to satisfy a Coverage Test is not a default or breach) or in any certificate or writing delivered pursuant to the Indenture, or if any representation or warranty of either Issuer made in the Indenture or in any certificate or writing delivered by either Issuer pursuant thereto proves to be incorrect in any material respect when made, and the continuation of such default or breach for a period of 30 days after notice thereof shall have been given to the Issuers and the Collateral Manager by the Trustee or to the Issuers, the Collateral Manager and the Trustee by the Holders of at least 50% in aggregate outstanding principal amount of the Controlling Class; and
- vi. certain events of bankruptcy, insolvency, receivership or reorganization of either of the Issuers.

For the avoidance of doubt, if the Put Option is exercised and the maturity of the CP Notes are extended, an Event of Default under clause (ii) above due to a default in the payment of the CP Face Amount of any CP Note shall not occur unless such CP Notes remain unpaid after the maturity date has been extended.

If an Event of Default should occur and be continuing, the Trustee may and will at the direction of the Holders of at least a Majority of the Controlling Class declare the principal of and accrued and unpaid interest on all Notes, Class X Notes, LIBOR CP Notes and the Face Amount of the CP Notes (other than the LIBOR CP Notes) to be immediately due and payable (except that in the case of an Event of Default described in clause (vi) above, such an acceleration will occur automatically and shall not require any action by the Trustee or any Noteholder or CP Noteholder).

If an Event of Default should occur and be continuing, the Trustee is required to retain the Collateral intact and collect all payments in respect of the Collateral and continue making payments in the manner described under Priority of Payments unless (a) the Trustee determines (which determination will be based upon a certificate from the Collateral Manager) that the anticipated proceeds of a sale or liquidation of the Collateral based on an estimate obtained from a nationally recognized investment banking firm (which estimate takes into account the time elapsed between such estimate and the anticipated sale of the Collateral) would equal the amount necessary to pay in full (after deducting the reasonable expenses of such sale or liquidation) the sum of (i) the principal (including any Class C Deferred Interest, Class D Deferred Interest and Class E Deferred Interest) and accrued interest (including all Defaulted Interest, and interest thereon) and any other amounts due with respect to all the outstanding Notes and CP Notes; (ii) all Administrative Expenses; (iii) all amounts payable by the Issuer to the Hedge Counterparty net of all amounts payable to the Issuer by any Hedge Counterparty; (iv) all amounts payable by the Issuer to the CP Put Counterparty and each CP Note Placement Agent net of all amounts payable to the Issuer by the CP Put Counterparty and the CP Note Placement Agents; and (v) all other items in the Priority of Payments ranking prior to payments on the Notes and the CP Notes, and, in any case, the Holders of a Majority of the Controlling Class agree with such determination or (b) the Holders of at least 66-2/3% of the aggregate outstanding principal amount of the Controlling Class, each Hedge Counterparty (other than any Hedge Counterparty which will be paid in full the amounts due to it, including in any applicable termination payments other than Defaulted Hedge Termination Payments at the time of distribution of the proceeds of any sale or liquidation of the Collateral), the CP Put Counterparty (unless the CP Put Agreement has expired by its terms or a CP Put Counterparty Default has occurred) and the CP Note Placement Agents direct, subject to the provisions of the Indenture, the sale and liquidation of the Collateral.

The Holders of a Majority of the Controlling Class will have the right to direct the Trustee in writing in the conduct of any proceedings or in the sale of any or all of the Collateral, but only if (i) such direction will not conflict with any rule of law or the Indenture (including the limitations described in the paragraph above), (ii) the Trustee determines that such action will not involve it in liability (unless the Trustee has received an indemnity which is reasonably acceptable to the Trustee against any such liability) and (iii) any direction to the Trustee to undertake a sale of the Collateral shall be by at least 66-2/3% of the outstanding principal amount of the Controlling Class.

In addition to any voting and consent rights the CP Put Counterparty may have in its individual capacity, unless expressly provided otherwise, for any purpose described herein, the CP Put Counterparty (for so long as the CP Put Agreement is in effect and no CP Put Counterparty Default has occurred and is continuing) will have the right to exercise the voting and consent rights of the then Outstanding CP Notes as "Holder" of such CP Notes, including as part of the Controlling Class. The CP Put Counterparty will also have certain voting and consent rights with respect to the Class A-1LT-b Notes as described herein.

Subject to the provisions of the Indenture relating to the duties of the Trustee, in case an Event of Default with respect to the Notes, the Class X Notes or the CP Notes occurs and is continuing, the Trustee is under no obligation to exercise any of the rights or powers under the Indenture at the request of any Holders of Notes, the Class X Notes or the CP Notes, unless such Holders have offered to the

Trustee reasonable security or an indemnity which is reasonably acceptable to the Trustee. The Holders of a Majority of the Controlling Class may waive any default with respect to the Notes, the Class X Notes or the CP Notes, except (a) a default in the payment of principal or interest on any Note or CP Note; (b) failure on any Payment Date to disburse amounts available in the Payment Account in accordance with the Priority of Payments and continuation of such failure for a period of five days; (c) certain events of bankruptcy or insolvency with respect to the Issuers; or (d) a default in respect of a provision of the Indenture that cannot be modified or amended without the waiver or consent of the CP Put Counterparty and Holder of each outstanding Note and Class X Note adversely affected thereby.

Furthermore, any declaration of acceleration of maturity of the Notes, the Class X Notes or the CP Notes may be revoked and annulled by the Holders of a Majority of the Controlling Class before a judgment or decree for the payment of money has been obtained by the Trustee or the Collateral has been sold or foreclosed in whole or in part, by notice to the Issuers, the Trustee, the CP Put Counterparty and any Hedge Counterparty, if (a) the Issuer has paid or deposited with the Trustee a sum sufficient to pay, in accordance with the Priority of Payments, the principal and accrued interest (including all Defaulted Interest and the interest thereon), discount or other unpaid amounts with respect to the outstanding Notes, Class X Notes and CP Notes and any other administrative expenses, fees or other amounts that, under the Transaction Documents and pursuant to the Priority of Payments, are payable prior to the payment of the principal of and interest on the outstanding Notes, Class X Notes and CP Notes, and (b) the Trustee has determined that all Events of Default, other than the non-payment of the interest on or principal of the outstanding Notes, Class X Notes and CP Notes that have become due solely by such acceleration, have been cured and the Holders of a Majority of the Controlling Class by notice to the Trustee have agreed with such determination (which agreement shall not be unreasonably withheld) or waived such Event of Default in accordance with the provisions set forth in the Indenture; provided, however, that no such revocation or annulment shall affect the rights of the CP Put Counterparty under the CP Put Agreement.

Only the Trustee may pursue the remedies available under the Indenture, the Notes, the Class X Notes and the CP Notes and no Holder of a Note, Class X Note or a CP Note will have the right to institute any proceeding with respect to the Indenture, its Note, Class X Note, CP Note or otherwise unless (i) such Holder previously has given to the Trustee written notice of a continuing Event of Default; (ii) except in the case of a default in the payment of principal or interest, the Holders of at least 25%, by aggregate outstanding principal amount, of the Controlling Class have made a written request upon the Trustee to institute such proceedings in its own name as Trustee and such Holders have offered the Trustee an indemnity which is reasonably acceptable to the Trustee; (iii) the Trustee has for 30 days failed to institute any such proceeding; and (iv) no direction inconsistent with such written request has been given to the Trustee during such 30-day period by the Holders of a Majority of the Controlling Class.

In determining whether the Holders of the requisite percentage of Notes or CP Notes have given any direction, notice or consent, Notes, Class X Notes and CP Notes owned by the Issuer, the Co-Issuer or any affiliate thereof shall be disregarded and deemed not to be outstanding. In addition, Holders of Preferred Shares will not be considered to be affiliates of the Issuer or Co-Issuer by virtue of such ownership of Preferred Shares.

Notices. Notices to the Holders of the Notes and the Class X Notes shall be given by first-class mail, postage prepaid, to each Noteholder at the address appearing in the applicable note register. In addition, for so long as any of the Notes or Class X Notes are listed on any stock exchange and so long as the rules of such exchange so require, notices to the Holders of such Notes and the Class X Notes shall also be published by the Listing and Paying Agent in the official list thereof or as otherwise required by the rules of such exchange.

Modification of the Indenture. Except as provided below, with the consent of the Holders of at least a Majority, by aggregate outstanding principal amount, of the Notes and the CP Notes materially adversely affected thereby, voting together as a single class, at least a Majority of the Class X Notes materially and adversely affected thereby and at least a Majority of the Preferred Shares materially and adversely affected thereby, the Trustee and the Issuers, with respect to the Notes, the Class X Notes and

the CP Notes, may execute a supplemental Indenture to add provisions to, or change in any manner or eliminate any provisions of, the Indenture or modify in any manner the rights of the Holders of the Class X Notes, the CP Notes, the Notes of such Class or the Preferred Shares; provided that the Rating Agency Condition would be satisfied after such addition, change or elimination. The Trustee may, consistent with the written advice of legal counsel or an officer's certificate, at the expense of the Issuer, determine whether or not the Holders of the Class X Notes, the CP Notes, Notes or Preferred Shares would be materially and adversely affected by such change. Such determination shall be conclusive and binding on all present and future Holders.

Without the consent of the Holders of each adversely affected Note, each adversely affected Class X Note, and each adversely affected Preferred Share, and unless the Rating Agency Condition is satisfied, no supplemental indenture may be entered into which would (i) change the Stated Maturity of the principal of or the due date of any installment of interest, discount or other distribution on a Note, Class X Note or a CP Note; reduce the principal amount thereof or the rate of interest thereon, or the applicable Note Redemption Price with respect thereto; change the earliest date on which a Note, Class X Note or a CP Note may be redeemed or Defeased; change the provisions of the Indenture relating to the application of proceeds of any Collateral to the payment of principal of or interest or discount or other distribution on Notes, Class X Notes or CP Notes or change any place where, or the coin or currency in which, Notes, Class X Notes or CP Notes or the principal thereof or interest or discount thereon are payable; or impair the right to institute suit for the enforcement of any such payment on or after the Stated Maturity thereof (or, in the case of redemption, on or after the Redemption Date); (ii) reduce the percentage in aggregate principal amount or number of shares, as applicable, of Holders of the Notes of each Class, the CP Put Counterparty and Holders of the Class X Notes and the Preferred Shares whose consent is required for the authorization of any supplemental indenture or for any waiver of compliance with certain provisions of the Indenture or certain defaults thereunder or their consequences; (iii) impair or adversely affect the Collateral except as otherwise permitted by the Indenture; (iv) permit the creation of any security interest ranking prior to or on a parity with the security interest created by the Indenture with respect to any part of the Collateral (it being understood that the addition of the Hedge Counterparties or any replacement CP Put Counterparty having the benefit of the Indenture pursuant to its terms does not require consent under this clause) or terminate such security interest on any property at any time subject thereto or deprive the Holder of any Note, Class X Note or CP Note, the Trustee, the CP Issuing and Paying Agent or any other Secured Party of the security afforded by the Indenture; (v) reduce the percentage of Holders of the CP Notes, Class X Notes and Notes of each Class and the CP Put Counterparty whose consent is required to request the Trustee to preserve the Collateral or rescind the Trustee's election to preserve the Collateral or to sell or liquidate the Collateral pursuant to the Indenture; (vi) modify any of the provisions of the Indenture with respect to supplemental indentures, except to increase the percentage of outstanding Notes, Class X Notes or CP Notes whose Holders' (or, in case of the CP Notes, the CP Put Counterparty's) consent is required for any such action or to provide that other provisions of the Indenture cannot be modified or waived without the consent of the Holder of each outstanding Note, Class X Note and CP Note adversely affected thereby; (vii) modify the definition of the term "Outstanding" or the Priority of Payments set forth in the Indenture; (viii) modify any of the provisions of the Indenture in such a manner as to affect the calculation of the amount of any payment of interest or discount on or principal of any Note or CP Note or modify any amount distributable to the Holders of the Class X Notes or modify any amount distributable to the Preferred Share Paying Agent for payment to the Holders of the Preferred Shares on any Quarterly Payment Date or to affect the right of the Holders of the Notes, the Class X Notes or the CP Notes, the CP Put Counterparty or the Trustee to the benefit of any provisions for the redemption of such Notes, Class X Notes or CP Notes contained therein; (ix) amend any provision of the Indenture or any other agreement entered into by the Issuer with respect to the transactions contemplated by the Indenture relating to the institution of proceedings for the Issuer or the Co-Issuer to be adjudicated as bankrupt or insolvent, or the consent of the Issuer or the Co-Issuer to the institution of bankruptcy or insolvency proceedings against it, or the filing with respect to the Issuer or the Co-Issuer of a petition or answer or consent seeking reorganization, arrangement, moratorium or liquidation proceedings, or other proceedings under the United States Bankruptcy Code or any similar laws, or the consent of the Issuer or the Co-Issuer to the filing of any such petition or the appointment of a receiver, liquidator, assignee, trustee or sequestrator (or other similar official) of the Issuer or the Co-

Issuer or any substantial part of its property, respectively; (x) increase the amount of the Collateral Management Fees payable to the Collateral Manager beyond the amount provided for in the original Collateral Management Agreement; (xi) amend any provision of the Indenture or any other agreement entered into by the Issuer with respect to the transactions contemplated thereby that provides that the obligations of the Issuers or the Issuer, as the case may be, are limited recourse obligations of the Issuers or the Issuer, respectively, payable solely from the Collateral and the CP Reserve Accounts in accordance with the terms of the Indenture; (xii) at the time of execution of such supplemental indenture, cause the Issuer, any Hedge Counterparty, the Collateral Manager, the Collateral Adviser, the CP Put Counterparty or any Paying Agents to become subject to withholding or other taxes, fees or assessments or cause the Issuer to be treated as engaged in a United States trade or business or otherwise be subject to United States federal, state or local income tax on a net income basis; or (xiii) at the time of execution of such supplemental indenture, result in a deemed sale or exchange of any of the Notes or Class X Notes under Section 1001 of the Code (items (i) through (xiii) above collectively, the "Reserved Matters").

Except as provided above, the Issuers and the Trustee may also enter into one or more supplemental indentures, without obtaining the consent of Holders of the Notes, the Class X Notes, the CP Notes or the Preferred Shares but with satisfaction of the Rating Agency Condition, (i) if such supplemental indentures would have no material adverse effect on any of the Noteholders or Holders of the CP Notes (as evidenced by an officer's certificate delivered by the Issuer, or the Collateral Manager on behalf of the Issuer, to the Trustee) or (ii) for any of the following purposes: (a) to evidence the succession of any person to either the Issuer or Co-Issuer and the assumption by any such successor of the covenants of the Issuer or Co-Issuer in the Notes, the Preferred Shares and the Indenture; (b) to add to the covenants of the Issuers or the Trustee for the benefit of the Holders of the Notes, the Class X Notes, the CP Notes or the Preferred Shares or to surrender any right or power conferred upon the Issuers; (c) to convey, transfer, assign, mortgage or pledge any property to the Trustee, or add to the conditions, limitations or restrictions on the authorized amount, terms and purposes of the issue, authentication and delivery of the Notes, the Class X Notes or the Preferred Shares; (d) to evidence and provide for the acceptance of appointment by a successor trustee and to add to or change any of the provisions of the Indenture as shall be necessary to facilitate the administration of the trusts under the Indenture by more than one Trustee; (e) to correct or amplify the description of any property at any time subject to the security interest created by the Indenture, or to better assure, convey, and confirm unto the Trustee any property subject or required to be subject to the security interest created by the Indenture (including, without limitation, any and all actions necessary or desirable as a result of changes in law or regulations) or subject to the security interest created by the Indenture any additional property; (f) to otherwise correct any inconsistency or cure any ambiguity; (g) to take any action necessary or advisable to prevent the Issuer, the Trustee, the CP Put Counterparty, the Collateral Manager, the Collateral Adviser or any Paying Agents from becoming subject to withholding or other taxes, fees or assessments or to prevent the Issuer from being treated as engaged in a United States trade or business or otherwise being subject to United States federal, state or local income tax on a net income basis; (h) to conform the Indenture to the descriptions thereof in the final Offering Circular; (i) to comply with any reasonable requests made by any stock exchange in order to list or maintain the listing of any Securities on such stock exchange; (j) to facilitate the issuance of the CP Notes and the maintenance of the Issuer's CP Note program; or (k) to enter into any additional agreements not expressly prohibited by any of the Indenture or the other Transaction Documents, as well as any amendment, modification or waiver if the Issuer determines that entering into such an agreement or such amendment, modification or waiver thereof would not, upon or after becoming effective, materially and adversely affect the rights or interests of Holders of any CP Notes, Class of Notes, Class X Notes, Preferred Shares or the CP Put Counterparty. The Trustee may, consistent with the written advice of counsel or an officer's certificate, at the expense of the Issuer, determine whether or not the Holders of Notes, Class X Notes, CP Notes or Preferred Shares, the CP Put Counterparty, the Collateral Manager, the Collateral Adviser or any Hedge Counterparty or CP Note Placement Agent would be materially adversely affected by such change (after giving notice of such change to the CP Put Counterparty, the Collateral Manager, the Collateral Adviser and the Hedge Counterparty) and may require the delivery of an opinion of counsel or an officer's certificate delivered by the Issuer (or another party) to the Trustee, reasonably satisfactory to it, at the expense of the Issuer, that such amendment or modification is permitted under the terms of the Indenture.

Such determination shall be conclusive and binding on all present and future Holders of the Notes, the CP Notes, the Class X Notes, the Preferred Shares, the CP Put Counterparty, the Collateral Manager, the Collateral Adviser and any Hedge Counterparty or CP Note Placement Agent.

Notwithstanding anything to the contrary herein, (i) the Issuer will not consent to enter into any supplemental indenture or any supplement or amendment to any other document related thereto unless and until the Collateral Manager has received written notice of such proposed amendment or supplement and has consented in writing thereto and has received a final copy thereof from the Issuer or the Trustee and, if any such supplement or amendment could reasonably be expected to have a material adverse effect on the CP Put Counterparty or CP Placement Agent, the CP Put Counterparty and CP Note Placement Agent, as applicable, has received written notice of such supplement or amendment and has consented thereto in writing (which consent shall not be unreasonably withheld) and (ii) no amendment to the Indenture will be effective until the consent of each Hedge Counterparty (which shall not be unreasonably withheld) has been obtained to the extent required under the Hedge Agreements.

Notwithstanding anything in the Indenture to the contrary, for so long as the CP Put Agreement is in effect and no CP Put Counterparty Default has occurred, in addition to any voting and consent rights the CP Put Counterparty may have in its capacity as CP Put Counterparty, (x) the CP Put Counterparty will have the right to exercise the voting and consent rights of the then outstanding CP Notes for any purpose, including as a part of the Controlling Class and (y) any modification to the Indenture that would materially and adversely affect the Class A-1LT-b Notes, if they were outstanding (or the rights of any Holders thereof, if the Class A-1LT-b Notes were outstanding) shall be deemed to materially and adversely affect the CP Put Counterparty, even if there are no Class A-1LT-b Notes outstanding at the time of such modification. Any time that the consent of the CP Put Counterparty is required with respect to the transactions contemplated hereunder and such consent is not allowed to be unreasonably withheld, if the CP Put Counterparty is not permitted to so consent without violating another contract to which the CP Put Counterparty is a party related to its rights and obligations under the CP Put Agreement, the denial of consent in such case will be deemed to be reasonable.

Under the Indenture, the Trustee will, for so long as any of the Securities or CP Notes are outstanding and rated by the Rating Agencies, deliver a copy of any proposed supplemental indenture (whether or not required to be approved by the Holders of any Notes, CP Notes, Class X Notes or Preferred Shares) to the Rating Agencies, each Hedge Counterparty, the CP Issuing and Paying Agent and the CP Put Counterparty not later than 20 Business Days prior to the execution of such proposed supplemental indenture, and no such supplemental indenture shall be entered into unless the Rating Agency Condition is met; *provided* that the Trustee shall, with the consent of the Holders of 100% of the aggregate outstanding amount of Notes of each Class, the Class X Notes, the CP Notes and the Preferred Shares, the CP Put Counterparty and each Hedge Counterparty, enter into any such supplemental indenture notwithstanding any potential reduction or withdrawal of the ratings of any outstanding Class of Notes or the CP Notes. The Trustee must provide copies of any amendment or modification of the Indenture (whether or not required to be approved by the Holders of any Notes, CP Notes, Class X Notes or Preferred Shares or the CP Put Counterparty) to the Holders of the Notes, the Class X Notes and Preferred Shares, each Hedge Counterparty, the CP Put Counterparty, the CP Issuing and Paying Agent, and, for so long as any Notes or Preferred Shares are listed on any stock exchange, the Listing and Paying Agent, promptly upon the execution of such supplemental indenture.

In connection with any amendment, the Trustee may require the delivery of an opinion of counsel satisfactory to it, at the expense of the Issuer, that such amendment is permitted under the terms of the Indenture.

Jurisdictions of Incorporation and Formation. Under the Indenture, the Issuer and the Co-Issuer will be required to maintain their rights and franchises as a company incorporated under the laws of the Cayman Islands and a corporation formed under laws of the State of Delaware, respectively, to comply with the provisions of their respective organizational documents and to obtain and preserve their qualification to do business as foreign corporations in each jurisdiction in which such qualifications are or shall be necessary to protect the validation and enforceability of the Indenture, the Notes, the CP Notes

or any of the Collateral; provided, however, that the Issuers shall be entitled to change their jurisdictions of incorporation from the Cayman Islands or Delaware, as applicable, to any other jurisdiction reasonably selected by such Issuer or Co-Issuer, as applicable, and approved by its common shareholders, so long as (i) the Issuer or Co-Issuer, as applicable, does not believe such change is disadvantageous in any material respect to such entity or the Holders of any Class of Notes or the CP Notes, the CP Put Counterparty, the Collateral Manager or any Hedge Counterparty; (ii) written notice of such change shall have been given by the Issuer or Co-Issuer, as applicable to the other of the Issuer or Co-Issuer, as applicable, the Trustee, the Note Paying Agent, the Collateral Manager, the Collateral Adviser, each Hedge Counterparty, the CP Put Counterparty, the CP Note Placement Agents, the Holders of each Class of Notes and each of the Rating Agencies at least thirty (30) Business Days prior to such change of jurisdiction; and (iii) on or prior to the 25th Business Day following such notice the Trustee shall not have received written notice from Holders of a Majority of the Controlling Class, the Collateral Manager, the Collateral Adviser or any Counterparty or, so long as any Notes or Preferred Shares are listed thereon, any stock exchange objecting to such change.

Petitions for Bankruptcy. The Indenture will provide that neither (i) any Hedge Counterparty, the CP Put Counterparty, any CP Note Placement Agent, the Paying Agents, the Collateral Manager, the Note Registrar, or the Trustee, in its own capacity, or on behalf of any Noteholder, CP Noteholder or Holder of Class X Notes, nor (ii) the Noteholders, the CP Noteholders or the Holders of the Preferred Shares may, prior to the date which is one year and one day (or, if longer, the applicable preference period then in effect) after the payment in full of all Notes and the CP Notes, institute against, or join any other person in instituting against, the Issuer or Co-Issuer any bankruptcy, reorganization, arrangement, moratorium, liquidation or similar proceedings under the laws of any jurisdiction.

Satisfaction and Discharge of the Indenture. The Indenture will be discharged with respect to the Collateral securing the Notes, the Class X Notes and the CP Notes upon delivery to the Note Paying Agent for cancellation all of the Notes, Class X Notes and the payment in full of the CP Notes, or, within certain limitations (including the obligation to pay principal and interest), upon deposit with the Trustee of funds sufficient for the payment or redemption thereof and the payment by the Issuers of all other amounts due under the Indenture.

Trustee. LaSalle Bank National Association will be the Trustee under the Indenture. The Issuers and their affiliates may maintain other banking relationships in the ordinary course of business with the Trustee. The payment of the fees and expenses of the Trustee relating to the Notes is solely the obligation of the Issuers. The Trustee and/or its affiliates may receive compensation in connection with the Trustee's investment of trust assets in certain Eligible Investments as provided in the Indenture and in connection with the Trustee's administration of any securities lending activities of the Issuer.

The Indenture contains provisions for the indemnification of the Trustee for any loss, liability or expense incurred without negligence, willful misconduct or bad faith on its part, arising out of or in connection with the acceptance or administration of the Indenture. The Trustee will not be bound to take any action unless indemnified for such action. The Noteholders and CP Noteholders shall together have the power, exercisable by Extraordinary Resolution, to remove the Trustee as set forth in the Indenture. The removal of the Trustee shall not become effective until the later of the effective date of the appointment of a successor trustee and the acceptance of appointment by a successor trustee. If the Trustee is removed without cause, costs and expenses of the Trustee incurred in connection with the transfer to the successor Trustee shall be paid by the successor Trustee or the Issuer.

Agents. Goldman, Sachs & Co., SG Americas Securities, L.L.C. and any other person who enters into a CP Note Placement Agreement with the Issuer will be the initial CP Note Placement Agents ("CP Note Placement Agents") under the CP Placement Agreements. LaSalle Bank National Association will be the Note Paying Agent, the Note Registrar, the Note Calculation Agent and the Note Transfer Agent under the Indenture. The Issuers and their affiliates may maintain other banking relationships in the ordinary course of business with LaSalle Bank National Association. The payment of the fees and expenses of LaSalle Bank National Association relating to the Notes is solely the obligation of the Issuers.

The Indenture contains provisions for the indemnification of LaSalle Bank National Association for any loss, liability or expense incurred without gross negligence, willful misconduct, default or bad faith on its part arising out of or in connection with the acceptance or administration of the Indenture.

Listing and Paying Agent. For so long as any of the Securities are listed on any stock exchange and the rules of such exchange shall so require, the Issuers will have a Listing and Paying Agent and a paying agent in accordance with the requirements of the rules of such exchange (which shall be the "Listing and Paying Agent") for the Securities. The Issuers and their affiliates may maintain other relationships in the ordinary course of business with the Listing and Paying Agent. The payment of the fees and expenses of the Listing and Paying Agent relating to the Securities is solely the obligation of the Issuers. The Indenture contains provisions for the indemnification of the Listing and Paying Agent for any loss, liability or expense incurred without negligence, willful misconduct or bad faith on their respective parts arising out of or in connection with the acceptance or administration of the Indenture.

Status of the Preferred Shares. The Holders of the Preferred Shares will have certain rights to vote with respect to limited matters arising under the Indenture and the Collateral Management Agreement including, without limitation, in connection with certain modifications to the Indenture. However, the Holders of the Preferred Shares will have no right to vote in connection with the realization of the Collateral or certain other matters under the Indenture.

Preferred Share Paying and Transfer Agency Agreement

Pursuant to the Preferred Share Paying and Transfer Agency Agreement, the Preferred Share Paying Agent and the Preferred Share Transfer Agent will perform various fiscal services on behalf of the Holders of the Preferred Shares. The payment of the fees and expenses of the Preferred Share Paying Agent and Preferred Share Transfer Agent is solely the obligation of the Issuer. The Preferred Share Paying and Transfer Agency Agreement contains provisions for the indemnification of the Preferred Share Paying Agent and Preferred Share Transfer Agent for any loss, liability or expense incurred without gross negligence, willful misconduct or bad faith on its part, arising out of or in connection with the acceptance or administration of the Preferred Share Paying and Transfer Agency Agreement.

Consolidation, Merger or Transfer of Assets. The Holders of the Preferred Shares, as a condition to acquiring the Preferred Shares, and the Share Trustee, as a condition to acquiring the Issuer Ordinary Shares, will be required to covenant that, except under the limited circumstances set forth in the Indenture and the declaration of trust made by the Share Trustee in respect of the Issuer Ordinary Shares, they will not permit the Issuer to consolidate with, merge into, or transfer or convey all or substantially all of its assets to, any other corporation, partnership, trust or other person or other entity. The Share Trustee, as a condition to acquiring the common equity of the Co-Issuer, will be required to covenant that, except under the limited circumstances set forth in the Indenture, it will not permit the Co-Issuer to consolidate with, merge into, or transfer or convey all or substantially all of its assets to, any other limited liability company, corporation, partnership, trust or other person or other entity.

Governing Law of the Indenture, the Notes, the Preferred Share Paying and Transfer Agency Agreement, the Hedge Agreements, the CP Put Agreements, the Collateral Management Agreement and the Collateral Advisory Agreement

The Indenture, the Notes, the Class X Notes, the CP Notes, the Preferred Share Paying and Transfer Agency Agreement, the Hedge Agreements, the CP Put Agreements, the Collateral Management Agreement and the Collateral Advisory Agreement will be governed by, and construed in accordance with, the laws of the State of New York applicable to agreements made and to be performed therein without regard to the conflict of laws principles thereof. Under the Indenture, the Preferred Share Paying and Transfer Agency Agreement, the Hedge Agreements, the CP Put Agreements, the Collateral Management Agreement and the Collateral Advisory Agreement the Issuers have submitted irrevocably to the non-exclusive jurisdiction of the courts of the State of New York and the courts of the United States of America in the State of New York (in each case sitting in the County of New York) for the purposes of hearing and determining any suit, action or proceedings or settling any disputes arising out of or in

connection with the Indenture, the Notes, the Preferred Share Paying and Transfer Agency Agreement, the Hedge Agreements, the CP Put Agreements, the Collateral Management Agreement and the Collateral Advisory Agreement. The Preferred Shares will be governed by, and construed in accordance with, the laws of the Cayman Islands.

Form of the Securities

The Notes and the Regulation S Preferred Shares. Each Class of Notes (other than the Class E Notes) sold in reliance on Rule 144A under the Securities Act will be represented by one or more Rule 144A Global Notes and will be deposited with LaSalle Bank National Association as custodian for DTC and registered in the name of Cede & Co., a nominee of DTC. The Rule 144A Notes which are Class E Notes will be issued in definitive, fully registered form, registered in the name of the owner thereof ("Definitive Notes"). The Rule 144A Global Notes and the Definitive Notes (and any Notes issued in exchange therefor) will be subject to certain restrictions on transfer as set forth under "Notice to Investors."

Each Class of Notes and Preferred Shares sold in offshore transactions in reliance on Regulation S will initially be represented by a Temporary Regulation S Global Note or a Regulation S Preferred Share, as applicable, deposited on the Closing Date with LaSalle Bank National Association as custodian for DTC and registered in the name of Cede & Co., a nominee of DTC, for the respective accounts of Euroclear and Clearstream. Beneficial interests in a Temporary Regulation S Global Note or a Regulation S Preferred Share may be held only through Euroclear or Clearstream. Beneficial interests in a Temporary Regulation S Global Note will be exchanged for beneficial interests in a permanent Regulation S Global Note for the related Class of Notes in definitive, fully registered form upon the later of (i) the expiration of the Distribution Compliance Period and (ii) the first date on which the requisite certifications (in the form provided in the Indenture) are provided to the Trustee. The Regulation S Global Note and the Regulation S Preferred Share will be registered in the name of Cede & Co., a nominee of DTC, and deposited with LaSalle Bank National Association as custodian for DTC for credit to the accounts of Euroclear and Clearstream for the respective accounts of the Holders of such Notes. Beneficial interests in a Regulation S Global Note and a Regulation S Preferred Share may be held only through Euroclear or Clearstream.

A beneficial interest in a Regulation S Global Note or a Temporary Regulation S Global Note may be transferred, whether before or after the expiration of the Distribution Compliance Period, to a U.S. person only, with respect to the Class A Notes, the Class B Notes, the Class C Notes or the Class D Notes, in the form of a beneficial interest in a Rule 144A Global Note, and, with respect to any Regulation S Class E Notes, in the form of a definitive Class E Note, and only upon receipt by the Note Transfer Agent of a written certification from the transferor (in the form provided in the Indenture) to the effect that the transfer is being made to a person the transferor reasonably believes is a Qualified Institutional Buyer and a Qualified Purchaser. A beneficial interest in a Regulation S Preferred Share may be transferred to a U.S. person only in the form of a Preferred Share Certificate, and only upon receipt by the Preferred Share Paying and Transfer Agent of a written certification from the transferor (in the form provided in the Preferred Share Paying and Transfer Agency Agreement) to the effect that the transfer is being made to a person the transferor reasonably believes is a Qualified Institutional Buyer that has acquired an interest in the Preferred Shares in a transaction meeting the requirements of Rule 144A, or an Accredited Investor having a net worth of not less than U.S.\$10 million in a transaction exempt from registration under the Securities Act, and a Qualified Purchaser. In addition, transfers of a beneficial interest in a Regulation S Global Note or Temporary Regulation S Global Note to a person who takes delivery in the form of an interest in a Rule 144A Global Note may occur only in denominations greater than or equal to the minimum denominations applicable to the Rule 144A Global Notes.

A beneficial interest in a Rule 144A Global Note may be transferred to a person who takes delivery in the form of an interest in a Temporary Regulation S Global Note or a Regulation S Global Note, as the case may be, whether during or after the expiration of the Distribution Compliance Period, only upon receipt by the Note Registrar of a written certification from the transferor (in the form provided in the Indenture) to the effect that such transfer is being made to a non U.S. Person in accordance with Rule 903 or 904 of Regulation S.

Any beneficial interest in one of the Global Securities that is transferred to the person who takes delivery in the form of an interest in another Global Security will, upon transfer, cease to be an interest in such Global Security and become an interest in the other Global Security and, accordingly, will thereafter be subject to all transfer restrictions and other procedures applicable to beneficial interests in such other Global Security for as long as it remains such interest.

Except in the limited circumstances described below, owners of beneficial interests in any Global Note will not be entitled to receive a Definitive Note. The Notes are not issuable in bearer form.

Each Note will be issued in minimum denominations of \$250,000 (in the case of Rule 144A Notes) and \$100,000 (in the case of Regulation S Notes) and integral multiples of \$1 in excess thereof.

The Preferred Shares will be issued in minimum numbers of 25 Preferred Shares per investor and integral multiples of one Preferred Share in excess thereof.

Global Securities. Upon the issuance of the Global Notes and Regulation S Preferred Shares (together, "Global Securities"), DTC or its custodian will credit, on its internal system, the respective aggregate original principal amount of the individual beneficial interests represented by such Global Notes or the original number of such Regulation S Preferred Shares, as applicable, to the accounts of persons who have accounts with DTC. Such accounts initially will be designated by or on behalf of the Initial Purchaser. Ownership of beneficial interests in Global Securities will be limited to persons who have accounts with DTC ("participants") or persons who hold interests through participants. Ownership of beneficial interests in a Global Security will be shown on, and the transfer of that ownership will be effected only through, records maintained by DTC or its nominee (with respect to interests of participants) and the records of participants (with respect to interests of persons other than participants).

So long as DTC, or its nominee, is the registered owner or Holder of the Global Securities, DTC or such nominee, as the case may be, will be considered the sole owner or Holder of each Class of the Notes represented by such Global Notes for all purposes under the Indenture and such Notes and the sole owner or Holder of the Preferred Shares represented by such Regulation S Preferred Shares for all purposes under the Preferred Share Paying and Transfer Agency Agreement and such Preferred Shares. Unless DTC notifies the Issuers that it is unwilling or unable to continue as depository for a Global Security or ceases to be a "Clearing Agency" registered under the Exchange Act, owners of the beneficial interests in the Global Securities will not be entitled to have any portion of such Global Securities registered in their names, will not receive or be entitled to receive physical delivery of Securities in certificated form and will not be considered to be the owners or Holders of any Securities under the Indenture or the Preferred Share Paying and Transfer Agency Agreement, as applicable. In addition, no beneficial owner of an interest in the Global Securities will be able to transfer that interest except in accordance with DTC's applicable procedures (in addition to those under the Indenture referred to herein and, if applicable, those of Euroclear and Clearstream).

Investors may hold their interests in a Regulation S Global Note, a Temporary Regulation S Global Note or a Regulation S Preferred Share directly through Clearstream or Euroclear, if they are participants in these systems, or indirectly through organizations which are participants in these systems. Clearstream and Euroclear will hold interests in the Regulation S Global Notes and Regulation S Preferred Shares on behalf of their participants through their respective depositories, which in turn will hold the interests in the Regulation S Global Notes, Temporary Regulation S Global Notes and Regulation S Preferred Shares in customers' securities accounts in the depositories' names on the books of DTC. Investors may hold their interests in a Rule 144A Global Note directly through DTC if they are participants in the system, or indirectly through organizations which are participants in the system.

Payments of the principal of and interest on the Global Notes and payments of dividends, redemption payments or other distributions in respect of a Regulation S Preferred Share will be made to DTC or its nominee, as the registered owner thereof. Neither the Issuers, the Trustee nor any paying agent will have any responsibility or liability for any aspect of the records relating to or payments made on account of beneficial ownership interests in the Global Securities or for any notice permitted or required to

be given to Holders of Securities or any consent given or actions taken by DTC as Holder of Securities. The Issuers expect that DTC or its nominee, upon receipt of any payment of principal or interest in respect of a Global Note representing any Notes or any payment of dividends, redemption payments or other distributions in respect of a Regulation S Preferred Share, as the case may be, held by it or its nominee, will immediately credit participants' accounts with payments in amounts proportionate to their respective interests in the principal amount of such Global Notes or the number of such Preferred Shares, as applicable, as shown on the records of DTC or its nominee. The Issuers also expect that payments by participants to owners of interests in such Global Securities held through such participants will be governed by standing instructions and customary practices, as is now the case with securities held for the accounts of customers registered in the names of nominees for such customers. Such payments will be the responsibility of such participants.

Transfers between participants will be effected in the ordinary way in accordance with DTC rules and will be settled in same-day funds. The laws of some jurisdictions require that certain persons take physical delivery of securities in definitive form. Consequently, the ability to transfer beneficial interests in Global Securities to these persons may be limited. Because DTC can only act on behalf of participants, who in turn act on behalf of indirect participants and certain banks, the ability of a person having a beneficial interest in Global Securities to pledge its interest to persons or entities that do not participate in the DTC system, or otherwise take actions in respect of its interest, may be affected by the lack of a physical certificate of the interest. Transfers between account holders in Euroclear and Clearstream will be effected in the ordinary way in accordance with their respective rules and operating procedures.

Subject to compliance with the transfer restrictions applicable to the Notes and Regulation S Preferred Shares described above, cross-market transfers between DTC participants, on the one hand, and, directly or indirectly through Euroclear or Clearstream account holders, on the other, will be effected in DTC in accordance with DTC rules on behalf of Euroclear or Clearstream, as the case may be, by its respective depository; however, these cross-market transactions will require delivery of instructions to Euroclear or Clearstream, as the case may be, by the counterparty in the system in accordance with its rules and procedures and within its established deadlines (Brussels time). Euroclear or Clearstream, as the case may be, will, if the transaction meets its settlement requirements, deliver instructions to its respective depository to take action to effect final settlement on its behalf by delivering or receiving interests in a Temporary Regulation S Global Note, a Regulation S Global Note or a Regulation S Preferred Share in DTC, and making or receiving payment in accordance with normal procedures for a same-day funds settlement applicable to DTC. Clearstream and Euroclear account holders may not deliver instructions directly to the depositories for Clearstream or Euroclear.

Because of time zone differences, the securities account of a Euroclear or Clearstream participant purchasing an interest in a Global Security from a DTC participant will be credited during the securities settlement processing day (which must be a Business Day for Euroclear or Clearstream, as the case may be) immediately following the DTC settlement date and the credit of any transactions in interests in a Global Security settled during the processing day will be reported to the relevant Euroclear or Clearstream participant on that day. Cash received in Euroclear or Clearstream as a result of sales of interests in a Global Security by or through a Euroclear or Clearstream participant to a DTC participant will be received with value on the DTC settlement date but will be available in the relevant Euroclear or Clearstream cash account only as of the Business Day following settlement in DTC.

DTC has advised the Issuers that it will take any action permitted to be taken by a Holder of the Global Notes or Regulation S Preferred Shares (including the presentation of the applicable Global Securities for exchange as described below) only at the direction of one or more participants to whose account with DTC interests in a Global Security are credited and only in respect of that portion of the aggregate principal amount of the Notes or that portion of the Preferred Shares represented by the Regulation S Preferred Shares as to which the participant or participants has or have given direction.

The giving of notices and other communications by DTC to participants, by participants to persons who hold accounts with them and by such persons to Holders of beneficial interests in a Global Security will be governed by arrangements between them, subject to any statutory or regulatory requirements as may exist from time to time.

DTC has advised the Issuers as follows: DTC is a limited purpose trust company organized under the laws of the State of New York, a member of the Federal Reserve System, a "clearing corporation" within the meaning of the Uniform Commercial Code and a "Clearing Agency" registered pursuant to the provisions of Section 17A of the Exchange Act. DTC was created to hold securities for its participants and facilitate the clearance and settlement of securities transactions between participants through electronic book-entry changes in accounts of its participants, thereby eliminating the need for physical movement of certificates. Participants include securities brokers and dealers, banks, trust companies and clearing corporations and may include certain other organizations. Indirect access to the DTC system is available to others such as banks, brokers, dealers and trust companies that clear through or maintain a custodial relationship with a participant, either directly or indirectly ("indirect participants").

Clearstream. Clearstream Banking, société anonyme, was incorporated as a limited liability company under Luxembourg law. Clearstream is owned by Cedel International, société anonyme, and Deutsche Börse AG. The shareholders of these two entities are banks, securities dealers and financial institutions.

Clearstream holds securities for its customers and facilitates the clearance and settlement of securities transactions between Clearstream customers through electronic book-entry changes in accounts of Clearstream customers, thus eliminating the need for physical movement of certificates. Clearstream provides to its customers, among other things, services for safekeeping, administration, clearance and settlement of internationally traded securities, securities lending and borrowing and collateral management. Clearstream interfaces with domestic markets in a number of countries. Clearstream has established an electronic bridge with Euroclear Bank S.A./N.V., the operator of the Euroclear System, to facilitate settlement of trades between Clearstream and Euroclear.

As a registered bank in Luxembourg, Clearstream is subject to regulation by the Luxembourg Commission for the Supervision of the Financial Sector. Clearstream customers are recognized financial institutions around the world, including underwriters, securities brokers and dealers, banks, trust companies and clearing corporations. In the United States, Clearstream customers are limited to securities brokers and dealers and banks and may include the Initial Purchaser. Other institutions that maintain a custodial relationship with a Clearstream customer may obtain indirect access to Clearstream. Clearstream is an indirect participant in DTC.

Distributions with respect to the Notes and Regulation S Preferred Shares held beneficially through Clearstream will be credited to cash accounts of Clearstream customers in accordance with its rules and procedures, to the extent received by Clearstream.

The Euroclear System. The Euroclear System was created in 1968 to hold securities for participants of the Euroclear System and to clear and settle transactions between Euroclear participants through simultaneous electronic book-entry delivery against payment, thus eliminating the need for physical movement of certificates and risk from lack of simultaneous transfers of securities and cash. Transactions may now be settled in many currencies, including U.S. Dollars and Japanese Yen. The Euroclear System provides various other services, including securities lending and borrowing and interfaces with domestic markets in several countries generally similar to the arrangements for cross-market transfers with DTC described above.

The Euroclear System is operated by Euroclear Bank S.A./N.V. (the "Euroclear Operator"), under contract with Euroclear Clearance System plc, a U.K. corporation (the "Euroclear Clearance System"). The Euroclear Operator conducts all operations, and all Euroclear securities clearance accounts and Euroclear cash accounts are accounts with the Euroclear Operator, not the Euroclear Clearance System. The Euroclear Clearance System establishes policy for the Euroclear System on behalf of Euroclear participating organizations. Euroclear participants include banks (including central banks), securities brokers and dealers and other professional financial intermediaries and may include the Initial Purchaser. Indirect access to the Euroclear System is also available to other firms that clear through or maintain a custodial relationship with a Euroclear participant, either directly or indirectly. Euroclear is an indirect participant in DTC.

The Euroclear Operator is a Belgian bank. The Belgian Banking Commission regulates and examines the Euroclear Operator.

The Terms and Conditions Governing Use of Euroclear and the related Operating Procedures of the Euroclear System and applicable Belgian law govern securities clearance accounts and cash accounts with the Euroclear Operator. Specifically, these terms and conditions govern:

- (a) transfers of securities and cash within the Euroclear System;
- (b) withdrawal of securities and cash from the Euroclear System; and
- (c) receipts of payments with respect to securities in the Euroclear System.

All securities in the Euroclear System are held on a fungible basis without attribution of specific certificates to specific securities clearance accounts. The Euroclear Operator acts under the terms and conditions only on behalf of Euroclear participants and has no record of or relationship with persons holding securities through Euroclear participants.

Distributions with respect to Notes and Regulation S Preferred Shares held beneficially through Euroclear will be credited to the cash accounts of Euroclear participating organizations in accordance with the Euroclear Terms and Conditions, to the extent received by the Euroclear Operator and by Euroclear.

Although DTC, Clearstream and Euroclear have agreed to the foregoing procedures in order to facilitate transfers of interests in the Regulation S Global Notes, the Rule 144A Global Notes and the Regulation S Preferred Shares among participants of DTC, Clearstream and Euroclear, they are under no obligation to perform or continue to perform these procedures, and the procedures may be discontinued at any time. Neither the Issuers, the Preferred Share Paying and Transfer Agent, the Share Registrar nor the Trustee will have any responsibility for the performance by DTC, Clearstream, Euroclear or their respective participants or indirect participants of their respective obligations under the rules and procedures governing their operations.

Payments; Certifications by Holders of Temporary Regulation S Global Notes. A Holder of a beneficial interest in a Temporary Regulation S Global Note must provide Clearstream or Euroclear, as the case may be, with a certificate in the form required by the Indenture certifying that the beneficial owner of the interest in such Global Note is not a U.S. Person (as defined in Regulation S), and Clearstream or Euroclear, as the case may be, must provide to the Trustee a certificate in the form required by the Indenture prior to (i) the payment of interest or principal with respect to such Holder's beneficial interest in the Temporary Regulation S Global Note and (ii) any exchange of such beneficial interest for a beneficial interest in a Regulation S Global Note.

Individual Definitive Notes and Preferred Share Certificates. The Class A Notes, the Class B Notes, the Class C Notes, the Class D Notes, the Regulation S Class E Notes and the Regulation S Preferred Shares will be initially issued in global form. The Class E Notes other than the Regulation S Class E Notes will not be global and will be represented by one or more Definitive Notes. If DTC or any successor to DTC advises the Issuer in writing that it is at any time unwilling or unable to continue as a depository for the reasons described in "—Global Securities" and a successor depository is not appointed by the Issuers within ninety (90) days or as a result of any amendment to or change in, the laws or regulations of the Cayman Islands or the State of Delaware, as applicable, or of any authority therein or thereof having power to tax or in the interpretation or administration of such laws or regulations which become effective on or after the Closing Date, the Issuers, the Note Paying Agent or the Preferred Share Paying and Transfer Agent, as applicable, is or will be required to make any deduction or withholding from any payment in respect of the Notes or the Regulation S Preferred Shares which would not be required if the Notes or the Regulation S Preferred Shares were in definitive form and the Issuers will issue Definitive Notes in registered form and Preferred Share Certificates in exchange for the Regulation S Global Notes, the Rule 144A Global Notes and the Regulation S Preferred Shares, as the case may be. Upon receipt of such notice from DTC, the Issuers will use their best efforts to make arrangements with DTC for the exchange of (i) interests in the Global Notes for individual Definitive Notes and cause the requested

individual Definitive Notes to be executed and delivered to the Note Registrar in sufficient quantities and authenticated by or on behalf of the Note Transfer Agent for delivery to Holders of the Notes (ii) interests in the Regulation S Preferred Shares for Preferred Share Certificates and cause the requested Preferred Share Certificates to be executed and delivered to the Share Registrar in sufficient quantities and authenticated by or on behalf of the Preferred Share Paying and Transfer Agent for delivery to Holders of the Preferred Shares. Persons exchanging interests in a Global Security for individual Definitive Notes or Preferred Share Certificates will be required to provide to the Note Transfer Agent or the Preferred Share Paying and Transfer Agent, as applicable, through DTC, Clearstream or Euroclear, (i) written instructions and other information required by the Issuers and the Note Transfer Agent or the Preferred Share Paying and Transfer Agent, as applicable, to complete, execute and deliver such individual Definitive Notes or Preferred Share Certificates, (ii) in the case of an exchange of an interest in a Rule 144A Global Note, such certification as to Qualified Institutional Buyer status and that such Holder is a Qualified Purchaser, as the Issuers shall require and (iii) in the case of an exchange of an interest in a Regulation S Global Note or a Regulation S Preferred Share, such certification as the Issuers shall require as to non-U.S. Person status. In all cases, individual Definitive Notes or Preferred Share Certificates delivered in exchange for any Global Security or beneficial interests therein will be registered in the names, and issued in denominations or lots in compliance with the minimum denominations or lots specified for the applicable Global Securities, requested by DTC.

Individual Definitive Notes will bear, and be subject to, such legend as the Issuers require in order to assure compliance with any applicable law. Individual Definitive Notes will be transferable subject to the minimum denomination applicable to the Rule 144A Global Notes and Regulation S Global Notes, in whole or in part, and exchangeable for individual Definitive Notes of the same Class at the office of the Note Paying Agent, Note Transfer Agent or the office of any transfer agent, upon compliance with the requirements set forth in the Indenture. Individual Definitive Notes may be transferred through any transfer agent upon the delivery and duly completed assignment of such Notes. Upon transfer of any individual Definitive Note in part, the Note Transfer Agent will issue in exchange therefor to the transferee one or more individual Definitive Notes in the amount being so transferred and will issue to the transferor one or more individual Definitive Notes in the remaining amount not being transferred. No service charge will be imposed for any registration of transfer or exchange, but payment of a sum sufficient to cover any tax or other governmental charge may be required. The Holder of a restricted individual Definitive Note may transfer such Note, subject to compliance with the provisions of the legend thereon. Upon the transfer, exchange or replacement of Notes bearing the legend, or upon specific request for removal of the legend on a Note, the Issuer will deliver only Notes that bear such legend, or will refuse to remove such legend, as the case may be, unless there is delivered to the Issuer such satisfactory evidence, which may include an opinion of counsel, as may reasonably be required by the Issuer that neither the legend nor the restrictions on transfer set forth therein are required to ensure compliance with the provisions of the Securities Act and the Investment Company Act. Payments of principal and interest on individual Definitive Notes shall be payable by the Note Paying Agents by U.S. Dollar check drawn on a bank in the United States of America and sent by mail to the registered Holder thereof, by wire transfer in immediately available funds. In addition, for so long as any Notes are listed on any stock exchange and the rules of such exchange shall so require, in the case of a transfer or exchange of individual Definitive Notes, a Holder thereof may effect such transfer or exchange by presenting such Notes at, and obtaining a new individual Definitive Note from the office of the Listing and Paying Agent, in the case of a transfer of only a part of an individual Definitive Note, a new individual Definitive Note in respect of the balance of the principal amount of the individual Definitive Note not transferred will be delivered at the office of applicable stock exchange, and in the case of a replacement of any lost, stolen, mutilated or destroyed individual Definitive Notes, a Holder thereof may obtain a new individual Definitive Note from the Listing and Paying Agent.

The Class E Notes (other than Regulation S Class E Notes) and the Class X Notes. The Class E Notes (other than Regulation S Class E Notes) and the Class X Notes will be represented by one or more notes in definitive form and will be subject to certain restrictions on transfer as set forth under "Notice to Investors."

The Class E Notes (other than Regulation S Class E Notes) and the Class X Notes may be transferred only upon receipt by the Issuer and Note Transfer Agent of a Class E Notes and Class X Notes Purchase and Transfer Letter to the effect that the transfer is being made (i) to a Qualified Institutional Buyer or, in the case of the Class X Notes, to an Accredited Investor having a net worth of not less than U.S.\$10 million in a transaction exempt from registration under the Securities Act, who is, in each case, a Qualified Purchaser, that has acquired an interest in the Class E Notes or Class X Notes in a transaction meeting the requirements of Rule 144A who is also a Qualified Purchaser or (ii) to a non-U.S. Person in an offshore transaction complying with Rule 903 or Rule 904 of Regulation S. The transferee must also make certain other representations applicable to such transferee, as set forth in the Class E Notes and Class X Notes Purchase and Transfer Letter.

Payments on the Class E Notes (other than Regulation S Class E Notes) and the Class X Notes on any Quarterly Payment Date will be made to the person in whose name the relevant Note is registered as of the close of business 10 Business Days prior to such Payment Date.

The Preferred Shares. The Preferred Shares (other than the Regulation S Preferred Shares) will be represented by one or more Preferred Share Certificates in definitive form and the Preferred Shares will be subject to certain restrictions on transfer as set forth under "Notice to Investors."

Preferred Shares may be transferred only upon receipt by the Issuer and Preferred Share Transfer Agent of a Preferred Shares Purchase and Transfer Letter to the effect that the transfer is being made (i)(a) to a Qualified Institutional Buyer that has acquired an interest in the Preferred Shares in a transaction meeting the requirements of Rule 144A, or (b) to an Accredited Investor having a net worth of not less than U.S.\$10 million in a transaction exempt from registration under the Securities Act, who is a Qualified Purchaser, or (ii) to a non-U.S. Person in an offshore transaction complying with Rule 903 or Rule 904 of Regulation S. The transferee must also make certain other representations applicable to such transferee, as set forth in the Preferred Shares Purchase and Transfer Letter.

The Preferred Shares will be issued in minimum numbers of 25 Preferred Shares per investor and integral multiples of one Preferred Share in excess thereof. Payments on the Preferred Shares (other than the Regulation S Preferred Shares) on any Quarterly Payment Date will be made to the person in whose name the relevant Preferred Share is registered in the share register as of the close of business on the first calendar day of the month in which such Quarterly Payment Date occurs (or if such day is not a Business Day, the next succeeding Business Day).

USE OF PROCEEDS

The gross proceeds associated with the offering of the Securities and the CP Notes are expected to equal approximately U.S.\$1,511,067,851. Approximately U.S.\$11,255,835 of such gross proceeds will be applied by the Issuer to pay upfront fees and expenses associated with the offering of the Securities and the CP Notes. On the Closing Date or promptly thereafter as is consistent with customary settlement procedures, pursuant to agreements to purchase entered into on or before the Closing Date, the Issuer will apply the net proceeds to purchase the Collateral Assets described herein having an aggregate Principal Balance of approximately U.S.\$1,500,900,000 and will have entered into the Hedge Agreements. To the extent any payments of principal are received on the Collateral Assets prior to October 31, 2005, up to U.S.\$15,000,000 of such Principal Proceeds may be invested in a specified Residential Mortgage-Backed Security as described herein. In addition, on the Closing Date, approximately U.S.\$200,000 of the net proceeds from the issuance of the Securities will be deposited into the Expense Reserve Account.

RATINGS OF THE NOTES

It is a condition to the issuance of the Notes that the Class A-1LT-a Notes, the Class A-1LT-b Notes and the Class A-2 Notes be rated "Aaa" by Moody's and "AAA" by S&P, that the Class B Notes be rated at least "Aa2" by Moody's and at least "AA" by S&P, that the Class C Notes be rated at least "A2" by Moody's and at least "A" by S&P, that the Class D Notes be rated at least "Baa2" by Moody's and at least "BBB" by S&P, that the Class E Notes be issued with an initial rating on the Closing Date of at least "Ba3"

by Moody's and at least "BB+" by S&P assuming the Maximum Issuance Amount and the Maximum Coupon for the Class E Notes. The Preferred Shares will not be rated. A rating is not a recommendation to buy, sell or hold securities and may be subject to revision or withdrawal at any time.

Moody's Ratings

The ratings assigned to the Notes by Moody's are based upon its assessment of the probability that the Collateral Assets will provide sufficient funds to pay such Notes, based largely upon Moody's statistical analysis of historical default rates on debt obligations with various ratings, expected recovery rates on the Collateral Assets, the asset and interest coverage required for such Notes (which is achieved through the subordination of more junior Notes), and the diversification requirements that the Collateral Assets must satisfy.

Moody's rating of (i) the Class A Notes and the Class B Notes addresses the ultimate cash receipt of all required principal payments and the timely cash receipt of all interest payments as provided in the governing documents and (ii) the Class C Notes, the Class D Notes and the Class E Notes addresses the ultimate cash receipt of all required interest and principal payments as provided in the governing documents. Moody's ratings are based on the expected loss posed to the Holders of the Notes relative to the promise of receiving the present value, calculated using a discounted rate equal to the promised interest rate of such payments. Moody's analyzes the likelihood that each debt obligation included in the portfolio will default, based on historical default rates for similar debt obligations, the historical volatility of such default rates (which increases as securities with lower ratings are added to the portfolio) and an additional default assumption to account for future fluctuations in defaults. Moody's then determines the level of credit protection necessary to achieve the expected loss associated with the rating of the structured securities, taking into account the potential recovery value of the Collateral Assets and the expected volatility of the default rate of the portfolio based on the level of diversification by issuer and industry.

In addition to these quantitative tests, Moody's ratings take into account qualitative features of a transaction, including the experience of the Collateral Manager, the legal structure and the risks associated with such structure, its view as to the quality of the participants in the transaction and other factors that it deems relevant.

S&P Ratings

S&P will rate the Notes in a manner similar to the manner in which it rates other structured issues. The ratings assigned to the Class A Notes and the Class B Notes by S&P address the likelihood of the timely payment of interest and the ultimate payment of principal on such Notes. The ratings assigned to the Class C Notes, the Class D Notes and the Class E Notes by S&P address the likelihood of the ultimate payment of interest and principal on such Notes. This requires an analysis of the following: (i) credit quality of the Collateral Assets securing the Notes; (ii) cash flow used to pay liabilities and the priorities of these payments; and (iii) legal considerations. Based on these analyses, S&P determines the necessary level of credit enhancement needed to achieve a desired rating.

S&P's analysis includes the application of its proprietary default expectation computer model, the Standard & Poor's CDO Monitor (which will be provided to the Collateral Manager), which is used to estimate the default rate the portfolio is likely to experience. The Standard & Poor's CDO Monitor calculates the projected cumulative default rate of a pool of Collateral Assets consistent with a specified benchmark rating level based upon S&P's proprietary corporate debt default studies. The Standard & Poor's CDO Monitor takes into consideration the rating of each issuer or obligor, the number of issuers or obligors, the issuer or obligor industry concentration and the remaining weighted average maturity of each of the Collateral Assets and Eligible Investments included in the portfolio. The risks posed by these variables are accounted for by effectively adjusting the necessary default level needed to achieve a desired rating. The higher the desired rating, the higher the level of defaults the portfolio must withstand.

Credit enhancement to support a particular rating is then provided based, in part, on the results of the Standard & Poor's CDO Monitor, as well as other more qualitative considerations such as legal issues and management capabilities. Credit enhancement is typically provided by a combination of overcollateralization/subordination, cash collateral/reserve account, excess spread/interest and amortization. A transaction-specific cash flow model (the "Transaction-Specific Cash Flow Model") is used to evaluate the portfolio and determine whether it can withstand an estimated level of default while fully repaying the class of debt under consideration.

There can be no assurance that actual loss on the Collateral Assets will not exceed those assumed in the application of the Standard & Poor's CDO Monitor or that recovery rates and the timing of recovery with respect thereto will not differ from those assumed in the Transaction-Specific Cash Flow Model. The Issuers make no representation as to the expected rate of defaults on the portfolio or as to the expected timing of any defaults that may occur.

S&P's rating of the Notes will be established under various assumptions and scenario analyses. There can be no assurance, and no representation is made, that actual defaults on the Collateral Assets will not exceed those in S&P's analysis, or that recovery rates with respect thereto (and, consequently, loss rates) will not differ from those in S&P's analysis.

SECURITY FOR THE NOTES

Under the terms of the Indenture, the Issuer will grant to the Trustee, for the benefit of the Secured Parties (but not the Holders of the Preferred Shares), a first priority perfected security interest in the Collateral, including the Collateral Assets, that is free of any adverse claim, to secure the Issuers' obligations under the Indenture, the Notes, the Class X Notes, the CP Notes, the CP Put Agreement, the CP Note Placement Agreement, the Collateral Management Agreement and the Hedge Agreements.

On the Closing Date, the Issuer expects to acquire approximately U.S.\$1,500,900,000 in aggregate principal balance of Collateral Assets. The Collateral Assets will consist of Residential Mortgage-Backed Securities, Commercial Mortgage-Backed Securities, CDO Securities and Asset-Backed Securities. Certain information with respect to the Collateral Assets is included herein (including in Appendix B) on the CD-ROM attached to this Offering Circular. This information was provided by or derived from information provided by the issuers, underwriters and/or the servicers for each underlying Collateral Asset. In addition, the prospectus supplements, private placement memoranda, offering circulars or similar disclosure documents with respect to the Collateral Assets for which such documents are available, together with the most recently available investor or trustee reports with respect to Collateral Assets issued six months prior to the Closing Date (such documents and reports, the "Disclosure Documents"), are included on the CD-ROM attached hereto. None of the Issuers, the Initial Purchaser, the Collateral Manager, the Collateral Adviser, the Hedge Counterparty (or any guarantor thereof), the Trustee or any party on their behalf has made any independent review or verification as to the accuracy and completeness of the information contained below or is making any representation or warranty regarding, or assuming any responsibility for, the accuracy, completeness, or applicability of such information. Accordingly, prospective purchasers must make their own evaluation regarding the extent to which they will rely on such information in making an investment decision. None of the issuers of the Collateral Assets makes any representation or warranty as to the appropriateness of any Disclosure Document for use in connection with the offering of the Offered Securities or takes any responsibility for such use. None of the Issuers, the Initial Purchaser, the Collateral Manager, the Collateral Adviser, the Hedge Counterparty, or any guarantor thereof, the Trustee, any of their affiliates or any party on their behalf takes responsibility for, or makes any representation or warranty as to the accuracy or completeness of any of the Disclosure Documents.

The Collateral Assets

The Collateral Assets had an aggregate principal balance (an aggregate "Collateral Asset Principal Balance") on or about October 17, 2005 (the "Reference Date") of approximately U.S.\$1,500,900,000. The Reference Date balances of the Collateral Assets reflect their principal

balances after giving effect to distributions received on October 17, 2005 and (without duplication) after application of all payments due on the Collateral Assets before the Reference Date, whether or not received. However, the first distributions on the Collateral Assets available to make payments on the Notes will be those made from October 20, 2005 to the end of the first Due Period. The use of a later Reference Date would result in a lower Reference Date balance for certain Collateral Assets and, consequently, a lower aggregate Collateral Asset Principal Balance. The Collateral Assets consist of:

1. 9 issues across 3 categories of CMBS constituting approximately 3.3% of the Collateral Assets (by principal balance),
2. 230 issues across 4 categories of RMBS constituting approximately 87.8% of the Collateral Assets (by principal balance),
3. 19 issues across 4 categories of CDO Securities constituting approximately 8.2% of the Collateral Assets (by principal balance), and
4. 3 issues across 1 category of Asset-Backed Securities consisting of approximately 0.7% of Collateral Assets (by principal balance).

CMBS. The Collateral Assets include 9 whole and partial classes of commercial mortgage pass-through certificates. The following is a list of the respective classes and series of CMBS included in the Collateral Assets:

The CMBS evidence direct and indirect interests in 6 separate segregated pools (each, an "Underlying CMBS Trust Fund") of commercial and multifamily mortgage loans and/or participations and other certificated interests in commercial and multifamily mortgage loans (the "Commercial Mortgage Loans"). The Commercial Mortgage Loans are secured by liens on the respective borrowers' fee and/or leasehold interests in commercial and multifamily mortgaged properties (each, a "Commercial Mortgaged Property"). Each series of certificates of which a CMBS included in the Collateral Assets is a part (each, an "Underlying CMBS Series") collectively represents the entire beneficial ownership interest in, or is

secured by, an Underlying CMBS Trust Fund. Each Commercial Mortgage Loan is evidenced by a promissory note, bond or other evidence of indebtedness of the related borrower (as to such loan, the "Commercial Mortgagor") and is secured by one or more mortgages, deeds of trust or similar security instruments (each, a "Commercial Mortgage") that, in each case, creates a lien on a fee simple or leasehold interest of the related Commercial Mortgagor in the related Commercial Mortgaged Property. As described below and in the corresponding Disclosure Documents referred to herein, any particular Commercial Mortgage Loan: (i) may provide for the accrual of interest thereon at an interest rate (a "Commercial Mortgage Rate") that is fixed over its remaining term or that adjusts in relation to an index or in connection with the exercise of an extension option; (ii) may provide for level Monthly Payments to maturity; (iii) may be fully amortizing over its term to maturity or, alternatively, may provide for no amortization prior to maturity or for an amortization schedule that is significantly longer than its remaining term, thereby having a substantial principal amount due and payable on such loan's maturity, unless prepaid prior thereto; or (iv) may prohibit voluntary prepayments of principal for a specified period or may require payment of a prepayment premium or yield maintenance payment (in either case, a "Prepayment Premium") in connection with a voluntary prepayment of principal. In general, the Commercial Mortgage Loans constitute nonrecourse obligations of the related Commercial Mortgagors and, upon any such Commercial Mortgagor's default in the payment of any amount due under the related loan, the holder thereof may look only to the related Commercial Mortgaged Property or Properties or, with respect to Commercial Mortgage Loans as to which a defeasance has taken place, the U.S. government obligations that have been substituted therefor for satisfaction of the Commercial Mortgagor's obligation. In addition, in those cases where recourse to a Commercial Mortgagor or guarantor is permitted by the loan documents, the Issuer has not undertaken an evaluation of the financial condition of any such person, and prospective investors should thus consider all the Commercial Mortgage Loans to be nonrecourse.

Each Underlying CMBS Series included in the Collateral Assets is serviced by a servicer/special servicer. As of the Closing Date, Midland Loan Services, Inc. is the servicer/special servicer with respect to approximately 1.5%, by principal balance, of the Collateral Assets and Wachovia Bank N.A. is the servicer/special servicer with respect to approximately 0.9%, by principal balance, of the Collateral Assets.

For further information about the CMBS included in the Collateral Assets, investors should refer to the information in Appendix B to this Offering Circular, and to the Disclosure Documents therefor set forth on the CD-ROM attached to this Offering Circular.

Additional Credit Support of CMBS. While each of the CMBS included in the Collateral Assets is rated at least investment grade as of the date hereof, certain of the CMBS are subordinate to one or more senior classes of the same Underlying CMBS Series, which classes have not been included in the Collateral Assets, for purposes of, among other things, offsetting losses and other shortfalls with respect to the related Underlying CMBS Trust Fund. In addition, all of the CMBS included in the Collateral Assets are senior to one or more junior classes of Certificates of the same Underlying CMBS Series, which more junior classes have not been included in the Collateral Assets, for purposes of, among other things, offsetting losses and other shortfalls with respect to the related Underlying CMBS Trust Fund. None of the Commercial Mortgage Loans or the CMBS is insured or guaranteed by the United States, any governmental agency or instrumentality, or any other person.

The RMBS evidence direct and indirect interests in 148 separate segregated pools (each, an "Underlying RMBS Trust Fund") of residential mortgage loans and/or participations and other certificated interests in residential mortgage loans (the "Residential Mortgage Loans"). The Residential Mortgage Loans are secured by liens on the respective borrowers' fee and/or leasehold interests in residential

mortgaged properties (each, a "Residential Mortgaged Property"). Each series of certificates of which an RMBS included in the Collateral Assets is a part (each, an "Underlying RMBS Series") collectively represents the entire beneficial ownership interest in, or is secured by, an Underlying RMBS Trust Fund. Each Residential Mortgage Loan is evidenced by a promissory note, bond or other evidence of indebtedness of the related borrower (as to such loan, the "Residential Mortgagor") and is secured by one or more mortgages, deeds of trust or similar security instruments (each, a "Residential Mortgage") that, in each case, creates a lien on a fee simple or leasehold interest of the related Residential Mortgagor in the related Residential Mortgaged Property. As described below and in the corresponding Disclosure Documents referred to herein, any particular Residential Mortgage Loan: (i) may provide for the accrual of interest thereon at an interest rate that is fixed over its remaining term or that adjusts in relation to an index; (ii) may provide for level Monthly Payments to maturity; or (iii) may be fully amortizing over its term to maturity or, alternatively, may provide for an amortization schedule that is longer than its remaining term. The Residential Mortgage Loans generally do not restrict prepayments or require the payment of prepayment penalties. The origination and servicing of the Residential Mortgage Loans may be subject to various federal and state laws and regulations with respect to interests rates and other charges, or may require certain disclosures, required licensing of originators and regulate debt collection practices.

Each Underlying RMBS Series included in the Collateral Assets is serviced by a primary servicer. As of the Closing Date, Countrywide Home Loans is the primary servicer with respect to approximately 26.5%, by principal balance, of the Collateral Assets and Option One Mortgage Corporation is the primary servicer with respect to approximately 6.0%, by principal amount, of the Collateral Assets.

In addition, to the extent any payments of principal are received on the Collateral Assets prior to October 31, 2005, up to U.S.\$15,000,000 of such Principal Proceeds may be invested in GSAA 2005-9 2A3, CUSIP 362341GL7 at the direction of the Collateral Manager.

For further information about the RMBS included in the Collateral Assets, investors should refer to the information in Appendix B to this Offering Circular, and to the Disclosure Documents set forth on the CD-ROM attached to this Offering Circular.

Additional Credit Support of RMBS. While each of the RMBS included in the Collateral Assets is rated investment grade as of the date hereof, certain of the RMBS are subordinate to one or more senior classes of the same Underlying RMBS Series, which classes have not been included in the Collateral Assets, for purposes of, among other things, offsetting losses and other shortfalls with respect to the related Underlying RMBS Trust Fund. In addition, all of the RMBS included in the Collateral Assets are senior to one or more junior classes of Certificates of the same Underlying RMBS Series, which classes have not been included in the Collateral Assets, for purposes of, among other things, offsetting losses and other shortfalls with respect to the related Underlying RMBS Trust Fund. None of the Residential Mortgage Loans or the RMBS is insured or guaranteed by the United States, any governmental agency or instrumentality, or any other person.

CDO Securities. The Collateral Assets include 19 whole and partial classes of CDO Securities, representing 8.2% of the principal balance of the Collateral Assets as of the Reference Date. Each of the CDO Securities are debt securities issued by a special purpose issuer, all of the assets of which are pledged to repay the CDO Securities and other classes of securities issued by such issuer. Certain of the CDO Securities provide for a revolving period during which certain proceeds of the underlying assets are reinvested in additional assets, and for a lockout period during which the CDO Securities will be redeemed or receive principal payments only in limited circumstances. While the classes of CDO Securities included in the Collateral Assets are each rated investment grade as of the date hereof, certain of the CDO Securities are subordinate in right of payment and rank junior to other securities in the same issuance, and all of the CDO Securities are senior to other more subordinate securities of the same issuance. Ten (10) of the classes of CDO Securities included in the Collateral Assets provide for the deferral of interest under certain circumstances and the failure to pay current interest on such classes of CDO Securities generally will not be an event of default so long as any more senior classes of securities are outstanding. The deferral of interest payments, if it occurs, would adversely affect the cash flow available to the Issuer. The CMBS and RMBS underlying certain of the CDO Securities have characteristics similar to the characteristics of the CMBS and RMBS described herein.

Asset-Backed Securities. The Collateral Assets include 3 partial classes of Asset-Backed Securities, representing approximately 0.7% of the principal balance of the Collateral Assets as of the Reference Date.

The Coverage Tests will be used primarily to determine whether interest may be paid on the Class C Notes, the Class D Notes and the Class E Notes and whether Proceeds will be distributed to the Holders of the Preferred Shares, and whether Proceeds must be used to make mandatory redemptions of the Class A-1LT-a Notes, the Class A-1LT-b Notes, the Class A-2 Notes, the Class B Notes, the Class C Notes and the Class D Notes and to Defeas the CP Notes. See "Description of the Securities—Principal" and "—Priority of Payments." The Coverage Tests will consist of the Class A/B Overcollateralization Test, the Class A/B Interest Coverage Test, the Class C Overcollateralization Test, the Class C Interest Coverage Test, the Class D Overcollateralization Test and the Class D Interest Coverage Test. For purposes of the Coverage Tests, (i) the calculation of the Class A/B Overcollateralization Ratio, the Class C Overcollateralization Ratio and the Class D Overcollateralization Ratio on any Determination Date that such Coverage Test is applicable shall be made by giving effect to all payments scheduled or expected to be made pursuant to the Priority of Payments on the Payment Date following such Determination Date, and (ii) the calculation of the Class A/B Interest Coverage Ratio, the Class C Interest Coverage Ratio and the Class D Interest Coverage Ratio on any Determination Date that such Coverage Test is applicable shall be made without giving effect to payments scheduled or expected to be made pursuant to the Priority of Payments on the Payment Date following such Determination Date. For purposes of each of the Class A/B Overcollateralization Test, the Class C Overcollateralization Test and the Class D Overcollateralization Test, notwithstanding the definition of Principal Balance contained herein, the Principal Balance of any security that is not currently paying cash interest (excluding any security that is, in accordance with its terms, making payments due thereon "in kind") shall be the accreted value of such security as of the date on which it was purchased by the Issuer; provided, that such accreted value shall not exceed the par amount of such security.

The "Class A/B Overcollateralization Ratio" as of any Determination Date will equal the ratio (expressed as a percentage) obtained by dividing (i) the Net Outstanding Portfolio Collateral Balance on such Determination Date (provided that such amount shall exclude Principal Proceeds held as cash and Eligible Investments) by (ii) the sum of the aggregate outstanding principal amount of the CP Notes, the Class A Notes and the Class B Notes *minus* any amount deposited in the CP Principal Reserve Account to Defeas the CP Notes, *minus* Principal Proceeds expected to be available prior to clause (xiii) of the Priority of Payments on the related Payment Date assuming that the Coverage Tests are satisfied, (excluding, without duplication, Principal Proceeds required to be deposited in the CP Interest Reserve Account).

The "Class A/B Overcollateralization Test" will be satisfied on any Determination Date on which any CP Notes, Class A Notes or Class B Notes remain outstanding if the Class A/B Overcollateralization Ratio on such Determination Date is equal to or greater than 102.0%. As of the Closing Date, the Class A/B Overcollateralization Ratio is expected to be equal to 104.4%.

The Class A/B Interest Coverage Test

CP Interest Reserve Account from the Cashflow Swap Counterparty) less any amounts scheduled to be paid to any Hedge Counterparty (including amounts payable to the Cashflow Swap Counterparty relating to any unreimbursed Interim Cashflow Swap Payments that are not paid out of the CP Interest Reserve Account) (in each case, other than termination payments and termination receipts related to such Hedge Agreements), *minus* (d) the excess of amounts expected to be paid on the related Payment Date under clauses (i), (ii), (iii) and (v) of the Priority of Payments over amounts on deposit in the Expense Reserve Account on the Determination Date; by

(B) an amount not less than U.S.\$1.00 equal to the sum of (a) the interest payments due on the Class A Notes and the Class B Notes, on the related Payment Date, (b) the aggregate interest due and payable on CP Notes from but excluding the prior Payment Date to and including the current Payment Date (which will not include discounts on CP Notes), (c) any CP Put Premium and any CP Note Placement Agent Fees (excluding any such amounts paid as discount on CP Notes) due on such Payment Date and (d) without duplication the CP Interest Reserve Deposit Amount in Interest less any CP Interest Reserve Interest Release Amount excluding any net payments from the CP Interest Reserve Account to the Cashflow Swap Counterparty.

For purposes of calculating the Class A/B Interest Coverage Ratio, amounts scheduled to be received under any Hedge Agreement which the Issuer or the Collateral Manager reasonably expects will not be received during the applicable Due Period will not be included; provided that notice of such amounts must be provided to the Trustee on or before the Determination Date.

The Class C Overcollateralization Test

The "Class C Overcollateralization Ratio" as of any Determination Date will equal the ratio (expressed as a percentage) obtained by dividing (i) the Net Outstanding Portfolio Collateral Balance on such Determination Date (provided that such amount shall exclude Principal Proceeds held as cash and Eligible Investments) by (ii) the sum of the aggregate outstanding principal amount of the CP Notes and the Notes (other than the Class D Notes and the Class E Notes and including Class C Deferred Interest), *minus* Principal Proceeds expected to be available prior to clause (xiii) of the Priority of Payments on the related Payment Date assuming that the Coverage Tests are satisfied (excluding, without duplication, Principal Proceeds required to be deposited in the CP Interest Reserve Account).

The "Class C Overcollateralization Test" will be satisfied on any Determination Date on which any Class C Notes remain outstanding if the Class C Overcollateralization Ratio on such Determination Date is equal to or greater than 100.5%. As of the Closing Date, the Class C Overcollateralization Ratio is expected to be equal to 102.2%.

Class C Interest Coverage Test

The "Class C Interest Coverage Test" will be satisfied as of any Determination Date if the Class C Interest Coverage Ratio is equal to or greater than 102.0%. As of the Closing Date, the Class C Interest Coverage Ratio is expected to be equal to 105.4%.

The "Class C Interest Coverage Ratio" as of any Determination Date will equal the ratio (expressed as a percentage) obtained by dividing:

(A) the sum of (a) the cash interest payments (or any purchase discount in the case of Eligible Investments) received in the related Due Period on the Collateral Assets and the Eligible Investments (other than Defaulted Obligations and Deferred Interest PIK Bonds) held in any of the Accounts, *plus* (b) prepayment premiums received, *plus* (c) without duplication, amounts scheduled to be received by the Issuer from any Hedge Counterparty under any Hedge Agreement (excluding any net payments into the CP Interest Reserve Account from the Cashflow Swap Counterparty) less any amounts

scheduled to be paid to any Hedge Counterparty (including amounts payable to the Cashflow Swap Counterparty relating to any unreimbursed Interim Cashflow Swap Payments that are not paid out of the CP Interest Reserve Account) (in each case, other than termination payments and termination receipts related to such Hedge Agreements), *minus* (d) the excess of amounts expected to be paid on the related Payment Date under clauses (i), (ii), (iii) and (v) of the Priority of Payments over amounts on deposit in the Expense Reserve Account on the Determination Date; by

(B) an amount not less than U.S.\$1.00 equal to the sum of (a) interest payments due on the Class A Notes, Class B Notes and Class C Notes on the related Payment Date, (b) the aggregate interest due and payable on CP Notes from but excluding the prior Payment Date to and including the current Payment Date (which will not include discounts on CP Notes), (c) any CP Put Premium and any CP Note Placement Agent Fees (excluding any such amounts paid as discount on CP Notes) due on such Payment Date and (d) without duplication the CP Interest Reserve Deposit Amount in Interest less any CP Interest Reserve Interest Release Amount excluding any net payments from the CP Interest Reserve Account to the Cashflow Swap Counterparty.

For purposes of calculating the Class C Interest Coverage Ratio amounts scheduled to be received under any Hedge Agreement which the Issuer or the Collateral Manager reasonably expects will not be received during the applicable Due Period will not be included, provided that notice of such amounts must be provided to the Trustee on or before the Determination Date, and interest scheduled to be paid on the Class C Notes on the related Payment Date shall be considered due even if all or a portion of such interest shall become Class C Deferred Interest on such Payment Date.

The Class D Overcollateralization Test

The "Class D Overcollateralization Ratio" as of any Determination Date will equal the ratio (expressed as a percentage) obtained by dividing (i) the Net Outstanding Portfolio Collateral Balance on such Determination Date (provided that such amount shall exclude Principal Proceeds held as cash and Eligible Investments) by (ii) the sum of the aggregate outstanding principal amount of the CP Notes and the Notes (other than the Class E Notes and including Class C Deferred Interest and Class D Deferred Interest), *minus* Principal Proceeds expected to be available prior to clause (xiii) of the Priority of Payments on the related Payment Date assuming that the Coverage Tests are satisfied (excluding, without duplication, Principal Proceeds required to be deposited in the CP Interest Reserve Account).

The "Class D Overcollateralization Test" will be satisfied on any Determination Date on which any Class D Notes remain outstanding if the Class D Overcollateralization Ratio on such Determination Date is equal to or greater than 100.3%. As of the Closing Date, the Class D Overcollateralization Ratio is expected to be equal to 100.6%.

Class D Interest Coverage Test

The "Class D Interest Coverage Test" will be satisfied as of any Determination Date if the Class D Interest Coverage Ratio is equal to or greater than 101.0%. As of the Closing Date, the Class D Interest Coverage Ratio is expected to be equal to 102.7%.

The "Class D Interest Coverage Ratio" as of any Determination Date will equal the ratio (expressed as a percentage) obtained by dividing:

(A) the sum of (a) the cash interest payments (or any purchase discount in the case of Eligible Investments) received in the related Due Period on the Collateral Assets and the Eligible Investments (other than Defaulted Obligations and Deferred Interest PIK Bonds) held in any of the Accounts, *plus* (b) prepayment premiums received, *plus* (c) without duplication, amounts scheduled to be received by the Issuer from any Hedge Counterparty under any Hedge Agreement (excluding any net payments into the

CP Interest Reserve Account from the Cashflow Swap Counterparty) less any amounts scheduled to be paid to any Hedge Counterparty (including amounts payable to the Cashflow Swap Counterparty relating to any unreimbursed Interim Cashflow Swap Payments that are not paid out of the CP Interest Reserve Account) (in each case, other than termination payments and termination receipts related to such Hedge Agreements), *minus* (d) the excess of amounts expected to be paid on the related Payment Date under clauses (i), (ii), (iii) and (v) of the Priority of Payments over amounts on deposit in the Expense Reserve Account on the Determination Date; by

(B) an amount not less than U.S.\$1.00 equal to the sum of (a) interest payments due on the Class A Notes, Class B Notes, Class C Notes and Class D Notes on the related Payment Date, (b) the aggregate interest due and payable on CP Notes from but excluding the prior Payment Date to and including the current Payment Date (which will not include discounts on CP Notes), (c) any CP Put Premium and any CP Note Placement Agent Fees (excluding any such amounts paid as discount on CP Notes) due on such Payment Date and (d) without duplication the CP Interest Reserve Deposit Amount in Interest less any CP Interest Reserve Interest Release Amount excluding any net payments from the CP Interest Reserve Account to the Cashflow Swap Counterparty.

For purposes of calculating the Class D Interest Coverage Ratio amounts scheduled to be received under any Hedge Agreement which the Issuer or the Collateral Manager reasonably expects will not be received during the applicable Due Period will not be included, *provided* that notice of such amounts must be provided to the Trustee on or before the Determination Date, and interest scheduled to be paid on the Class C Notes and the Class D Notes on the related Payment Date shall be considered due even if all or a portion of such interest shall become Class C Deferred Interest or Class D Deferred Interest on such Payment Date.

Disposition of Collateral Assets

The Collateral Assets may be retired prior to their respective final maturities due to, among other things, the existence and frequency of exercise of any optional or mandatory redemption features of such Collateral Assets. In addition, pursuant to the Indenture and subject to the restrictions contained therein, so long as no Event of Default has occurred and is continuing, the Collateral Manager may direct the Issuer to sell Credit Risk Obligation, Defaulted Obligation or equity securities. The sale price for any such disposition of a Collateral Asset will equal the fair market value of such Collateral Asset. The fair market value of any such Collateral Asset will be the highest bid received by the Collateral Manager after attempting to solicit a bid from up to three independent third parties making a market in such Collateral Assets, at least one of which is not from the Collateral Manager or an affiliate thereof; *provided* that, if upon commercially reasonable efforts of the Collateral Manager, bids from three independent third parties making a market in such Collateral Assets are not available, the higher of the bids from two such third parties may be used; *provided, further* that, if upon commercially reasonable efforts of the Collateral Manager, bids from two independent third parties making a market in such Collateral Assets are not available, one such bid may be used so long as it is not from the Collateral Manager. The proceeds from any such sale of Collateral Assets will be applied as Principal Proceeds on the next succeeding Payment Date. A "Credit Risk Obligation" is a Collateral Asset (i) the rating of which has been downgraded, qualified or withdrawn by any Rating Agency or has been put on "negative credit watch" or similar status for possible downgrading, qualification or withdrawal from the ratings that were in place as of the date the Issuer purchased such Collateral Asset and in respect of which the Collateral Manager believes that, since such Collateral Asset was purchased by the Issuer, it has a material risk of declining in credit quality or, with a lapse of time, a risk of becoming a Defaulted Obligation, (ii) that bears interest at a fixed rate which the Collateral Manager believes has become under hedged and in respect of which the Collateral Manager believes that, since such Collateral Asset was purchased by the Issuer, has a material risk of declining in credit quality or, with a lapse of time, a risk of becoming a Defaulted Obligation or (iii) in respect of which the Collateral Manager believes that, since such Collateral Asset was purchased by the Issuer, it has a material risk of declining in credit quality or, with a lapse of time, a risk of becoming a Defaulted Obligation. The proceeds from the disposition of a Collateral Asset may not be reinvested in other Collateral Assets.

The Issuer may also (i) in the case of an Auction, at the direction of the Collateral Manager, direct the Trustee to sell, and the Trustee shall sell in the manner directed by the Collateral Manager in writing, the Collateral Assets and liquidate the remaining Collateral in connection with an Auction; *provided*, that the criteria for an Auction can be demonstrably met prior to any such sale and that the expected Liquidation Proceeds equal or exceed the Minimum Bid Amount; (ii) in the case of a Tax Redemption, at the direction, or with the consent, of the Collateral Manager on any Payment Date, direct the Trustee to sell, and the Trustee shall sell in the manner directed by the Collateral Manager in writing, the Collateral Assets and liquidate the remaining Collateral in connection with a Tax Redemption; *provided* that the criteria for a Tax Redemption can be demonstrably met prior to any such sale and that the expected Liquidation Proceeds equal or exceed the Total Redemption Amount; and (iii) in the case of an Optional Redemption, at the direction of the Collateral Manager, direct the Trustee to sell, and the Trustee shall sell in the manner directed by the Collateral Manager in writing, the Collateral Assets and liquidate the remaining Collateral in connection with an Optional Redemption; *provided* that the criteria for an Optional Redemption can be demonstrably met prior to any such sale and that the expected Liquidation Proceeds equal or exceed the Total Redemption Amount. See "Description of the Securities—Auction," "—Tax Redemption" and "—Optional Redemption."

Accounts

Pursuant to the Indenture, the Issuer shall cause there to be opened and at all times maintained the Collection Account, the Payment Account, the Expense Reserve Account, the Collateral Account, the CP Interest Reserve Account, the CP Principal Reserve Account, the CP Put Collateral Account, the Hedge Termination Receipts Account, the Hedge Replacement Account and the Hedge Collateral Account (each as hereinafter defined), each of which shall be a segregated account or sub-account established with the Securities Intermediary in the name of the Trustee for the benefit of the Secured Parties as further described in the Indenture. Each Account is required to be maintained by the Trustee or by another financial institution that is an Eligible Depository.

All distributions on the Collateral Assets and any proceeds received from the disposition of any Collateral Assets, all net proceeds from, and associated with the issuance of the Notes, the Class X Notes, the CP Notes and the Preferred Shares not used on the Closing Date to purchase Collateral Assets, to pay for expenses, to enter into Hedge Agreements, the initial payment pursuant to the Rate Swap Agreement, any Hedge Receipt Amounts received prior to the Business Day prior to a Payment Date and any other amounts transferred to the Collection Account from other Accounts as provided for in the Indenture will be remitted to an account (the "Collection Account") and will be available, together with reinvestment earnings thereon, for application in accordance with the Priority of Payments. On any date on which funds on deposit in the CP Interest Reserve Account are insufficient to pay amounts coming due on maturing CP Notes, after taking into account funds on deposit in the CP Principal Reserve Account and the CP Interest Reserve Account, the Trustee shall transfer to the CP Interest Reserve Account from the Collection Account (to the extent of funds on deposit therein) the shortfall amount necessary to pay such maturing CP Notes in full, first, from available Principal Proceeds and second, from available Interest Proceeds.

On the Business Day prior to each Payment Date other than a Final Payment Date (the "Transfer Date"), the Trustee will deposit into a separate account (the "Payment Account") all funds (including any reinvestment income) in the Collection Account (to the extent received prior to the end of the related Due Period) and any Hedge Receipt Amount received on the Transfer Date related to such Payment Date for application in accordance with the Priority of Payments.

Principal Proceeds shall be deposited in the Collection Account and applied in accordance with the Priority of Payments.

On the Closing Date, U.S.\$200,000 from the net proceeds of the offering of the Securities will be deposited by the Trustee into a single, segregated account established and maintained by the Trustee under the Indenture (the "Expense Reserve Account"). On each Payment Date, to the extent that funds are available for such purpose in accordance with and subject to the limitations of the Priority of

Payments, the Trustee will deposit into the Expense Reserve Account an amount from Proceeds such that the amount on deposit in the Expense Reserve Account (after giving effect to such deposit) will equal U.S.\$275,000. Amounts on deposit in the Expense Reserve Account may be withdrawn from time to time to pay accrued and unpaid Administrative Expenses of the Issuers. With respect to the first Payment Date, funds on deposit in the Expense Reserve Account in excess of U.S.\$275,000 will be transferred by the Trustee to the Payment Account for application as interest proceeds. All funds on deposit in the Expense Reserve Account at the time when substantially all of the Issuer's assets have been sold or otherwise disposed of will be transferred by the Trustee to the Payment Account for application as Proceeds on the immediately succeeding Payment Date.

On or prior to the Closing Date, pursuant to the terms of the Indenture, the Trustee will establish the CP Interest Reserve Account (the "CP Interest Reserve Account") and the CP principal reserve account (the "CP Principal Reserve Account" and, together with the CP Interest Reserve Account, the "CP Reserve Accounts"). The Trustee shall, from time to time, withdraw amounts from the CP Reserve Accounts for use by the CP Issuing and Paying Agent to make payments on maturing CP Notes pursuant to the CP Issuing and Paying Agency Agreement. If on any Determination Date, the Trustee determines that amounts expected to be on deposit in the CP Interest Reserve Account on the related Interim Payment Date, taking into account amounts expected to be withdrawn from and deposited to such account on such Payment Date, exceed the CP Interest Reserve Required Amount, such excess amount will be transferred to the Payment Account on the related Transfer Date for distribution as interest or principal proceeds in accordance with the Priority of Payments on such Payment Date. On any Interim Payment Date, after the payment of the Interim Issuer Cashflow Payments to the Cashflow Swap Counterparty, the CP Interest Reserve Interest Release Amount and the CP Interest Reserve Principal Release Amount, to the extent available, will be deposited to the Collection Account from the CP Interest Reserve Account and will be treated as Interest Proceeds or Principal Proceeds, as applicable. The Trustee shall transfer all amounts and deposit all amounts required to be deposited in the CP Reserve Accounts in accordance with the Priority of Payments and the CP Put Agreement. Withdrawals from the CP Reserve Accounts will be made in accordance with the CP Issuing and Paying Agency Agreement and not in accordance with the Priority of Payments.

In the event any Hedge Counterparty fails to maintain the ratings required under the Hedge Agreement, such Hedge Counterparty will be required to (i) post collateral under the terms of the related Hedge Agreement; (ii) transfer its rights and obligations to a replacement Hedge Counterparty having the required ratings in accordance with the related Hedge Agreement subject to satisfaction of the Rating Agency Condition; (iii) obtain a guarantor for such Hedge Counterparty's obligations meeting the ratings requirements set forth in the related Hedge Agreement; or (iv) take such other steps as each Rating Agency may require. The Hedge Collateral pledged by such Hedge Counterparty will be deposited by the Trustee into a segregated account (the "Hedge Collateral Account") established in the name of the Trustee and held therein pursuant to the terms of the related Hedge Agreement. Each item of collateral deposited in the Hedge Collateral Account will be deposited in a separate subaccount relating to the Hedge Agreement for which the related Hedge Counterparty has pledged such collateral.

Amounts retained in the Accounts during a Due Period will be invested in Eligible Investments.

Reports

A report will be made available to the Holders of the Notes and Holders of the Preferred Shares and will provide information on the Collateral Assets as well as information with respect to payments made on the related Payment Date (each, a "Note Valuation Report"), beginning in January 2006.

The information in each Payment Report will be prepared as of the Determination Date preceding the related Payment Date and will set out, among other things, the amounts payable in accordance with the Priority of Payments on such Payment Date. The Issuer will instruct the Trustee to transfer the amounts set forth in such Payment Report in the manner specified in, and in accordance with, the Priority of Payments. As long as any Notes are listed on any stock exchange, the Payment Reports will be obtainable at the office of the Listing and Paying Agent.

Hedge Agreements

General. From time to time the Issuer will enter into one or more Rate Swap Agreements or Cashflow Swap Agreements (collectively, "Hedge Agreements") in order to protect against interest rate risk, mismatches in the timing of cash flows received from the Collateral Assets and the Payment Dates on the Notes and maturing CP Notes during certain periods. On the Closing Date, the Issuer will enter into a Rate Swap Agreement and a Cashflow Swap Agreement with AIG Financial Products Corp. ("AIG FP") as initial Cashflow Swap Counterparty and initial Interest Rate Swap Counterparty. The Issuer will receive an aggregate initial payment on the Closing Date of approximately U.S.\$10,357,000 from AIG FP under the initial Hedge Agreements. The Issuer shall not enter into any additional Rate Swap Agreements or Cashflow Swap Agreements without obtaining the consent of AIG FP (which consent shall not be unreasonably withheld) and subject to certain other restrictions specified in the initial Rate Swap Agreements and initial Cashflow Swap Agreement, as applicable, as long as AIG FP remains a Hedge Counterparty, and unless the Rating Agency Condition is satisfied.

The Issuer shall ensure that each Hedge Agreement shall provide that (i) the Issuer will have the option to terminate any Hedge Agreement without cause, in whole or in part, at any time upon payment (or receipt) of the termination price quoted by such Hedge Counterparty and upon satisfaction of the Rating Agency Condition, (ii) the Hedge Counterparty will agree (a) that the Issuer's obligations under the Hedge Agreements are limited recourse obligations of the Issuer payable solely from the Collateral and subordinated as set forth in the Priority of Payments and (b) to a standard non-petition clause, and (iii) such Hedge Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.

Payments (other than Defaulted Hedge Termination Payments) due to any Hedge Counterparty under any Hedge Agreement shall be paid, in accordance with the Priority of Payments, prior to any payments on the Securities, from Proceeds available therefor on each Payment Date. The claims of each Hedge Counterparty shall rank equally and *pari passu* with the claims of other Hedge Counterparties entitled to receive payments at the same level of priority within the Priority of Payments. Defaulted Hedge Termination Payments shall be paid after payment of Principal Proceeds to the Notes in accordance with the Priority of Payments.

The initial Hedge Agreements entered into between the Issuer and AIG FP on the Closing Date shall generally provide that if (A)(i) the long-term senior unsecured debt rating from S&P of American International Group, Inc. (the "Credit Support Provider") falls below "A+" or no such long-term rating from S&P exists and (ii) the short-term rating of the Credit Support Provider falls below "A-1" or no such short-term rating from S&P exists, (B) the long-term senior unsecured debt rating from Moody's of the Credit Support Provider falls to "Aa3" (and is on credit watch for possible downgrade) or below "Aa3" if the Credit Support Provider has no short-term rating or (C) the long-term senior unsecured debt rating of the Credit Support Provider from Moody's falls to "A1" (and is on credit watch for possible downgrade) or below "A1" or the short-term senior unsecured debt rating of the Hedge Counterparty or, if no such rating is available, the Credit Support Provider or, if no such rating is available, a guaranteed affiliate thereof (whose rating is based solely upon the support of the Credit Support Provider) from Moody's, if so rated by Moody's, falls to "P-1" (and is on credit watch for possible downgrade) or below "P-1" (any such event, a "Collateralization Event"), then the Hedge Counterparty shall generally be required to within 30 days, (i) provide sufficient collateral as required under the Hedge Agreement, (ii) transfer its rights and obligations upon 10 days prior notice to a replacement Hedge Counterparty who satisfies the Hedge Counterparty Ratings Requirement, *provided* that (1) the Rating Agency Condition is satisfied and (2) certain other requirements set forth in the Hedge Agreement are satisfied, (iii) obtain a guarantor for the Hedge Counterparty's obligations under the Hedge Agreement who satisfies the Hedge Counterparty Ratings Requirement, or (iv) take such other steps to allow the Issuer (as confirmed by the Collateral Manager in writing) to satisfy conditions of the Rating Agencies. If the Hedge Counterparty fails to comply with at least one of the obligations as set forth in clauses (i)-(iv) of the preceding sentence, or if certain further downgrades occur, a substitution event shall have occurred (a "Hedge Substitution Event"). Upon the occurrence of a Hedge Substitution Event, the Hedge Counterparty will generally be required to assign its rights and obligations under such Hedge Agreement to a new Hedge Counterparty in accordance with the terms of the Hedge Agreement, provided that such substitute Hedge Counterparty or

its guarantor satisfies the Hedge Counterparty Ratings Requirement and the Rating Agency Condition is satisfied with respect to such assignment. Parallel collateralization events and substitution events in Hedge Agreements entered into after the Closing Date, if any, will comply with the requirements set forth in the Indenture and may differ significantly from the foregoing.

Each Hedge Agreement may be terminated, whether or not the Notes have been paid in full on or prior to such termination, upon, among other things, (i) certain events of bankruptcy, insolvency, conservatorship, receivership or reorganization of the Issuer or the related Hedge Counterparty, (ii) failure on the part of the Issuer or the related Hedge Counterparty to make any payment under the Hedge Agreement within the applicable grace period, (iii) certain withholding or other taxes being imposed on payments to be made under the Hedge Agreement as set forth in Sections 5(b)(ii) and (iii) of the ISDA Master Agreement incorporated in the Hedge Agreement, (iv) a change in law making it illegal for either the Issuer or the related Hedge Counterparty to be a party to, or perform an obligation under, the Hedge Agreement or (v) the declaration of acceleration following an Event of Default under the Indenture which cannot be rescinded or annulled.

A termination of a Hedge Agreement will not constitute an Event of Default under the Indenture. Although the Issuer believes that any such termination is unlikely, the Issuer has agreed to use reasonable efforts to enter into a substitute Hedge Agreement on similar terms to the extent that the Issuer is able to enter into such an agreement, and shall apply any termination receipts to the purchase of a new Hedge Agreement. If the Issuer is unable to obtain a substitute Hedge Agreement, interest due on the Notes will be paid from amounts received on the Collateral Assets without the benefit of any Hedge Agreement. There can be no assurance that such amounts will be sufficient to provide for the full payment of interest on the Notes, or that amounts that would otherwise be distributable to the Holders of the Preferred Shares and the Class X Notes will not be reduced.

In the event of any early termination of a Hedge Agreement (i) any hedge termination receipts paid to the Issuer and not concurrently applied in connection with the Issuer's entering into a replacement Hedge Agreement will be deposited in a single, segregated trust account held in the name of the Trustee (the "Hedge Termination Receipts Account") for the benefit of the Secured Parties and (ii) any amounts received by the Issuer from a replacement counterparty in consideration for entering into a substantially similar replacement agreement that preserves for the Issuer the economic equivalent of the terminated Hedge Agreement ("Hedge Replacement Proceeds") will be deposited in a single, segregated trust account held in the United States in the name of the Trustee (the "Hedge Replacement Account") for the benefit of the Secured Parties.

The Collateral Manager may cause the Issuer, promptly following the early termination of a Hedge Agreement (other than with respect to a Final Payment Date) and to the extent possible through application of funds available in the Hedge Termination Receipts Account, to enter into a replacement Hedge Agreement (a "Replacement Hedge Agreement") which may have different terms, including different notional amounts, *provided* that the Rating Agency Condition is satisfied.

If (i) the funds available in the Hedge Termination Receipts Account exceed the costs of entering into a Replacement Hedge Agreement, (ii) the Collateral Manager determines not to replace the terminated Hedge Agreement and the Rating Agency Condition is satisfied, or (iii) the termination is occurring with respect to a Final Payment Date, then amounts in the Hedge Termination Receipts Account (after providing for the costs of entering into a Replacement Hedge Agreement, if any) will be transferred to the Collection Account on the next following Transfer Date and will be treated as Principal Proceeds and distributed in accordance with the Priority of Payments on the next Payment Date (or on such Final Payment Date, in the event the Notes and the Class X Notes are redeemed and the CP Notes are defeased in full thereon).

If a Hedge Agreement is terminated and the costs of entering into a Replacement Hedge Agreement exceed the funds on deposit and available therefor in the Hedge Termination Receipts Account, then, after using the funds in the Hedge Termination Receipts Account, the Issuer may enter into a Replacement Hedge Agreement with the amount of such shortfall payable to the replacement Hedge Counterparty in accordance with the Priority of Payments on following Payment Dates.

The amounts in the Hedge Replacement Account will be applied directly to the payment of termination amounts owing to the Hedge Counterparties, if any. To the extent not fully paid from Hedge Replacement Proceeds, such amounts will be payable to the Hedge Counterparties on subsequent Payment Dates in accordance with the Priority of Payments. To the extent that the funds available in the Hedge Replacement Account exceed any such termination amounts (or if there are no termination amounts), the excess amounts in the Hedge Replacement Account will be transferred to the Collection Account on the next Transfer Date and will be treated as Principal Proceeds and distributed in accordance with the Priority of Payments on the next Payment Date. If the termination amounts owing to Hedge Counterparties exceed the Hedge Replacement Proceeds for such agreements, then, unless such amounts represent Defaulted Hedge Termination Payments, they will be paid before funds are applied to pay principal or interest on any Notes in accordance with the Priority of Payments.

In order to effect an Optional Redemption or Tax Redemption, Auction or liquidation of the Collateral following an Event of Default, the Hedge Agreements must be terminated and the proceeds from such termination and from the liquidation of the remaining Collateral must be sufficient to pay any termination payment owing to the Hedge Counterparties in addition to any amounts owing under the Securities and certain other expenses. The Indenture will not permit the termination of a Hedge Agreement in connection with the liquidation of Collateral following an Optional Redemption, Tax Redemption or Auction or Event of Default prior to the time that the Collateral Manager shall have furnished to the Trustee evidence that the Issuer has entered into one or more binding agreements with purchasers whose short term debt obligations are rated at least "P-1" by Moody's and "A-1+" by S&P, to purchase such Collateral on a date not later than 10 days after such termination and that such redemption or liquidation is non-revocable.

The Issuer may not terminate any Hedge Agreement without satisfaction of the Rating Agency Condition.

Each Hedge Agreement (other than with respect to the initial Hedge Counterparty) will provide that a Hedge Counterparty, with the consent of the Collateral Manager (on behalf of the Issuer) (such consent not to be unreasonably withheld), may assign its obligations under a Hedge Agreement to any institution which satisfies the Rating Agency Condition with respect to such assignment; *provided* that the Hedge Counterparty may assign its obligations to an affiliate in accordance with the Hedge Agreement without satisfaction of the Rating Agency Condition or consent of the Issuer, but with prior notice to the Rating Agencies, *provided* that such affiliate has the higher ratings required in accordance with the terms of the Hedge Agreement.

In connection with the Mandatory Redemption, the Hedge Counterparty may terminate a portion of any Hedge Agreement in accordance with the terms thereof upon satisfaction of the Rating Agency Condition.

The initial Interest Rate Swap Counterparty and the initial Cashflow Swap Counterparty is AIG Financial Products Corp. Affiliates of the Initial Purchaser or the Collateral Manager may also act as Hedge Counterparties from time to time, which may create certain conflicts of interest. See "Risk Factors—Other Considerations—Certain Conflicts of Interest."

The Hedge Counterparty ratings requirements and the required consents and actions described herein are subject to modification prior to the Closing Date, and may be revised thereafter upon satisfaction of the Rating Agency Condition. The description of the provisions of the Hedge Agreements herein may vary from Hedge Agreements entered into by the Issuer after the Closing Date.

Rate Swap Agreements. As of the Closing Date, the Issuer will enter into a Rate Swap Agreement with AIG FP as initial Interest Rate Swap Counterparty that will provide for the Issuer to pay the initial Interest Rate Swap Counterparty an amount equal to 5.667% per annum from the February 2006 Payment Date in exchange for payments equal to LIBOR on an initial notional amount of U.S.\$304,000,000. After the Closing Date, the Issuer may enter into additional Rate Swap Agreements with AIG FP or other counterparties (each, an "Interest Rate Swap Counterparty") which may consist of interest rate swaps and/or interest rate caps.

Pursuant to any additional Rate Swap Agreements that are interest rate swap agreements, the Issuer will generally agree to pay to the Interest Rate Swap Counterparty an amount equal to interest on the notional amount at a fixed interest rate specified therein and the Interest Rate Swap Counterparty will agree to pay the Issuer an amount equal to interest on the notional amount at LIBOR. The Issuer may also enter into offsetting Rate Swap Agreements, subject to satisfaction of the Rating Agency Condition, pursuant to which the Interest Rate Swap Counterparty will agree to pay to the Issuer an amount equal to interest on the notional amount at a fixed interest rate specified therein and the Issuer will agree to pay the Interest Rate Swap Counterparty an amount equal to interest on the notional amount at LIBOR. Only a single net payment will be made under a Rate Swap Agreement with respect to each Payment Date.

Pursuant to any additional Rate Swap Agreements that are interest rate cap agreements, the Interest Rate Swap Counterparty will agree to pay to the Issuer with respect to each interest rate cap payment date an amount equal to the excess, if any, of LIBOR over a fixed strike rate on a notional amount. The Issuer will make a single fixed payment to the Interest Rate Swap Counterparty at the beginning of such transaction or a series of fixed payments to the Interest Rate Swap Counterparty on two or more Payment Dates.

The Issuer has agreed to enter into Rate Swap Agreements in notional amounts based on amortization schedules derived from the anticipated amortization as reasonably determined by the Collateral Manager of those Collateral Assets that bear interest at a fixed rate that the Issuer expects to own as of the Closing Date. The amortization schedules will be designed by the Collateral Manager such that on the Closing Date and thereafter on each Determination Date, the aggregate notional amount under such Rate Swap Agreements will be slightly less than (i) the outstanding scheduled principal amount of the Notes scheduled to be outstanding on such date less (ii) the outstanding principal amount of Collateral Assets that pay interest pursuant to a floating rate on such date. However, there can be no assurance that the actual amortization of the Collateral Assets will correspond to the anticipated amortization on which the Rate Swap Agreements will be based.

Cashflow Swap Agreements. As of the Closing Date, the Issuer will enter into a Cashflow Swap Agreement with AIG FP and may from time to time enter into additional Cashflow Swap Agreements (each, a "Cashflow Swap Agreement") with AIG FP or other counterparties (each, a "Cashflow Swap Counterparty"), in order to manage mismatches between the timing of payment receipts on the Collateral Assets and Eligible Investments and the timing of payments due on Payment Dates in accordance with the Priority of Payments. In a Cashflow Swap Agreement, the Issuer will receive a payment from a Cashflow Swap Counterparty on dates relating to each Interim Payment Date and each Payment Date in exchange for the Issuer's obligations to make payments to the Cashflow Swap Counterparty, relating to interest payments on Collateral Assets which pay less frequently than monthly, out of Proceeds to the extent available in accordance with the Priority of Payments. The Cashflow Swap Agreement will be reduced automatically for any Collateral Assets which prepay or default or which are sold and will be increased for any Collateral Assets which are purchased.

In addition to the foregoing, the Issuer will enter into a Cashflow Swap Agreement with AIG FP (the "Cashflow Swap Counterparty") which, together with proceeds deposited to the CP Interest Reserve Account directly by the Issuer on Payment Dates and Interim Payment Dates and amounts deposited to the CP Interest Reserve Account from the Collection Account, will provide a reserve for the CP Notes (the "CP Interest Reserve Facility"). Any discount on the CP Notes issued on the Closing Date will be funded through the Cashflow Swap Agreement. Under the CP Interest Reserve Facility, on each Payment Date in accordance with the Priority of Payments and on each Interim Payment Date, the Issuer will be required to transfer to the CP Interest Reserve Account, first, from available Principal Proceeds and second, from available Interest Proceeds, an amount (subject to certain limitations) equal to the CP Interest Reserve Deposit Amount. If, on any Interim Payment Date, amounts on deposit in the CP Interest Reserve Account, after taking into account the CP Interest Reserve Deposit Amount to be deposited thereto by the Issuer, are less than the CP Interest Reserve Required Amount, the Cashflow Swap Counterparty will be required to fund the Interim Cashflow Swap Payment on each Interim Payment Date. The Cashflow Swap Counterparty will not be required to make cumulative net payments (including all accrued and unpaid interest) to the Issuer in excess of the Cashflow Swap Capped Amount *minus* the

balance of the Cashflow Swap Agreement due to AIG FP. If AIG FP fails to pay such amount, funds otherwise available to make payments to AIG FP will instead be used to pay amounts to the CP Interest Reserve Account as required. To the extent funds are available for such purpose and after the payment of certain amounts, the Issuer will pay to AIG FP on each Payment Date the equivalent amount of unreimbursed Interim Cashflow Swap Payments as of such Payment Date.

In addition, on any date on which funds on deposit in the CP Interest Reserve Account are insufficient to pay amounts coming due on maturing CP Notes, after taking into account funds on deposit in the CP Principal Reserve Account and the CP Interest Reserve Account, the Trustee shall transfer to the CP Interest Reserve Account from the Collection Account the shortfall amount necessary to pay such maturing CP Notes in full.

On each Payment Date and Interim Payment Date, after the payment of the Interim Issuer Cashflow Payments to the Cashflow Swap Counterparty, the CP Interest Reserve Interest Release Amount and the CP Interest Reserve Principal Release Amount, to the extent available, will be deposited to the Collection Account from the CP Interest Reserve Account and will be treated as Interest Proceeds or Principal Proceeds, as applicable.

CP Put Agreement

The Issuer and the CP Put Counterparty will enter into a 1992 ISDA Master Agreement and a schedule and confirmation thereto, each dated as of October 20, 2005, as amended from time to time (together, the "CP Put Agreement"). On the Closing Date, the CP Put Counterparty will be entitled to a fixed structuring fee. Under the CP Put Agreement, on, or on any of the three Business Days after, the initial scheduled maturity date of any CP Notes, the CP Put Counterparty is obligated, under the circumstances and subject to satisfaction of the conditions described in the CP Put Agreement and below, to purchase newly issued Class A-1LT-b Notes (the "CP Put Option"). If an early termination condition occurs and is continuing under the CP Put Agreement, the CP Put Counterparty will be obligated to purchase Class A-1LT-b Notes issued pursuant to the terms of the Indenture at par in accordance with the terms of (and subject to satisfaction of the conditions described in) the CP Put Agreement. The purchase of such new Class A-1LT-b Notes (together with amounts on deposit in the CP Principal Reserve Account), will provide the Issuer with sufficient funds on such maturity date to enable the Issuers to repay maturing CP Notes in accordance with the CP Put Agreement.

The CP Put Agreement is scheduled to terminate on the Stated Maturity of the Notes. At any time on or after October 19, 2006, the CP Put Counterparty may at its option terminate the CP Put Agreement in whole or in part. If the CP Put Counterparty elects to terminate the CP Put Agreement, the outstanding CP Notes in an amount equal to the amount of the CP Put Agreement so terminated will be retired at their next maturity date and the CP Put Counterparty will be required to purchase Class A-1LT-b-2 Notes in an equivalent amount. Class A-1LT-b-2 Notes issued to the CP Put Counterparty upon the exercise of its right to terminate the CP Put Agreement will bear interest at the Class A-1LT-b-2 Note Interest Rate for each Interest Accrual Period from and after their issuance date and will mature on the Stated Maturity of the Notes. In all other cases where the CP Put Option is exercised, the CP Put Counterparty will be required to purchase Class A-1LT-b-1 Notes which will bear interest at the Class A-1LT-b-1 Note Interest Rate for each Interest Accrual Period from and after their issuance date. The CP Put Agreement is also subject to termination in accordance with the typical ISDA termination provisions as described therein. Other than amounts due and owing under the CP Put Agreement at the time of termination, no termination payments will be due to or from the Issuer and the CP Put Counterparty in connection with any termination of the CP Put Agreement other than amounts already due and owing thereunder.

The CP Put Option in respect of the CP Notes will be exercised by the Trustee on behalf of the Issuer on the date when:

(i) the Issuers are not able to issue, sell or place new CP Notes having maturities of no more than 270 days, at a discount amount, if any, less than or equal to any amounts in the CP Interest Reserve Account (including amounts deposited to the CP Interest Reserve Account directly from the Collection Account) *plus* any CP Interest Deposit Amounts held by the Trustee for the following Interim Payment

Date (including the original amount of any CP Put Counterparty Deposit Amount (as defined below) but excluding any withdrawals made or to be made from the CP Interest Reserve Account on such date) and a discount rate less than or equal to the Maximum CP Put Option Strike Rate in a face amount at least equal to the face amount of maturing CP Notes less amounts on deposit in the CP Principal Reserve Account,

(ii) the short-term senior unsecured debt rating of the CP Put Counterparty is downgraded below "A-1" or "P-1" by S&P or Moody's, respectively, collateral is not posted in accordance with the CP Put Agreement, the CP Put Counterparty is not replaced in accordance with the CP Put Agreement and Goldman, Sachs & Co., is a CP Note Placement Agent (it being agreed that there is no obligation of the CP Put Counterparty to post collateral or be replaced),

(iii) a payment default under the Indenture has occurred with respect to the Class A Notes, the CP Notes, a required deposit to the CP Principal Reserve Account or the Class B Notes solely as a result of a failure by a Hedge Counterparty to make a payment under a Hedge Agreement,

(iv) the CP Put Counterparty has notified the Issuer or the Issuer has notified the CP Put Counterparty that it elects to terminate the CP Put Agreement as a consequence of the occurrence of an event of default or termination event thereunder,

(v) the CP Put Agreement is scheduled to terminate as the result of the occurrence of an Event of Default under the Indenture and acceleration under the Indenture and the commencement of the liquidation of Collateral thereunder,

(vi) the CP Put Agreement is scheduled to terminate as the result of an early redemption in full of the Notes and Defeasance of the CP Notes in full under the Indenture (with such Put Option termination not in any case becoming effective prior to the earlier of the date on which no CP Notes remain outstanding and the date on which all outstanding CP Notes have been Defeased in full under the Indenture),

(vii) on or after October 19, 2006 the CP Put Counterparty elects to terminate the CP Put Agreement in whole or in part, or

(viii) a prospective purchaser of CP Notes to be placed on any date fails in its obligation to pay the cash purchase price for such CP Notes it was obligated to purchase on such date.

In addition to the occurrence of one or more of the events described above, for the CP Put Option to be exercised none of the following events may have occurred on or prior to the applicable initial maturity date of the applicable CP Notes or, in the case of clause (viii) above, the settlement date: (1) a bankruptcy or insolvency default under the Indenture has occurred with respect to either of the Issuers, (2) the CP Put Premium due to be paid to the CP Put Counterparty by the Issuer under the CP Put Agreement has not been paid, (3) there are any payment defaults on the Class A Notes, the CP Notes or with respect to a required deposit to the CP Principal Reserve Account and all CP Notes which were Outstanding on the date such Event of Default originally occurred have matured (unless such payment default is due solely to a failure by a Hedge Counterparty to make payments required to be made under any of the Hedge Agreements) or (4) the Class A Overcollateralization Ratio is less than 100%. Notwithstanding the foregoing, the CP Put Option will not be exercised if, upon the occurrence of either condition described in clause (i) or (viii) above, the Issuer is able to issue CP Notes having a discount rate that is less than or equal to the discount equivalent of the Maximum CP Put Option Strike Rate on or before the date of settlement of such CP Put Option. The CP Put Counterparty will be permitted to (but is not obligated to) make deposits to the CP Interest Reserve Account in an amount sufficient to prevent the CP Put Option from being exercised under certain conditions. If the CP Put Counterparty does make such a deposit, discount on the issued CP Notes may in certain cases, exceed the Maximum CP Put Option Strike Rate. The CP Put Counterparty is not entitled to be reimbursed for any such deposits.

WEIGHTED AVERAGE LIFE AND YIELD CONSIDERATIONS

The Stated Maturity of the Notes and the Class X Notes is the Payment Date in January 2041. However, the principal of the Notes is expected to be paid in full prior to the Stated Maturity. Average life refers to the average amount of time that will elapse from the date of delivery of a security until each dollar of the principal of such security will be paid to the investor. The average lives of the Notes will be determined by the amount of principal payments which are dependent on a number of factors, including when the Collateral Assets are repaid.

Weighted Average Life. Weighted average life refers to the average amount of time that will elapse from the date of delivery of a security until each dollar of the principal of such security will be paid to the investor. The weighted average lives of the Notes of each Class will be determined by the amount and frequency of principal payments, which are dependent upon, among other things, the amount of payments received at or in advance of the scheduled maturity of the Collateral Assets (whether through sale, maturity, redemption, prepayment, default or other liquidation or disposition). The actual weighted average lives and actual maturities of the Notes will be affected by the financial conditions of the obligors on or the issuers of the Collateral Assets or the obligors on the underlying assets, and the characteristics of such securities and assets, including the existence and frequency of exercise of any optional or mandatory redemption features, the prevailing level of interest rates, the redemption price, prepayment rates, any lockout periods or prepayment premiums or penalties, the actual default rate and the actual level of recoveries on any Defaulted Obligations, and the frequency of tender or exchange offers for such Collateral Assets. Any disposition of a Collateral Asset will change the composition and characteristics of the Collateral Assets and the scheduled payments and payment characteristics thereon, and, accordingly, may affect the actual weighted average lives of the Notes. The rate of future defaults and the amount and timing of any cash realization from Defaulted Obligations and Credit Risk Obligations also will affect the maturity and weighted average lives of the Notes. The weighted average life of the Notes of each Class may also vary depending on whether or not the Notes are redeemed. The weighted average lives of the Notes are expected to be shorter, and may be substantially shorter, than the Stated Maturity of the Notes.

The table set forth below indicates the percentage of the initial balance of each Class of Notes that would be outstanding on each Payment Date assuming no prepayments or losses and the weighted average life of each Class of Notes and principal window of each Class based on the assumptions (the "Collateral Assets Assumptions") set forth below. The table set forth below is included only for illustrative purposes, and none of the Issuers, the Collateral Manager, the Collateral Adviser, the Trustee or the Initial Purchaser makes any representation as to whether such assumptions will be realized.

- i. Forward 1-month LIBOR curve and 3-month LIBOR curve as of October 14, 2005 are assumed;
- ii. the Closing Date is October 20, 2005, the first Payment Date is January 8, 2006 and the first Quarterly Payment Date is January 8, 2006;
- iii. all of the net proceeds of the offering of the Securities and the CP Notes are invested as of the Closing Date in the Collateral Assets;
- iv. the Coverage Tests are satisfied as of the Closing Date;
- v. expenses due under clauses (i), (ii) and (iii) of the Priority of Payments are paid on each Payment Date and are 0.02% per annum of the outstanding Principal Balance of the Collateral Assets; the Collateral Management Fee is 0.045% per annum of the outstanding Principal Balance of the Collateral Assets; and the Class X Payment is 0.045% per annum of the outstanding Principal Balance of the Collateral Assets;

- vi. each Collateral Asset will pay monthly on the 8th day of the month in which such payment is due and receipts will be reinvested for 10 days at a rate equal to one-month LIBOR *minus* 0.25%;
- vii. asset payments are fully paid out in accordance with the Priority of Payments on the 8th day of the month in which they are received (each of which is assumed to be a Business Day), commencing January 8, 2006;
- viii. failure to pay interest to the Holders of the Class A Notes is not an Event of Default;
- ix. all unpaid Class C Note, Class D Note and Class E Note interest is Deferred Interest;
- x. the Class E Notes are issued with an Aggregate Outstanding Amount of \$3,000,000 and Maximum Coupon on January 8, 2008;
- xi. there are no sales;
- xii. no rating change occurs on any Collateral Asset or the Notes;
- xiii. there is no Optional Redemption, Tax Redemption or Auction;
- xiv. all Classes of Notes are issued at par;
- xv. defaults are incurred at the constant annual default rates and are applied on each Payment Date to the outstanding Principal Balance of the Collateral Assets as of such Payment Date commencing on the Payment Date in July 2007;
- xvi. there is no termination of the Hedge Agreements;
- xvii. each Hedge Counterparty makes all required payments to the Issuer on a timely basis;
- xviii. Class A-1LT-a Notes bear interest at a per annum rate equal to 1-month LIBOR *plus* 0.32% from the Closing Date to and including the Payment Date in November 2008 and *plus* 0.34% thereafter;
- xix. CP Notes bear interest at a per annum rate equal to one-month LIBOR;
- xx. Clause (A)(d) of the definitions of Class A/B Interest Coverage Ratio, the Class C Interest Coverage Ratio and the Class D Interest Coverage Ratio is assumed to equal \$0.00 for each Payment Date;
- xxi. The CP Put Premium Rate is 0.18% per annum from the Closing Date to and including the November 2008 Payment Date and 0.22% per annum thereafter; and
- xxii. Amounts retained in the Collection Account pursuant to clause (xxii) of the Priority of Payments are reinvested at a rate equal to one-month LIBOR *minus* 0.25% until applied on the following Payment Date.

Cumulative Defaults represent the sum of such defaults divided by the aggregate principal balance of the Collateral Assets as of the Closing Date.

Yield. The yield to maturity of the Notes of each Class will also be affected by the rate of repayment of the Collateral Assets, as well as by the redemption of the Notes in an Auction, an Optional Redemption or Tax Redemption (and upon the Note Redemption Price then payable). The Issuer is not required to repay the Notes on any date prior to their Stated Maturity. The receipt of principal payments on the Notes at a rate slower than the rate anticipated by investors purchasing the Notes at a discount will result in an actual yield that is lower than anticipated by such investors.

The yield to maturity of the Notes may also be affected by the rate of delinquencies and defaults on and liquidations of the Collateral Assets, to the extent not absorbed by the Preferred Shares; sales of Collateral Assets; and/or purchases of Collateral Assets having different scheduled payments and payment characteristics and the effect of the Coverage Tests on payments under the Priority of Payments. The yield to investors in the Notes will also be adversely affected to the extent that the Issuers incur certain expenses that are not absorbed by the Preferred Shares.

The yield on the Class X Notes will be highly sensitive to the rate, timing and amount of defaults, delinquencies, interest deferrals and losses on the Collateral Assets. In addition, the yield on the Class X Notes will be affected by any Optional Redemption, Tax Redemption, Auction or redemption due to an Event of Default resulting in acceleration of the Securities and liquidation of the Collateral and may also be highly sensitive to prepayments on the Collateral Assets after the Reinvestment Period. See "Risk Factors—Securities—Special Considerations with respect to the Class X Notes."

THE COLLATERAL MANAGER

The information appearing in this section (other than the information contained under the subheading "General") has been prepared by the Collateral Manager and has not been independently verified by the Initial Purchaser or either of the Issuers. Neither the Initial Purchaser nor the Issuers assume any responsibility for the accuracy, completeness or applicability of such information.

General

Certain management, administrative and advisory functions with respect to the Collateral Assets will be performed by Wharton Asset Management Bermuda Limited, a private limited company incorporated under the laws of Bermuda ("Wharton Asset Management"), as the Collateral Manager under a Collateral Management Agreement between the Issuer and Wharton Asset Management dated as of the Closing Date (the "Collateral Management Agreement"). The Collateral Manager was incorporated on November 4, 2003. Pursuant to the terms of the Collateral Management Agreement, the Collateral Manager will (i) monitor the Collateral Assets and provide certain information with respect to the Collateral Assets to the Trustee, (ii) direct the disposition of the Collateral Assets under the limited circumstances described herein, (iii) direct the reinvestment of the proceeds therefrom in Eligible Investments, (iv) monitor all Hedge Agreements and, subject to the terms of the Collateral Management Agreement, determine whether and when the Issuer should exercise any rights available under any Hedge Agreement and (v) subject to the terms of the Collateral Management Agreement, monitor the issuance and sale of the CP Notes. The Collateral Manager will perform its duties in accordance with the requirements set forth in the Indenture and in accordance with the provisions of the Collateral Management Agreement. The Collateral Manager is also subject to certain other conflicts of interest. See "Risk Factors—Other Considerations—Certain Conflicts of Interest" and "Risk Factors—Other Considerations—The Collateral Manager."

The Collateral Manager has engaged the Collateral Adviser to perform certain of its management and execution functions. In addition to its activities on behalf of the Issuer, the Collateral Manager provides and anticipates providing, management and/or investment advisory services to other companies investing in collateral debt obligations and investment funds and individual clients with specialized investment programs, some of which may utilize strategies similar to that of the Issuer. The Collateral Manager will perform its services pursuant to the Collateral Management Agreement.

The Collateral Manager will engage, pursuant to the Collateral Advisory Agreement, the Collateral Adviser to perform certain advisory, credit analysis and execution functions with respect to the Portfolios for and on behalf of the Collateral Manager. See "The Collateral Adviser and the Collateral Advisory Agreement". The Collateral Manager will be responsible for the overall management of the Collateral Assets.

Key Personnel

Set forth below is information regarding the Board of Directors of the Collateral Manager. For information regarding those personnel who will be primarily responsible for managing the Collateral Assets and for performing the advisory and administrative functions related thereto, see "The Collateral Adviser and the Collateral Advisory Agreement–Key Personnel".

Board of Directors

Anthony T. Riker

Mr. Riker is a Vice President and Business Development Manager, Global Fund Services at The Bank of Bermuda Limited. He graduated in 1982 from Boston University with a degree in Economics. Following graduation, Mr. Riker worked in the Internal Audit group at The Bank of Bermuda. He left the Bank of Bermuda in 1987 as an Audit Senior and went to work for Boston Safe Deposit and Trust Company as an Audit Officer. In 1992, he transferred to its London office to work as Credit Officer and Audit Manager. Mr. Riker returned to the Bank of Bermuda in 1993, where he held various positions in the Global Fund Services Group.

Nigel Timothy Bentley

Mr. Bentley was admitted as a solicitor in 1980 and originally specialized in commercial conveyancing in London, he then joined the Jersey firm of English Solicitors Galsworthy & Stones in 1984 and was made a partner in 1986. Nigel now specializes in commercial, banking, corporate and offshore structures. Nigel is also a director of Rathbone Trust Company Jersey Limited which is part of the Rathbones Plc Group. Nigel is a committee member of the Association of English Solicitors Practising in Jersey (AESJ) and represents the AESJ on a number of the Island's regulatory steering groups. He is also a member of the Society of Trust & Estate Practitioners, the Jersey Taxation Society and the Jersey Compliance Officers Association.

Michael Edmund Powell

Mr. Powell originally qualified as an English Barrister in 1989 before qualifying as an English Solicitor in 1992. He joined the Jersey firm of English Solicitors Galsworthy & Stones in 1990, becoming a Partner in 1994, and specializes in trust, tax planning, corporate and offshore structures companies. Mr. Powell is a committee member of the Association of English Solicitors Practising in Jersey. He is also a member of the Society of Trust & Estate Practitioners and the Jersey Taxation Society. Michael is also a director of Rathbone Trust Company Jersey Limited which is part of the Rathbones Plc Group.

Conflicts of Interest

Various potential and actual conflicts of interest may arise from the overall advisory, investment and other activities of the Collateral Manager, the Collateral Adviser, their affiliates and their clients. The following briefly summarizes some of these conflicts, but is not intended to be an exhaustive list of all such conflicts.

The Collateral Manager, the Collateral Adviser and/or their affiliates may have ongoing relationships with, render service to, finance and engage in transactions with, and may own debt or equity securities issued by issuers of certain of the Collateral Assets. The Collateral Manager, the Collateral Adviser, their affiliates and/or their clients may invest in securities that are senior or subordinated to, or have interests different from or adverse to, the Collateral Assets. The interests of such parties may be

different than or adverse to the interest of the holders of the Securities. In addition, such persons may possess information relating to the Collateral Assets which is not known to the individuals at the Collateral Manager or the Collateral Adviser responsible for monitoring the Collateral Assets and performing the other obligations under the Collateral Management Agreement or the Collateral Advisory Agreement, as the case may be. Such persons will not be required (and may not be permitted) to share such information or pass it along to the Issuer, the Collateral Manager, the Collateral Adviser or any holder of any Security. None of the Collateral Manager, the Collateral Adviser or any of such persons will have liability to the Issuer or any holder of any Security for failure to disclose such information or for taking, or failing to take, any action based upon such information.

In addition, the Collateral Manager, the Collateral Adviser and/or any of their affiliates may engage in any other business and furnish investment management and advisory services to others which may include, without limitation, serving as consultant or servicer for, investing in, lending to, being affiliated with or have other ongoing relationships with, other entities organized to issue collateralized debt obligations secured by assets similar to the Collateral Assets, and other trusts and pooled investments vehicles that acquire interests in, provide financing to, or otherwise deal with securities issued by issuers that would be suitable investments for the Issuer. In the course of monitoring the Collateral Assets held by the Issuer, the Collateral Manager may consider its relationships with other clients (including entities whose securities (or those of its affiliates) are pledged to secure the Notes) and its affiliates (including the Collateral Adviser). In providing services to other clients, the Collateral Manager, the Collateral Adviser and their affiliates may recommend activities that would compete with or otherwise adversely affect the Issuer. In addition, the Collateral Manager and the Collateral Adviser will be free, each in its sole discretion, to make recommendations to others, or effect transactions on behalf of itself or for others, that may be the same as or different from those effected on behalf of the Issuer, and the Collateral Manager and the Collateral Adviser may furnish advisory services to others who may have investment policies similar to those followed by the Issuer and who may own securities of the same class, or which are the same type as, the Collateral Assets. Under the terms of the Collateral Management Agreement and the Collateral Advisory Agreement, each of the Collateral Manager and the Collateral Adviser will be permitted to take whatever action is in the Collateral Manager's or the Collateral Adviser's, respectively, best interest regardless of the impact on the Collateral Assets. In addition, under certain circumstances the Collateral Manager may direct the Issuer to sell certain Collateral Assets. Such sales of Collateral Assets may result in losses by the Issuer, which losses may result in the reduction or withdrawal of the rating of any or all of the Securities by any of the Rating Agencies. In determining whether to exercise such right, the Collateral Manager and the Collateral Adviser need not take into account the interests of the Issuers, the Noteholders, the Preferred Shareholders or any other party.

Each of the Collateral Manager, the Collateral Adviser and/or their affiliates may at certain times be simultaneously seeking to purchase or dispose of investments for their respective accounts or for another entity, including other collateralized debt obligation vehicles, at the same time as the Collateral Manager is disposing of investments for the Issuer. Accordingly, conflicts may arise regarding the allocation of sale opportunities. The Collateral Manager may aggregate sales of securities placed with respect to the Collateral Assets with similar sales being made simultaneously for other clients or other accounts managed by the Collateral Manager or the Collateral Adviser or with accounts of their affiliates, if in the Collateral Manager's or the Collateral Adviser's reasonable business judgment such aggregation will result in an overall economic benefit to the Issuer, taking into consideration the advantageous selling price, brokerage commission and other expenses. However, no provision of the Collateral Management Agreement requires the Collateral Manager or its affiliates to execute orders as part of concurrent authorizations or to aggregate sales. Nevertheless, the Collateral Manager may, in the allocation of business, take into consideration research and other brokerage services furnished to the Collateral Manager, the Collateral Adviser or their affiliates by brokers and dealers. Such services may be used by the Collateral Manager or the Collateral Adviser in connection with the Collateral Manager's and the Collateral Adviser's other advisory services or investment operations.

No provision in the Collateral Management Agreement or the Collateral Advisory Agreement prevents the Collateral Manager, the Collateral Adviser or any of their affiliates from rendering services of any kind to the issuer of any Collateral Assets and its affiliates, the Trustee, the holders of the Securities,

the Hedge Counterparty or any other entity. Without prejudice to the generality of the foregoing, the Collateral Manager, the Collateral Adviser and their affiliates, directors, officers, employees and agents may, among other things: (a) serve as directors, partners, officers, employees, agents, nominees or signatories for an issuer of any Collateral Assets; (b) receive fees for services rendered to the issuer of any Collateral Assets or any affiliate thereof; (c) be a secured or unsecured creditor of, or hold an equity interest in, any issuer of any Collateral Assets; (d) serve as a member of any "creditors' board" or "creditors' committee" with respect to any Collateral Assets which has become or may become a Defaulted Obligation or with respect to any commercial mortgage loan securing any Collateral Assets or the respective borrower for any such commercial mortgage loan; and (e) own or make loans to, or otherwise transact with, any borrower or affiliate of any borrower on any of the commercial mortgage loans securing the Collateral Assets. Under the terms of the Collateral Management Agreement and the Collateral Advisory Agreement, the Collateral Manager and the Collateral Adviser, respectively, will be permitted to take whatever action is in the Collateral Manager's or the Collateral Adviser's best interest regardless of the impact on the Collateral Assets.

On the Closing Date it is expected that the Collateral Manager or one or more affiliates of the Collateral Manager will purchase up to U.S.\$1,000,000 in notional amount of the Preferred Shares and may purchase Notes and/or Preferred Shares on or after the Closing Date. The Collateral Manager or such affiliates may at times also own other Securities. There is no assurance that the Collateral Manager or any of such affiliates will continue to hold any or all of the Notes or the Preferred Shares (including the Preferred Shares purchased on the Closing Date) or that they will continue to hold interests in any securities related to the Collateral Assets.

Wharton Asset Management or any of its affiliates or subsidiaries will be permitted to exercise all voting rights with respect to any Securities which they may acquire (other than with respect to a vote regarding the removal of the Collateral Manager or the termination or assignment of the Collateral Management Agreement). The interests of the Preferred Shares may be different from or adverse to the interests of the Notes.

The Collateral Manager (or the Collateral Adviser, on its behalf) will, as an agent of the Issuer, monitor the issuance, sale and payment of the CP Notes. Such activities may give rise to conflicts of interest with respect to the Collateral Manager or the Collateral Adviser.

Neither the Collateral Manager nor the Collateral Adviser has previously been involved in a collateralized debt obligation transaction involving the issuance and sale of commercial paper notes such as the CP Notes. Accordingly, there is no operating history from which potential purchasers of the Offered Securities may evaluate the likelihood of successful performance of the Collateral Manager (or the Collateral Adviser on its behalf) with respect to its duties of monitoring, and advising the Issuer with respect to, the issuance, sale and payment of the CP Notes. In addition, only a limited number of individuals employed by the Collateral Manager and the Collateral Adviser are involved in (and have expertise relevant to) the monitoring, issuance, sale and payment of commercial paper notes. Consequently, the loss of one or more of the individuals employed by the Collateral Manager to provide services to the Issuer with respect to the CP Notes could have a significant adverse effect on the performance of the Issuer and the Offered Securities.

THE COLLATERAL MANAGEMENT AGREEMENT

General

The Collateral Manager will perform certain investment management and administrative functions on behalf of the Issuer in accordance with the applicable provisions of the Indenture and the Collateral Management Agreement.

The Collateral Manager and its members and their respective directors, officers, stockholders and employees (collectively, the "Collateral Manager Affiliates") will not be liable to the Issuer, the Trustee, the holders of the Notes, the holders of the CP Notes or any other person, for any loss incurred as a result of the actions taken or recommended or for any omissions by the Collateral Manager, its members, officers;

stockholders or employees under the Collateral Manager Agreement or the Indenture or for any decrease in the value of the Collateral Assets, except by reason of acts constituting bad faith, willful misconduct or gross negligence in the performance of, or reckless disregard of, its duties thereunder.

The Collateral Management Agreement may not be amended or modified (other than an amendment or modification of the type that may be made to the Indenture without the consent of the holders of the Notes) without satisfaction of the Rating Agency Condition and the prior written consent of the Noteholders, the CP Noteholders, any Hedge Counterparty, the Collateral Adviser and the CP Put Counterparty, if the consent of such parties would be required were such an amendment made pursuant to the Indenture.

The Collateral Manager may be removed for cause by a Majority of each Class of Notes and the CP Notes, each voting separately upon 20 calendar days written notice to the Collateral Manager; provided, however, that any such vote will exclude any Securities held by the Collateral Manager, any affiliate of the Collateral Manager or any Securities over which the Collateral Manager or any of its affiliates has discretionary voting authority (the "Collateral Manager Securities"). For purposes of the Collateral Management Agreement, "cause" will mean (i) willful violation by the Collateral Manager of any material provision of the Collateral Management Agreement or the Indenture applicable to it and failure to cure such violation within forty-five (45) days of becoming aware of, or receiving notice from the Trustee of, such violation, (ii) certain events of bankruptcy or insolvency in respect of the Collateral Manager, (iii) the occurrence and continuation of an Event of Default under the Indenture which directly results from any breach by the Collateral Manager of its duties under the Indenture or the Collateral Management Agreement, (iv) the occurrence of an act by the Collateral Manager which constitutes fraud or criminal activity in the performance of its obligations under the Collateral Management Agreement or the conviction of the Collateral Manager or any of its officers or directors for a criminal offense materially related to its business of providing investment advisory services and (v) the failure of any representation, warranty, certification or statement made or delivered by the Collateral Manager in or pursuant to the Collateral Management Agreement or the Indenture to be correct in any material respect when made if such failure (a) has a material adverse effect on either of the Co-Issuers, the Noteholders, the CP Noteholders or the Holders of the Preferred Shares and (b) if such failure can be cured, such failure is not cured within 60 days after the Collateral Manager acquires actual knowledge of or receives notice from the Trustee of such violation.

The Collateral Manager and its affiliates, and each of their respective partners, shareholders, members, officers, directors, managers, employees, agents, accountants and attorneys will be entitled to indemnification by the Issuer from and against any claims that may be made against such party by third parties and any damages, losses, claims, liabilities, costs or expenses (including all reasonable legal and other expenses) which such party may incur or become subject to as a result of, or in connection with, any act or omission in the performance by or on behalf of the Collateral Manager of the Collateral Manager's obligations and services under the Collateral Management Agreement, except for liability that is directly attributable to willful misconduct, bad faith, gross negligence or reckless disregard of the obligations of the Collateral Manager under the Collateral Management Agreement and the Indenture.

The Collateral Manager may resign upon 90 days' written notice to the Issuer, the Trustee, the Hedge Counterparty, the Collateral Adviser and the Rating Agencies or such shorter notice as is acceptable to the Issuer, the Trustee and the Rating Agencies; provided that the Collateral Manager shall have the right to resign immediately upon the effectiveness of any material change in applicable laws or regulations which renders the performance by the Collateral Manager of its duties under the Collateral Management Agreement or the Indenture to be a violation of such laws or regulations. The Collateral Management Agreement will terminate automatically in the event the Notes, the Preferred Shares and CP Notes are redeemed, Defeased or cancelled in their entirety, or in the event of its assignment by the Collateral Manager in violation of the Collateral Management Agreement.

No removal, termination of appointment or resignation of the Collateral Manager or termination of the Collateral Management Agreement will be effective unless (i) a successor Collateral Manager is appointed by the Issuer and agrees in writing to assume all of the Collateral Manager's obligations

pursuant to the Collateral Management Agreement, (ii) the successor Collateral Manager is not objected to by a Special Majority-in-Interest (as such term is defined in the Collateral Management Agreement) of Preferred Shareholders or a Majority of the Controlling Class (including any Collateral Manager Securities) within 30 days after notice and (iii) the Rating Condition has been satisfied with respect to the appointment of such successor Collateral Manager. Such successor Collateral Manager must, in addition, meet certain qualifications specified in the Collateral Management Agreement (the "Replacement Manager Conditions").

In the event that the Collateral Manager has been removed, its appointment has been terminated or it has resigned and a successor Collateral Manager meeting the Replacement Manager Conditions has not been appointed on or prior to (i) in the case of removal of the Collateral Manager "for cause," the date that is 60 days following the date of notice of removal delivered in accordance with the Collateral Management Agreement and (ii) in the case of any other removal or resignation of the Collateral Manager, the date of removal or resignation specified in the relevant notice, the resigning or removed Collateral Manager shall be entitled to appoint a successor Collateral Manager and shall so appoint a replacement manager satisfying the Replacement Manager Conditions within 60 days thereafter, provided that such successor Collateral Manager is not objected to by a Majority-in-Interest (as such term is defined in the Collateral Management Agreement) of Preferred Shareholders (excluding any Collateral Manager Securities) within 15 days after such appointment. In lieu thereof, or if the successor Collateral Manager appointed by the resigning or removed Collateral Manager is not approved, the resigning or removed Collateral Manager may petition any court of competent jurisdiction for the appointment of a replacement manager satisfying the successor Collateral Manager Conditions, but such appointment shall not require the consent of, nor be subject to the disapproval of, the Issuer or any Noteholder, CP Noteholder or Preferred Shareholder. Upon the appointment of a successor Collateral Manager satisfying the Replacement Manager Conditions and the written acceptance of such appointment by the successor Collateral Manager, all authority and power of the Collateral Manager under the Collateral Management Agreement will be automatically vested in the successor Collateral Manager. No compensation payable to a successor Collateral Manager from the Collateral Assets shall be greater than that paid to the Collateral Manager without (i) the prior written consent of (a) a Majority-in-Interest (as such term is defined in the Collateral Management Agreement) of Preferred Shareholders and (b) in the case of any increase or any Collateral Management Fee, the prior written consent of a majority in aggregate outstanding principal amount of each Class of Notes and the CP Notes and (ii) the satisfaction of the Rating Agency Condition.

The Collateral Manager may only assign its rights or responsibilities under the Collateral Management Agreement in accordance with the terms of the Collateral Management Agreement. The Collateral Manager, without the prior consent of the Issuers, the Trustee, the Holders of the Notes, the Preferred Shares or the CP Notes or any other person, may employ third parties, including its affiliates, to render assistance in connection with its obligations under the Collateral Management Agreement. In such event, the Collateral Manager shall not be relieved of any of its duties or liabilities under the Collateral Management Agreement regardless of the performance of any services rendered by third parties.

Compensation

The Collateral Manager will be entitled to receive a fee of \$4,727,835 on the Closing Date. In addition, as compensation for the performance of its obligations under the Collateral Management Agreement, the Collateral Manager will be entitled to receive a fee in accordance with the Priority of Payments, payable in arrears on each Payment Date, of 0.045% per annum (the "Collateral Management Fee") times the Aggregate Principal Amount, measured as of the beginning of the Due Period preceding such Payment Date.

If amounts distributable on any Payment Date in accordance with the Priority of Payments are insufficient to pay the Collateral Management Fee in full, then the shortfall will be deferred and will be payable on subsequent Payment Dates on which funds are available therefor according to the Priority of Payments. Any interest due on the amounts so deferred will be payable in the same order of priority as the Collateral Management Fee and will accrue interest at a rate equal to LIBOR.

The Collateral Management Fee will be calculated on the basis of a 360 day year consisting of twelve 30-day months. All fees payable to the Collateral Manager on a Payment Date are subject to payment only in accordance with the Priority of Payments.

The Collateral Manager may, at its election and upon notice to the Issuer and the Trustee, direct for a predetermined period of time that all or a portion of the amount that is due to it as the Collateral Management Fee be paid directly to a third party; provided, that the Collateral Manager will not (unless it is assigning all of its rights and obligations in accordance with the Collateral Management Agreement) be relieved of any of its duties under the Collateral Management Agreement or the Indenture as a result of the redirection of its right to receive all or a portion of the Collateral Management Fee.

THE COLLATERAL ADVISER AND THE COLLATERAL ADVISORY AGREEMENT

The information appearing in this section has been prepared by the Collateral Adviser and has not been independently verified by the Initial Purchaser or either of the Issuers. Neither the Initial Purchaser nor the Issuers assume any responsibility for the accuracy, completeness or applicability of such information.

General

The Collateral Adviser is Wharton Asset Management UK Limited, a private limited company incorporated in England and Wales (registered number 04012461), with offices located in London. The Collateral Adviser is authorized under the Financial Services and Markets Act 2000 and was approved by the Financial Services Authority to (a) give investment advice to its customers in respect of relevant instruments, (b) arrange deals in relevant instruments for its customers, including the negotiation with banks and brokers of the details and method of carrying out a transaction, the terms and the price, and receiving and transmitting customers' orders, and (c) deal as agent on behalf of its customers in respect of relevant instruments.

The Collateral Adviser currently provides investment advice to:

- Wharton Asset Management Bermuda Limited as the Investment Manager of Y2K Finance Inc. ("Y2K"). Y2K is a fixed income performance fund designed to generate returns by applying leverage on AAA to A rated asset backed securities. Since its inception Y2K has been funded in the repo market;
- Wharton Asset Management Bermuda Limited as the Investment Manager of H2 Finance Ltd., an ABS CDO which is funded primarily in the repo market;
- Wharton Asset Management Bermuda Limited as the Investment Manager of G Square Finance Ltd., a cash CDO of ABS;
- Wharton Asset Management Bermuda Limited as the Investment Manager of Delta CDO plc, in respect of the Delta CDO Series 2005-1 Notes; and
- Wharton Asset Management Bermuda Limited as the Investment Manager of Delta CDO plc, in respect of the Delta CDO Series 2005-2 Notes.

In addition to its activities on behalf of the Collateral Manager in respect of this transaction, the Collateral Adviser anticipates providing investment advisory services to the Collateral Manager and other companies investing in collateral debt obligations and investment funds and individual clients with specialized investment programs, some of which may utilize strategies similar to that of the Issuer. The Collateral Adviser will be engaged, pursuant to the Collateral Advisory Agreement, by the Collateral Manager to perform certain advisory, credit analysis and execution functions with respect to the Collateral Assets for and on behalf of the Collateral Manager. The Collateral Adviser will not be responsible for providing any services to the Issuer.

The Collateral Advisory Agreement

On the Closing Date, the Collateral Adviser will enter into an Collateral Advisory Agreement with the Issuer and the Collateral Manager under which the Collateral Adviser will perform certain advisory, credit analysis and execution functions with respect to the Collateral Assets for and on behalf of the Collateral Manager. The main duties of the Collateral Adviser under the Collateral Advisory Agreement will be to:

- evaluate Collateral Assets which appear to the Collateral Adviser as being appropriate for investment by the Issuer, and advise on the price movements in respect of such Collateral Assets and on such other factors relating thereto as the Collateral Adviser considers relevant for consideration by the Collateral Manager in its initial selection of the Collateral Assets;
- advise the Collateral Manager as to the redemption of Securities in accordance with the Indenture;
- advise the Collateral Manager with respect to the Hedge Agreements;
- on behalf of the Collateral Manager, monitor the issuance and sale of the CP Notes (to the extent contemplated in the Collateral Management Agreement);
- advise the Collateral Manager as to the exercise of the discretions of the Collateral Manager contemplated in the Indenture;
- analyze continually the progress of all Collateral Assets which are for the time being and from time to time represented in the portfolio of Collateral Assets and provide quarterly (or more frequently if the Collateral Manager shall so reasonably require) reports in writing thereon; and
- advise the Collateral Manager as to all other matters incidental thereto, or as may be further specified therein.

The Collateral Advisory Agreement and the appointment by the Collateral Manager of the Collateral Adviser thereunder will terminate immediately upon the termination of the appointment of the Collateral Manager in accordance with the terms of the Collateral Management Agreement.

Key Personnel

Set forth below is information regarding the background, principal responsibilities and other affiliations of certain of the principal officers and other employees of the Collateral Adviser, including those personnel who will be primarily responsible for advising the Collateral Manager on the management of the Collateral Assets and for performing the advisory and administrative functions related thereto. Although these individuals are currently employed by the Collateral Adviser and hold the offices indicated below with the Collateral Adviser, such persons will not be engaged full time in the management of the Collateral. In addition, such persons may not necessarily continue to be so employed by the Collateral Adviser during the entire term of the Collateral Advisory Agreement or the Collateral Management Agreement or may not continue to perform services for the Collateral Adviser under the Collateral Advisory Agreement.

Maurice Salem, Managing Director

Mr. Salem founded the Collateral Adviser in 1993, and is currently the Managing Director. He has extensive experience in credit trading and the management of fixed income portfolios, particularly asset backed securities. In 1999, Mr. Salem established Y2K, a fixed income performance fund designed to generate returns by applying leverage on the highest quality portion of the asset-backed market. Prior to founding the Collateral Adviser, Mr. Salem was responsible for French Franc credit trading at Swiss Bank Corporation. Mr. Salem holds a BA (Honours) Degree in Economics and French Literature from London University.

Paul (Dan) Cook, Head of Structured Products

Mr. Cook joined the Collateral Adviser as Head of Structured Products in September 2003. Prior to joining the Collateral Adviser, Mr. Cook was a Managing Director, Head of ABS Syndicate and Trading at UBS in London, which he joined in 1991. At UBS, Mr. Cook was responsible for the pricing and underwriting of all European ABS products as well as coordinating the distribution of the products. Prior to UBS, Mr. Cook worked for CIBC for six years as Head of Syndication. Mr. Cook holds a BA (Honours) in Engineering Science from Oxford University.

David Prosser, Senior Consultant

Mr. Prosser joined the Collateral Adviser in February 2000 as a senior consultant. He trades all fixed income securities, including convertibles and asset backed securities. Mr. Prosser has wide ranging experience Mr. Prosser spent four years as Head of Trading & Sales and Head of Non-Japanese Syndication at Mitsui Trust International in London. Prior to Mitsui, Mr. Prosser spent five years at Daiwa Bank as a Deputy Managing Director, Head of Capital Markets. For the fifteen years prior to Daiwa, Mr. Prosser held key trading and distribution positions at Citicorp Investment Bank and Prudential-Bache.

Caroline Velarde, Senior Analyst

Ms. Velarde joined the Collateral Adviser as a Senior Analyst in May 2001 after having spent one year in the European Securitisation Group of Deutsche Bank AG in London and six years in the International Asset Backed Securities Group of Bear Stearns International Ltd in New York, Paris and London. She worked on the origination and structuring of several asset-backed securities transactions in Europe and the first Japanese residential mortgage deal, with a particular focus on the due diligence and marketing aspects of a transaction. At the Collateral Adviser, she shares with Stefano Loreti the responsibility for doing the credit work analysis for all asset backed securities that Y2K acquires, and conducts an ongoing monitoring of all positions. She also deals with the day-to-day administration of the fund and maintains the relationship with the investors. Ms. Velarde graduated in June 1994 from Northeastern University with a Bachelor in Business and Science Administration.

Stefano Loreti, Senior Analyst

Mr. Loreti joined the Collateral Adviser as a Senior Analyst in June 2003 after having spent two years as a senior analyst in the ABS department of Abbey National, where he was responsible for the analysis and monitoring of Abbey's U.S.\$30 billion ABS/CDO portfolio. At Abbey National, Mr. Loreti was involved in the detailed analysis of a variety of asset classes including European ABS and CMBS, US RMBS and CMBS and CDOs. Before Abbey National, he worked for five years as a senior analyst for the ABS portfolios of Bank of Bermuda and Gulf International Bank. Before moving to the United Kingdom, Mr. Loreti worked as a credit analyst with Citibank and Fitch Ratings Limited in Milan. At the Collateral Adviser, Mr. Loreti shares with Caroline Velarde the responsibility for doing the credit work analysis for all asset backed securities that Y2K acquires, and conducts an ongoing monitoring of all positions. Mr. Loreti graduated in 1993 from LUISS G Carli University with a degree in Economics achieved cum-laude (110 e lode), and he is also a qualified chartered accountant (dottore commercialista).

Arin Ion, CDO Management

Mr. Ion joined the Collateral Adviser from Barclays Capital where he worked as a CDO structurer in the European CDO Group. At Barclays, he was responsible for documentation, quantitative analysis and rating agency negotiations on a number of CDO transactions including synthetic CDOs of ABS, CLOs and synthetic portfolio risk transfer transactions. At the Collateral Adviser, Mr. Ion works on the structuring and execution of CDO transactions, CDO management, and performing credit analysis on CDO investments. Prior to joining Barclays Capital, Arin worked for Milestone Merchant Partners and Charlemagne Capital as an investment analyst focused on private and public equity investments in Eastern Europe. Mr. Ion has an MBA degree from London Business School and a BSc in Finance from the Academy of Economic Studies in Bucharest.

Ash Shah, Chief Financial Officer

Mr. Shah joined the Collateral Adviser as a Financial Officer with responsibility for heading up the Finance, Compliance, Administration, and Operations functions. For the prior 10 years, Mr. Shah served as a Chief Financial & Compliance Officer of Malabar Capital, a global equities asset manager with more than U.S.\$1.5 billion under management. At Malabar, Mr. Shah managed the entire middle office, back office, reporting and compliance office functions, and managed the broker and custodian relationships. Between 1985-1994, Mr. Shah worked for Deloitte & Touche as a Senior Manager, performing due diligence on corporate acquisitions, management buy-outs, and flotations, auditing clients' accounts and systems of control, and advising clients on the implementation of new accounting systems. Mr. Shah is a Chartered Accountant with the Institute of Chartered Accountants in England & Wales (1988) and graduated with a Bachelor Degree in Economics with a concentration on Accounting & Finance from Manchester University in 1985.

James McCunn, Analyst

Mr. McCunn joined the Collateral Adviser as a Trading Assistant in mid-2004 before becoming an Analyst in early 2005. He previously worked at JPMorgan as a Profit and Loss and Risk Analyst in the Hedge Fund Services team. Mr. McCunn's responsibilities include short term funding and use of the balance sheet, asset monitoring and compliance modeling. He graduated in 2000 with a BA (Hons.) degree in Finance from UCE.

THE ISSUERS

General

The Issuer was incorporated on June 14, 2005 in the Cayman Islands with the registered number 150350. The registered office of the Issuer is at the offices of Maples Finance Limited, P.O. Box 1093 GT, Queensgate House, South Church Street, George Town, Grand Cayman, Cayman Islands. The Issuer has no prior operating history. The Issuer's Memorandum of Association sets out the objects of the Issuer, which are unrestricted and therefore include the business to be carried out by the Issuer in connection with the Securities.

The Co-Issuer was incorporated on July 11, 2005 under the laws of the State of Delaware with the registered number 3998322. The registered office of the Co-Issuer is at Donald J. Puglisi, Puglisi & Associates, 850 Library Avenue, Suite 204, Newark, Delaware, 19711. The Co-Issuer has no prior operating history. Article 3 of the Co-Issuer's Certificate of Incorporation sets out the purposes of the Co-Issuer, which include the business to be carried out by the Co-Issuer in connection with the issuance of the Notes (other than the Class E Notes).

The Notes (other than the Class E Notes) and the CP Notes are obligations only of the Issuers, and the Class E Notes and the Class X Notes are obligations only of the Issuer, and not of the Trustee, the Initial Purchaser, the Issuer Administrator, the Collateral Administrator, the CP Put Counterparty, the CP Note Placement Agents, the Collateral Manager, the Collateral Adviser, the Holders of the Preferred Shares, the Agents, the Share Trustee or any directors, managers or officers of the Issuers or any of their respective affiliates. The Preferred Shares are equity interests only in the Issuer.

The authorized share capital of the Issuer consists of 1,000 Preferred Shares, par value U.S.\$0.01 per share and 250 ordinary shares, U.S.\$1.00 par value per share (the "Issuer Ordinary Shares"). All of the Issuer Ordinary Shares will be issued on or prior to the Closing Date. All of the outstanding Issuer Ordinary Shares will be held by the Share Trustee under the terms of a charitable trust. All of the outstanding common equity of the Co-Issuer will be held by the Share Trustee under the terms of the charitable trust which holds the Issuer Ordinary Shares. For so long as any of the Notes or CP Notes are outstanding, no beneficial interest in the ordinary shares of the Issuer or of the common equity of the Co-Issuer shall be registered to a U.S. Person.

Capitalization of the Issuer

The initial proposed capitalization of the Issuer as of the Closing Date after giving effect to the issuance of the Securities and the Issuer Ordinary Shares and entry into the Hedge Agreement before deducting expenses of the offering of the Securities and the CP Notes is as set forth below.

Holders of Notes, the Class X Notes and CP Notes must rely on the Collateral held by the Issuer and pledged to the Trustee for payment on their respective Notes and CP Notes, in accordance with the Priority of Payments.

Business

The Issuers will not undertake any business other than the issuance of the Notes (other than the Class E Notes) and the CP Notes and, in the case of the Issuer, the issuance of the Preferred Shares, the Class X Notes and the Class E Notes, the acquisition and management of the Collateral and, in each case, other related transactions. Neither of the Issuers will have any subsidiaries.

The Issuer Administrator will act as the administrator of the Issuer. The office of the Issuer Administrator will serve as the general business office of the Issuer. Through this office and pursuant to the terms of an agreement to be dated on or about June 22, 2005 by and between the Issuer Administrator and the Issuer (the "Administration Agreement"), the Issuer Administrator will perform various administrative functions on behalf of the Issuer, including communications with shareholders and the general public, and the provision of certain clerical, administrative and other services until termination of the Administration Agreement. In consideration of the foregoing, the Issuer Administrator will receive various fees and other charges payable by the Issuer at rates agreed upon from time to time *plus* expenses. The directors of the Issuer listed below are also officers and/or employees of the Issuer Administrator and may be contacted at the address of the Issuer Administrator.

The activities of the Issuer Administrator under the Administration Agreement will be subject to the overview of the Issuer's Board of Directors. The Administration Agreement may be terminated by either the Issuer or the Issuer Administrator upon 3 months' written notice (or, upon the occurrence of certain events, 14 days' written notice).

INCOME TAX CONSIDERATIONS

United States Tax Considerations

The following is a summary of certain of the United States federal income tax consequences of an investment in the Notes, the Class X Notes and Preferred Shares (for purposes of this Section, the "Securities") by purchasers that acquire their Notes or Preferred Shares in their initial offering. The

discussion and the opinions referenced below are based upon laws, regulations, rulings and decisions currently in effect, all of which are subject to change, possibly with retroactive effect. Prospective investors should note that no rulings have been or are expected to be sought from the Internal Revenue Service (the "IRS") with respect to any of the United States federal income tax consequences discussed below, and no assurance can be given that the IRS will not take contrary positions. Further, the following summary does not deal (except, in some instances, in very general terms) with all United States federal income tax consequences applicable to any given investor; nor does it address the United States federal income tax considerations applicable to all categories of investors, some of which may be subject to special rules, such as Non-U.S. Holders (defined below), banks, RICs, REITs, insurance companies, tax-exempt organizations, dealers in securities or currencies, electing large partnerships, natural persons, cash method taxpayers, S corporations, estates and trusts, investors that hold the Securities as part of a hedge, straddle, or an integrated or conversion transaction, or investors whose "functional currency" is not the United States dollar. Furthermore, it does not address alternative minimum tax consequences or the indirect effects on the investors of equity interests in either a U.S. Holder (defined below) or a Non U.S. Holder. In addition, this summary is generally limited to investors that will hold the Securities as "capital assets" within the meaning of Section 1221 of the Internal Revenue Code 1986 (the "Code"). Investors should consult their own tax advisors to determine the United States federal, state, local and other tax consequences of the purchase, ownership and disposition of the Securities.

As used herein, "U.S. Holder" means a beneficial holder of a Security that is an individual citizen or resident of the United States for U.S. federal income tax purposes, a corporation or partnership or other entity treated as a corporation or partnership for U.S. federal income tax purposes created or organized in or under the laws of the United States or any state thereof (including the District of Columbia), an estate the income of which is subject to U.S. federal income taxation regardless of its source or a trust for which a court within the United States is able to exercise primary supervision over its administration and for which one or more U.S. persons (as defined in the Code) have the authority to control all of its substantial decisions or a trust that has made a valid election under U.S. Treasury Regulations to be treated as a domestic trust. If a partnership holds the Securities, the tax treatment of a partner will generally depend upon the status of the partner and upon the activities of the partnership. Partners of partnerships holding the Securities should consult their own tax advisors. "Non-U.S. Holder" means any holder (or beneficial holder) of a Security that is not a U.S. Holder.

U.S. Federal Income Tax Consequences to the Issuer

Upon the issuance of the Securities, Orrick, Herrington & Sutcliffe LLP, special U.S. tax counsel to the Issuer, will deliver an opinion generally to the effect that under current law, and assuming compliance with the Indenture (and certain other documents) and based on certain factual representations made by the Issuer and the Collateral Manager, although the matter is not free from doubt, the Issuer will not be engaged in the conduct of a trade or business in the United States. Accordingly, the Issuer does not expect to be subject to net income taxation in the United States. Prospective investors should be aware that opinions of counsel are not binding on the IRS and there can be no absolute assurance that the IRS will not seek to treat the Issuer as engaged in a United States trade or business. If the IRS were to successfully characterize the Issuer as engaged in such a trade or business, among other consequences, the Issuer would be subject to net income taxation in the United States (as well as the branch profits tax) on its income. The levying of such taxes would materially affect the Issuer's financial ability to pay principal and interest on the Securities.

The Issuer intends to acquire Collateral Assets the interest on which, and any gain from the sale or disposition thereof, is expected not to be subject to United States federal withholding tax or withholding tax imposed by other countries (unless subject to being "grossed up"). The Issuer will not, however, make any independent investigation of the circumstances surrounding the issuance of the individual assets comprising the Collateral Assets and thus there can be no absolute assurance that in every case payments will be received free of withholding tax. If the Issuer is a CFC (defined below), the Issuer would incur U.S. withholding tax on interest received from a related United States person. Under current law, payments received on the Hedge Agreements are not subject to U.S. federal withholding tax.

In addition, it is not expected that the Issuer will derive material amounts of any other items of income that would be subject to United States withholding taxes.

If withholding or deduction of any taxes from payments is required by law in any jurisdiction, the Issuer shall be under no obligation to make any additional payments to the holders of any Securities in respect of such withholding or deduction.

Notwithstanding the foregoing, any commitment or facility fee (or other similar fee) that the Issuer earns may be subject to a 30% withholding tax.

Classification and Tax Treatment of the Notes. The Issuer has agreed and, by its acceptance of a Note, each Noteholder will be deemed to have agreed, to treat each of the Notes (other than the Class E Notes) as debt of the Issuer for U.S. federal income tax purposes except to the extent a Noteholder makes a protective QEF election (described below). By its acceptance of the Class E Note, such Class E Noteholder will agree to treat such Class E Note in accordance with the treatment accorded to it by the Issuer (as debt or equity as the case may be) upon the issuance of the Class E Note. In the event that the Class E Notes are intended to be treated as debt, they will be taxed in the manner indicated under "—Classification of the Notes," herein and "—Alternative Characterization of the Notes." In the event that the Class E Notes are intended to be treated as equity, they will be taxed in the manner indicated under "United States Tax Treatment of Holders of Preferred Shares." Upon the issuance of the Notes, Orrick, Herrington & Sutcliffe LLP will deliver an opinion generally to the effect that assuming compliance with the Indenture (and certain other documents) and based on certain factual representations made by the Issuer and the Collateral Manager, the Class A Notes, the Class B Notes and the Class C Notes will and the Class D Notes should be characterized as debt of the Issuer for U.S. federal income tax purposes. Prospective investors should be aware that opinions of counsel are not binding on the IRS and there can be no assurance that the IRS will not seek to characterize any Class of Notes as other than indebtedness. Except as provided under "—Alternative Characterization of the Notes," below, the balance of this discussion assumes that the Notes will be characterized as debt of the Issuer for federal income tax purposes.

For U.S. federal income tax purposes, the Issuer of the Notes, and not the Co-Issuer, will be treated as the issuer of the Notes.

U.S. Holders of the Notes will include payments of stated interest received on the Notes in income in accordance with their method of tax accounting as ordinary interest income. While not absolutely certain, it appears that the Class C Notes and the Class D Notes will be issued with original issue discount and a U.S. Holder of a Class C Note or a Class D Note will be required to include original issue discount ("OID") in gross income as it accrues under a constant yield method, based on the original yield to maturity of the Note. Thus, the Holder of a Class C Note or a Class D Note will be required to include original issue discount in income as it accrues, prior to the receipt of the cash attributable to such income. U.S. Holders, however, would be entitled to claim a loss upon maturity or other disposition of a Class C Note or a Class D Note with respect to interest amounts accrued and included in gross income for which cash is not received. Such a loss generally would be a capital loss.

Although there can be no assurance, the Notes should not be "contingent payment debt instruments" ("CPDIs") within the meaning of Treasury Regulation section 1.1275-4, effective for debt instruments issued after August 12, 1996. If any Class of Notes were considered such instruments, among other consequences, gain on the sale of such Notes that might otherwise be capital gain would be ordinary income. Prospective investors should consult their own tax advisors regarding the possible characterization of the Notes as CPDIs.

The Notes may be debt instruments described in section 1272(a)(6) of the Code (debt instruments that may be accelerated by reason of the prepayment of other debt obligations securing such debt instruments). Special tax rules principally relating to the accrual of original issue discount, market discount and bond premium apply to debt instruments described in section 1272(a)(6). Further, those debt instruments may not be part of an integrated transaction with a related hedge under Treasury Regulation § 1.1275-6. Prospective investors should consult with their own tax advisors regarding the effects of section 1272(a)(6).

In general, a U.S. Holder of a Note will have a basis in such Note equal to the cost of such Note increased by any market discount includible in income by such U.S. Holder and reduced by any amortized premium and any payments thereon other than payments of interest on such Note. Upon a sale, exchange or other disposition of a Note, a U.S. Holder will generally recognize gain or loss equal to the difference between the amount realized on the sale, exchange or other disposition (less any accrued and unpaid interest, which would be taxable as such) and the U.S. Holder's tax basis in such Note. Such gain or loss generally will be long term capital gain or loss if the U.S. Holder held the Note for more than one year at the time of disposition. In certain circumstances, U.S. Holders that are individuals may be entitled to preferential treatment for net long term capital gains; however, the ability of U.S. Holders to offset capital losses against ordinary income is limited.

U.S. Holders should recognize that there is some uncertainty regarding the appropriate classification of instruments such as the Notes. It is possible, for example, that the IRS may contend that a class of Notes should be treated as equity interests (or as part debt, part equity) in the Issuer. Such a recharacterization might result in material adverse tax consequences to U.S. Holders. If U.S. Holders of Notes were treated as owning equity interests in the Issuer, the U.S. federal income tax consequences to U.S. Holders of such recharacterized Notes would be as described under "–United States Tax Treatment of Holders of preferred Shares." In addition, in order to avoid one application of the PFIC rules, each U.S. Holder should consider making a qualified electing fund election (the "QEF election") provided in Section 1295 of the Code on a "protective" basis (although such protective election may not be respected by the IRS because current regulations do not specifically authorize that particular election). See "–United States Tax Treatment of Holders of Preferred Shares–Status of the Issuer as a PFIC–QEF Election."

Non-U.S. Holders

Assuming that (i) the Notes are respected as debt or (ii) if the Notes are treated as equity in a Non-U.S. corporation, that such corporation is not engaged in a U.S. trade or business, a Non-U.S. Holder of a Note that has no connection with the United States, will not be subject to U.S. withholding tax on interest payments, provided that the Non-U.S. Holder complies with applicable identification requirements. Non-U.S. Holders may be required to make certain tax representations regarding the identity of the beneficial owner of the Notes in order to receive payments free of withholding.

United States Tax Treatment of Holders of the Class X Notes and the Preferred Shares

General. Prospective investors of the Preferred Shares should not rely on this summary and should consult their own tax advisors regarding alternative characterizations of the Class X Notes and the Preferred Shares and the consequences of their acquiring, holding, and disposing of the Class X Notes and the Preferred Shares, including the possibility that the Class X Notes and the Preferred Shares will be treated as contingent payment debt instruments. For purposes of this Section "Income Tax Considerations–United States Tax Treatment of Holders of the Class X Notes and the Preferred Shares," a U.S. Holder is defined to be U.S. Holder of a Class X Note or a Preferred Share, as applicable. Subject to the anti-deferral rules discussed below, distributions on the Class X Notes and the Preferred Shares distributed by the Issuer to a U.S. holder that is subject to United States federal income tax will be taxable to such U.S. holder as a dividend to the extent of the current and accumulated earnings and profits of the Issuer. Dividends will not be eligible for the dividends received deduction allowable to corporations. Distributions in excess of earnings and profits will be non-taxable to the extent of, and will be applied against and reduce, the U.S. holder's adjusted tax basis in the Class X Notes or Preferred Shares, as applicable. Distributions in excess of earnings and profits and basis will be taxable as gain from the sale or exchange of property.

Prospective investors should be aware that certain of the procedural rules for PFICs and QEF elections (described below) are complex and should consult their own tax advisors regarding such rules.

The tax consequences discussed in the second preceding paragraph are likely to be materially modified by the anti-deferral rules discussed below. In general, each U.S. holder's investment in the Issuer will be taxed as an investment in a "passive foreign investment company" ("PFIC") or as an

investment in a CFC, depending (in part) upon the percentage of the Issuer's equity that is acquired and held by certain U.S. holders. If applicable, the rules pertaining to CFCs generally override those pertaining to PFICs (although, in certain circumstances, more than one set of rules may be applicable simultaneously).

Prospective investors should be aware that in determining what percentage of the equity of the Issuer is held by various categories of investors (for example, for purposes of the CFC, and information reporting rules described below), the Collateral Manager's interest in certain portions of its fee and certain classes of Notes may be considered equity (and might be considered voting equity).

Status of the Issuer as a PFIC. The Issuer will be treated as a "passive foreign investment company" or "PFIC" for United States federal income tax purposes. U.S. holders in PFICs, other than U.S. holders that make a timely "qualified electing fund" or "QEF" election described below, are subject to special rules for the taxation of "excess distributions" (which include both certain distributions by a PFIC and any gain recognized on a disposition of PFIC stock). In general, Section 1291 of the Code provides that the amount of any "excess distribution" will be allocated to each day of the U.S. holder's holding period for its PFIC stock. The amount allocated to the current year will be included in the U.S. holder's gross income for the current year as ordinary income. With respect to amounts allocated to prior years, the tax imposed for the current year will be increased by the "deferred tax amount" (an amount calculated with respect to each prior year by multiplying the amount allocated to such year by the highest rate of tax in effect for such year, together with an interest charge, as though the amounts of tax were overdue).

An excess distribution is the amount by which distributions for a taxable year exceed 125 percent of the average distribution in respect of the Class X Notes or Preferred Shares during the three preceding taxable years (or, if shorter, the investor's holding period for the Class X Notes or Preferred Shares). As indicated above, any gain recognized upon disposition (or deemed disposition) of the Class X Notes or Preferred Shares will be treated as an excess distribution and taxed as described above (i.e., not be taxable as capital gain). For this purpose, a U.S. holder that uses a Class X Note or a Preferred Share as security for an obligation may be treated as having disposed of the Class X Note or Preferred Share.

Special rules apply to certain regulated investment companies that own interests in PFICs and any such investor should consult with its own tax advisors regarding the consequences to it of acquiring Class X Notes or Preferred Shares.

QEF Election. If a U.S. holder (including certain U.S. holders indirectly owning Class X Notes or Preferred Shares) makes the qualified electing fund election (the "QEF election") provided in Section 1295 of the Code, the U.S. holder will be required to include its *pro rata* share of the Issuer's ordinary income and net capital gains (unreduced by any prior year losses) in income (as ordinary income and long-term capital gain, respectively) for each taxable year and pay tax thereon even if such income and gain is not distributed to the U.S. holder by the Issuer. In addition, any losses of the Issuer will not be deductible by such U.S. holder. A U.S. holder that makes the QEF election, may, however (in general) elect to defer the payment of tax on undistributed income (until such income is distributed or the Class X Note or Preferred Share is transferred), provided it agrees to pay interest on such deferred tax liability. For this purpose, a U.S. holder that uses a Class X Note or Preferred Share as security for an obligation may be treated as having disposed of the Class X Note or Preferred Share, as applicable. If the Issuer later distributes the income or gain on which the U.S. holder has already paid taxes, amounts so distributed to the U.S. holder will not be further taxable to the U.S. holder. A U.S. holder's tax basis in the Class X Notes or Preferred Shares will be increased by the amount included in such U.S. holder's income and decreased by the amount of nontaxable distributions. In general, a U.S. holder making the QEF Election will recognize, on the disposition of the Class X Notes or Preferred Shares, capital gain or loss equal to the difference, if any, between the amount realized upon such disposition (including redemption or retirement) and his adjusted tax basis in such Class X Notes or Preferred Shares. In general, a QEF election should be made on or before the due date for filing a U.S. holder's federal income tax return for the first taxable year for which it held a Class X Note or Preferred Share.

The QEF election is effective only if certain required information is made available by the Issuer to the IRS. The Issuer will undertake to comply with the IRS information requirements necessary to be a QEF, which will permit U.S. holders to make the QEF election. Nonetheless, there can be no absolute assurance that such information will always be available or presented.

Where a QEF election is not timely made by a U.S. holder for the year in which it acquired its Class X Notes or Preferred Shares, but is made for a later year, the excess distribution rules can be avoided by making an election to recognize gain from a deemed sale of the Class X Notes or Preferred Shares at the time when the QEF election becomes effective.

A U.S. holder should consult its own tax advisors regarding whether it should make a QEF election (and, if it failed to make an initial election, whether it should make an election in a subsequent taxable year).

Prospective investors should be aware that the Issuer's income that is allocated to holders (under the QEF rules as well as under the CFC rules discussed below) will not necessarily bear any particular relationship in any year to the amount of cash that is distributed on the Class X Notes or Preferred Shares and in any given year may be substantially greater. Such an excess will arise, among other circumstances, when Collateral Assets are purchased at a discount, or interest or other income on the Collateral Assets (which is included in gross income) is used to acquire other Collateral Assets or to repay principal on the Notes and the CP Notes (which does not give rise to a deduction).

Status of the Issuer as a CFC. U.S. tax law also contains special provisions dealing with CFCs. A U.S. holder (or any other holder of an interest treated as voting equity in the foreign corporation that would meet the definition of U.S. Holders but for the fact that such holder does not hold Class X Notes or Preferred Shares) that owns (directly or indirectly) at least 10 percent of the voting stock of a foreign corporation, the U.S. holder is considered a "U.S. Shareholder" with respect to the foreign corporation. If U.S. Shareholders in the aggregate own (directly or indirectly) more than 50% of the voting power or value of the stock of such corporation, the foreign corporation will be classified as a CFC. Complex attribution rules apply for purposes of determining ownership of stock in a foreign corporation such as the Issuer.

If the Issuer is classified as a CFC, a U.S. Shareholder (and possibly any U.S. Holder that is a direct or indirect holder of a grantor trust that is considered to be a U.S. Shareholder) that is a shareholder of the Issuer as of the end of the Issuer's taxable year generally would be subject to current U.S. tax on the income of the Issuer, regardless of cash distributions from the Issuer. Earnings subject to tax generally as income of the U.S. Holder generally will not be taxed again when they are distributed to the U.S. Holder. In addition, income that would otherwise be characterized as capital gain and gain on the sale of the CFC's stock by a U.S. Shareholder (during the period that the corporation is a CFC and thereafter for a five-year period) would be classified in whole or in part as dividend income.

Certain income generated by a corporation conducting a banking, financing, insurance, or other similar business would not be includible in a holder's income under the CFC rules. However, each holder of a Class X Note or a Preferred Share will agree not to take the position that the Issuer is engaged in such a business. Accordingly, if the CFC rules apply, a U.S. Shareholder would generally be subject to tax on its share of all of the Issuer's income.

In general, U.S. Holders who acquire any Class X Notes or Preferred Shares for cash may be required to file a Form 926 with the IRS and to supply certain additional information to the IRS if (i) such U.S. Holder owns (directly or indirectly) immediately after the transfer, at least 10% by vote or value of the Issuer or (ii) the transfer when aggregated with all related transfers under applicable regulations, exceeds \$100,000. In the event a U.S. Holder that is required to file such form, fails to file such form, the U.S. Holder could be subject to a penalty of up to \$100,000 (computed as 10% of the gross amount paid for the Class X Notes or the Preferred Shares) or more if the failure to file was due to intentional disregard of its obligation). Other important information reporting requirements apply to persons that acquire 10% or more of a foreign corporation's equity.

Tax-Exempt Investors. Special considerations apply to pension plans and other investors ("Tax-Exempt Investors") that are subject to tax only on their "unrelated business taxable income" ("UBTI"). A Tax-Exempt Investor's income from an investment in the Issuer generally should not be treated as resulting in UBTI under current law, so long as such investor's acquisition of stock in the Issuer is not debt-financed.

Tax-Exempt Investors should consult their own tax advisors regarding an investment in the Issuer.

Taxation of Non-U.S. holders. Assuming that the Issuer at no time is engaged in a United States trade or business, dividends on, and gain from the sale, exchange or redemption of, Class X Notes or Preferred Shares generally should not be subject to United States federal income tax in the hands of a Non-U.S. holder that has no connection with the United States other than the holding of the Class X Notes or Preferred Shares.

Circular 230

Under 31 C.F.R. part 10, the regulations governing practice before the Internal Revenue Service (Circular 230), we and our tax advisors are (or may be) required to inform you that:

- i. Any advice contained herein, including any opinions of counsel referred to herein, is not intended or written to be used, and cannot be used by any taxpayer, for the purpose of avoiding penalties that may be imposed on the taxpayer;
- ii. Any such advice is written to support the promotion or marketing of the Notes and the transactions described herein (or in such opinion or other advice); and
- iii. Each taxpayer should seek advice based on the taxpayer's particular circumstances from an independent tax advisor.

Cayman Islands Tax Considerations

The following discussion of certain Cayman Islands income tax consequences of an investment in the Notes is based on the advice of Maples and Calder as to Cayman Islands law. The discussion is a general summary of present law, which is subject to prospective and retroactive change. It assumes that the Issuer will conduct its affairs in accordance with assumptions made by, and representations made to, counsel. It is not intended as tax advice, does not consider any investor's particular circumstances, and does not consider tax consequences other than those arising under Cayman Islands law.

Under existing Cayman Islands laws:

(i) payments of principal and interest in respect of the Notes and the Class X Payment will not be subject to taxation in the Cayman Islands and no withholding will be required on such payments to any Holder of a Note or Class X Note and gains derived from the sale of Notes and Class X Notes will not be subject to Cayman Islands income or corporation tax. The Cayman Islands currently have no income, corporation or capital gains tax and no estate duty, inheritance tax or gift tax; and

(ii) the Holder of any Note or Class X Note (or the legal personal representative of such Holder) whose Security is brought into the Cayman Islands may in certain circumstances be liable to pay stamp duty imposed under the laws of the Cayman Islands in respect of such Security. In addition, an instrument transferring title to a Security, if bought or executed in the Cayman Islands, would be subject to Cayman Islands stamp duty.

The Issuer has been incorporated under the laws of the Cayman Islands as an exempted company and, as such, has applied for and obtained an undertaking from the Governor In Cabinet of the Cayman Islands in the following form:

**THE TAX CONCESSIONS LAW
(1999 REVISION)
UNDERTAKING AS TO TAX CONCESSIONS**

In accordance with Section 6 of the Tax Concessions Law (1999 Revision) the Governor in Cabinet undertakes with G Street Finance Ltd. (the "Company"):

- (a) that no law which is hereafter enacted in the Islands imposing any tax to be levied on profits, income, gains or appreciations shall apply to the Company or its operations; and
- (b) in addition, that no tax to be levied on profits, income, gains or appreciations or which is in the nature of estate duty or inheritance tax shall be payable
 - (i) on or in respect of the shares, debentures or other obligations of the Company; or
 - (ii) by way of the withholding in whole or in part of any relevant payment as defined in Section 6(3) of the Tax Concessions Law (1999 Revision).

These concessions shall be for a period of twenty years from the 28th day of June, 2005.

CERTAIN ERISA CONSIDERATIONS

The U.S. Employee Retirement Income Security Act of 1974, as amended ("ERISA"), imposes certain requirements on "employee benefit plans" (as defined in Section 3(3) of ERISA) subject to Title I of ERISA, including entities such as collective investment funds and separate accounts whose underlying assets include the assets of such plans (collectively, "ERISA Plans"), and on those persons who are fiduciaries with respect to ERISA Plans. Investments by ERISA Plans are subject to ERISA's general fiduciary requirements, including the requirement of investment prudence and diversification and the requirement that an ERISA Plan's investments be made in accordance with the documents governing the Plan. The prudence of a particular investment must be determined by the responsible fiduciary of an ERISA Plan by taking into account the ERISA Plan's particular circumstances and all of the facts and circumstances of the investment including, but not limited to, the matters discussed above under "Risk Factors" and the fact that in the future there may be no market in which such fiduciary will be able to sell or otherwise dispose of the Securities.

Section 406 of ERISA and Section 4975 of the Code prohibit certain transactions involving the assets of an ERISA Plan (as well as those plans that are not subject to ERISA but which are subject to Section 4975 of the Code, such as individual retirement accounts (together with ERISA Plans, "Plans")) and certain persons (referred to as "parties in interest" under ERISA or "disqualified persons" under the Code (collectively, "Parties in Interest")) having certain relationships to such Plans, unless a statutory, regulatory or administrative exemption is applicable to the transaction. A Party in Interest who engages in a prohibited transaction may be subject to excise taxes and other penalties and liabilities under ERISA and Section 4975 of the Code.

The U.S. Department of Labor ("DOL") has promulgated a regulation, 29 C.F.R. Section 2510.3-101 (the "Plan Asset Regulation"), describing what constitutes the assets of a Plan ("Plan Assets") with respect to the Plan's investment in an entity for purposes of applying ERISA and Section 4975 of the Code. Under the Plan Asset Regulation, if a Plan invests in an "equity interest" of an entity that is neither a "publicly offered security" nor a security issued by an investment company registered under the Investment Company Act, the Plan's assets include both the equity interest and an undivided interest in each of the entity's underlying assets, unless it is established that the entity is an "operating company" or that equity participation in the entity by Benefit Plan Investors is not "significant."

Prohibited transactions may arise under Section 406 of ERISA or Section 4975 of the Code if Securities are acquired with Plan Assets with respect to which the Issuer, the Initial Purchaser, the Collateral Manager, or any of their respective affiliates, is a Party in Interest. Certain exemptions from the

prohibited transaction provisions of Section 406 of ERISA and Section 4975 of the Code may be applicable, however, depending in part on the type of Plan fiduciary making the decision to acquire a Security and the circumstances under which such decision is made. Included among these exemptions are: DOL Prohibited Transaction Class Exemption ("PTCE") 96-23, regarding transactions effected by "in-house asset managers"; PTCE 95-60, regarding investments by insurance company general accounts; PTCE 91-38, regarding investments by bank collective investment funds; PTCE 90-1, regarding investments by insurance company pooled separate accounts; and PTCE 84-14, regarding transactions effected by "qualified professional asset managers." There can be no assurance that any class or other exemption will be available with respect to any particular transaction involving the Securities, or that, if available, the exemption would cover all possible prohibited transactions.

Governmental plans and certain church and other plans, while not necessarily subject to the fiduciary responsibility provisions of ERISA or the provisions of Section 4975 of the Code, may nevertheless be subject to state or other federal laws that are substantially similar to the foregoing provisions of ERISA and the Code. Fiduciaries of any such plans should consult with their counsel before purchasing any Securities.

Any insurance company proposing to invest assets of its general account in the Securities should consider the extent to which such investment would be subject to the requirements of ERISA in light of the U.S. Supreme Court's decision in *John Hancock Mutual Life Insurance Co. v. Harris Trust and Savings Bank*, 510 U.S. 86 (1993), and the enactment of Section 401(c) of ERISA. In particular, such an insurance company should consider the retroactive and prospective exemptive relief granted by the DOL for transactions involving insurance company general accounts in PTCE 95-60 and the regulations issued by the DOL, 29 C.F.R. Section 2550.401c-1 (January 5, 2000). Certain additional information regarding general accounts is set forth below.

Any Plan fiduciary or other person who proposes to use Plan Assets to purchase any Securities should consult with its counsel regarding the applicability of the fiduciary responsibility and prohibited transaction provisions of ERISA and Section 4975 of the Code to such an investment, and to confirm that such investment will not constitute or result in a non-exempt prohibited transaction or any other violation of an applicable requirement of ERISA.

The sale of any Security to a Plan, or to a person using Plan Assets to effect its purchase of any Security, is in no respect a representation by the Issuers, the Initial Purchaser, the Collateral Adviser or the Collateral Manager that such an investment meets all relevant legal requirements with respect to investments by Plans generally or any particular Plan, or that such an investment is appropriate for Plans generally or any particular Plan.

Class A Notes, Class B Notes, Class C Notes and Class D Notes

For purposes of the Plan Asset Regulation, an equity interest includes any interest in an entity other than an instrument that is treated as indebtedness under applicable local law and which has no substantial equity features. Because the Notes (other than the Class E Notes) (a) are expected to be treated as indebtedness under local law and for federal tax purposes (see "Income Tax Considerations" herein), and (b) should not be deemed to have any "substantial equity features," purchases of the Notes with Plan Assets should not be treated as equity investments and, therefore, the Collateral Assets should not be deemed to be Plan Assets of the investing Plans. Those conclusions are based, in part, upon the traditional debt features of the Notes, including the reasonable expectation of purchasers of the Notes that the Notes will be repaid when due, as well as the absence of conversion rights, warrants and other typical equity features. However, if the Notes were nevertheless treated as equity interests for purposes of the Plan Asset Regulation and if the assets of the Issuer were deemed to constitute Plan Assets of an investing Plan, (i) transactions involving the assets of the Issuer could be subject to the fiduciary responsibility and prohibited transaction provisions of ERISA and Section 4975 of the Code, (ii) the assets of the Issuer could be subject to ERISA's reporting and disclosure requirements, and (iii) the fiduciary causing the Plan to make an investment in the Notes could be deemed to have delegated its responsibility to manage Plan Assets.

By its purchase of any Class A Note, Class B Note, Class C Note or Class D Note, the purchaser thereof will be deemed to have represented and warranted either that (i) it is not and will not be Plan or an entity whose underlying assets include Plan Assets by reason of any Plan's investment in the entity, or an employee benefit plan which is subject to any federal, state, local or foreign law ("Similar Law") that is substantially similar to the provisions of Section 406 of ERISA or Section 4975 of the Code; or (ii) its purchase and holding of a Class A Note, Class B Note, Class C Note or Class D Note are eligible for the exemptive relief available under PTCE 84-14, 90-1, 91-38, 95-60, 96-23 or a similar exemption or, in the case of a plan subject to Similar Law, do not and will not constitute or result in a prohibited transaction under Similar Law for which an exemption is not available.

Class E Notes, Class X Notes and Preferred Shares

Equity participation in an entity by Benefit Plan Investors is "significant" under the Plan Asset Regulation (see above) if 25% or more of the value of any class of equity interest in the entity is held by Benefit Plan Investors. If equity participation in the Issuer by Benefit Plan Investors is "significant," the assets of the Issuer could be deemed to be Plan Assets of Plans investing in the equity. If the assets of the Issuer were deemed to constitute Plan Assets of an investing Plan, (i) transactions involving the assets of the Issuer could be subject to the fiduciary responsibility and prohibited transaction provisions of ERISA and Section 4975 of the Code, (ii) the assets of the Issuer could be subject to ERISA's reporting and disclosure requirements, and (iii) the fiduciary causing the Plan to make an equity investment in the Issuer could be deemed to have delegated its responsibility to manage Plan Assets. The term "Benefit Plan Investor" includes (i) an employee benefit plan (as defined in Section 3(3) of ERISA) whether or not it is subject to the provisions of Title I of ERISA, (ii) a plan described in Section 4975(e)(1) of the Code and (iii) any entity whose underlying assets include Plan Assets by reason of any such plan's investment in the entity. For purposes of making the 25% determination, the value of any equity interests in the Issuer held by a person (other than a Benefit Plan Investor) who has discretionary authority or control with respect to the assets of the Issuer, any person who provides investment advice for a fee (direct or indirect) with respect to such assets, or any affiliate of such a person (any of the foregoing, a "Controlling Person"), are disregarded. Under the Plan Asset Regulation, an "affiliate" of a person includes any person, directly or indirectly through one or more intermediaries, controlling, controlled by or under common control with the person, and "control" with respect to a person, other than an individual, means the power to exercise a controlling influence over the management or policies of such person.

The Preferred Shares are not indebtedness under applicable local law and will be equity interests for purposes of applying ERISA and Section 4975 of the Code. Because the Class E Notes and Class X Notes may be deemed to have "substantial equity features," the Class E Notes and the Class X Notes may be deemed to constitute equity interests for such purposes. Accordingly, purchases and transfers of Class E Notes, Class X Notes and Preferred Shares will be limited, so that less than 25% of the value of all Class E Notes, less than 25% of the value of all Class X Notes and less than 25% of the value of all the Preferred Shares will be held by Benefit Plan Investors, by requiring each purchaser or transferee of a Class E Note, Class X Note or Preferred Share to make certain representations and agree to additional transfer restrictions described under "Notice to Investors." No purchase of a Class E Note, Class X Note or Preferred Share by, or proposed transfer to, a person that has represented that it is a Benefit Plan Investor or a Controlling Person will be permitted to the extent that such purchase or transfer would result in persons that have represented that they are Benefit Plan Investors owning 25% or more of the outstanding Class E Notes, 25% or more of the outstanding Class X Notes or 25% or more of the outstanding Preferred Shares immediately after such purchase or proposed transfer (determined in accordance with the Plan Asset Regulation and the Indenture and the Preferred Share Paying and Transfer Agency Agreement), based upon the representations made by investors. In addition, the Initial Purchaser, the Collateral Manager and the Trustee agree that neither they nor any of their respective affiliates will acquire any Class E Notes, Class X Notes or Preferred Shares unless such acquisition would not, as determined by the Trustee, result in persons that have acquired Class E Notes, Class X Notes or Preferred Shares and represented that they are Benefit Plan Investors owning 25% or more of the outstanding Class E Notes, 25% or more of the outstanding Class X Notes or 25% or more of the outstanding Preferred Shares immediately after such acquisition by the Initial Purchaser, the Collateral Manager or the Trustee. Class E Notes, Class X Notes and Preferred Shares held as principal by the

Initial Purchaser, the Collateral Manager, the Trustee, any of their respective affiliates and persons that have represented that they are Controlling Persons will be disregarded and will not be treated as outstanding for purposes of determining compliance with the 25% limitation to the extent that such a Controlling Person is not a Benefit Plan Investor. Any Benefit Plan Investor that acquires Class E Notes, Class X Notes or Preferred Shares will be required to represent and agree that the acquisition and holding of the Class E Notes, Class X Notes or Preferred Shares do not and will not constitute a prohibited transaction under ERISA or Section 4975 of the Code, or under any Similar Law, for which an exemption is not available.

The U.S. Supreme Court, in *John Hancock* (noted above), held that those funds allocated to the general account of an insurance company pursuant to a contract with an employee benefit plan which vary with the investment experience of the insurance company are "plan assets." In the preamble to PTCE 95-60 (also noted above), the DOL noted that, for purposes of calculating the 25% threshold under the significant participation test of the Plan Asset Regulation, only the proportion of an insurance company general account's equity investment in the entity that represents Plan Assets should be taken into account in calculating that portion of the general account that is a Benefit Plan Investor. Any insurance company using general account assets to purchase Class E Notes, Class X Notes or Preferred Shares will be asked (i) to identify the maximum percentage of the assets of the general account that may be or become Plan Assets, (ii) whether it is a "Controlling Person" (defined above), and (iii) without limiting the remedies that may be available in the event that the maximum percentage is thereafter exceeded, to agree to notify the Issuer, and dispose of Class E Notes, Class X Notes or Preferred Shares as instructed by the Issuer, before the specified maximum percentage is exceeded.

Tax Penalty Avoidance

The summary of ERISA considerations contained herein was written to support the promotion and marketing of the Securities, and was not intended or written to be used, and cannot be used, by a taxpayer for the purpose of avoiding any U.S. federal tax penalties that may be imposed. Each taxpayer should seek advice based on the taxpayer's particular circumstances from an independent tax advisor.

CERTAIN LEGAL INVESTMENT CONSIDERATIONS

Institutions whose investment activities are subject to legal investment laws and regulations or to review by certain regulatory authorities may be subject to restrictions on investments in the Notes, the Class X Notes, the CP Notes and the Preferred Shares. Any such institution should consult its legal advisors in determining whether and to what extent there may be restrictions on its ability to invest in the Notes, the Class X Notes, the CP Notes and the Preferred Shares. Without limiting the foregoing, any financial institution that is subject to the jurisdiction of the Comptroller of Currency, the Board of Governors of the Federal Reserve System, the Federal Deposit Insurance Corporation, the Office of Thrift Supervision, the National Credit Union Administration, any state insurance commission, or any other federal or state agencies with similar authority should review any applicable rules, guidelines and regulations prior to purchasing the Notes, the Class X Notes, the CP Notes or the Preferred Shares. Depository institutions should review and consider the applicability of the Federal Financial Institutions Examination Council Supervisory Policy Statement on Securities Activities, which has been adopted by the respective federal regulators.

None of the Issuers or the Initial Purchaser make any representation as to the proper characterization of the Notes, the Class X Notes, the CP Notes or Preferred Shares for legal investment or other purposes, or as to the ability of particular investors to purchase the Notes, the Class X Notes, the CP Notes or the Preferred Shares for legal investment or other purposes, or as to the ability of particular investors to purchase the Notes, the Class X Notes, the CP Notes or the Preferred Shares under applicable investment restrictions. The Issuers understand that certain state insurance regulators, in response to a request for guidance, may be considering the characterization (as U.S. domestic or foreign (non-U.S.)) of certain collateralized debt obligation securities co-issued by a non-U.S. issuer and a U.S. co-issuer. There can be no assurance as to the nature of any guidance or other action that may result from such consideration. The uncertainties described above (and any unfavorable future determinations

concerning legal investment or financial institution regulatory characteristics of the Notes, CP Notes or Preferred Shares) may affect the liquidity of the Notes, the Class X Notes, the CP Notes or the Preferred Shares. Accordingly, all institutions whose activities are subject to legal investment laws and regulations, regulatory capital requirements or review by regulatory authorities should consult their own legal advisors in determining whether and to what extent the Notes, the Class X Notes, the CP Notes or the Preferred Shares are subject to investment, capital or other restrictions.

LISTING AND GENERAL INFORMATION

1. Application may be made to admit the Securities on a stock exchange of the Issuer's choice, if practicable. There can be no assurance that such admission will be sought or granted. Copies of this offering circular, the Memorandum and Articles of Association of the Issuer and the organization documents of the Co-Issuer, the Indenture, the Collateral Management Agreement, the Collateral Advisory Agreement, the CP Put Agreement, the Preferred Share Paying and Transfer Agency Agreement and any Hedge Agreements will be deposited with the Note Paying Agents, the Listing and Paying Agent and at the registered office of the Issuer, where copies thereof may be obtained, free of charge, upon request within fourteen days of the date of the Listing Particulars.

2. Copies of the Memorandum and Articles of Association of the Issuer, the organizational documents of the Co-Issuer, the resolutions of the Board of Directors of the Issuer authorizing the issuance of the Securities, and the execution of the Indenture, the Preferred Share Paying and Transfer Agency Agreement, the Collateral Management Agreement, the Collateral Advisory Agreement, the CP Put Agreement, the CP Issuing and Paying Agency Agreement, the CP Note Placement Agreement and the Hedge Agreements and the resolutions of the sole member of the Co-Issuer authorizing the issuance of the Notes, and the execution of the Indenture may be obtained free of charge upon request within thirty days of the date of this offering circular at the office of a Paying Agent on behalf of the Issuer.

3. Each of the Issuers represents that there has been no material adverse change in its financial position since its date of creation.

4. The Issuer is not required by Cayman Islands law, and the Issuer does not intend, to publish annual reports and accounts. The Co-Issuer is not required by Delaware law, and the Co-Issuer does not intend, to publish annual reports and accounts. The Indenture, however, requires the Issuer to deliver to the Trustee a Director's Certificate stating, as to each signatory thereof, that (a) a review of the activities of the Issuer during the prior year and of the Issuer's performance under the Indenture has been made under his supervision; and (b) to the best of his knowledge, based on such review, the Issuer has fulfilled all of its obligations under the Indenture throughout the prior year, or, if there has been a default in the fulfillment of any such obligation, specifying each such default known to him and the nature and status thereof.

5. The Issuers are not, and have not since incorporation or formation, as applicable, been, involved in any litigation or arbitration proceedings relating to claims in amounts which may have or have had a material effect on the Issuers in the context of the issue of the Notes nor, so far as each of the Issuers is aware, is any such litigation or arbitration involving it pending or threatened.

6. The issuance of the Securities will be authorized by the Board of Directors of the Issuer by resolutions passed on or about the Closing Date. The issuance of the Notes will be authorized by the sole member of the Co-Issuer by action by written consent of the sole member passed on or about the Closing Date. Since incorporation or formation, as applicable, neither the Issuer nor the Co-Issuer has commenced trading or established any accounts, except as disclosed herein or accounts used to hold amounts received with respect to share capital and fees.

7. The Notes sold in offshore transactions in reliance on Regulation S and represented by the Regulation S Global Notes have been accepted for clearance through Clearstream and Euroclear under the Common Codes indicated below. The CUSIP Numbers and International Securities Identification Numbers ("ISIN") for the Notes represented by Regulation S Global Notes and Rule 144A Global Notes are as indicated below:

LEGAL MATTERS

Certain legal matters will be passed upon for the Collateral Adviser by Speechly Bircham, with respect to English law, and for the Collateral Manager by Appleby Spurling Hunder, with respect to Bermudan law. Certain matters with respect to Cayman Islands law will be passed upon for the Issuer by Maples and Calder. Certain legal matters will be passed upon for the Issuer and Goldman, Sachs & Co. by Orrick, Herrington & Sutcliffe LLP, New York, New York.

UNDERWRITING

The Offered Securities will be offered by Goldman, Sachs & Co. (the "Initial Purchaser"), from time to time at varying prices in negotiated transactions subject to prior sale, when, as and if issued. Subject to the terms and conditions set forth in the Purchase Agreement (the "Purchase Agreement") dated as of October 20, 2005 among Goldman, Sachs & Co. and the Issuers, the Issuers have agreed to sell to Goldman, Sachs & Co. and Goldman, Sachs & Co. has agreed to purchase all of the Notes (other than the Class A-1LT-b Notes and the Class E Notes), the Class X Notes and the Preferred Shares. It is anticipated that Goldman, Sachs & Co. or one of its affiliates may initially retain the Class X Notes and may sell any such Securities from time to time in privately negotiated transactions.

Under the terms and conditions of the Purchase Agreement, Goldman, Sachs & Co. is committed to take and pay for all the Offered Securities to be offered by it, if any are taken. Furthermore, under the terms and conditions of the Purchase Agreement, Goldman, Sachs & Co. will be entitled to an

underwriting discount on the Offered Securities purchased by it and a fixed structuring fee based upon the aggregate principal amount of the Notes and aggregate Initial Stated Amount of the Preferred Shares. On the Closing Date, the CP Put Counterparty will be entitled to a fixed structuring fee.

The Offered Securities purchased from the Issuers by the Initial Purchaser will be offered by it from time to time for sale in negotiated transactions or otherwise at varying prices to be determined at the time of sale *plus* accrued interest, if any, from the Closing Date.

The Securities have not been and will not be registered under the Securities Act for offer or sale as part of their distribution and may not be offered or sold within the United States or to, or for the account or benefit of, a U.S. Person or a U.S. resident (as determined for purposes of the Investment Company Act, a "U.S. Resident") except in certain transactions exempt from, or not subject to, the registration requirements of the Securities Act.

The Issuers have been advised by the Initial Purchaser that (a) they propose to resell the Offered Securities outside the United States (in part, by Goldman, Sachs & Co., through its selling agent) in offshore transactions in reliance on Regulation S and in accordance with applicable law and (b) they propose to resell the Offered Securities in the United States only to (1) Qualified Institutional Buyers in reliance on Rule 144A purchasing for their own accounts or for the accounts of Qualified Institutional Buyers or (2) in the case of the Class X Notes and the Preferred Shares only, Accredited Investors, which have a net worth of not less than U.S.\$10 million each of which purchasers or accounts is a Qualified Purchaser. The Initial Purchaser's discount will be the same for the Regulation S Notes and the Rule 144A Notes offered hereby and for the Preferred Shares and the Class X Notes within each Class of Securities.

The Initial Purchaser has acknowledged and agreed that it will not offer, sell or deliver any Regulation S Notes or Regulation S Preferred Shares purchased by it to, or for the account or benefit of, any U.S. Person or U.S. Resident (as determined for purposes of the Investment Company Act) as part of its distribution at any time and that it will send to each distributor, dealer or person receiving a selling concession, fee or other remuneration to which it sells Regulation S Notes or Regulation S Preferred Shares purchased by it a confirmation or other notice setting forth the prohibition on offers and sales of the Regulation S Notes or Regulation S Preferred Shares within the United States or to, or for the account or benefit of, any U.S. Person or U.S. Resident.

With respect to the Securities initially sold pursuant to Regulation S, until the expiration of (x) 40 days after the commencement of the distribution of the offering of the Notes by the Initial Purchaser, with respect to offers or sales of the Notes and (y) one year after the commencement of the distribution of the Class X Notes and Preferred Shares, with respect to offers or sales of the Class X Notes or Preferred Shares purchased by Goldman, Sachs & Co., an offer or sale of Securities within the United States by a dealer that is not participating in the offering may violate the registration requirements of the Securities Act if such offer or sale is made otherwise than in accordance with Rule 144A or pursuant to another exemption from registration under the Securities Act.

The Initial Purchaser has represented, warranted and agreed that: (i) it has only communicated or caused to be communicated and will only communicate or cause to be communicated any invitation or inducement to engage in investment activity (within the meaning of section 21 of the Financial Services and Markets Act 2000 ("FSMA")) received by it in connection with the issue or sale of any Securities in circumstances in which section 21(1) of the FSMA does not apply to the Issuer; and (ii) it has complied and will comply with all applicable provisions of the FSMA with respect to anything done by it in relation to the Securities in, from or otherwise involving the United Kingdom. See "Underwriting."

The Securities may not be offered or sold by means of any document other than to persons whose ordinary business is to buy or sell shares or debentures, whether as principal or agent, or in circumstances which do not constitute an offer to the public within the meaning of the Companies Ordinance (Cap. 32) of Hong Kong, and no advertisement, invitation or document relating to the Securities may be issued, whether in Hong Kong or elsewhere, which is directed at, or the contents of which are likely to be accessed or read by, the public in Hong Kong (except if permitted to do so under

No action has been or will be taken in any jurisdiction that would permit a public offering of the Securities, or the possession, circulation or distribution of this Offering Circular or any other material relating to the Issuers or the Securities, in any jurisdiction where action for such purpose is required. Accordingly, the Securities may not be offered or sold, directly or indirectly, and neither this Offering Circular nor any other offering material or advertisements in connection with the Securities may be distributed or published, in or from any country or jurisdiction except under circumstances that will result in compliance with any applicable rules and regulations of any such country or jurisdiction.

The Securities are a new issue of securities with no established trading market. The Issuers have been advised by the Initial Purchaser that it may make a market in the Securities it is offering but is not obligated to do so and may discontinue market making at any time without notice. No assurance can be given as to the liquidity of the trading market for the Securities. There can be no assurance that any secondary market for any of the Securities will develop, or, if a secondary market does develop, that it will provide the Holders of the Securities with liquidity of investment or that it will continue for the life of the Securities.

Application may be made to admit the Securities on a stock exchange of the Issuer's choice, if practicable. There can be no assurance that such admission will be sought or granted.

The Issuers have agreed to indemnify the Initial Purchaser, the Collateral Manager, the Issuer Administrator and the Trustee and their respective directors, officers, employees and agents against certain liabilities, including in the case of the Initial Purchaser, liabilities under the Securities Act, or to contribute to payments they may be required to make in respect thereof. In addition, the Issuers have made certain representations and warranties to the Initial Purchaser and have agreed to reimburse the Initial Purchaser for certain of their expenses.

The Initial Purchaser may, from time to time as principal or through one or more investment funds that it manages, make investments in the equity securities of one or more of the issuers of Collateral Assets with the result that one or more of such issuers may be or may become controlled by the Initial Purchaser.

APPENDIX A Certain Definitions

"Accounts" means collectively, the Collection Account, the Payment Account, the Expense Reserve Account, the Hedge Termination Receipts Account, the Hedge Replacement Account, the Hedge Collateral Account, the Collateral Account, the CP Interest Reserve Account, the CP Principal Reserve Account and the CP Put Collateral Account.

"Actual Rating" means with respect to any Collateral Asset or Eligible Investment, the actual expressly monitored outstanding public rating assigned by a Rating Agency without reference to any other rating by another Rating Agency, and which rating by its terms addresses the full scope of the payment promise of the obligor on such Collateral Asset or Eligible Investment, after taking into account any applicable guarantee or insurance policy or if no such rating is available from a Rating Agency, any "credit estimate" or "shadow rating" assigned by such Rating Agency. For purposes of this definition, (i) the rating of "Aaa" assigned by Moody's to a Collateral Asset or an Eligible Investment placed on watch for possible downgrade by Moody's will be deemed to have been downgraded by Moody's by one subcategory and any other rating assigned by Moody's to a Collateral Asset or an Eligible Investment placed on watch for possible downgrade by Moody's will be deemed to have been downgraded by Moody's by two subcategories, (ii) the rating assigned by S&P to a Collateral Asset or an Eligible Investment placed on watch for possible downgrade by S&P will be deemed to have been downgraded by S&P by one subcategory, and (iii) the rating assigned by Moody's or S&P to a Collateral Asset or Eligible Investment placed on watch for possible upgrade by such Rating Agency will be deemed to have been upgraded by such Rating Agency by one subcategory.

"Adjusted Net Outstanding Portfolio Collateral Balance" means, on any Determination Date, the Net Outstanding Portfolio Collateral Balance reduced by the excess, if any, of (i) the product of (a) the Statistical Loss Amount and (b) the lesser of 1 and a fraction the numerator of which is U.S.\$1,500,900,000 and the denominator of which is the Net Outstanding Portfolio Collateral Balance as of such Determination Date over (ii) the product of (a) U.S.\$1,700,000 and (b) the lesser of 1 and a fraction the numerator of which is the Net Outstanding Portfolio Collateral Balance as of such Determination Date and denominator of which is U.S.\$1,500,900,000.

"Administrative Expenses" means amounts (including indemnities) due or accrued with respect to any Payment Date and payable by the Issuer and/or the Co-Issuer to (i) the Trustee pursuant to the Indenture or any co-trustee appointed pursuant to the Indenture; (ii) the Issuer Administrator pursuant to the Administration Agreement; (iii) the independent accountants, agents (including the Note Agents under the Indenture, the Preferred Share Agents as defined under the Preferred Share Paying and Transfer Agency Agreement, the Collateral Administrator under the Collateral Administration Agreement and the CP Issuing and Paying Agent under the CP Issuing and Paying Agency Agreement) and counsel of the Issuer for fees and expenses (including amounts payable in connection with the preparation of tax forms on behalf of the Issuers); (iv) the Collateral Manager pursuant to the Collateral Management Agreement (other than the Collateral Management Fee) and the Collateral Adviser pursuant to the Collateral Advisory Agreement; (v) the CP Note Placement Agents pursuant to the CP Note Placement Agreement (other than the CP Note Placement Agent Fee); (vi) the CP Put Counterparty pursuant to the CP Put Agreement (other than the CP Put Premium); (vii) the Rating Agencies for fees and expenses in connection with any rating or credit estimate (including the fees payable to the Rating Agencies for the monitoring of any rating or credit estimate) of the Notes and the CP Notes, including fees and expenses, if any, due or accrued in connection with any rating of the Collateral Assets; (viii) any other person in respect of any governmental fee, charge or tax in relation to the Issuer or the Co-Issuer; (ix) to the liquidator(s) of the Issuer for the fees and expenses of liquidating the Issuer following the redemption or Defeasance of all of the Notes and the CP Notes; (x) any stock exchange listing any Securities at the request of the Issuer; and (xi) any other person in respect of any other fees or expenses (including indemnities and fees relating to the provision of the Issuer's registered office) permitted under the Transaction Documents; provided that Administrative Expenses shall not include (a) any amounts due or accrued with respect to the actions

taken on or in connection with the Closing Date, (b) amounts payable in respect of the Notes, the CP Notes and the Preferred Shares, (c) amounts payable under any Hedge Agreement and (d) any Collateral Management Fee payable pursuant to the Collateral Management Agreement.

"Aggregate Calculation Amount of Defaulted Obligations and Deferred Interest PIK Bonds" means the least of (a) the Aggregate Moody's Recovery Value of all Defaulted Obligations and Deferred Interest PIK Bonds, (b) the Aggregate S&P Recovery Value of all Defaulted Obligations and Deferred Interest PIK Bonds, and (c) the aggregate of the Market Values of all Defaulted Obligations and Deferred Interest PIK Bonds.

"Aggregate Moody's Recovery Value" means, with respect to Defaulted Obligations and Deferred Interest PIK Bonds, the aggregate of (a) the Moody's Recovery Rate for each such asset multiplied by (b) the Principal Balance of such asset.

"Aggregate Outstanding Amount" means, with respect to any of the Notes, CP Notes or Preferred Shares, the aggregate principal amount of such Notes or CP Notes or the Stated Amount of Preferred Shares Outstanding at the date of determination.

"Aggregate Principal Amount" means the aggregate of the Principal Balances of all Collateral Assets and Eligible Investments purchased with Principal Proceeds and the amount of any cash which constitutes Principal Proceeds.

"Aggregate S&P Recovery Value" means the sum of, with respect to each Defaulted Obligation and each Deferred Interest PIK Bond of the lesser of (a) the Market Value for such Defaulted Obligation or Deferred Interest PIK Bond, as applicable, and (b) the S&P Recovery Rate for such Collateral Asset multiplied by the Principal Balance of such Collateral Asset.

"Applicable Recovery Rate" means, with respect to any Collateral Asset on any Determination Date, the lesser of (a) the Moody's Recovery Rate and (b) the S&P Recovery Rate.

"Asset-Backed Securities" or "ABS Securities" means asset-backed securities that entitle the holders thereof to receive payments that depend (except for rights or other assets designed to assure the servicing or timely distribution of proceeds to holders of such asset-backed securities) on the cash flow from loans arising from certain shipping loans.

"Auction Payment Date" means the Auction Date on which the Notes and Preferred Shares will be redeemed, the LIBOR CP Notes will be redeemed and Defeased and the other CP Notes will be Defeased in whole in connection with a successful Auction.

"Board of Directors" means, with respect to the Issuer or the Co-Issuer, the directors of the Issuer or the Co-Issuer, as applicable, duly appointed by the shareholders or the directors of the Issuer or the Co-Issuer, as applicable.

"Calculation Amount" means, with respect to any Defaulted Obligation or Deferred Interest PIK Bond at any time, the lesser of (a) the Market Value of such Defaulted Obligation or Deferred Interest PIK Bond or (b) the Applicable Recovery Rate multiplied by the Principal Balance of such Defaulted Obligation or Deferred Interest PIK Bond. For purposes of determining the Calculation Amount, the Principal Balance of a Defaulted Obligation shall be deemed to be its outstanding principal amount and the Principal Balance of a Deferred Interest PIK Bond shall be deemed to be its outstanding principal amount without regard to any deferred or capitalized interest.

"Cashflow Swap Capped Amount" means an amount equal to U.S.\$20,000,000; *provided* that, if the Class A/B Overcollateralization Ratio is less than 102.3% as of the most recent Determination Date, then U.S.\$10,000,000 and *provided further*, that if the Class A/B Overcollateralization Ratio is less than 101.0% on any Determination Date, then zero.

"CDO RMBS Securities" means CDO Securities that entitle the holders thereof to receive payments that depend (except for rights or other assets designed to assure the servicing or timely distribution of proceeds to holders of such CDO Securities) on the cash flow from (and not the market value of) a portfolio of at least 80% by principal balance of RMBS Securities.

"CDO Securities" means collateralized debt obligations (including, without limitation, any synthetic collateralized debt obligations or collateralized loan obligations) which may be categorized as CDO Structured Product Securities, CDO RMBS Securities, Collateralized Loan Securities and CDO Trust Preferred Securities.

"CDO Structured Product Securities" means CDO Securities that entitle the holders thereof to receive payments that depend (except for rights or other assets designed to assure the servicing or timely distribution of proceeds to holders of such CDO Securities) on the cash flow from a portfolio diversified among categories of REIT Debt Securities, Asset-Backed Securities, Residential Mortgage-Backed Securities, Commercial Mortgage-Backed Securities and CDO Securities or any combination of more than one of the foregoing or solely of CDO Securities (and which may include limited amounts of corporate securities), generally having the following characteristics: (i) repayment thereof can vary substantially from the contractual payment schedule (if any), with early prepayment of individual debt securities depending on numerous factors specific to the particular issuers or obligors and upon whether, in the case of loans or securities bearing interest at a fixed rate, such loans or securities include an effective prepayment premium, and (ii) proceeds from such repayments can for a limited period and subject to compliance with certain eligibility criteria be reinvested in additional loans and/or debt securities.

"CDO Trust Preferred Securities" means CDO Securities that entitle the holder thereof to receive payments that depend (except for rights or other assets designed to assure the servicing or timely distribution of proceeds to holders of such CDO Securities) on the cash flow from a portfolio of trust preferred securities issued by bank, thrift, other depository institutions or trust subsidiaries.

"Class" means each class of Notes or Class X Notes having the same Stated Maturity and same alphabetical (but not necessarily numerical) designation of any of "A", "B", "C", "D", "E" and "X", as a single class, the CP Notes (considered as a whole, regardless of the date of issuance or the date of maturity thereof) as a single class and the Preferred Shares as a single class.

"Class A Adjusted Overcollateralization Ratio" means, with respect to any Determination Date, the Adjusted Net Outstanding Portfolio Collateral Balance (for the purposes of such calculation, the Adjusted Net Outstanding Portfolio Collateral Balance will not include Principal Proceeds held as cash and Eligible Investments) divided by the aggregate outstanding principal amount of the Class A Notes and the CP Notes, after giving effect to payments or Defeasance, as applicable, to be made on the succeeding Payment Date (or, with respect to Defeasance, thereafter) in accordance with the Priority of Payments.

"Class A Note Redemption Price" shall equal the Class A-1LT-a Note Redemption Price, the Class A-1LT-b-1 Note Redemption Price, the Class A-1LT-b-2 Note Redemption Price and the Class A-2 Note Redemption Price.

"Class A Overcollateralization Ratio" as of any Determination Date will equal the ratio (expressed as a percentage) obtained by dividing (i) the Net Outstanding Portfolio Collateral Balance on such Determination Date calculated (x) without including Double B Rated Assets and Single B Rated Assets in the calculation of the amount subtracted under clause (iii) of the definition thereof and (y) without including the Double B Calculation Amount and the Single B Calculation Amount in the calculation of the amount added under clause (iv) of the definition thereof and (z) without excluding Double B Rated Assets and Single B Rated Assets from the calculation of the amount subtracted under clause (v) of the definition thereof (provided that such amount shall exclude Principal Proceeds held as cash and Eligible Investments) by (ii) the sum of the aggregate outstanding principal amount of the CP Notes and the Class A Notes minus any amount deposited in the CP Principal Reserve Account to Defeasance the CP Notes,

minus Principal Proceeds expected to be available prior to clause (xiii) of the Priority of Payments on the related Payment Date assuming that the Coverage Tests are satisfied, (excluding, without duplication, Principal Proceeds required to be deposited in the CP Interest Reserve Account).

"Class A-1LT-a Note Redemption Price" shall equal (i) the outstanding principal amount of the Class A-1LT-a Notes *plus* (ii) accrued and unpaid interest thereon (including Defaulted Interest and interest on Defaulted Interest, if any) to but excluding the Redemption Date.

"Class A-1LT-b-1 Note Redemption Price" shall equal (i) the outstanding principal amount of the Class A-1LT-b-1 Notes *plus* (ii) accrued and unpaid interest thereon (including Defaulted Interest and interest on Defaulted Interest, if any) to but excluding the Redemption Date.

"Class A-1LT-b-2 Note Redemption Price" shall equal (i) the outstanding principal amount of the Class A-1LT-b-2 Notes *plus* (ii) accrued and unpaid interest thereon (including Defaulted Interest and interest on Defaulted Interest, if any) to but excluding the Redemption Date.

"Class A-2 Note Redemption Price" shall equal (i) the outstanding principal amount of the Class A-2 Notes *plus* (ii) accrued and unpaid interest thereon (including Defaulted Interest and interest on Defaulted Interest, if any) to but excluding the Redemption Date.

"Class B Adjusted Overcollateralization Ratio" means, with respect to any Determination Date, the Adjusted Net Outstanding Portfolio Collateral Balance (for the purposes of such calculation, the Adjusted Net Outstanding Portfolio Collateral Balance will not include Principal Proceeds held as cash and Eligible Investments) divided by the sum of the aggregate outstanding principal amount of the CP Notes, Class A Notes and the Class B Notes, after giving effect to payments or Defeasance, as applicable to be made on the succeeding Payment Date (or, with respect to Defeasance, thereafter) in accordance with the Priority of Payments.

"Class B Note Redemption Price" shall equal (i) the outstanding principal amount of the Class B Notes, *plus* (ii) accrued interest thereon (including Defaulted Interest and interest on Defaulted Interest, if any) to, but excluding, the Redemption Date.

"Class C Adjusted Overcollateralization Ratio" means, with respect to any Determination Date, the Adjusted Net Outstanding Portfolio Collateral Balance (for the purposes of such calculation, the Adjusted Net Outstanding Portfolio Collateral Balance will not include Principal Proceeds held as cash and Eligible Investments) divided by the sum of the aggregate outstanding principal amount of the Class A Notes, the CP Notes, the Class B Notes and the Class C Notes, after giving effect to payments or Defeasance, as applicable, to be made on the succeeding Payment Date (or, with respect to Defeasance, thereafter) in accordance with the Priority of Payments.

"Class C Note Redemption Price" shall equal the sum of (i) the outstanding principal amount of the Class C Notes (including any Class C Deferred Interest) *plus* (ii) accrued interest thereon (including any Defaulted Interest and any interest on Defaulted Interest, if any) to but excluding the Redemption Date.

"Class D Note Redemption Price" shall equal the sum of (i) the outstanding principal amount of the Class D Notes (including any Class D Deferred Interest) *plus* (ii) accrued interest thereon (including any Defaulted Interest and any interest on Defaulted Interest, if any) to but excluding the Redemption Date.

"Class D Notes Amortizing Principal Amount" means an amount equal to the lesser of (a) with respect to the first Quarterly Payment Date, any amounts remaining after payment of all amounts payable under clauses (i) through (xiv) of the Priority of Payments, with respect to each Quarterly Payment Date on or after April 2006 and before October 2009, U.S.\$100,000, with respect to each Quarterly Payment Date on or after October 2009 and before April 2011, U.S.\$200,000, and with respect to any other Quarterly Payment Date, U.S.\$300,000 and (b) the remaining principal balance of the Class D Notes (including any Deferred Interest and any Defaulted Interest and interest thereon).

"Class E Note Redemption Price" shall equal the sum of (i) the outstanding principal amount of the Class E Notes (including any Class E Deferred Interest) *plus* (ii) accrued interest thereon (including any Defaulted Interest and any interest on Defaulted Interest, if any) to but excluding the Redemption Date.

"Class E Notes Amortizing Principal Amount" means, with respect to any Quarterly Payment Date, an amount equal to the lesser of (a) 10% or the original aggregate outstanding principal amount of the Class E Notes and (b) the remaining principal balance of the Class E Notes (including any Deferred Interest and any Defaulted Interest and interest thereon).

"Class X Note Redemption Price" shall equal zero.

"Class X Payment" means, with respect to any Payment Date, an amount equal to 0.045% per annum times the Notional Principal Balance of the Class X Notes calculated on the basis of a 360 day year consisting of twelve 30-day months.

"CMBS Conduit Securities" means Commercial Mortgage Backed Securities that entitle the holders thereof to receive payments that depend (except for rights or other assets designed to assure the servicing or timely distribution of proceeds to holders of such Commercial Mortgage Backed Securities) on the cash flow from a pool of commercial mortgage loans.

"CMBS Credit Tenant Lease Securities" means Commercial Mortgage Backed Securities (other than CMBS Large Loan Securities and CMBS Conduit Securities) that entitle the holders thereof to receive payments that depend (except for rights or other assets designed to assure the servicing or timely distribution of proceeds to holders of such Commercial Mortgage Backed Securities) on the cash flow from a pool of commercial mortgage loans made to finance the acquisition, construction and improvement of properties leased to corporate tenants (or on the cash flow from such leases).

"CMBS Large Loan Securities" means Commercial Mortgage Backed Securities (other than CMBS Conduit Securities and CMBS Credit Tenant Lease Securities) that entitle the holders thereof to receive payments that depend (except for rights or other assets designed to assure the servicing or timely distribution of proceeds to holders of such Commercial Mortgage Backed Securities) on the cash flow from a commercial mortgage loan or a pool of commercial mortgage loans made to finance the acquisition, construction and improvement of properties. Generally, five or fewer commercial mortgage loans shall account for more than 20% of the aggregate principal balance of the entire pool of commercial mortgage loans supporting payments on the securities.

"CMBS Repackaging Securities" means a security that entitles the holders thereof to receive payments that depend on the cash flow from a portfolio of all (100%) CMBS Securities, REIT Debt Securities and other interests in commercial mortgage loans or similar commercial real estate interests.

"Collateral Account" means a segregated non-interest bearing trust account, including all sub-accounts thereof, held in the name of the Trustee into which Collateral will be deposited from time to time.

"Collateral Administration Agreement" means the Collateral Administration Agreement, dated as of the Closing Date, among the Issuer, the Collateral Administrator and the Collateral Manager, as the same may be amended, supplemented or otherwise modified from time to time in accordance with its terms.

"Collateral Administrator" means LaSalle Bank National Association, or any successor Collateral Administrator under the Collateral Administration Agreement.

"Collateralized Loan Obligation" means CDO Securities that entitle the holders thereof to receive payments that depend (except for rights or other assets designed to assure the servicing or timely distribution of proceeds to holders of such securities) on the cash flow from (and not the market value of) a portfolio of at least 80% by principal balance of commercial loans.

"Commercial Mortgage-Backed Securities" or "CMBS" means securities backed by obligations (including certificates of participation in obligations) that are principally secured by mortgages on real property or interests therein having a multifamily or commercial use, such as regional malls, other retail space, office buildings, industrial or warehouse properties, hotels, nursing homes and senior living centers and shall include, without limitation, CMBS Conduit Securities, CMBS Credit Tenant Lease Securities, CMBS Large Loan Securities and CMBS Repackaging Securities.

"Conditions to Exercise" shall have the meaning set forth in the CP Put Agreement.

"Controlling Class" will be the Class A Notes and the CP Put Counterparty (for so long as the CP Put Agreement is in effect and no CP Put Counterparty Default has occurred and is continuing) voting in the amount of the then outstanding aggregate face amount of the CP Notes (voting together as a single class), for so long as any Class A Notes or CP Notes are outstanding; if no Class A Notes or CP Notes are outstanding, then the Class B Notes, so long as any Class B Notes are outstanding; if no Class A Notes, CP Notes or Class B Notes are outstanding, then the Class C Notes, so long as any Class C Notes are outstanding, if no Class A Notes, CP Notes, Class B Notes or Class C Notes are outstanding, then the Class D Notes, so long as any Class D Notes are outstanding; and if no Class A Notes, CP Notes, Class B Notes, Class C Notes or Class D Notes are outstanding, then the Class E Notes, so long as any Class E Notes are outstanding. For purposes of any vote by the CP Notes or Class A Notes as part of the Controlling Class, the Trustee will provide the CP Put Counterparty with notice of such vote. Each Class of Notes having the same Stated Maturity and same priority, and the Preferred Shares as a single class, is referred to herein as a "Class."

"CP Account" means the segregated trust account established by the CP Issuing and Paying Agent under the CP Issuing and Paying Agency Agreement.

"CP Face Amount" means with respect to any CP Note, the amount payable to the Holder thereof at Maturity (excluding interest on LIBOR CP Notes).

"CP Interest Reserve Deposit Amount" means, as of any date of determination, the sum of (i) the CP Interest Reserve Deposit Amount in Principal, (ii) the CP Interest Reserve Deposit Amount in Interest and, (iii) the Interim Cashflow Swap Payment.

"CP Interest Reserve Deposit Amount in Interest" means with respect to any date of determination that corresponds to an Interim Payment Date, zero, and with respect to any date of determination that corresponds to a Payment Date, the lesser of (A) the product of (i) the CP Face Amount (excluding LIBOR CP Notes) then outstanding, (ii) LIBOR *plus* 0.09% and (iii) the actual number of days in the corresponding accrual period for such Payment Date, divided by 360 and (B) the sum of (i) (a) the sum of, for each day from the last Payment Date to the date of determination (both days inclusive), the product of the CP Face Amount (excluding LIBOR CP Notes) outstanding on that day and the weighted average discount rate on CP Notes (excluding LIBOR CP Notes) for that day, multiplied by (b) the actual number of days in the corresponding accrual period for such Payment Date, divided by (c) the actual number of days from the last Payment Date to such date of determination (both days inclusive), divided by (d) 360, (ii) the interest payable to the Cashflow Swap Counterparty during the corresponding accrual period for such Payment Date, as calculated under the Cashflow Swap Agreement, (iii) with respect to the last Payment Date, the difference (positive or negative) between the actual discount paid on CP Notes in the related accrual period and the amount calculated in clause (B) (i) of this definition for the last Payment Date and (iv) without duplication, for all prior Payment Dates, the excess of the amount calculated in clause (B) over the amount calculated in clause (A) of this definition.

"CP Interest Reserve Deposit Amount in Principal" means with respect to any date of determination, the least of (A) Principal Proceeds, (B) the CP Interest Reserve Required Amount *plus* the balance of the Cashflow Swap Agreement due to the Cashflow Swap Counterparty *minus* the balance of funds on deposit in the CP Interest Reserve Account and (C) U.S. \$20,000,000 *minus* net Principal Proceeds deposited to the CP Interest Reserve Account (netted against all CP Interest Reserve Principal Release Amounts to date); provided that, if the Net Outstanding Portfolio Collateral Balance is less than U.S. \$500,000,000, the CP Interest Reserve Deposit Amount in Principal will equal zero.

"CP Interest Reserve Interest Release Amount" means on any date of determination, the greater of zero and the lesser of (A) the balance on deposit in the CP Interest Reserve Account (after all net payments into and out of such account), *minus* the CP Interest Reserve Required Amount and (B) the sum of (i) the product of (a) the weighted average discount rate of CP Notes outstanding (excluding LIBOR CP Notes), (b) the CP Face Amount (excluding LIBOR CP Notes) and (c) the weighted average remaining day count life of such CP Notes until their respective maturities, divided by 360, *minus* (ii) net Principal Proceeds deposited to the CP Interest Reserve Account (netted against all CP Interest Reserve Principal Release Amounts to date) and *minus* (iii) the balance of the Cashflow Swap Agreement due to the Cashflow Swap Counterparty.

"CP Interest Reserve Principal Release Amount" means on any date of determination, the greater of zero and the balance on deposit in the CP Interest Reserve Account, *minus* the CP Interest Reserve Required Amount, *minus* the CP Interest Reserve Interest Release Amount, *minus* the balance of the Cashflow Swap Agreement due to the Cashflow Swap Counterparty.

"CP Interest Reserve Required Amount" means, as of any date of determination, for each CP Note maturing (assuming no extension) on or prior to the next Payment Date or Interim Payment Date, whichever is earlier, the sum of (A) the discount that would be required to issue new discount CP Notes with a 90 day maturity and with a CP Face Amount equal to the lesser of U.S.\$500,000,000 and the CP Face Amount of the maturing CP Notes, and (B) the discount required to issue new discount CP Notes with a 45 day maturity and a face amount equal to the excess of the CP Face Amount of the maturing CP Notes over U.S.\$500,000,000, each such issuance in (A) and (B) at the Forward Expected LIBOR Rate *plus* 0.09%.

"CP Note Placement Agent Fees" has the meaning set forth in the CP Note Placement Agreement.

"CP Note Placement Agents" means Goldman, Sachs & Co. and SG Americas Securities, L.L.C., as CP Note placement agents pursuant to the CP Note Placement Agreement, or any successor placement agent thereunder.

"CP Note Placement Agreement" means the agreement among the Issuer, the Co-Issuer and the CP Note Placement Agents, dated as of the Closing Date as the same may be amended, supplemented or otherwise modified from time to time in accordance with its terms.

"CP Note Redemption Price" means with respect to the CP Notes (other than the LIBOR CP Notes) to be Defeased, the amount payable to the CP Issuing and Paying Agent for payment to the Holders thereof on the applicable maturity date on which such CP Notes mature in accordance with their terms, *plus* with respect to any LIBOR CP Notes to be redeemed and Defeased, the outstanding principal amount of the LIBOR CP Notes and accrued and unpaid interest thereon at the LIBOR CP Note Interest Rate (including Defaulted Interest and interest on Defaulted Interest) to but excluding the Redemption Date.

"CP Noteholder" means with respect to any CP Note, the Person in whose name such CP Note is registered; provided that, for purposes of voting, the granting of consents and other similar determinations under the Indenture, in addition to any voting and consent rights the CP Put Counterparty may have in its individual capacity, the CP Put Counterparty (for so long as the CP Put Agreement is in effect and no CP Put Counterparty Default has occurred and is continuing) will have the right to exercise the voting and consent rights of the then outstanding CP Notes for any purpose as "CP Noteholder" of such CP Notes, including as part of the Controlling Class.

"CP Principal Reserve Required Amount" means on each Payment Date, an amount equal to the Notional Amount of the CP Notes.

"CP Put Collateral Account" means any cash, securities or other collateral delivered and/or pledged by the CP Put Counterparty to or for the benefit of the Issuer.

"CP Put Counterparty Default" means the occurrence of any of the following events:

(i) the CP Put Counterparty fails to make a payment required under the CP Put Agreement in accordance with its terms (beyond any applicable grace or notice periods);

(ii) the CP Put Counterparty (a) files any petition or commences any case or proceeding under any provision or chapter of the United States Bankruptcy Code or any other similar foreign, federal or state law relating to insolvency, bankruptcy, rehabilitation, liquidation or reorganization, (b) makes a general assignment for the benefit of its creditors or (c) has an order for relief entered against it under the United States Bankruptcy Code or any other similar foreign, federal or state law relating to insolvency, bankruptcy, rehabilitation, liquidation or reorganization which is final and nonappealable; or

(iii) a court of competent jurisdiction or other competent regulatory authority enters a final and nonappealable order, judgment or decree (a) appointing a custodian, trustee, agent or receiver for the CP Put Counterparty or for all or any material portion of its property or (b) authorizing the taking of possession by a custodian, trustee, agent or receiver of the CP Put Counterparty (or the taking of possession of all or any material portion of the property of the CP Put Counterparty).

"CP Put Premium" means, with respect to the CP Notes, an amount equal to the product of the CP Put Premium Rate applicable to the CP Notes and the average daily outstanding Notional Amount, calculated on the basis of actual days elapsed in a year of 360 days; provided that the CP Put Premium shall cease to accrue upon termination of the CP Put Agreement.

"CP Put Premium Rate" means, with respect to the CP Notes, 0.18% per annum from the Closing Date to and including the November 2008 Payment Date and 0.22% per annum thereafter.

"Defaulted Hedge Termination Payments" means any termination payment required to be made by the Issuer to the Hedge Counterparty pursuant to a Hedge Agreement in the event of a termination of a Hedge Agreement in respect of which such Hedge Counterparty is the sole Defaulting Party or the sole Affected Party (as defined in the Hedge Agreement), other than with respect to "Illegality" or "Tax Event" (as defined in the Hedge Agreement).

"Defaulted Obligation" means any Collateral Asset with respect to which:

(i) there has occurred and is continuing for any applicable grace period, a default with respect to the payment of interest or principal on such Collateral Asset (or a security *pari passu* or senior with such Collateral Asset) in accordance with its terms; provided that, the Collateral Asset shall not constitute a Defaulted Obligation if and when such default has been cured through the payment of all past due interest and principal or waived; provided, further, however, that, notwithstanding the foregoing, any Collateral Asset (or a security *pari passu* or senior with such Collateral Asset) that is in default with respect to the payment of interest or principal as of the Determination Date shall not be a Defaulted Obligation if the Collateral Manager believes the default on such Collateral Asset will be cured as of the next Determination Date;

(ii) the principal amount of such Collateral Asset has been written down;

(iii) any bankruptcy, insolvency or receivership proceeding has been initiated in connection with the issuer of such Collateral Asset and is unstayed and undismissed; provided, that, if such proceeding is an involuntary proceeding, the condition of this clause (iii) will not be satisfied until the earliest of the following: (I) the issuer consents to such proceeding, (II) an order for relief under the United States Bankruptcy Code, or any similar order under a proceeding not taking place under the United States Bankruptcy Code, has been entered, and (III) such proceeding remains unstayed and undismissed for 60 days;

(iv) such Collateral Asset has an S&P Rating of "CC" or lower, "D" or "SD" or, if S&P withdraws its rating and the S&P Rating at the time of withdrawal is "CCC" or below or such Collateral Asset has a Moody's Rating of "C" or lower or "Ca"; or

(v) the Collateral Manager believes that such Collateral Asset will default on or before the next Determination Date.

"Deferred Interest PIK Bond" means a PIK Bond with respect to which interest thereon has been deferred and capitalized more than once in the last 12 monthly periods, but only until such time as payment of interest on such PIK Bond has resumed and all capitalized or deferred interest has been paid in full in accordance with the underlying documents.

"Distribution Compliance Period" with respect to the Notes ends 40 days after the later of (i) the commencement of the offering of the Notes and (ii) the Closing Date.

"Double B Calculation Amount" means the sum of the products of (i) the Principal Balance of each Double B Rated Asset and (ii) 90%.

"Double B Rated Asset" means any Collateral Asset with an Actual Rating or Implied Rating from S&P less than "BBB-" but with an Actual Rating greater than "B+" or with an Actual Rating or Implied Rating from Moody's less than "Baa3" but with an Actual Rating greater than "B1".

"Eligible Bidders" are (i) any institutions, which may include affiliates of the Initial Purchaser, the Collateral Manager and Holders of the Notes, the Class X Notes, CP Notes and the Preferred Shares, whose short-term unsecured debt obligations have a rating of at least "P-1" by Moody's or "A-1+" by S&P and (ii) the Collateral Manager.

"Eligible Depository" shall be a financial institution organized under the laws of the United States or any state thereof, authorized to accept deposits, having a combined capital and *surplus* of at least U.S.\$200,000,000, and having (or if its obligations are guaranteed by its parent company, its parent having), a long term debt rating of at least "Baa1" by Moody's (and if rated "Baa1", such rating is not on watch for downgrade) and "BBB+" by S&P and a short term debt rating of "P-1" by Moody's (and not on watch for downgrade) and at least "A-1" by S&P.

"Eligible Investment" means any U.S. Dollar-denominated investment that, at the time it is delivered to the Trustee, is one or more of the following obligations or securities (including security entitlements with respect thereto): (i) direct Registered obligations of, and Registered obligations fully guaranteed by, the United States or any agency or instrumentality of the United States the obligations of which are expressly backed by the full faith and credit of the United States; (ii) demand and time deposits in, certificates of deposit of, or banker's acceptances issued by, any depository institution or trust company incorporated in the United States or any state thereof, which depository institution or trust company is subject to supervision and examination by federal or state authorities, with a maturity not in excess of 183 days; and with a credit rating by S&P of at least "A-1+" or at least "AA-", as applicable, a credit rating by Moody's of at least "P-1" or at least "Aa3" (and if rated "Aa3", not on watch for downgrade), as applicable, in the case of a maturity in excess of 30 days, or a credit rating by S&P of at least "A-1" and a credit rating by Moody's of at least "P-1" (and not on watch for downgrade) in the case of a maturity of less than 30 days; (iii) repurchase obligations with respect to (a) any security described in clause (i) above or (b) any other security issued or guaranteed by an agency or instrumentality of the United States, entered into with a depository institution or trust company described in clause (ii) above or entered into with a corporation whose long-term senior unsecured rating is at least "A1" (and if rated "A1", not on watch for downgrade) by Moody's and "A+" by S&P and whose short-term credit rating is "P-1" (and not on watch for downgrade) by Moody's and "A-1" by S&P at the time of such investment, with a term not in excess of 91 days; (iv) Registered debt securities bearing interest or sold at a discount issued by any corporation incorporated under the laws of the United States or any state thereof that have a credit rating of at least "Aa3" (and if rated "Aa3", not on watch for downgrade) or "P-1" (and not on watch for downgrade) by Moody's and "A+" or "A-1" by S&P; (v) commercial paper or other short-term obligations of

a corporation, partnership, limited liability company or trust, or any branch or agency thereof located in the United States or any of its territories, such commercial paper or other short-term obligations having a credit rating of "P-1" (and not on watch for downgrade) by Moody's and "A-1" by S&P, and that are Registered and either are interest bearing or are sold at a discount from the face amount thereof and have a maturity of not more than 91 days from their date of issuance; and (vi) offshore money market funds which have a credit rating of not less than "Aaa/MR1+" by Moody's and "AAA" or "AAAm" or "AAAm-G" by S&P, provided however, that each rating in clauses (iii) through (vi) above by Moody's or S&P shall be an Actual Rating and provided further, that any such investment purchased on the basis of S&P's short-term rating of "A-1" shall mature no later than 30 days after the date of purchase and may not exceed 20% of the Aggregate Outstanding Amount of the Notes rated by S&P. Eligible Investments shall not include any RMBS, CMBS, any inverse floater, any security subject to withholding tax if owned by the Issuer, any security subject to an offer, any interest only security, any principal only security (other than treasury bills or commercial paper) or any security with a price in excess of 100% of par or any security the repayment of which is dependent on substantial non-credit related risk as determined by the Collateral Manager. Each such Eligible Investment shall mature no later than the second Business Day immediately preceding the Payment Date next following the Due Period in which the date of investment occurs, unless such Eligible Investment is issued by the institution acting as Securities Intermediary, in which event such Eligible Investment may mature on the Business Day preceding such Payment Date. Eligible Investments may include those investments with respect to which the Securities Intermediary, the Trustee, the Collateral Manager, the CP Note Placement Agents, the CP Put Counterparty or the Initial Purchaser or an affiliate of the Trustee, the Collateral Manager, the CP Note Placement Agents, the CP Put Counterparty or the Initial Purchaser provides services. As used in this definition, ratings may not include ratings with an "r", "p", "q", "pi" or "t" subscript.

"Extraordinary Resolution" means a resolution passed at a meeting of Holders of each affected Class of Notes and the CP Notes duly convened and held in accordance with the terms of the Indenture and the Notes by not less than a SupraMajority of each such Class of Notes.

"Final Payment Date" means a Payment Date with respect to an Optional Redemption, a Payment Date in connection with the Stated Maturity, Tax Redemption, an Auction or redemption due to an Event of Default resulting in acceleration of the Notes and liquidation of the Collateral in full.

"Forward Expected LIBOR Rate" means with respect to the CP Notes, the forward expected London interbank offered three-month rate for U.S. dollar deposits, as calculated by the Lead CP Note Placement Agent.

"Hedge Collateral" means, any cash, securities or other collateral delivered and/or pledged by the Hedge Counterparty to or for the benefit of the Issuer, including, without limitation, any upfront payment of cash or delivery of securities made by the Hedge Counterparty to satisfy or secure its payment obligations pursuant to the terms of the related Hedge Agreement.

"Hedge Counterparty" means Rate Swap Counterparties and Cashflow Swap Counterparties; AIG Financial Products Corp. shall be the initial Interest Rate Swap Counterparty and the initial Cashflow Swap Counterparty.

"Hedge Counterparty Ratings Requirement" means (i) with respect to the rating of a Hedge Counterparty or its guarantor (or any replacement pursuant to the relevant Hedge Agreement), as an issuer or with respect to (A) the long-term senior unsecured debt of such party, "Aa3" (and not on credit watch for possible downgrade) or better by Moody's, if such party has a long-term rating only or (B) the long-term senior unsecured debt of such party, as applicable, "A1" (and not on credit watch for possible downgrade) or better by Moody's; (ii) with respect to the short-term debt of a Hedge Counterparty or its guarantor (or any replacement pursuant to the relevant Hedge Agreement), "P-1" (and not on credit watch for possible downgrade) by Moody's, or, if no such rating is available, a guaranteed affiliate thereof from Moody's, if so rated by Moody's; and (iii) with respect to a Hedge Counterparty or its guarantor (or any replacement pursuant to the relevant Hedge Agreement) as an issuer or with respect to the short-term unsecured debt of such party, "A-1" by S&P or, if no such short-term rating is available, the long-term

senior unsecured debt of such party, "A+" by S&P (so long as any of the Notes outstanding hereunder are rated by such Rating Agency); provided, that should a Rating Agency effect an overall downward adjustment of its required ratings for hedge counterparties in collateralized debt obligation transactions, then the applicable Hedge Counterparty Ratings Requirement shall be adjusted downward accordingly; provided further, that any adjustment to the Hedge Counterparty Ratings Requirement will be subject to the satisfaction of the Rating Agency Condition with respect to the applicable Rating Agency.

"Holder" or "Noteholder" or "CP Noteholder" means, with respect to any Note or CP Note the person in whose name such Note or CP Note is registered, or, for purposes of voting, the granting of consents and other similar determinations under the Indenture, with respect to any Notes in global form, a beneficial owner thereof; provided that, in addition to any voting and consent rights the CP Put Counterparty may have in its individual capacity, the CP Put Counterparty (for so long as the CP Put Agreement is in effect and no CP Put Counterparty Default has occurred and is continuing) will have the right to exercise the voting and consent rights of the then Outstanding CP Notes for any purpose as "Holder" or "CP Noteholder" of such CP Notes, including as part of the Controlling Class and, with respect to any Preferred Share, the person in whose name such Preferred Share is registered in the share register of the Issuer.

"Implied Rating" means, in the case of a rating on a Collateral Asset, a rating that is determined by reference to any publicly available, fully monitored rating by another Rating Agency that, by its terms, addresses the full scope of the payment promise of the obligor.

"Interest Coverage Tests" means the Class A/B Interest Coverage Test, the Class C Interest Coverage Test and the Class D Interest Coverage Test.

"Interest Proceeds" means Proceeds other than Principal Proceeds.

"Interim Cashflow Swap Payment" means with respect to any date of determination, the lesser of (A) the Cashflow Swap Capped Amount *minus* the balance of the Cashflow Swap Agreement due to the Cashflow Swap Counterparty and (B) the CP Interest Reserve Required Amount *minus* the balance of funds on deposit in the CP Interest Reserve Account, *minus* CP Interest Reserve Deposit Amount, taking only into account any CP Interest Reserve Deposit Amount in Principal and any CP Interest Reserve Deposit Amount in Interest to actually be deposited in connection therewith.

"Interim Issuer Cashflow Swap Payment" means as of any date of determination, the lesser of (A) the balance of the Cashflow Swap Agreement due to the Cashflow Swap Counterparty and (B) the balance on deposit in the CP Interest Reserve Account (after making all distributions into such account on such date) *minus* the CP Interest Reserve Required Amount.

"Interim Payment Date" means November 8, 2005, November 22, 2005, December 8, 2005 and December 22, 2005 and the 22nd day of each month thereafter; provided that if such day is not a Business Day, then the next succeeding Business Day.

"Issue" of a Collateral Asset means any such Collateral Asset issued by the same issuer, having the same terms and conditions (as to, among other things, coupon, maturity, security and subordination) and otherwise being fungible with one another.

"Lead CP Note Placement Agent" means Goldman, Sachs & Co., as lead CP Note placement agent pursuant to the CP Note Placement Agreement, or any successor lead placement agent thereunder.

"Liquidation Proceeds" with respect to any Optional Redemption or Tax Redemption including, without duplication, (i) all Sale Proceeds from Collateral Assets sold in connection with such redemption, (ii) the aggregate amount received by the Issuer on or prior to the Business Day immediately preceding the relevant Payment Date from the termination of any Hedge Agreement in connection with such redemption, and (iii) cash and Eligible Investments on deposit in the Accounts, to the extent available therefor, including any amounts designated by the Collateral Manager as retained for reinvestment in

Eligible Investments (and also including any payments received under any Hedge Agreements on or prior to the day preceding the Payment Date, but only to the extent that such payments are required to be paid as a result of an Optional Redemption or Tax Redemption of Notes and the CP Notes), in each case as determined by the Collateral Manager.

"Majority" means (a) with respect to any Class or Classes of Notes or Class X Notes, the Holders of more than 50% of the aggregate outstanding principal amount of such Class or Classes of Notes or the Notional Principal Balance of the Class X Notes, (b) with respect to the CP Notes, the CP Put Counterparty (for so long as the CP Put Agreement is in effect and no CP Put Counterparty Default has occurred and is continuing) voting in the amount of the then outstanding aggregate face amount of the CP Notes, and (c) with respect to the Preferred Shares, more than 50% of the outstanding Preferred Shares.

"Market Value" means, with respect to the Collateral Assets and/or Eligible Investments, (i) the average of three bona fide bids for such Collateral Asset or Eligible Investment obtained by the Collateral Manager at such time from any three nationally recognized dealers, which dealers are independent from one another and from the Collateral Manager, or (ii) if the Collateral Manager is unable to obtain three such bids, the lesser of two bona fide bids for such Collateral Asset or Eligible Investment obtained by the Collateral Manager at such time from any two nationally recognized dealers acceptable to the Collateral Manager, which dealers are independent from one another and from the Collateral Manager, or (iii) if the Collateral Manager is unable to obtain two such bids, one bona fide bid for such Collateral Asset or Eligible Investment obtained by the Collateral Manager at such time from any nationally recognized dealer acceptable to the Collateral Manager, which dealer is independent from the Collateral Manager, or (iv) in the event the Collateral Manager is unable to obtain one such bid, the price on such date provided to the Collateral Manager by an independent pricing service, or (v) in the event the Collateral Manager cannot in good faith determine the market value of such Collateral Asset or Eligible Investment using commercially reasonable efforts to apply the methods specified in clauses (i) through (iv) above, as determined in good faith by the Collateral Manager using commercially reasonable efforts to apply its reasonable business judgment. If the method of determining Market Value is based solely on the Collateral Manager's determination, such Market Value shall be considered zero after the earlier of 30 days and such time as the Collateral Manager obtains a bid for such Collateral Asset or Eligible Investment.

"Maximum CP Put Option Strike Rate" means (a) with respect to the CP Notes, a discount rate less than or equal to LIBOR *plus* 0.09% per annum (which rate includes CP Note Placement Agent Fees) or (b) in the case of LIBOR CP Notes, an interest rate less than or equal to LIBOR *plus* 0.04% per annum (which rate does not include CP Note Placement Agent Fees) of an applicable maturity.

"Minimum Bid Amount" is an amount equal to the sum of (a) the Note Redemption Price with respect to the Auction Payment Date, (b) any amount payable by the Issuer to the Hedge Counterparties upon termination of the Hedge Agreements assuming the Issuer is the defaulting or affected party less any amounts payable by the Hedge Counterparty to the Issuer upon the termination of the Hedge Agreements, (c) accrued and unpaid Collateral Management Fees and accrued and unpaid Class X Payments, (d) an amount sufficient to pay any amount payable to the CP Put Counterparty and the CP Note Placement Agents in connection with the termination of the CP Put Agreement and the CP Note Placement Agreement and (e) 101% of all unpaid expenses of the Issuer, less amounts on deposit in the Accounts which are available to redeem the Notes and the Defeasance of the LIBOR CP Notes. The Minimum Bid Amount does not include any additional amounts for the payment to the Holders of the Class X Notes or the Preferred Shares.

"Monthly Asset Amount" means, with respect to any Payment Date, the Aggregate Principal Amount on the first day of the related Due Period.

"Moody's Rating" means the rating determined in accordance with the methodology described in the Indenture.

"Moody's Recovery Rate" means, with respect to a Collateral Asset, an amount equal to the percentage for such Collateral Asset set forth in the recovery rate assumptions for Moody's attached as Part I of Schedule D to the Indenture; provided, however, that (A) Defaulted Obligations which exceed

2.5% of the Aggregate Principal Amount and have been defaulted for more than one year will be deemed to have a Moody's Recovery Rate of 0%, (B) Defaulted Obligations which exceed 1.00% of the Aggregate Principal Amount and have been defaulted for more than 2 years shall be deemed to have a Moody's Recovery Rate of 0%; and (C) Defaulted Obligations which have been defaulted for more than 3 years shall be deemed to have a Moody's Recovery Rate of 0%.

"Net Outstanding Portfolio Collateral Balance" means, on any Determination Date, an amount equal to (i) the aggregate Principal Balance on such Determination Date of all Collateral Assets, *plus* (ii) the aggregate Principal Balance of all Principal Proceeds held as cash and Eligible Investments purchased with Principal Proceeds, *plus* the sum of all CP Interest Reserve Deposit Amounts made from Principal Proceeds, *minus* the sum of all CP Interest Reserve Principal Release Amounts until the CP Notes are no longer outstanding, *minus* (iii) the aggregate Principal Balance on such date of determination of all Collateral Assets that are (A) Defaulted Obligations, (B) Deferred Interest PIK Bonds, (C) Double B Rated Assets, (D) Single B Rated Assets and (E) Triple C Rated Assets, *plus* (iv) the Aggregate Calculation Amount of Defaulted Obligations and Deferred Interest PIK Bonds, the Double B Calculation Amount, the Single B Calculation Amount and the Triple C Calculation Amount, *minus* (v) 25% of the projected Principal Balance of each Collateral Asset other than a Defaulted Obligation, Deferred Interest PIK Bond, Double B Rated Asset, Single B Rated Asset or Triple C Rated Asset that is expected to be paid after the Stated Maturity of the Class B Notes, *minus* (vi) any appraisal reductions applicable to any class of CMBS (other than any CMBS which are Defaulted Obligations) held by the Issuer to the extent such appraisal reduction is intended to reduce the interest payable to such Collateral Asset and only in proportion to such interest reduction.

"Note Redemption Price" is the Class X Note Redemption Price, the CP Note Redemption Price, the Class A Note Redemption Price, the Class B Note Redemption Price, the Class C Note Redemption Price, the Class D Note Redemption Price and the Class E Note Redemption Price, as applicable.

"Notional Amount" means an amount equal to U.S.\$1,064,000,000, *minus* the aggregate original principal amount of all Class A-1LT-b Notes purchased by the CP Put Counterparty since the Closing Date, *minus* the sum of all amounts deposited to the CP Principal Reserve Account after the Closing Date.

"Notional Principal Balance" means, as of any date of determination with respect to the Class X Notes, the Aggregate Principal Amount, measured as of the beginning of the Due Period preceding such Payment Date.

"Overcollateralization Tests" means the Class A/B Overcollateralization Test, the Class C Overcollateralization Test and the Class D Overcollateralization Test.

"PIK Bond" means a CDO Security on which the deferral of interest does not constitute an event of default pursuant to the terms of the related underlying instruments (while any other senior debt obligation is outstanding if so provided by the related indenture or other underlying instruments).

"Principal Balance" means, with respect to any Collateral Asset or Eligible Investment, as of any date of determination, the outstanding principal amount of such Collateral Asset or Eligible Investment; subject to the following exceptions: (i) the Principal Balance of a Collateral Asset received upon acceptance of an offer to exchange a Collateral Asset for such Collateral Asset shall be deemed to be the percentage of the outstanding principal amount equal to the least of (a) the Moody's Recovery Rate and (b) the S&P Recovery Rate for such Collateral Asset until such time as Proceeds are first received when due with respect to such Collateral Asset; (ii) the Principal Balance of each Defaulted Obligation shall be deemed to be zero, except (A) for purposes of the calculation of the Coverage Tests, in which case, the Principal Balance of Defaulted Obligations shall equal their respective outstanding principal amount (unless otherwise indicated in such tests), (B) for purposes of determining whether an Event of Default described in clause (vi) of the definition thereof has occurred, Defaulted Obligations shall be included at their Applicable Recovery Rate, (C) for purposes of calculating any trustee fees and the Collateral Management Fee, the Principal Balance of each Defaulted Obligation shall equal the Calculation Amount

for such Defaulted Obligations and (D) as otherwise expressly indicated; (iii) the Principal Balance of any cash shall be the amount of such cash; (iv) the Principal Balance of any Collateral Assets and any Eligible Investments in which the Trustee does not have a perfected security interest shall be deemed to be zero; (v) the Principal Balance of any Collateral Asset that is an equity security shall be deemed to be zero; and (vi) for purposes of calculating the Class A Overcollateralization Ratio, the Class A/B Overcollateralization Ratio, the Class C Overcollateralization Ratio and the Class D Overcollateralization Ratio, the Principal Balance of any RMBS Security that is experiencing negative amortization shall be deemed to be its outstanding principal amount without regard to any deferred or capitalized interest.

"Principal Proceeds" means, with respect to any Due Period, the sum (without duplication) of: (i) all payments of principal on the Collateral Assets and Eligible Investments received in cash by the Issuer during such Due Period including prepayments or mandatory sinking fund payments, or payments in respect of optional redemptions, exchange offers, tender offers (other than payments of principal of Eligible Investments acquired with Proceeds other than Principal Proceeds) and recoveries on Defaulted Obligations; (ii) Sale Proceeds received by the Issuer during such Due Period (excluding accrued interest on sold or disposed Collateral Assets or Eligible Investments); (iii) all amendment, waiver, late payment fees, restructuring and other fees and commissions collected during the related Due Period in respect of Defaulted Obligations up to the par amount; (iv) any proceeds resulting from the termination, replacement and liquidation of any Hedge Agreement to the extent such proceeds exceed the cost of entering into a replacement Hedge Agreement; (v) all CP Interest Reserve Principal Release Amounts; and (vi) all payments received in cash by the Issuer during such Due Period that represent call, prepayment or redemption premiums but not in excess of the purchase premium paid thereon; provided, however, that Principal Proceeds shall not include any accrued interest or any funds from the Preferred Share Payment Account and all funds deposited in or credited thereto, transaction fees payable to the Issuer and its share capital on account of its ordinary shares held in its account in the Cayman Islands.

"Proceeds" means, with respect to any Due Period, without duplication, all amounts received by the Trustee with respect to the Collateral Assets (excluding any payments of interest on Collateral Assets subject to the Cashflow Swap Agreements), all amounts received as amendment, waiver, late payment fees and commissions collected during the Due Period on Collateral Assets, all amounts received with respect to Eligible Investments in the Accounts, any amounts to be released or withdrawn on the related Payment Date from the Expense Reserve Account and all amounts received under any Hedge Agreements relating to the Due Period, including Principal Proceeds.

"Quarterly Payment Date" means the 8th day of every January, April, July and October, or if any such date is not a Business Day, the immediately following Business Day, commencing on January 9, 2006.

"Rating Agency Condition" means, with respect to any action taken or to be taken under the Transaction Documents, a condition that is satisfied when each Rating Agency has confirmed in writing to the Issuer and the Collateral Manager that such action will not result in the immediate withdrawal, reduction or other adverse action with respect to any then-current rating of any Class of Notes.

"Redemption Date" means any Tax Redemption Date, Optional Redemption Date or Auction Payment Date.

"Registered" means, with respect to any debt obligation or debt security, a debt obligation or debt security that is issued after July 18, 1984, and that is in registered form within the meaning of Section 881(c)(2)(B)(i) of the Code and the Treasury regulations promulgated thereunder.

"REIT Debt Security" means a security issued by publicly held real estate investment trusts (as defined in Section 856 of the Code or any successor provision).

"Residential Mortgage-Backed Securities" or "RMBS" means securities that represent interests in pools of residential mortgage loans secured by 1 to 4 family residential mortgage loans and shall include, without limitation, RMBS Alt-A Mortgage Securities, RMBS Residential A Mortgage Securities, RMBS Residential B/C Mortgage Securities and RMBS Home Equity Loan Securities.

"RMBS Alt-A Mortgage Securities" means Residential Mortgage-Backed Securities (other than RMBS Residential A Mortgage Securities and RMBS Residential B/C Mortgage Securities) that entitle the holders thereof to receive payments that depend (except for rights or other assets designed to assure the servicing or timely distribution of proceeds to holders of such Mortgage-Backed Securities) on the cash flow from residential mortgage loans secured (on a first priority basis, subject to permitted liens, easements and other encumbrances) by 1- to 4-family residential real estate, the proceeds of which are used to purchase real estate and purchase or construct dwellings thereon (or to refinance indebtedness previously so used) and that were originated in connection with "Alt-A" underwriting criteria.

"RMBS Home Equity Loan Securities" means Residential Mortgage-Backed Securities that entitle the holders thereof to receive payments that depend (except for rights or other assets designed to assure the servicing or timely distribution of proceeds to holders of such Mortgage-Backed Securities) on the cash flow from balances (including revolving balances) outstanding under lines of credit secured by a first and/or subordinate lien on residential real estate (1- to 4-family properties), the proceeds of which lines of credit are not used to purchase such real estate or to purchase or construct dwellings thereon (or to refinance indebtedness previously so used), generally having the following characteristics: (i) the balances have standardized payment terms and require minimum monthly payments; (ii) the balances are obligations of numerous borrowers and accordingly represent a diversified pool of obligor credit risk; (iii) the repayment of such balances may be based on a fixed scheduled payment or, alternatively, may not depend upon a contractual payment schedule, with early repayment depending primarily on interest rates, availability of credit against a maximum line of credit and general economic matters; and (iv) the combined loan to value ratios are higher than customary in the primary mortgage markets.

"RMBS Residential A Mortgage Securities" means Residential Mortgage-Backed Securities (other than RMBS Residential B/C Mortgage Securities and RMBS Alt-A Mortgage Securities) that entitle the holders thereof to receive payments that depend (except for rights or other assets designed to assure the servicing or timely distribution of proceeds to holders of such Mortgage-Backed Securities) on the cash flow from residential mortgage loans secured (on a first priority basis, subject to permitted liens, easements and other encumbrances) by residential real estate (1- to 4-family properties) the proceeds of which are used to purchase real estate and purchase or construct dwellings thereon (or to refinance indebtedness previously so used), generally having the following characteristics: (i) the mortgage loans have generally been underwritten to the standards of the Federal National Mortgage Association, the Federal Home Loan Mortgage Corporation or the Government National Mortgage Association (without regard to the size of the loan); (ii) the mortgage loans have standardized payment terms and require minimum monthly payments; (iii) the mortgage loans are obligations of numerous borrowers and accordingly represent a very diversified pool of obligor credit risk; and (iv) the repayment of such mortgage loans is subject to a contractual payment schedule, with early repayment depending primarily on interest rates and the sale of the mortgaged real estate and related dwelling.

"RMBS Residential B/C Mortgage Securities" means Residential Mortgage-Backed Securities (other than RMBS Residential A Mortgage Securities and RMBS Alt-A Mortgage Securities) that entitle the holders thereof to receive payments that depend (except for rights or other assets designed to assure the servicing or timely distribution of proceeds to holders of such Mortgage-Backed Securities) on the cash flow from subprime residential mortgage loans secured (on a first priority basis, subject to permitted liens, easements and other encumbrances) by residential real estate (1- to 4-family properties) the proceeds of which are used to purchase real estate and purchase or construct dwellings thereon (or to refinance indebtedness previously so used), generally having the following characteristics: (i) the mortgage loans have generally not been underwritten to the standards of the Federal National Mortgage Association, the Federal Home Loan Mortgage Corporation or the Government National Mortgage Association (without regard to the size of the loan); (ii) the mortgage loans have standardized payment terms and require minimum monthly payments; (iii) the mortgage loans are obligations of numerous borrowers and accordingly represent a very diversified pool of obligor credit risk; and (iv) the repayment of such mortgage loans is subject to a contractual payment schedule, with early repayment depending primarily on interest rates and the sale of the mortgaged real estate and related dwelling.

"S&P Rating" means the rating determined in accordance with the methodology described in the Indenture.

"S&P Recovery Rate" means, with respect to a Collateral Asset on any Determination Date, an amount equal to the percentage for such Collateral Asset set forth in the S&P Recovery Rate Matrix attached as a schedule to the Indenture (determined in accordance with procedures prescribed by S&P for such Collateral Asset on the date of its purchase by the Issuer or, in the case of a Defaulted Obligation, the S&P Rating immediately prior to default).

"Sale Proceeds" means all amounts representing Proceeds (including accrued interest) from the sale or other disposition of any Collateral Asset or Eligible Investment received during such Due Period, net of any reasonable amounts expended by the Collateral Manager or the Trustee in connection with such sale or other disposition.

"Servicer" means, with respect to any Issue of Collateral Assets, the entity that, absent any default, event of default or similar condition (however described), is primarily responsible for monitoring and otherwise administering the cash flows from which payments to investors in such Collateral Assets are made.

"Single B Calculation Amount" means the sum of the products of (i) the Principal Balance of each Single B Rated Asset and (ii) 70%.

"Single B Rated Asset" means any Collateral Asset, that is not a Triple C Rated Asset, with an Actual Rating from S&P less than "BB-" or with an Actual Rating from Moody's less than "Ba3".

"Statistical Loss Amount" means, as of any Determination Date, the sum of, for each Collateral Asset, the product of (i) the Principal Balance of such Collateral Asset and (ii) the Moody's "Idealized" Cumulative Expected Loss Rate as set forth in the Indenture for such Collateral Asset. For purposes of the calculation of the Statistical Loss Amount on any Determination Date with respect to Single B Rated Assets, Deferred Interest PIK Bonds, Double B Rated Assets, Triple C Rated Assets, Defaulted Obligations and the principal amount of any Collateral Assets expected to be paid in full after the January 2041 Payment Date, the principal amount thereof expected to be paid after the Payment Date related to such Determination Date shall be excluded.

"SupraMajority" means (a) with respect to any Class of Notes, the Holders of more than 66-2/3% of the aggregate outstanding principal amount of such Class of Notes, (b) with respect to the CP Notes, the CP Put Counterparty (for so long as the CP Put Agreement is in effect and no CP Put Counterparty Default has occurred and is continuing) voting in the amount of more than 66-2/3% of the then outstanding aggregate face amount of the CP Notes, and (c) with respect to the Preferred Shares, more than 66-2/3% of the outstanding Preferred Shares.

"Tax Event" means (i) the adoption of, or a change in, any tax statute (including the Code), treaty, regulation (whether temporary or final), rule, ruling, practice, procedure or judicial decision or interpretation which results or will result in withholding tax payments representing in excess of 3% of the aggregate interest due and payable on the Collateral Assets during the Due Period in which such event occurs as a result of the imposition of U.S. or other withholding tax with respect to which the obligors are not required to make gross-up payments that cover the full amount of such withholding taxes on an after-tax basis or (ii) the adoption of, or change in, any tax statute (including the Code), treaty, regulation (whether temporary or final), rule, ruling, practice, procedure or judicial decision or interpretation which results or will result in taxation of the Issuer's net income in an amount equal to 3% or more of the net income of the Issuer during any Due Period in which such event occurs.

"Total Redemption Amount" means the sum of (a) all amounts due as of the Redemption Date pursuant to clauses (i), (ii), (iii), (iv), (v), (xix) and (xx) of the Priority of Payments and (b) the Note Redemption Prices.

"Treasury" means the United States Department of the Treasury.

"Triple C Calculation Amount" means the sum of the products of (i) the Principal Balance of each Triple C Rated Asset and (ii) 50%.

"Triple C Rated Asset" mean any Collateral Asset (other than a Defaulted Obligation) with an Actual Rating from S&P of less than "B-" or with an Actual Rating from Moody's of less than "B3".

The Purchaser and each such account: (a) was not formed for the specific purpose of investing in the Purchased Notes (except when each beneficial owner of the Purchaser and each such account is a Qualified Purchaser), (b) to the extent the Purchaser is a private investment company formed before April 30, 1996, the Purchaser has received the necessary consent from its beneficial owners, (c) is not a pension, profit sharing or other retirement trust fund or plan in which the partners, beneficiaries or participants, as applicable, may designate the particular investments to be made; and (d) is not a broker-dealer that owns and invests on a discretionary basis less than U.S.\$25,000,000 in securities of unaffiliated issuers. Further, the Purchaser agrees: (i) that neither it nor such account shall hold the Purchased Notes for the benefit of any other person and such purchaser of such account shall be the sole beneficial owner thereof for all purposes; and (ii) that neither it nor such account shall sell participation interests in the Purchased Notes or enter into any other arrangement pursuant to which any other person shall be entitled to a beneficial interest in the distributions on the Purchased Notes. - (e) In connection with the purchase of the Purchased Notes: (i) none of the Issuers, the Initial Purchaser, the Collateral Manager, the Collateral Adviser or the Issuer Administrator is acting as a fiduciary or financial or investment adviser for the Purchaser; (ii) the Purchaser is not relying (for purposes of making any investment decision or otherwise) upon any advice, counsel or representations (whether written or oral) of the Issuers, the Initial Purchaser, the Collateral Manager, the Collateral Adviser or the Issuer Administrator other than in the Offering Circular and any representations expressly set forth in a written agreement with such party; (iii) none of the Issuers, the Initial Purchaser, any Hedge Counterparty, the CP Put Counterparty, the Collateral Manager, the Collateral Adviser or the Issuer Administrator has given to the Purchaser (directly or indirectly through any other person) any assurance, guarantee, or representation whatsoever as to the expected or projected success, profitability, return, performance, result, effect, consequence or benefit (including legal, regulatory, tax, financial, accounting or otherwise) as to an investment in the Purchased Notes; (iv) the Purchaser has consulted with its own legal, regulatory, tax, business, investment, financial and accounting advisers to the extent it has deemed necessary, and it has made its own investment decisions (including decisions regarding the suitability of any transaction pursuant to the Indenture) based upon its own judgment and upon any advice from such advisers as it has deemed necessary and not upon any view expressed by the Issuers, the Initial Purchaser, any Hedge Counterparty, the CP Put Counterparty, the Collateral Manager, the Collateral Adviser or the Issuer Administrator; (v) the Purchaser has evaluated the rates, prices or amounts and other terms and conditions of the purchase and sale of the Purchased Notes with a full understanding of all of the risks thereof (economic and otherwise), and it is capable of assuming and willing to assume (financially and otherwise) those risks; and (vi) the Purchaser is a sophisticated investor.
